## ADOPTED SENATE

## A RESOLUTION

- 1 Authorizing the conveyance of certain state owned real property located in Richmond
- 2 County, Georgia; to repeal conflicting laws; and for other purposes.
- 3 WHEREAS, the State of Georgia is the owner of a certain tract of real property located in
- 4 Richmond County, Georgia, being a portion of the Georgia Golf Hall of Fame; and
- 5 WHEREAS, said property is all that tract or parcel of land lying and being in Richmond
- 6 County, Georgia, being in the 87th GMD, containing approximately 4.25 acres and is more
- 7 particularly described on a drawing prepared by the Georgia Golf Hall of Fame, and on file
- 8 in the offices of the State Properties Commission; and
- 9 WHEREAS, the Georgia Golf Hall of Fame Authority wishes to advertise for the
- development of a facility to be built on the above-described property a portion of which will
- be used as the museum for the Georgia Golf Hall of Fame with the remaining portion of the
- 12 facility being occupied by either the developer of the site or other public or private sector
- 13 entities; and
- 14 WHEREAS, the Georgia Golf Hall of Fame Authority has agreed to acquire the
- 15 above-described state owned real property for the fair market value and the fair market value
- has been determined to be \$970,000.00.
- 17 NOW, THEREFORE, BE IT RESOLVED BY THE GENERAL ASSEMBLY OF
- 18 GEORGIA:
- 19 **SECTION 1.**
- 20 That the State of Georgia is the owner of the above-described real property and that all
- 21 matters relating to the conveyance of the real property interest the State of Georgia is acting
- by and through the State Properties Commission for consideration of \$970,000.00 and such

1 further consideration and provisions as the State Properties Commission shall in its discretion

2 determine to be in the best interest of the State of Georgia.

3 SECTION 3.

- 4 That the above-described property shall not be conveyed to the Georgia Golf Hall of Fame
- 5 Authority until after the State Properties Commission has reviewed and approved the process
- 6 of selecting the developer of the site considered in this resolution.
- 7 SECTION 4.
- 8 That the Georgia Golf Hall of Fame Authority shall have the authority to approve all tenants
- 9 in the facility to be developed.
- 10 SECTION 5.
- 11 That the State Properties Commission is authorized and empowered to do all acts and things
- 12 necessary and proper to effect such conveyance.
- SECTION 6.
- 14 That the deed of conveyance shall be recorded by the grantee in the Superior Court of
- 15 Richmond County and a recorded copy shall be forwarded to the State Properties
- 16 Commission.
- SECTION 7.
- 18 All laws and parts of laws in conflict with this Act are repealed.
