

The House Committee on Motor Vehicles offers the following substitute to SB 407:

A BILL TO BE ENTITLED

AN ACT

1 To amend Chapter 2 of Title 40 of the Official Code of Georgia Annotated, relating to
2 registration and licensing of motor vehicles, so as to provide for special license plates
3 promoting historical preservation efforts in Georgia, promoting the AIDS Survival Project,
4 Inc., promoting the Boy Scouts of America, promoting the Georgia Chapter, Inc., an affiliate
5 of the National Wild Turkey Federation, promoting Georgia veterans and supporting the
6 Georgia War Veterans Nursing Home and the Georgia State War Veterans Home, promoting
7 organ and tissue donation organizations, promoting Special Olympics Georgia, promoting
8 the Thanks Mom and Dad Fund, promoting the 501(c)(3) foundations of the Braves, Falcons,
9 Hawks, and Thrashers sports teams in Georgia, promoting "Share the Road" messages for
10 motorists and bicyclists and programs related to such motorists and bicyclists, promoting the
11 Masons, promoting Girl Scouts U.S.A., and commemorating the Georgia Association of
12 Realtors; to provide for issuance, renewal, fees, licensing agreements, applications, transfers,
13 and disposition of funds relative to such license plates; to provide that any Georgia license
14 plate issued in the year 1970 or before shall be an authentic historical Georgia license plate
15 and to provide for display of such license plates on certain motor vehicles; to change certain
16 provisions relating to the administrative process for additional special license plates; to
17 provide for Purple Heart license plates for motorcycles; to provide for special license plates
18 promoting the Benevolent and Protective Order of the Elks; to provide for special license
19 plates displaying an image of the flag of the United States; to provide for special license
20 plates for veterans who have been awarded the Bronze Star, the Silver Star, and the
21 Distinguished Service Cross; to provide for issuance, renewal, fees, licensing agreements,
22 applications, and transfers relative to such special license plates; to provide for related
23 matters; to provide for a contingent effective date; to provide for automatic repeal under
24 certain circumstances; to repeal conflicting laws; and for other purposes.

25 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

SECTION 1.

Chapter 2 of Title 40 of the Official Code of Georgia Annotated, relating to registration and licensing of motor vehicles, is amended by adding new Code Sections 40-2-86.9 through 40-2-86.21 to read as follows:

"40-2-86.9.

(a) In order to promote historic preservation efforts in Georgia and the Division of Historic Preservation of the Department of Natural Resources, there shall be issued beginning January 1, 2005, special license plates promoting historic preservation efforts in Georgia, subject to the conditions set forth in this Code section.

(b) The commissioner shall design special distinctive license plates appropriate to promote historic preservation efforts in Georgia. The license plates must be of the same size as general issue motor vehicle license plates and shall include a unique design and identifying number, whereby the total number of characters does not exceed six. No two recipients shall receive identically numbered plates. The graphic on the special license plate shall be placed to the left of the alphanumeric characters and shall be no larger than three inches by three inches.

(c) Notwithstanding the provisions of subsection (b) of this Code section, this Code section shall not be implemented until such time as the State of Georgia has, through a licensing agreement or otherwise, received any licenses or other permissions that may be required to implement this Code section. The design of the initial edition of the license plates, as well as the design of subsequent editions and excepting only any part or parts of the designs owned by others and licensed to the state, shall be owned solely by the State of Georgia for its exclusive use and control, except as authorized by the commissioner. The commissioner may take such steps as may be necessary to give notice of and protect such right, including the copyright or copyrights. However, such steps shall be cumulative of the ownership and exclusive use and control established by this subsection as a matter of law, and no person shall reproduce or otherwise use such design or designs, except as authorized by the commissioner.

(d) Beginning in calendar year 2005, any Georgia resident who is the owner of a motor vehicle, except a vehicle registered under the International Registration Plan, upon complying with the motor vehicle laws relating to registration and licensing of motor vehicles and upon the payment of a manufacturing fee of \$25.00 in addition to the regular motor vehicle registration fee shall be issued a license plate promoting historic preservation efforts in Georgia. Revalidation decals shall be issued for such license plates in the same manner as provided for general issue license plates.

(e) From the additional \$25.00 fee charged for the issuance and renewal of the license plates authorized under this Code section, \$2.00 shall be used by the department for

1 manufacturing and purchase costs, \$13.00 shall be paid to the general fund of the state
2 treasury, and \$10.00 shall be exclusively dedicated for the purpose of promoting historic
3 preservation efforts in Georgia, pursuant to Article III, Section IX, Paragraph VI(n) of the
4 Constitution. Such dedicated funds shall be appropriated for such purpose to the
5 Department of Natural Resources or such other public agency as may be specified in the
6 general or amended general appropriations Act. The agency or organization ultimately
7 making use of such funds shall periodically provide to the commissioner an audit of the use
8 of the funds or other evidence of use of the funds satisfactory to the commissioner. Any
9 audit performed under Chapter 6 of Title 50 shall meet this auditing requirement. If an
10 audit demonstrates that the funds are not being used for the purposes set forth in this Code
11 section or if the required audit or evidence is not provided to the commissioner, then the
12 commissioner shall so notify the House and Senate Appropriations Committees. Any funds
13 appropriated pursuant to this Code section shall not lapse.

14 (f) An applicant may request a historic preservation license plate any time during the
15 applicant's registration period. If such a license plate is to replace a current valid license
16 plate, the historic preservation license plate shall be issued with appropriate decals
17 attached.

18 (g) No special license plate authorized pursuant to this Code section shall be issued except
19 upon the application of at least 1,000 applications. The special license plate shall have an
20 application period of two years after January 1, 2005, for payment of the manufacturing
21 fee. After such time if the minimum number of applications is not met, the department
22 shall not continue to accept the manufacturing fee, and all fees shall be refunded to
23 applicants.

24 (h) The department shall not be required to continue to manufacture the special license
25 plate if the number of active registrations falls below 500 registrations at any time during
26 the five-year period as provided in subsection (b) of Code Section 40-2-31. A current
27 registrant may continue to renew such special license plate during his or her annual
28 registration period upon payment of an additional \$25.00 annual special tag fee, which fee
29 shall be collected by the county tag agent at the time of collection of other registration fees
30 and shall be remitted to the state as provided in Code Section 40-2-34. The department
31 may continue to issue such special license plates that it has in its inventory to assist in
32 achieving the minimum number of registrations. If the special license plate falls below 500
33 active registrations at any time during the five-year period as provided in subsection (b) of
34 Code Section 40-2-31, manufacture of the license plates shall not be continued until the
35 commissioner receives 1,000 applications.

36 (i) Historic Preservation license plates shall be transferred from one vehicle to another
37 vehicle in accordance with the provisions of Code Section 40-2-80.

1 (j) Historic Preservation license plates shall be issued within 30 days of application once
2 the requirements of this Code section have been met.

4 (a) In order to promote the AIDS Survival Project, Inc., and activities directly in support
5 thereof, there shall be issued beginning January 1, 2005, special license plates promoting
6 the AIDS Survival Project, Inc., subject to the conditions set forth in this Code section.

7 (b) The commissioner shall design special distinctive license plates appropriate to promote
8 the AIDS Survival Project, Inc. The license plates shall be of the same size as general issue
9 motor vehicle license plates and shall include a unique design and identifying number,
10 whereby the total number of characters does not exceed six. No two recipients shall
11 receive identically numbered plates. The graphic on the special license plate shall be
12 placed to the left of the alphanumeric characters and shall be no larger than three inches by
13 three inches.

14 (c) Notwithstanding the provisions of subsection (b) of this Code section, this Code section
15 shall not be implemented until such time as the State of Georgia has, through a licensing
16 agreement or otherwise, received any licenses or other permissions that may be required

36 treasury, and \$10.00 shall be exclusively dedicated for the purpose of assisting programs

1 committed to providing people living with HIV the information and support they need
2 to live healthy and productive lives, pursuant to Article III, Section IX, Paragraph VI(n)
3 of the Constitution. Such dedicated funds shall be appropriated for such purpose to the
4 Department of Human Resources or such other public agency as may be specified in the
5 general or amended general appropriations Act. The agency or organization ultimately
6 making use of such funds shall periodically provide to the commissioner an audit of the
7 use of the funds or other evidence of use of the funds satisfactory to the commissioner.
8 Any audit performed under Chapter 6 of Title 50 shall meet this auditing requirement. If
9 an audit demonstrates that the funds are not being used for the purposes set forth in this
10 Code section or if the required audit or evidence is not provided to the commissioner,
11 then the commissioner shall so notify the House and Senate Appropriations Committees.
12 Any funds appropriated pursuant to this Code section shall not lapse.

13 (2) Subject to the general appropriations process, it is the intent of the General Assembly
14 in the enactment of this Code section that the funds dedicated by this subsection be made
15 available for the ultimate use of a nonprofit organization. Subject to the general
16 appropriations process and the audit requirements of this Code section, it is contemplated
17 that such dedicated funds will be for the ultimate use of the AIDS Survival Project, Inc.,
18 if the General Assembly finds that the license plate program and appropriation authorized
19 by this Code section will benefit both the state and the nonprofit organization having the
20 ultimate use of the dedicated funds.

21 (f) An applicant may request an AIDS Survival Project, Inc., license plate any time during
22 the applicant's registration period. If such a license plate is to replace a current valid
23 license plate, the AIDS Survival Project, Inc., license plate shall be issued with appropriate
24 decals attached.

25 (g) No special license plate authorized pursuant to this Code section shall be issued except
26 upon the application of at least 1,000 applications. The special license plate shall have an
27 application period of two years after January 1, 2005, for payment of the manufacturing
28 fee. After such time if the minimum number of applications is not met, the department
29 shall not continue to accept the manufacturing fee, and all fees shall be refunded to
30 applicants.

31 (h) The department shall not be required to continue to manufacture the special license
32 plate if the number of active registrations falls below 500 registrations at any time during
33 the five-year period as provided in subsection (b) of Code Section 40-2-31. A current
34 registrant may continue to renew such special license plate during his or her annual
35 registration period upon payment of an additional \$25.00 annual special tag fee, which fee
36 shall be collected by the county tag agent at the time of collection of other registration fees
37 and shall be remitted to the state as provided in Code Section 40-2-34. The department

1 may continue to issue such special license plates that it has in its inventory to assist in

6 (i) AIDS Survival Project, Inc., license plates shall be transferred from one vehicle to
7 another vehicle in accordance with the provisions of Code Section 40-2-80.

8 (j) AIDS Survival Project, Inc., license plates shall be issued within 30 days of application
9 once the requirements of this Code section have been met.

11 (a) In order to promote youth organizations that promote character development and
12 leadership training and activities directly in support thereof, there shall be issued beginning
13 January 1, 2005, special license plates promoting the Boy Scouts of America, subject to the
14 conditions set forth in this Code section.

15 (b) The commissioner shall design special distinctive license plates appropriate to promote
16 the Boy Scouts of America. The license plates shall be of the same size as general issue
17 motor vehicle license plates and shall include a unique design and identifying number,
18 whereby the total number of characters does not exceed six. No two recipients shall
19 receive identically numbered plates. The graphic on the special license plate shall be
20 placed to the left of the alphanumeric characters and shall be no larger than three inches by
21 three inches.

22 (c) Notwithstanding the provisions of subsection (b) of this Code section, this Code section
23 shall not be implemented until such time as the State of Georgia has, through a licensing
24 agreement or otherwise, received any licenses or other permissions that may be required
25 to implement this Code section. The design of the initial edition of the license plates, as

13 The agency or organization ultimately making use of such funds shall periodically

16 50 shall meet this auditing requirement. If an audit demonstrates that the funds are not

22 promoting the Georgia Chapter, Inc., an affiliate of the National Wild Turkey Federation,
23 subject to the conditions set forth in this Code section.

24 (b) The commissioner shall design special distinctive license plates appropriate to promote
25 the Georgia Chapter, Inc., an affiliate of the National Wild Turkey Federation. The license
26 plates shall be of the same size as general issue motor vehicle license plates and shall
27 include a unique design and identifying number, whereby the total number of characters
28 does not exceed six. No two recipients shall receive identically numbered plates. The
29 graphic on the special license plate shall be placed to the left of the alphanumeric

35 (a) In order to enhance the provision of care of the residents of the state's veterans nursing
36 homes and activities directly in support thereof, there shall be issued beginning January 1,

1 2005, special license plates promoting Georgia veterans to support the Georgia War
2 Veterans Nursing Home in Augusta, Georgia, and the Georgia State War Veterans Home
3 in Milledgeville, Georgia, subject to the conditions set forth in this Code section.

4 (b) The commissioner shall design special distinctive license plates appropriate to promote
5 Georgia veterans. The license plates must be of the same size as general issue motor
6 vehicle license plates and shall include a unique design and identifying number, whereby
7 the total number of characters does not exceed six. No two recipients shall receive
8 identically numbered plates. The graphic on the special license plate shall be placed to the
9 left of the alphanumeric characters and shall be no larger than three inches by three inches.

10 (c) Notwithstanding the provisions of subsection (b) of this Code section, this Code section
11 shall not be implemented until such time as the State of Georgia has, through a licensing

 9 transportation or for boat trailers. Additional words or symbols, in addition to the numbers
 10 and letters prescribed by law, shall be inscribed upon such license plates so as to identify
 11 distinctively the owner as a Purple Heart recipient.

12 (d) The license plate issued pursuant to this Code section shall be transferred between
 13 vehicles as provided in Code Section 40-2-80. The spouse of a deceased veteran of the
 14 armed forces of the United States who was awarded the Purple Heart citation shall continue
 15 to be eligible to be issued a distinctive personalized license plate as provided in this Code
 16 section for any vehicle owned by such veteran ownership of which is transferred to the
 17 surviving spouse or for any other vehicle owned by such surviving spouse either at the time
 18 of the qualifying veteran's death or acquired thereafter, so long as such person does not
 19 remarry.

20 (e) For each additional special license plate issued under this Code section there shall be
 21 an additional \$25.00 annual registration fee which fee shall be collected by the county tag
 22 agent at the time of collection of other registration fees and shall be remitted to the state
 23 as provided in Code Section 40-2-34.

24 (f) In lieu of the special license plate provided for in this Code section, a veteran may
 25 receive a standard Georgia license plate under the same terms and conditions."

26 SECTION 5.

27 Said chapter is further amended by adding new Code Sections 40-2-86.22 through
 28 40-2-86.24 to read as follows:

29 "40-2-86.22.

30 (a) There shall be issued beginning in 2005 special and distinctive vehicle license plates
 31 commemorating the Benevolent and Protective Order of Elks for its contributions to
 32 Georgians through programs dedicated to our youth such as 'Hoop Shoot,' 'Soccer Shoot,'
 33 'Drug Awareness and Prevention,' and youth scholarship contests; our veterans in local VA
 34 hospitals; the Elks major state project, 'Elks Aidmore Children's Center,' a home for
 35 disadvantaged youth of Georgia; and the many contributions made by local Elks lodges
 36 across the state, subject to the conditions set forth in this Code section.

1 (b) The commissioner, in cooperation with the Benevolent and Protective Order of Elks,
2 shall design special distinctive license plates to commemorate the Benevolent and
3 Protective Order of Elks. The license plates must be of the same size as general issue
4 motor vehicle license plates and shall include a unique design and identifying number,
5 whereby the total number of characters does not exceed six. No two recipients shall
6 receive identically numbered plates. The graphic on the special license plate shall be
7 placed to the left of the alphanumeric characters and shall be no larger than three inches by
8 three inches. Such design shall not provide space in which to indicate the name of the
9 county of issuance.

10 (c) Notwithstanding the foregoing provisions of this Code section, this Code section shall
11 not be implemented until such time as the State of Georgia has, through a licensing
12 agreement or otherwise and at no cost to the state, received such licenses or other
13 permissions as may be required for the use of the Benevolent and Protective Order of Elks
14 logo or as may otherwise be necessary or appropriate to implement this Code section. No
15 royalty, license fee, or other moneys shall be paid to any organization or its licensor for the
16 use by the state of such logo or design on license plates authorized by this Code section.
17 The commissioner may charge fees, take other actions, and agree to or impose terms and
18 conditions which might normally be envisioned in licensing and cross-licensing agreements
19 for the use of designs and similar intellectual property. Without limitation, the
20 commissioner may agree to allow to others the exclusive or nonexclusive use of the design
21 of the special license plate. The design of the special license plate, excepting only the
22 Benevolent and Protective Order of Elks logo and any other part of the design owned by
23 others and licensed to the state, shall be owned solely by the State of Georgia for its
24 exclusive use and control, except as authorized by the commissioner. The commissioner
25 may take such steps as may be necessary to give notice of and protect such right, including
26 the copyright. However, such steps shall be cumulative of the ownership and exclusive use
27 and control established by this subsection as a matter of law and no person shall reproduce
28 or otherwise use such design, except as authorized by the commissioner.

29 (d) Beginning in calendar year 2005, any Georgia resident who is the owner of a motor
30 vehicle, except a vehicle registered under the International Registration Plan, upon
31 complying with the motor vehicle laws relating to registration and licensing of motor
32 vehicles and upon the payment of a manufacturing fee of \$25.00 in addition to the regular
33 motor vehicle registration fee shall be issued a license plate commemorating the
34 Benevolent and Protective Order of Elks. Revalidation decals shall be issued for such
35 license plates in the same manner as provided for general issue license plates.

36 (e) An applicant may request a license plate commemorating the Benevolent and
37 Protective Order of Elks at any time during the applicant's registration period. If such a

1 license plate is to replace a current valid license plate, such license plate shall be issued
2 with appropriate decals attached.

3 (f) No special license plate authorized pursuant to this Code section shall be issued except
4 upon the receipt by the department of at least 1,000 applications. The special license plate
5 shall have an application period of two years after the effective date of this Code section,
6 for payment of the manufacturing fee. After such time if the minimum number of
7 applications is not met, the department shall not continue to accept the manufacturing fee,
8 and all fees shall be refunded to applicants.

9 (g) The department shall not be required to continue to manufacture the special license
10 plate if the number of active registrations falls below 500 registrations at any time during
11 the five-year period as provided in subsection (b) of Code Section 40-2-31. A current
12 registrant may continue to renew such special license plate during his or her annual
13 registration period upon payment of an additional \$25.00 annual special tag fee which fee
14 shall be collected by the county tag agent at the time of collection of other registration fees
15 and shall be remitted to the state as provided in Code Section 40-2-34. The department
16 may continue to issue such special license plates that it has in its inventory to assist in
17 achieving the minimum number of registrations. If the special license plate falls below 500
18 active registrations at any time during the five-year period as provided in subsection (b) of
19 Code Section 40-2-31, the department must receive 1,000 applications accompanied by the
20 manufacturing fee to continue to manufacture the license plate.

21 (h) Benevolent and Protective Order of Elks license plates shall be transferred from one
22 vehicle to another vehicle in accordance with the provisions of Code Section 40-2-80.

23 (i) Benevolent and Protective Order of Elks license plates shall be issued within 30 days
24 of application once the requirements of this Code section have been met.

25 40-2-86.23.

26 (a) There shall be issued beginning in 2005 special and distinctive vehicle license plates
27 prominently displaying an image of the flag of the United States, subject to the conditions
28 set forth in this Code section.

29 (b) The commissioner shall design special and distinctive license plates prominently
30 displaying an image of the flag of the United States. The license plates must be of the same
31 size as general issue motor vehicle license plates and shall include a unique design and
32 identifying number, whereby the total number of characters does not exceed six. No two
33 recipients shall receive identically numbered plates. The graphic on the special license
34 plate shall be placed to the left of the alphanumeric characters and shall be no larger than
35 three inches by three inches. Such design shall not provide space in which to indicate the

1 name of the county of issuance but shall instead display the phrase 'Proud To Be An
2 American.'

3 (c) The commissioner shall provide for the design of the special license plates, which
4 design, excepting only the image of the United States flag and the slogan, shall be owned
5 solely by the State of Georgia for its exclusive use and control, except as authorized by the
6 commissioner. The commissioner may take such steps as may be necessary to give notice
7 of and protect such right, including the copyright. However, such steps shall be cumulative
8 of the ownership and exclusive use and control established by this subsection as a matter
9 of law and no person shall reproduce or otherwise use such design, except as authorized
10 by the commissioner.

11 (d) Beginning in calendar year 2005, any Georgia resident who is the owner of a motor
12 vehicle, except a vehicle registered under the International Registration Plan, upon
13 complying with the motor vehicle laws relating to registration and licensing of motor
14 vehicles and upon the payment of a manufacturing fee of \$25.00 in addition to the regular
15 motor vehicle registration fee shall be issued a license plate prominently displaying an
16 image of the flag of the United States. Revalidation decals shall be issued for such license
17 plates in the same manner as provided for general issue license plates.

18 (e) An applicant may request a license plate prominently displaying an image of the flag
19 of the United States at any time during the applicant's registration period. If such a license
20 plate is to replace a current valid license plate, such license plate shall be issued with
21 appropriate decals attached.

22 (f) No special license plate authorized pursuant to this Code section shall be issued except
23 upon the receipt by the department of at least 1,000 applications. The special license plate
24 shall have an application period of two years after the effective date of this Code section,
25 for payment of the manufacturing fee. After such time if the minimum number of
26 applications is not met, the department shall not continue to accept the manufacturing fee,
27 and all fees shall be refunded to applicants.

28 (g) The department shall not be required to continue to manufacture the special license
29 plate if the number of active registrations falls below 500 registrations at any time during
30 the five-year period as provided in subsection (b) of Code Section 40-2-31. A current
31 registrant may continue to renew such special license plate during his or her annual
32 registration period upon payment of an additional \$25.00 annual special tag fee which fee
33 shall be collected by the county tag agent at the time of collection of other registration fees
34 and shall be remitted to the state as provided in Code Section 40-2-34. The department
35 may continue to issue such special license plates that it has in its inventory to assist in
36 achieving the minimum number of registrations. If the special license plate falls below 500
37 active registrations at any time during the five-year period as provided in subsection (b) of

1 Code Section 40-2-31, the department must receive 1,000 applications accompanied by the
2 manufacturing fee to continue to manufacture the license plate.

3 (h) United States flag license plates shall be transferred from one vehicle to another
4 vehicle in accordance with the provisions of Code Section 40-2-80.

5 (i) United States flag license plates shall be issued within 30 days of application once the
6 requirements of this Code section have been met.

7 40-2-86.24.

8 (a) Motor vehicle or boat trailer owners who are veterans of the armed forces of the United
9 States who have been awarded the Bronze Star (Valor), Silver Star, and Distinguished
10 Service Cross citation shall be eligible to receive at no cost a special and distinctive vehicle
11 license plate or a standard Georgia license plate for a private passenger car or truck used
12 for personal transportation or for a boat trailer. Such license plates shall be issued in
13 compliance with the state motor vehicle laws relating to registration and licensing of motor
14 vehicles as prescribed in Article 2 of this chapter.

15 (b) A veteran who qualifies for the special and distinctive license plate pursuant to
16 subsection (a) of this Code section shall make application therefor with the commissioner
17 and include the requisite fee. Said applicant may apply for and be limited to not more than
18 one free license plate at a time; provided, however, that upon payment of the regular
19 license fee provided for in Code Section 40-2-151 and payment of the manufacturing fee
20 provided for in this Code section, a veteran may obtain an additional distinctive vehicle
21 license plate. The commissioner shall promulgate such rules and regulations as may be
22 necessary to enforce compliance with all state license laws relating to the use and operation
23 of private passenger cars and trucks and boat trailers before issuing these license plates in
24 lieu of the regular Georgia license plates. The manufacturing fee for each additional special
25 and distinctive license plate shall be \$25.00. The commissioner is specifically authorized
26 to promulgate all rules and regulations necessary to ensure compliance in instances where
27 such vehicles have been transferred or sold. Except as provided in subsection (d) of this
28 Code section, such plates shall be nontransferable.

29 (c) The special and distinctive vehicle license plates shall be as prescribed in Article 2 of
30 this chapter for private passenger cars or trucks used for personal transportation or for boat
31 trailers. Additional words or symbols, in addition to the numbers and letters prescribed by
32 law, shall be inscribed upon such license plates so as to identify distinctively the owner as
33 a Bronze Star (Valor), Silver Star, or Distinguished Service Cross recipient, as appropriate.

34 (d) The license plate issued pursuant to this Code section shall be transferred between
35 vehicles as provided in Code Section 40-2-80. The spouse of a deceased veteran of the
36 armed forces of the United States who was awarded a Bronze Star (Valor), Silver Star, or

1 Distinguished Service Cross citation shall continue to be eligible to be issued a distinctive
2 personalized license plate as provided in this Code section for any vehicle owned by such
3 veteran ownership of which is transferred to the surviving spouse or for any other vehicle
4 owned by such surviving spouse either at the time of the qualifying veteran's death or
5 acquired thereafter, so long as such person does not remarry.

6 (e) For each additional special license plate issued under this Code section there shall be
7 an additional \$25.00 annual registration fee which fee shall be collected by the county tag
8 agent at the time of collection of other registration fees and shall be remitted to the state
9 as provided in Code Section 40-2-34."

10 **SECTION 6.**

11 Sections 1 and 3 of this Act shall become effective on January 1, 2005; provided, however,
12 that Sections 1 and 3 of this Act shall only become effective on January 1, 2005, upon the
13 ratification of the resolution at the November, 2004, state-wide general election, which
14 resolution amends the Constitution of the State of Georgia so as to authorize the dedication
15 of revenue from the sales of license plates to general purpose funds relating to the nature of
16 the special license plates. If such resolution is not ratified, Sections 1 and 3 of this Act shall
17 not become effective and shall stand repealed in their entirety on January 1, 2005, and no
18 such motor vehicle license plates shall be issued pursuant to Sections 1 and 3 of this Act.

19 **SECTION 7.**

20 All laws and parts of laws in conflict with this Act are repealed.
