A BILL TO BE ENTITLED

AN ACT

1 To amend an Act providing a new charter for the City of Soperton, approved March 14, 1984
 2 (Ga. L. 1984, p. 4212), as amended, particularly by an Act approved May 1, 2002 (Ga. L.
 3 2002, p. 5491), so as to annex certain tracts or parcels of land into the City of Soperton and
 4 to change the description of the council districts; to provide for definitions and inclusions;
 5 to provide for continuation in office of current members; to provide for submission of this
 6 Act for approval under the Voting Rights Act of 1965, as amended; to provide an effective
 7 date; to repeal conflicting laws; and for other purposes.

8 **BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:**

9 **SECTION 1.**

10 An Act providing a new charter for the City of Soperton, approved March 14, 1984 (Ga. L.
 11 1984, p. 4212), as amended, particularly by an Act approved May 1, 2002 (Ga. L. 2002, p.
 12 5491), is amended by adding at the end of Section 1.11 the following:

13 "In addition, the following tracts or parcels of land shall be and are included as being a part
 14 of the City of Soperton:

15 **TRACT 1:** All that tract or parcel of land lying, being and situate in the 1386th G. M.
 16 District of Treutlen County, Georgia, being described as follows: beginning at a point
 17 formed by the intersection of the existing City Limits of the City of Soperton with the
 18 southern margin of Barwick Avenue; from said point of beginning thence run north 78
 19 degrees 39 minutes 45 seconds west a distance of 273.84 feet to an iron pin; thence
 20 south 11 degrees 49 minutes 15 seconds west a distance of 208.59 feet to an iron pin;
 21 thence north 79 degrees 04 minutes 26 seconds west a distance of 416.49 feet to an iron
 22 pin; thence north 11 degrees 21 minutes 49 seconds east a distance of 207.78 feet to an
 23 iron pin situated on the southern margin of Barwick Avenue; thence running along said
 24 margin of Barwick Avenue north 78 degrees 10 minutes 05 seconds west a distance of
 25 508.48 feet to an iron pin; thence south 10 degrees 59 minutes 03 seconds west a
 26 distance of 2,350.34 feet to an iron pin; thence south 77 degrees 50 minutes 21 seconds

1 east a distance of 962.56 feet to an iron pin; thence south 04 degrees 27 minutes 03
2 seconds east a distance of 1,310.25 feet to an iron pin; thence south 10 degrees 27
3 minutes 19 seconds east a distance of 174.13 feet to an iron pin situated on the
4 southeastern margin of Georgia Highway 46; thence running along said margin of
5 Georgia Highway 46 south 56 degrees 09 minutes 27 seconds west a distance of 176.22
6 feet to an iron pin situated at the intersection of said margin of Georgia Highway 46 with
7 the northeasterly margin of County Road 159; thence continuing along the said margin
8 of County Road 159 south 44 degrees 57 minutes 05 seconds east a distance of 557.75
9 feet to an iron pin; thence north 44 degrees 56 minutes 35 seconds east a distance of
10 412.85 feet to an iron pin; thence north 15 degrees 18 minutes 18 seconds east a distance
11 of 67.0 feet to an iron pin; thence north 17 degrees 42 minutes 45 seconds west a
12 distance of 175.45 feet to an iron pin; thence north 30 degrees 20 minutes 23 seconds
13 east a distance of 179.39 feet to an iron pin; thence south 59 degrees 26 minutes 20
14 seconds east a distance of 657.56 feet to an iron pin; thence south 45 degrees 04 minutes
15 and 34 seconds west a distance of 889.43 feet to an iron pin situated on the northeastern
16 margin of County Road 159; thence continuing along said margin of County Road 159
17 south 45 degrees 08 minutes 33 seconds east a distance of 1,562.95 feet to an iron pin
18 situated at the intersection of said margin of County Road 159 with the northwestern
19 margin of County Road 131; thence continuing along the said margin of County Road
20 131 south 38 degrees 31 minutes 48 seconds west a distance of 252.83 feet to a point;
21 thence along the arc of a curve formed by the western margin of County Road 131 to a
22 point where said margin of County Road 131 intersects with the center line of Little Red
23 Bluff Creek a chord line distance and direction being south 0 degrees 45 minutes 30
24 seconds east a chord line distance of 944.34 feet to said point. From said point where
25 said margin intersects with the center line of Little Red Bluff Creek; thence run down
26 the center line of the run of Little Red Bluff Creek to an iron pin, the straight line distance
27 and direction being north 48 degrees 34 minutes 49 seconds east a distance of 463.64
28 feet to an iron pin; thence south 11 degrees 18 minutes 16 seconds east a distance of
29 365.00 feet to an iron pin; thence south 86 degrees 04 minutes 09 seconds east a distance
30 of 301.70 feet to an iron pin; thence north 03 degrees 32 minutes 33 seconds east a
31 distance of 163.32 feet to an iron pin; thence south 85 degrees 59 minutes 18 seconds
32 east a distance of 811.99 feet to an iron pin; thence south 03 degrees 47 minutes 01
33 seconds west a distance of 352.43 feet to an iron pin; thence south 78 degrees 31
34 minutes 49 seconds west a distance 442.04 feet to an iron pin; thence south 11 degrees
35 34 minutes 23 seconds east a distance of 376.87 feet to an iron pin; thence south 78
36 degrees 14 minutes 46 seconds west a distance of 274.22 feet to an iron pin; thence south
37 11 degrees 26 minutes 41 seconds east a distance of 632.29 feet to an iron pin; thence

1 north 78 degrees 19 minutes 43 seconds east a distance of 274.78 feet to an iron pin;
 2 thence south 11 degrees 44 minutes 51 seconds east a distance of 253.35 feet to an iron
 3 pin; thence north 82 degrees 50 minutes 10 seconds east a distance of 1,227.22 feet to
 4 an iron pin; thence along the center line of a branch to an iron pin situated on the
 5 western margin of U. S. Highway 221, the straight line distance and direction being north
 6 54 degrees 19 minutes 35 seconds east a distance of 1,162.99 feet; thence along the said
 7 westerly margin of U. S. Highway 221 north 04 degrees 41 minutes 19 seconds west a
 8 distance of 1,288.36 feet to an iron pin; thence south 73 degrees 23 minutes 51 seconds
 9 west a distance of 308.41 feet to an iron pin; thence south 73 degrees 26 minutes 01
 10 seconds west a distance of 669.28 feet to an iron pin; thence north 16 degrees 39
 11 minutes 43 seconds west a distance of 339.75 feet to an iron pin situated on the northern
 12 margin of Whelchel Street; thence continuing along said margin of Whelchel Street north
 13 72 degrees 27 minutes 28 seconds east a distance of 93.67 feet to an iron pin; thence
 14 north 16 degrees 49 minutes 34 seconds west a distance of 530.37 feet to an iron pin;
 15 thence north 33 degrees 32 minutes 43 seconds west a distance of 115.65 feet to an iron
 16 pin; thence north 05 degrees 37 minutes 05 seconds east a distance 336.05 feet to an iron
 17 pin; thence north 83 degrees 20 minutes 58 seconds east a distance of 534.45 feet to an
 18 iron pin; thence continuing along the western margin of Session Street in a northerly
 19 direction 230.94 feet to a point formed by the intersection of said margin of Session
 20 Street with the currently existing City Limits of the City of Soperton. Thence run along
 21 the arc formed by the old City limits in a Northwesterly direction to the point where said
 22 city limits intersects with Barwick Avenue and the point of beginning. Said tract is more
 23 particularly described in that certain plat of survey prepared by Larry C. Jones, Georgia
 24 Registered Land Surveyor, dated April 29, 2003 and recorded in Plat Book 8, page 29,
 25 and a second plat also prepared by Larry C. Jones, Surveyor, dated April 29, 2003 and

 33 Soperton with the easterly margin of U. S. Highway 221 as said highway runs south from
 34 the City of Soperton and continuing along the eastern margin of U. S. Highway 221 in

9 70 degrees 29 minutes 22 seconds west a distance of 90.0 feet to an iron pin; thence
10 north 17 degrees 46 minutes 43 seconds east a distance of 155.80 feet to an iron pin;

12 situated on the southern margin of Woodland Drive; thence continuing along said

25 distance of 168.41 feet to an iron pin; thence north 70 degrees 44 minutes 06 seconds
26 east a distance of 764.57 feet to an iron pin situated on the western margin of Georgia
27 Highway 29 as said Georgia Highway 29 runs southeast from the center of The City of
28 Soperton; from said iron pin thence run along said margin of Georgia Highway 29 in a
29 northwesterly direction a distance of 339.76 feet to the intersection of said margin with
30 the currently existing City Limits of The City of Soperton; thence running in a westerly
31 direction along the existing City Limits of The City of Soperton to a point formed by the
32 intersection of said City Limits with the eastern margin of U. S. Highway 221 as said U.
33 S. Highway 221 runs south from the center of The City of Soperton, said point being the
34 point of beginning. Said tract is more particularly described in those certain plats of
35 survey prepared by Larry C. Jones, Georgia Registered Land Surveyor, dated April 29,
36 2003, revised February 24, 2004 and recorded in Plat Book 8, page 30 in the office of the
37 Clerk of Superior Court of Treutlen County, Georgia. Said Plats are hereby incorporated

1 into this description by reference thereto for a more accurate description of the property
2 herein referred to.

3 **TRACT 3:** All that tract or parcel of land lying, being and situate in the 1386th G. M.
4 District of Treutlen County, Georgia, more particularly described as follows: Beginning
5 at a point formed by the intersection of the now existing City Limits of the City of
6 Soperton with the northern margin of Georgia Highway 46 as said highway runs in a
7 easterly direction from the center of the City of Soperton; from said point of beginning
8 thence run in an easterly direction along said margin of Georgia Highway 46 a distance
9 of 371.77 feet to an iron pin; thence north 03 degrees 22 minutes 00 seconds west a
10 distance of 210.0 feet to an iron pin; thence north 86 degrees 38 minutes 00 seconds east
11 a distance of 208.80 feet to an iron pin; thence south 03 degrees 22 minutes 00 seconds
12 east a distance of 210.0 feet to an iron pin situated on the northern margin of Georgia
13 Highway 46; thence continuing along said margin of Georgia Highway 46 north 86
14 degrees 38 minutes 00 seconds east a distance of 1,339.16 feet to a point; thence
15 continuing along the arc of a curve formed by the said northern margin of Georgia
16 Highway 46 to a point, said curve having a chord line direction of south 81 degrees 34
17 minutes 00 seconds east and a chord line distance of 1,707.99 feet to said point;
18 thence south 69 degrees 46 minutes 00 seconds east a distance of 346.42 feet to an iron pin
19 situated at the intersection of the northern margin of Georgia Highway 46 with the western
20 margin of Airport Road, also known as County Road 143; from said iron pin thence run
21 along said margin of Airport Road north 21 degrees 30 minutes 09 seconds west a distance
22 of 963.06 feet to an iron pin; thence north 20 degrees 32 minutes 13 seconds west a

29 forming the arc of a curve to a point of said curve having chord line direction of south 59

 4 an iron pin; thence south 79 degrees 07 minutes 00 seconds west a distance of 185.52 feet
 5 to an iron pin; thence south 08 degrees 06 minutes 00 seconds east a distance of 395.05 feet
 6 to an iron pin; thence north 64 degrees 08 minutes 00 seconds west a distance of 797.0 feet
 7 to a point formed by the intersection of said line with the existing City Limits of the City
 8 of Soperton; thence running along the existing City Limits of The City of Soperton in a
 9 southerly direction to a point formed by the intersection of said City Limits with the
 10 northern margin of Georgia Highway 46 and the point of beginning. Said property is more
 11 particularly described in that certain Plat of Survey prepared by Larry C. Jones, Georgia
 12 Registered Land Surveyor, dated April 29, 2003 and filed for record in Plat Book 8, page
 13 31, in the Office of the Clerk of Superior Court of Treutlen County, Georgia. Said Plat is

16 **SECTION 2.**

17 Said Act is further amended by striking Section 5.12 and inserting in its place a new Section
 18 5.12 to read as follows:

19 "SECTION 5.12.

20 Districts.

21 (a) For purposes of electing members of the city council, other than the mayor, the City
 22 of Soperton is divided into five council districts. One member of the city council shall be
 23 elected from each such district. The five council districts shall be and correspond to those
 24 five numbered districts described herein. Said districts are described as follows:

25 DISTRICT 1: Beginning at the intersection of Martin Luther King Drive with Georgia
 26 Avenue run in a northwesterly direction along Georgia Avenue to the intersection of
 27 Georgia Avenue with Manning Street; thence along Manning Street in a southwesterly
 28 direction to the intersection of Manning Street with Mississippi Avenue; thence in a
 29 southeasterly direction along Mississippi Avenue to the intersection of Mississippi
 30 Avenue with the Eastman Road; thence in a southwesterly direction along the Eastman
 31 Road to the intersection of Eastman Road with Barwick Avenue; thence running in a
 32 northwesterly direction along Barwick Avenue to the intersection of Barwick Avenue
 33 with New Street; thence along New Street in a southwesterly direction to the
 34 intersection of New Street with Outlaw Avenue; thence along Outlaw Avenue in a

1 southeasterly direction to the intersection of Outlaw Avenue with the Eastman Road;
2 thence along Eastman Road in a southeasterly direction to a point formed by the
3 intersection of the Eastman Road, also known as State Route 46, with the previously
4 existing City Limits; thence continuing along the old City Limits in a southeasterly
5 direction to a point formed by the intersection of the old City Limits with the center line
6 of Little Red Bluff Creek; thence running along the center line of Little Red Bluff Creek
7 to a point formed by the intersection of the center line of Little Red Bluff Creek with
8 Cedar Grove Road, also known as County Road No. 131: From said point where said
9 margin intersects with the center line of Little Red Bluff Creek; thence run down the
10 center line of the run of Little Red Bluff Creek to an iron pin, the straight line distance
11 and direction being north 48 degrees 34 minutes 49 seconds east a distance of 463.64
12 feet to an iron pin; thence south 11 degrees 18 minutes 16 seconds east a distance of
13 365.00 feet to an iron pin; thence south 86 degrees 04 minutes 09 seconds east a distance
14 of 301.70 feet to an iron pin; thence north 03 degrees 32 minutes 33 seconds east a
15 distance of 163.32 feet to an iron pin; thence south 85 degrees 59 minutes 18 seconds
16 east a distance of 811.99 feet to an iron pin; thence south 03 degrees 47 minutes 01
17 seconds west a distance of 352.43 feet to an iron pin; thence south 78 degrees 31

28 westerly margin of U. S. Highway 221 north 04 degrees 41 minutes 19 seconds west a
29 distance of 1,288.36 feet to an iron pin; thence south 73 degrees 23 minutes 51 seconds
30 west a distance of 308.41 feet to an iron pin; thence south 73 degrees 26 minutes 01
31 seconds west a distance of 669.28 feet to an iron pin; thence north 16 degrees 39
32 minutes 43 seconds west a distance of 339.75 feet to an iron pin situated on the northern
33 margin of Whelchel Street; thence continuing along said margin of Whelchel Street north
34 72 degrees 27 minutes 28 seconds east a distance of 93.67 feet to an iron pin; thence
35 north 16 degrees 49 minutes 34 seconds west a distance of 530.37 feet to an iron pin;
36 thence north 33 degrees 32 minutes 43 seconds west a distance of 115.65 feet to an iron
37 pin; thence north 05 degrees 37 minutes 05 seconds east a distance 336.05 feet to an iron

1 pin; thence north 83 degrees 20 minutes 58 seconds east a distance of 534.45 feet to an
 2 iron pin; thence continuing along the western margin of Session Street in a northerly
 3 direction 230.94 feet to a point formed by the intersection of said margin of Session
 4 Street with the currently existing City Limits of the City of Soperton. From the point
 5 formed by the intersection of Sessions Street with the old City Limits; thence run along
 6 the old City Limits in a northwesterly direction to a point formed by the intersection of
 7 the old City Limits with Fowler Street; thence running along Fowler Street in a
 8 northeasterly direction to a point formed by the intersection of Fowler Street with Jim
 9 Ricks Drive; thence in an easterly direction along Jim Ricks Drive to the intersection of
 10 Jim Ricks Drive with Sessions Street; thence running along Sessions Street in a
 11 northerly direction to a point formed by the intersection of Sessions Street with the Mount
 12 Vernon Road, also known as U.S. Highway 221; thence running along the Mount
 13 Vernon Road in a northerly direction to a point formed by the intersection of the Mount
 14 Vernon Road with Florida Street; thence running in a northwesterly direction along
 15 Florida Street to the intersection of Florida Street with Martin Luther King Drive; thence
 16 running along Martin Luther King Drive in a northeasterly direction to the intersection
 17 of Martin Luther King Drive with Georgia Avenue and the point of beginning.

18 DISTRICT 2: Beginning at the intersection of Eastman Road with Mississippi thence
 19 run in a northwesterly direction along Mississippi Avenue to the intersection of
 20 Mississippi Avenue with Carter Street; thence run along Carter Street in a northeasterly
 21 direction to the intersection of Carter Street with Georgia Avenue; thence running along
 22 Georgia Avenue in a southeasterly direction to the intersection of Georgia Avenue with
 23 Twiggs Street; thence running along Twiggs Street in a northeasterly direction to the
 24 intersection of Twiggs Street with Womack Avenue; thence running along Womack
 25 Avenue in a northwesterly direction to the intersection of Womack Avenue with Evans
 26 Street; thence running in a northeasterly direction along Evans Street to the intersection
 27 of Evans Street with West Louisiana Avenue; thence running in a northwesterly
 28 direction along West Louisiana Avenue to the intersection of West Louisiana Avenue
 29 with the City Limits of the City of Soperton; thence running along the arc formed by the
 30 City Limits of the City of Soperton in a southwesterly direction to the intersection of the
 31 said City Limits with Barwick Avenue; thence running along beginning at a point
 32 formed by the intersection of the existing City Limits of the City of Soperton with the
 33 southern margin of Barwick Avenue; from said point thence run north 78 degrees 39
 34 minutes 45 seconds west a distance of 273.84 feet to an iron pin; thence south 11
 35 degrees 49 minutes 15 seconds west a distance of 208.59 feet to an iron pin; thence
 36 north 79 degrees 04 minutes 26 seconds west a distance of 416.49 feet to an iron pin;
 37 thence north 11 degrees 21 minutes 49 seconds east a distance of 207.78 feet to an iron

1 pin situated on the southern margin of Barwick Avenue; thence running along said

24 (b) The Council Posts 1, 2, 3, 4, and 5, as they exist on December 31, 2003, shall be re-
 25 designated as Council Districts 1, 2, 3, 4, and 5, respectively, and as newly described under
 26 this Act, and on and after January 1, 2005, such members of the council serving from those
 27 former districts shall be deemed to be serving from and representing their respective
 28 council districts as newly described under this Act."

29 **SECTION 3.**

30 It shall be the duty of the attorney of the governing authority of the City of Soperton to
 31 submit this Act for approval pursuant to Section 5 of the federal Voting Rights Act of 1965,
 32 as amended.

33 **SECTION 4.**

34 This Act shall become effective January 1, 2005.

2 All laws and parts of laws in conflict with this Act are repealed.
