- 16 WHEREAS, she provides valuable leadership as president of the Georgia Cheerleading
- 17 Coaches' Association; and
- 18 WHEREAS, with Coach Canale's peerless leadership, the cheerleaders for Camden County
- 19 High School have compiled a brilliant record, qualifying for the state finals in every year that
- 20 cheerleading has been recognized by the Georgia High School Athletic Association and
- 21 finishing among the top ten teams in the last five years; winning the region championship in
- 22 1994, 1999, 2000, 2001, 2002, 2003, and 2004; finishing fourth place in AAAA in 2000 and
- 23 as AAAAA State Runners-Up in 2001; capturing 28 invitational victories for the varsity

- 5 2003 BBC television production of *Bring It On!*; cheered at the Georgia Dome in the football
- 6 semi-final competitions in 2002 and 2003; performed at half-time in the 1996 Nokia Sugar
- 7 Bowl; appeared on ABC's Flights and Highlights high school sports segment; and performed
- 8 in television commercials for Ironwood Homes and Quality Auto; and
