A RESOLUTION

- 1 Creating the Joint House and Senate LNG and Natural Gas Infrastructure Study Committee;
- 2 and for other purposes.
- 3 WHEREAS, the demand for natural gas in the United States is forecast to increase
- 4 significantly with all sectors of the economy, including residential, commercial, industrial,
- 5 and power generation, contributing to the growth; and
- 6 WHEREAS, clean burning liquefied natural gas (LNG) will play an increasingly significant
- 7 role in meeting that demand; and
- 8 WHEREAS, LNG facilities have historically been used to meet the peak demand for natural
- 9 gas in Georgia on the coldest days of the year; and
- 10 WHEREAS, the majority of the natural gas supply serving Georgia throughout the year has
- been transported from the Gulf of Mexico; and
- 12 WHEREAS, imported LNG is becoming an economically viable natural gas supply option;
- 13 and
- 14 WHEREAS, most imported LNG to the United States comes from Trinidad and Tobago,
- 15 Qatar, Algeria, Nigeria, Australia, and Indonesia and is transported in large, modern tankers
- 16 to one of four United States import terminals, including a facility at Elba Island, Georgia; and
- 17 WHEREAS, upon reaching its destination, imported LNG is turned back into a gas and sent
- 18 out through natural gas pipelines as ordinary natural gas; and
- 19 WHEREAS, the availability of imported LNG to the Elba Island LNG facility off the coast
- 20 of Georgia could provide additional supply reliability and supply diversity to Georgia; and

1 WHEREAS, increased diversity of natural gas supply to Georgia offsetting part of the need

- 2 for Gulf of Mexico supply will help to stabilize or lower the price for natural gas and help
- 3 to create a favorable energy market for Georgia consumers; and
- 4 WHEREAS, a favorable energy market in Georgia will aid economic development, help to
- 5 attract new jobs to Georgia, and help to secure existing jobs; and
- 6 WHEREAS, for the full benefits of LNG to be realized in Georgia, additional investment in
- 7 natural gas infrastructure, including pipelines, storage facilities, and additional LNG
- 8 terminals or facilities, is required; and
- 9 WHEREAS, accordingly, such investment in LNG and the necessary natural gas
- 10 infrastructure should be encouraged, and any disincentives to such investments contained in
- 11 current statutes, existing rules or regulations, or policies should be eliminated.
- 12 NOW, THEREFORE, BE IT RESOLVED BY THE GENERAL ASSEMBLY that there is
- 13 created the Joint House and Senate LNG and Natural Gas Infrastructure Study Committee
- 14 to be composed of five members of the House of Representatives to be appointed by the
- 15 Speaker of the House of Representatives and five members of the Senate to be appointed by
- 16 the Senate Committee on Assignments. The Speaker of the House shall designate a member
- 17 of the committee as cochairperson of the committee, and the Senate Committee on
- 18 Assignments shall designate a member of the committee as cochairperson of the committee.
- 19 The cochairpersons shall call all meetings of the committee. The cochairpersons may appoint
- 20 one or more advisory committees composed of nonmembers of the committee.
- 21 BE IT FURTHER RESOLVED that the committee shall undertake a study of the conditions,
- 22 needs, issues, challenges, and opportunities mentioned above or related thereto and shall
- 23 develop and recommend legislation which the committee deems necessary or appropriate to
- 24 address such issues. The committee may conduct such meetings at such places and at such
- 25 times as it may deem necessary or convenient to enable it to exercise fully and effectively
- 26 its powers, perform its duties, and accomplish the objectives and purposes of this resolution.
- 27 The legislative members of the committee shall receive the allowances authorized for
- 28 legislative members of interim legislative committees but shall receive the same for not more
- 29 than five days unless additional days are authorized. The members of any advisory
- 30 committee shall serve without compensation. The funds necessary to carry out the provisions
- 31 of this resolution shall come from the funds appropriated to the House of Representatives and
- 32 the Senate. In the event the committee makes a report of its findings and recommendations,

1 such report shall be made on or before December 31, 2005. The committee shall stand

2 abolished on December 31, 2005.
