ADOPTED SENATE

A RESOLUTION

- 1 Approving the creation of a new four-year college in Gwinnett County by the Board of
- 2 Regents of the University System of Georgia; and for other purposes.
- 3 WHEREAS, Article VIII, Section IV, Paragraph I(b) of the Constitution of the State of
- 4 Georgia grants to the Board of Regents of the University System of Georgia the exclusive
- 5 authority to create new public colleges, junior colleges, and universities in the State of
- 6 Georgia, subject to approval by majority vote in the House of Representatives and the
- 7 Senate; and
- 8 WHEREAS, the University System of Georgia has established an entity known as the
- 9 Gwinnett University Center, located in Lawrenceville, Georgia, as a consortium of the
- 10 University of Georgia, Georgia Perimeter College, Southern Polytechnic State University,
- and the Medical College of Georgia; and
- 12 WHEREAS, the Gwinnett University Center offers both graduate and undergraduate courses,
- and with its aggressive growth has enrolled approximately 8,000 students in Fall 2004, an
- 14 increase of 124 percent over the past five years; and
- 15 WHEREAS, Gwinnett County's burgeoning population creates a demand for access, which
- 16 the University System of Georgia wishes to provide, in that Gwinnett County has 676,000
- 17 residents and its population is expected to reach 1 million by 2020; and
- 18 WHEREAS, Gwinnett County has the largest school system in the state and already accounts
- 19 for 10 percent of Georgia's economy; and
- 20 WHEREAS, the board of regents has determined that a four-year state college with its own
- 21 leadership will better meet the higher education needs of the citizens of Gwinnett County and
- 22 the surrounding area; and

1 WHEREAS, it has been deemed by the board of regents to be in the best interest of the state

- 2 to create a free-standing four-year college in Gwinnett County as the 35th unit of the
- 3 University System of Georgia near the location of the Gwinnett University Center; and
- 4 WHEREAS, Article VIII, Section IV, Paragraph I(b) of the Constitution provides that
- 5 approval of both houses of the General Assembly is required for the creation of a new public
- 6 college.
- 7 NOW, THEREFORE, BE IT RESOLVED BY THE GENERAL ASSEMBLY OF
- 8 GEORGIA that, pursuant to Article VIII, Section IV, Paragraph I(b) of the Constitution of
- 9 the State of Georgia, this body approves the creation of a new four-year college in Gwinnett
- 10 County by the Board of Regents of the University System of Georgia.
- 11 BE IT FURTHER RESOLVED that the Secretary of the Senate is authorized and directed
- 12 to transmit an appropriate copy of this resolution to the Board of Regents of the University
- 13 System of Georgia.
