

House Bill 490

A BILL TO BE ENTITLED  
AN ACT

1 To amend Part 7 of Article 7 of Chapter 3 of Title 20 of the Official Code of Georgia  
2 Annotated, relating to HOPE scholarships and grants, so as to change certain provisions  
3 relating to HOPE scholarships at public postsecondary institutions; to provide that courses  
4 taken as postsecondary options shall not be included in HOPE hour limits for students who  
5 graduate from high school; to change certain provisions relating to HOPE scholarships at  
6 private postsecondary institutions to provide that courses taken as postsecondary options  
7 shall not be included in HOPE hour limits for students who graduate from high school; to  
8 change certain provisions relating to HOPE grants at a branch of the Georgia Department of  
9 Technical and Adult Education to provide that courses taken as postsecondary options shall  
10 not be included in HOPE hour limits for students who graduate from high school; to provide  
11 for related matters; to repeal conflicting laws; and for other purposes.

12 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

13 style="text-align:center">**SECTION 1.**

14 Part 7 of Article 7 of Chapter 3 of Title 20 of the Official Code of Georgia Annotated,  
15 relating to HOPE scholarships and grants, is amended by striking subsection (g) of Code  
16 Section 20-3-519.2, relating to eligibility requirements for HOPE scholarships at public  
17 postsecondary institutions, and inserting in lieu thereof the following:

18 "(g)(1) Except as set out in paragraph (2) of this subsection, a student may receive the  
19 HOPE scholarship until the first of these events:

20 (A) The student has earned a baccalaureate degree; or

21 (B) The student has attempted at any postsecondary institution a total of 190 quarter  
22 hours or 127 semester hours.

23 (2) A student enrolled in an undergraduate degree program designed to be more than 190  
24 quarter hours or 127 semester hours in length is eligible to receive the HOPE scholarship  
25 for the lesser of:

26 (A) A total of 225 attempted quarter hours or 150 attempted semester hours; or

1 (B) The number of hours required for graduation if the student has a cumulative grade  
 2 point average of at least 3.0 after the term in which the student attempted 190 quarter  
 3 hours or 127 semester hours.

4 (3) For purposes of this subsection, attempted hours shall include hours for courses taken  
 5 pursuant to Code Section 20-2-161.1, unless the student graduated from high school."

## 6 SECTION 2.

7 Said part is further amended by striking subsection (f) of Code Section 20-3-519.3, relating  
 8 to eligibility requirements for HOPE scholarships at private postsecondary institutions, and  
 9 inserting in lieu thereof the following:

10 "(f)(1) Except as set out in paragraph (2) of this subsection, a student may receive a HOPE  
 11 scholarship until the first of these events:

12 (A) The student has earned a baccalaureate degree; or

13 (B) The student has attempted at any postsecondary institution a total of 190 quarter  
 14 hours or 127 semester hours.

15 (2) A student enrolled in an undergraduate degree program designed to be more than 190  
 16 quarter hours or 127 semester hours in length is eligible to receive a HOPE scholarship  
 17 for the lesser of:

18 (A) A total of 225 attempted quarter hours or 150 attempted semester hours; or

19 (B) The number of hours required for graduation if the student has a cumulative grade  
 20 point average of at least 3.0 after the term in which the student attempted 190 quarter  
 21 hours or 127 semester hours.

22 (3) For purposes of this subsection, attempted hours shall include hours for courses taken  
 23 pursuant to Code Section 20-2-161.1, unless the student graduated from high school."

## 24 SECTION 3.

25 Said chapter is further amended by striking subsection (e) of Code Section 20-3-519.5,  
 26 relating to eligibility for HOPE grants at a branch of the Georgia Department of Technical  
 27 and Adult Education, and inserting in lieu thereof the following:

28 "(e) No student may receive HOPE grants for more than 95 quarter hours or 63 semester  
 29 hours of attempted coursework, except as provided for in subsection (f) of this Code  
 30 section. No student may receive more than a cumulative total of 190 quarter hours or 127  
 31 semester hours of combined HOPE scholarships and grants, unless in accordance with  
 32 Code Sections 20-3-519.2 and 20-3-519.3. For purposes of this subsection, attempted hours  
 33 shall include hours for courses taken pursuant to Code Section 20-2-161.1, unless the  
 34 student graduated from high school."
