A BILL TO BE ENTITLED AN ACT

- 1 To amend the Official Code of Georgia Annotated, so as to provide for notification to the
- 2 members of the General Assembly of the availability of annual reports, budgets, and audits;
- 3 to provide for related matters; to repeal conflicting laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

5 SECTION 1.

- 6 Code Section 8-5-8 of the Official Code of Georgia Annotated, relating to the annual report
- 7 relative to art in state buildings, is amended by striking said Code section in its entirety and
- 8 inserting in its place the following:
- 9 "8-5-8.

- In consultation with the director of the Office of Planning and Budget, the council shall
- prepare and distribute to the General Assembly an annual report relative to the art in state
- buildings program pursuant to this chapter. The council shall not be required to distribute
- copies of the annual report to the members of the General Assembly but shall notify the
- members of the availability of the annual report in the manner which it deems to be most
- 15 <u>effective and efficient.</u> Such report may be submitted as part of a report on the activities
- and programs of the council."
- 17 SECTION 2.
- 18 Code Section 10-4-58 of the Official Code of Georgia Annotated, relating to the annual
- 19 report of the state warehouse commissioner, is amended by striking said Code section in its
- 20 entirety and inserting in its place the following:
- 21 "10-4-58.
- 22 (a) The state warehouse commissioner shall make an annual report to the General
- Assembly, setting forth:
- 24 (1) Number and location of each warehouse where cotton has been received for storage
- 25 by the state;

- 1 (2) Cotton on storage and that delivered on presentation of receipts; and
- 2 (3) Such further information as the commissioner may think would be of benefit to the
- 3 public.
- 4 (b) The state warehouse commissioner shall not be required to distribute copies of the
- 5 annual report to the members of the General Assembly but shall notify the members of the
- 6 <u>availability of the annual report in the manner which he or she deems to be most effective</u>
- 7 <u>and efficient."</u>

8 SECTION 3.

- 9 Code Section 10-10-7 of the Official Code of Georgia Annotated, relating to publishing of
- an annual report by the Advanced Technology Development Center, is amended by striking
- said Code section in its entirety and inserting in its place the following:
- 12 "10-10-7.
- 13 The center, on behalf of the board, shall publish an annual report which shall be made
- 14 available to the Governor, the General Assembly, the Department of Economic
- 15 Development or any successor agency, the chairperson of the House Committee on
- 16 Economic Development and Tourism, the chairperson of the Senate Economic
- 17 Development and Tourism Committee, and the board setting forth in detail the operations
- and transactions conducted by it pursuant to this chapter. The annual report shall
- specifically account for the ways in which the needs, mission, and programs of the center
- described in this chapter have been carried out. The center shall distribute its annual report
- by such means that will make it widely available to those innovative enterprises of special
- importance to the Georgia economy. The center shall not be required to distribute copies
- of the annual report to the members of the General Assembly but shall notify the members
- of the availability of the annual report in the manner which it deems to be most effective
- 25 and efficient."

SECTION 4.

- 27 Code Section 12-3-1 of the Official Code of Georgia Annotated, relating to the duties and
- 28 powers of the Department of Natural Resources as to recreational policies and programs, is
- amended by striking paragraph (7) of subsection (a) of said Code section in its entirety and
- 30 inserting in its place the following:
- 31 "(7) To submit an annual report of activities and recommendations to the Governor and
- 32 to <u>notify</u> the General Assembly <u>of the availability of the annual report in the manner</u>
- 33 which it deems to be most effective and efficient;".

SECTION 5.

- 2 Code Section 12-5-212 of the Official Code of Georgia Annotated, relating to the annual
- 3 report relative to coastal waters, beaches, and sand dunes, is amended by striking said Code
- 4 section in its entirety and inserting in its place the following:
- 5 "12-5-212.
- 6 The department shall make an annual report to the General Assembly which shall include
- 7 a report on all funds and properties received or disbursed under this part. The department
- 8 shall not be required to distribute copies of the annual report to the members of the General
- 9 Assembly but shall notify the members of the availability of the annual report in the
- manner which it deems to be most effective and efficient."

11 SECTION 6.

- 12 Code Section 12-5-287 of the Official Code of Georgia Annotated, relating to leasing of state
- 13 owned marshland or water bottoms, is amended by striking subsection (i) of said Code
- section in its entirety and inserting in its place the following:
- 15 "(i) The department shall make an annual report of its activities each calendar year to the
- 16 General Assembly. The report shall include a summary of all applications received and
- leases granted, including length of terms, rentals, and locations. Copies of the annual report
- shall be provided to the director of the State Properties Commission, the chairperson of the
- 19 House Natural Resources and Environment Committee, the chairperson of the House
- 20 Committee on State Institutions and Property, the chairperson of the Senate Natural
- 21 Resources Committee, and the chairperson of the Senate Committee on State and Local
- Governmental Operations. The department shall not be required to distribute copies of the
- 23 <u>annual report to the members of the General Assembly but shall notify the members of the</u>
- 24 <u>availability of the annual report in the manner which it deems to be most effective and</u>
- 25 efficient."

SECTION 7.

- 27 Code Section 12-5-402 of the Official Code of Georgia Annotated, relating to powers and
- 28 duties of the Department of Natural Resources with regard to the development of the
- 29 Chattahoochee River Basin, is amended by striking paragraph (2) of subsection (b) of said
- 30 Code section in its entirety and inserting in its place the following:
- 31 "(2) To submit an annual report of its activities under this part and recommendations to
- 32 the Governor and to notify the members of the General Assembly of the availability of
- 33 the annual report and recommendations in the manner which it deems to be most effective
- 34 and efficient."

SECTION 8.

- 2 Code Section 12-5-422 of the Official Code of Georgia Annotated, relating to powers and
- 3 duties of the Department of Natural Resources with regard to the development of the
- 4 Altamaha River Basin, is amended by striking paragraph (2) of subsection (b) of said Code
- 5 section in its entirety and inserting in its place the following:
- 6 "(2) To submit an annual report of its activities under this part and recommendations to
- 7 the Governor and to notify the members of the General Assembly of the availability of
- 8 <u>the annual report and recommendations in the manner which it deems to be most effective</u>
- 9 <u>and efficient</u>."

SECTION 9.

- 11 Code Section 12-6-139 of the Official Code of Georgia Annotated, relating to audit of
- 12 accounts of the Herty Foundation, is amended by striking said Code section in its entirety and
- inserting in its place the following:
- 14 "12-6-139.
- 15 It shall be the duty of the state auditor to audit the books and accounts of the foundation
- and to submit such audit to the Governor, who shall transmit the same to each regular
- session of the General Assembly notify the members of the General Assembly of the
- availability of the audit in the manner which he or she deems to be most effective and
- 19 efficient."

20 **SECTION 10.**

- 21 Code Section 12-8-31 of the Official Code of Georgia Annotated, relating to the state solid
- waste management plan, is amended by striking the introductory language of subsection (d)
- 23 of said Code section in its entirety and inserting in its place the following:
- 24 "(d) In monitoring and reporting on the implementation success of the state solid waste
- 25 management plan required under this Code section, the Department of Community Affairs,
- with the cooperation of the division and the Georgia Environmental Facilities Authority,
- 27 beginning in January, 1992, shall report annually to the Governor and the General
- Assembly on the status of solid waste management in Georgia. The Department of
- 29 <u>Community Affairs shall not be required to distribute copies of the annual report to the</u>
- 30 members of the General Assembly but shall notify the members of the availability of the
- 31 <u>annual report in the manner which it deems to be most effective and efficient.</u> The annual
- report shall include but not be limited to:".

SECTION 11.

2 Code Section 12-8-33 of the Official Code of Georgia Annotated, relating to the Recycling

- 3 Market Development Council, is amended by striking subsection (b) of said Code section in
- 4 its entirety and inserting in its place the following:
- 5 "(b) The council shall meet as necessary and shall determine what actions, if any, are
- 6 needed to facilitate the development and expansion of markets for recovered materials in
- 7 Georgia and shall prepare an annual report with recommendations to the Governor and
- 8 General Assembly. The council shall not be required to distribute copies of the annual
- 9 report to the members of the General Assembly but shall notify the members of the
- availability of the annual report in the manner which it deems to be most effective and
- 11 <u>efficient.</u>"

12 SECTION 12.

- 13 Code Section 15-9-101 of the Official Code of Georgia Annotated, relating to powers of the
- 14 Probate Judges Training Council, bond of personnel employed by council and empowered
- 15 to handle funds, and audits, is amended by striking subsection (c) of said Code section in its
- 16 entirety and inserting in its place the following:
- 17 "(c) The training council shall establish such auditing procedures as may be required in
- connection with the handling of public funds. The state auditor is authorized and directed
- 19 to make an annual audit of the acts and doings of the training council and to make a
- complete report of the same to the General Assembly. The state auditor shall not be
- 21 required to distribute copies of the audit to the members of the General Assembly but shall
- 22 notify the members of the availability of the audit in the manner which he or she deems to
- be most effective and efficient. The report shall disclose all moneys received by the
- training council and all expenditures made by the training council, including administrative
- expense. He or she shall also make an audit of the affairs of the training council at any time
- required by a majority of the training council or the Governor of the state."

SECTION 13.

- 28 Code Section 15-18-44 of the Official Code of Georgia Annotated, relating to powers and
- 29 duties of the Prosecuting Attorneys' Council, employees' bonds, audits, and that certain
- 30 retired personnel are not to be compensated, is amended by striking subsection (c) of said
- 31 Code section in its entirety and inserting in its place the following:
- 32 "(c) The council shall establish such auditing procedures as may be required in connection
- with the handling of public funds. The state auditor is authorized and directed to make an

annual audit of the transactions of the council and to make a complete report of the same to the General Assembly. The state auditor shall not be required to distribute copies of the report to the members of the General Assembly but shall notify the members of the availability of the report in the manner which he or she deems to be most effective and efficient. The report shall disclose all moneys received by the council and all expenditures made by the council, including administrative expense. The state auditor shall also make an audit of the affairs of the council at any time when requested to do so by a majority of the council or by the Governor."

SECTION 14.

Code Section 20-2-740 of the Official Code of Georgia Annotated, relating to annual report by local boards of education regarding disciplinary and placement actions and annual study by Department of Education, is amended by striking subsection (c) of said Code section in its entirety and inserting in its place the following:

"(c) The Department of Education shall conduct a study for each school year based upon the statistical data filed by local boards pursuant to this Code section for the purpose of determining trends in discipline. The department shall also utilize existing demographic data on school personnel as needed to establish trends in discipline. Nothing in this Code section shall be construed to authorize the public release of personally identifiable information regarding students or school personnel. The department shall submit prepare a report on such study to for the General Assembly by December 1, 1999, and on the study annually thereafter and notify the members of the General Assembly of the availability of the report in the manner which it deems to be most effective and efficient."

SECTION 15.

Code Section 20-3-239 of the Official Code of Georgia Annotated, relating to annual audits and distribution of audit reports of the Georgia Student Finance Commission, is amended by striking said Code section in its entirety and inserting in its place the following:

The state auditor shall make an annual financial audit of the books, accounts, and records of the commission. The state auditor shall maintain a copy of the audit report on file in his or her office, make copies of the report available for inspection by the general public, and furnish a copy of the report to the commission, to members of the board of commissioners, and to the Governor, and to and shall notify the members of the General Assembly of the availability of the report in the manner which he or she deems to be most effective and efficient."

SECTION 16.

- 2 Code Section 20-3-268 of the Official Code of Georgia Annotated, relating to annual audits
- 3 of the Georgia Higher Education Assistance Corporation and distribution of audit reports,

- 11 corporation, <u>and</u> to the Governor, and to <u>and shall notify the</u> members of the General
- 12 Assembly of the availability of the report in the manner which he or she deems to be most
- 13 effective and efficient."

14 **SECTION 17.**

- 15 Code Section 20-3-320 of the Official Code of Georgia Annotated, relating to audits of the
- 16 Georgia Student Finance Authority and distribution of audit reports, is amended by striking
- said Code section in its entirety and inserting in its place the following:
- 18 "20-3-320.
- 19 The state auditor shall make an annual financial audit of the books, accounts, and records
- of the authority. The state auditor shall maintain a copy of the audit report on file in his or
- 21 <u>her</u> office, make copies of the report available for inspection by the general public, and
- furnish a copy of the report to the authority, to members of the board of directors of the
- authority, to the Governor, and to such other persons as may be required pursuant to
- 24 Subpart 2 of this part and shall notify the members of the General Assembly, and to such
- other persons as may be required pursuant to Subpart 2 of this part of the availability of the
- 26 report in the manner which he or she deems to be most effective and efficient. The
- authority is further authorized to have independent audits made of such books, accounts,
- and records of the authority as may be required pursuant to Subpart 2 of this part."

- 30 Code Section 20-12-8 of the Official Code of Georgia Annotated, relating to annual reports
- 31 by the board of regents regarding marine resources and oceanographic studies, is amended
- 32 by striking said Code section in its entirety and inserting in its place the following:
- 33 "20-12-8.

1 The board of regents shall make an annual report to the General Assembly which shall

- 2 include a report on all funds and properties received or disbursed under this chapter. The
- 3 board of regents shall not be required to distribute copies of the annual report to the
- 4 members of the General Assembly but shall notify the members of the availability of the

5 report in the manner which it deems to be most effective and efficient."

6 SECTION 19.

7 Code Section 20-14-27 of the Official Code of Georgia Annotated, relating to required

8 reports and publication format for the Office of Education Accountability, is amended by

striking subsection (b) of said Code section in its entirety and inserting in its place the
