

House Bill 552

A BILL TO BE ENTITLED  
AN ACT

1 To amend Part 5 of Article 1 of Chapter 8 of Title 40 of the Official Code of Georgia  
2 Annotated, relating to equipment of law enforcement and emergency vehicles, so as to  
3 provide that the commissioner of the Department of Public Safety may issue a permit to  
4 certain private vehicles for certain lights, sirens, and markings; to provide for limitations; to  
5 provide for sanctions for violations; to provide for related matters; to repeal conflicting laws;  
6 and for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 Part 5 of Article 1 of Chapter 8 of Title 40 of the Official Code of Georgia Annotated,  
10 relating to equipment of law enforcement and emergency vehicles, is amended by adding a  
11 new Code Section 40-8-92.1 to read as follows:

12 "40-8-92.1.

13 (a) Notwithstanding any provision of this part to the contrary, the commissioner may issue  
14 a permit for a private vehicle to be marked as a law enforcement vehicle and to be equipped  
15 with emergency lights and siren if such private vehicle:

16 (1) Is at least 20 years old;

17 (2) Is used only for entertainment, hobby, or historical purposes; and

18 (3) Is not used for emergency activities, to violate any traffic laws, or to cause other  
19 vehicles to stop or yield the right of way.

20 (b) The commissioner shall promulgate an application form for such vehicles. The  
21 application shall be filed by the owner of the vehicle. Each vehicle shall require a separate  
22 application. The application shall contain such information as the commissioner shall  
23 deem necessary for compliance with this Code section. The application shall identify the  
24 vehicle with particularity and shall identify the purpose or purposes for which the vehicle  
25 is to be used.

1 (c) Upon the submission of a completed application form and a fee as determined by the  
2 commissioner but not to exceed \$25.00, the commissioner shall be authorized to issue to  
3 the owner such permit for the specified vehicle. The commissioner may impose limitations  
4 on the use of such vehicle and the type of markings, lights, and sirens with which the  
5 vehicle may be equipped. Such permit shall not be transferrable.

6 (d) Upon the vehicle ceasing to be used or maintained by the person to which the permit  
7 was issued, the markings, lights, and sirens shall be removed from such vehicle and the  
8 permit returned to the commissioner with a certification that such items have been  
9 removed.

10 (e) It shall be unlawful for any person to use such a vehicle for the purpose of  
11 impersonating a law enforcement officer.

12 (f) It shall be unlawful for any person to use such a vehicle for any purpose other than the  
13 purposes permitted by this Code section or in violation of any limitation imposed by the  
14 commissioner in issuing a permit under this Code section.

15 (g) Violations of this Code section shall be punishable as a misdemeanor."

16 **SECTION 2.**

17 All laws and parts of laws in conflict with this Act are repealed.
