

The Senate Public Safety and Homeland Security Committee offered the following substitute to SB 175:

A BILL TO BE ENTITLED
AN ACT

1 To amend Article 4 of Chapter 11 of Title 16 of the Official Code of Georgia Annotated,
2 relating to dangerous instrumentalities and practices, so as to provide for the comprehensive
3 revision of certain provisions regarding Brady Law regulations; to require licensed gun
4 manufacturers, importers, and dealers to conduct the National Instant Criminal Background
5 Check; to provide for the transfer of information to the Federal Bureau of Investigation with
6 regard to persons involuntarily hospitalized; to provide for exemptions; to provide for a
7 penalty for compromising the security of records; to provide for the regulatory authority of
8 political subdivisions; to amend Code Section 35-3-34 of the Official Code of Georgia
9 Annotated, relating to disclosure and dissemination of criminal records to private persons and
10 businesses, so as to provide for the transfer of information to the Federal Bureau of
11 Investigation with regard to persons involuntarily hospitalized; to authorize the transfer and
12 dissemination of certain information for purposes of the National Instant Criminal
13 Background Check; to provide for related matters; to repeal conflicting laws; and for other
14 purposes.

15 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

SECTION 1.

16 Article 4 of Chapter 11 of Title 16 of the Official Code of Georgia Annotated, relating to
17 dangerous instrumentalities and practices, is amended by striking Part 5 in its entirety and
18 inserting in lieu thereof a new Part 5 to read as follows:

As used in this part, the term:

(1) ~~'Bureau' means the Georgia Bureau of Investigation.~~

~~(4)~~(3) ~~'Handgun' means a pistol or revolver or other handgun defined in Code Section 16-11-131 which has a short stock and is designed to be held and fired by the use of a single hand~~ 'Firearm' means any weapon that is designed to or may readily be converted to expel a projectile by the action of an explosive or the frame or receiver of any such weapon, any firearm muffler or firearm silencer, or any destructive device as defined in 18 U.S.C. Section 921(a)(3).

~~(5)~~(4) 'Involuntarily hospitalized' means hospitalized as an inpatient in any mental health facility pursuant to Code Section 37-3-81 or hospitalized as an inpatient in any mental health facility as a result of being adjudicated mentally incompetent to stand trial or being adjudicated not guilty by reason of insanity at the time of the crime pursuant to Part 2 of Article 6 of Title 17.

(5) 'NICS' means the National Instant Criminal Background Check System created by the federal 'Brady Handgun Violence Prevention Act' (P. L. No. 103-159).

~~On and after January 1, 1996, no dealer licensed pursuant to 18 U.S.C. Section 923 or Chapter 16 of Title 43 shall sell or deliver from his or her business inventory at his or her licensed premises any handgun to another person, other than a licensed importer, licensed manufacturer, licensed dealer, or licensed collector, until:~~

~~(1) The dealer has obtained a completed consent form from the potential buyer or transferee, which form shall have been promulgated by the bureau and provided by the licensed dealer, which shall include only the name, birth date, gender, race, and social security number or other identification number of such potential buyer or transferee;~~

12 (a) All transfers or purchases of firearms conducted by a licensed importer, licensed
13 manufacturer, or licensed dealer shall be subject to the NICS. To the extent possible, the
14 center shall provide to the NICS all necessary criminal history information and wanted
15 person records in order to complete an NICS check.

16 (b) The center shall forward to the Federal Bureau of Investigation information concerning
17 persons who have been involuntarily hospitalized as defined in this part for the purpose of
18 completing an NICS check.

19 (c) Any government official who willfully or intentionally compromises the identity,
20 confidentiality, and security of any records and data pursuant to this part shall be guilty of
21 a felony and fined no less than \$5,000.00 and shall be subject to automatic dismissal from
22 his or her employment.

23 (d) The provisions of this part shall not apply to:

24 (1) Any firearm, including any handgun with a matchlock, flintlock, percussion cap, or
25 similar type of ignition system, manufactured in or before 1898;

10 concerning persons involuntarily hospitalized after March 22, 1995, in a manner agreed
11 upon by the Council of Superior Court Clerks of Georgia and the Georgia Bureau of
12 Investigation to preserve the confidentiality of patients' rights in all other respects. After
13 five years have elapsed from the date that a person's involuntary hospitalization
14 information has been received by the Georgia Crime Information Center, the center shall
15 purge its records of such information as soon as practicable and in any event purge such
16 records within 30 days after the expiration of such five-year period.

17 (f) The council is empowered to adopt rules, regulations, and forms necessary to
18 implement this Code section. The council shall promulgate regulations to ensure the
19 identity, confidentiality, and security of all records and data provided in accordance with
20 this Code section."

21 SECTION 3.

22 All laws and parts of laws in conflict with this Act are repealed.
