**AS PASSED SENATE**

**A BILL TO BE ENTITLED  
AN ACT**

1 To amend Article 3 of Chapter 2 of Title 40 of the Official Code of Georgia Annotated,  
2 relating to prestige license plates for motor vehicles, so as to provide for special license  
3 plates supporting Georgia troops; to provide for issuance, renewal, fees, licensing  
4 agreements, applications, and transfers relative to such license plates; to provide for related  
5 matters; to provide an effective date; to repeal conflicting laws; and for other purposes.

6 **BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:**

7 **SECTION 1.**

8 Article 3 of Chapter 2 of Title 40 of the Official Code of Georgia Annotated, relating to  
9 prestige license plates for motor vehicles, is amended by adding a new Code Section  
10 40-2-86.10 to read as follows:

11 "40-2-86.10.

12 (a) There shall be issued beginning in 2006 special and distinctive vehicle license plates  
13 identifying persons supporting Georgia troops subject to the conditions set forth in this  
14 Code section.

15 (b) The commissioner shall design special distinctive license plates to identify persons  
16 who support Georgia troops. The license plates must be of the same size as general issue  
17 motor vehicle license plates and shall include a unique design and identifying number,  
18 whereby the total number of characters does not exceed six. No two recipients shall  
19 receive identically numbered plates. The license plate will contain the words 'Support  
20 Georgia Troops' in the space normally containing the county of issuance. Such design shall  
21 not provide space in which to indicate the name of the county of issuance. The graphic on  
22 the special license plate shall be placed to the left of the alphanumeric characters and shall  
23 be no larger than three inches by three inches.

24 (c) Notwithstanding the foregoing provisions of this Code section, this Code section shall  
25 not be implemented until such time as the State of Georgia has, through a licensing  
26 agreement or otherwise and at no cost to the state, received such licenses or other

1 permissions as may be required for the use of any logo or as may otherwise be necessary  
2 or appropriate to implement this Code section. No royalty, license fee, or other moneys  
3 shall be paid to any organization or its licensor for the use by the state of such logo or  
4 design on license plates authorized by this Code section. The commissioner may charge  
5 fees, take other actions, and agree to or impose terms and conditions which might normally  
6 be envisioned in licensing and cross-licensing agreements for the use of designs and similar  
7 intellectual property. Without limitation, the commissioner may agree to allow to others  
8 the exclusive or nonexclusive use of the design of the special license plate. The design of  
9 the special license plate, excepting only any part of the design owned by others and  
10 licensed to the state, shall be owned solely by the State of Georgia for its exclusive use and  
11 control, except as authorized by the commissioner. The commissioner may take such steps  
12 as may be necessary to give notice of and protect such right, including the copyright.  
13 However, such steps shall be cumulative of the ownership and exclusive use and control  
14 established by this subsection as a matter of law and no person shall reproduce or otherwise  
15 use such design, except as authorized by the commissioner.

16 (d) Beginning in calendar year 2006, any qualified Georgia resident who is the owner of  
17 a motor vehicle, except a vehicle registered under the International Registration Plan, upon  
18 complying with the motor vehicle laws relating to registration and licensing of motor  
19 vehicles and upon the payment of a manufacturing fee of \$25.00 in addition to the regular  
20 motor vehicle registration fee shall be issued a license plate identifying him or her as a  
21 person who supports Georgia troops. Revalidation decals shall be issued for such license  
22 plates in the same manner as provided for general issue license plates.

23 (e) An applicant may request a license plate identifying him or her as a person who  
24 supports Georgia troops at any time during the applicant's registration period. If such a  
25 license plate is to replace a current valid license plate, such license plate shall be issued  
26 with appropriate decals attached.

27 (f) No special license plate authorized pursuant to this Code section shall be issued except  
28 upon the receipt by the department of at least 1,000 applications. The special license plate  
29 shall have an application period of two years after July 1, 2005, for payment of the  
30 manufacturing fee. After such time if the minimum number of applications is not met, the  
31 department shall not continue to accept the manufacturing fee, and all fees shall be  
32 refunded to applicants.

33 (g) The department shall not be required to continue to manufacture the special license  
34 plate if the number of active registrations falls below 500 registrations at any time during  
35 the five-year period as provided in subsection (b) of Code Section 40-2-31. A current  
36 registrant may continue to renew such special license plate during his or her annual  
37 registration period upon payment of an additional \$25.00 annual special tag fee which fee

1 shall be collected by the county tag agent at the time of collection of other registration fees  
2 and shall be remitted to the state as provided in Code Section 40-2-34. The department  
3 may continue to issue such special license plates that it has in its inventory to assist in  
4 achieving the minimum number of registrations. If the special license plate falls below 500  
5 active registrations at any time during the five-year period as provided in subsection (b) of  
6 Code Section 40-2-31, the department must receive 1,000 applications accompanied by the  
7 manufacturing fee to continue to manufacture the license plate.

8 (h) License plates identifying persons who support Georgia troops shall be transferred  
9 from one vehicle to another vehicle in accordance with the provisions of Code Section  
10 40-2-80.

11 (i) License plates identifying persons who support Georgia troops shall be issued within  
12 30 days of application once the requirements of this Code section have been met."

13 **SECTION 2.**

14 This Act shall become effective on July 1, 2005.

15 **SECTION 3.**

16 All laws and parts of laws in conflict with this Act are repealed.
