

The House Committee on Game, Fish and Parks offers the following substitute to HB 662:

A BILL TO BE ENTITLED  
AN ACT

1 To amend Article 1 of Chapter 2 of Title 27 of the Official Code of Georgia Annotated,  
2 relating to hunting, trapping, and fishing licenses, so as to change certain provisions relating  
3 to game and fish license, permit, tag, and stamp fees; to repeal conflicting laws; and for other  
4 purposes.

5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

6 SECTION 1.

7 Article 1 of Chapter 2 of Title 27 of the Official Code of Georgia Annotated, relating to  
8 hunting, trapping, and fishing licenses, is amended by striking Code Section 27-2-23, relating  
9 to game and fish license, permit, tag, and stamp fees, and inserting in lieu thereof the  
10 following:  
11 "27-2-23.

 22 daily, seasonal, or annual use permits, licenses, or stamps to hunt and fish on or otherwise  
 23 use specially designated streams, lakes, or wildlife management areas or a fee not to  
 24 exceed \$73.00 for nonresident permits, licenses, or stamps issued under this paragraph."

## 25 **SECTION 2.**

26 Said article is further amended by striking Code Section 27-2-23, relating to game and fish  
 27 license, permit, tag, and stamp fees, and inserting in lieu thereof the following:
