

Senate Resolution 298

ADOPTED SENATE

A RESOLUTION

1 Creating the Joint House and Senate Emerging Communications Technologies Study
2 Committee; and for other purposes.

3 WHEREAS, as the competitiveness of broadband, Voice Over Internet Protocol, and wireless
4 services continues to increase; and

5 WHEREAS, these emerging technologies have prospered under a market based economy;
6 and

7 WHEREAS, a favorable market for these emerging technologies in Georgia will aid
8 economic development, help attract new jobs, and help secure existing jobs; and

9 WHEREAS, accordingly, investment in these emerging technologies should be encouraged
10 and any disincentives to such investments resulting from unnecessary government regulation
11 should be eliminated.

12 NOW, THEREFORE, BE IT RESOLVED BY THE GENERAL ASSEMBLY that there is
13 created the Joint House and Senate Emerging Communications Technologies Study
14 Committee to be composed of three members of the House of Representatives to be
15 appointed by the Speaker of the House of Representatives and three members of the Senate
16 to be appointed by the Senate Committee on Assignments. The Speaker of the House shall
17 designate a member of the committee as cochairperson of the committee, and the Senate
18 Committee on Assignments shall designate a member of the committee as cochairperson of
19 the committee. The cochairpersons shall call all meetings of the committee. The
20 cochairpersons may appoint an advisory committee composed of, but not limited to,
21 representatives of incumbent telecommunications companies, competitive
22 telecommunications companies (both facilities based and nonfacilities based), cable
23 companies, Internet service providers, power companies, wireless companies, consumer
24 groups, and the Public Service Commission.

1 BE IT FURTHER RESOLVED that the committee shall undertake a study of the emerging
2 technologies of broadband, Voice Over Internet Protocol, and wireless service and will
3 consider what role, if any, the Public Service Commission should play in the growth and
4 development of these competitive services, including the effect of state regulation of these
5 services on economic development, job growth, and capital investment in the State of
6 Georgia. The committee shall develop and recommend legislation for the 2006 session which
7 the committee deems necessary or appropriate to address such issues.

8 The committee may conduct such meetings at such places and at such times as it may deem
9 necessary or convenient to enable it to exercise fully and effectively its powers, perform its
10 duties, and accomplish the objectives and purposes of this resolution. The legislative
11 members of interim legislative committees shall receive the allowances authorized for
12 legislative members of interim legislative committees but shall receive the same for not more
13 than five days unless additional days are authorized. The members of any advisory
14 committee shall serve without compensation. The funds necessary to carry out the provisions
15 of this resolution shall come from the funds appropriated to the House of Representatives and
16 the Senate. In the event the committee makes a report of its findings and recommendations,
17 such report shall be made on or before December 31, 2005. The committee shall be abolished
18 on December 31, 2005.
