A BILL TO BE ENTITLED  
AN ACT

1 To amend an Act establishing the compensation of certain officials in Richmond County,  
2 approved April 12, 1982 (Ga. L. 1982, p. 3941), as amended, particularly by an Act approved  
3 February 4, 2002 (Ga. L. 2002, p. 3505), so as to provide for the compensation of certain  
4 officials in Richmond County; to provide for conforming amendments; to provide an  
5 effective date; to repeal conflicting laws; and for other purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 SECTION 1.

8 An Act establishing the compensation of certain officials in Richmond County, approved  
9 April 12, 1982 (Ga. L. 1982, p. 3941), as amended, particularly by an Act approved February  
10 4, 2002 (Ga. L. 2002, p. 3505), is amended by striking Section 1 and inserting in lieu thereof  
11 the following:

12 "SECTION 1.

13 (a) For the calendar year beginning January 1, 2006, the following officials of Richmond  
14 County, Georgia, shall receive an annual salary, payable from the funds of Richmond  
15 County, Georgia, as follows:

9 (b) For the calendar year beginning January 1, 2007, and thereafter, the following officials  
 10 of Richmond County, Georgia, shall receive an annual salary, payable from the funds of  
 11 Richmond County, Georgia, as follows:

13	(2) Judge of the probate court . . . . .	105,000.00

29 (c) The compensation provided for in subsections (a) and (b) of this section shall be paid  
 30 in equal monthly installments."

32 An Act providing for the consolidation of Richmond County and the City of Augusta,  
 33 approved March 27, 1995 (Ga. L. 1995, p. 3648), as amended, is amended by striking  
 34 subsection (e) of Section 2 in its entirety.
