

The House Committee on Ways and Means offers the following substitute to SB 227:

A BILL TO BE ENTITLED  
AN ACT

1 To amend Title 36 of the Official Code of Georgia Annotated, relating to local government,  
2 and Title 50 of the Official Code of Georgia Annotated, relating to state government, so as  
3 to provide for the entering into of cap, collar, swap, and other derivative transactions  
4 regarding interest rates that manage interest rate risk or cost with respect to the issuance of  
5 certain bonds; to provide for definitions; to provide for procedures, conditions, and  
6 limitations; to provide for powers, duties, and authority of the Georgia State Financing and  
7 Investment Commission; to provide for related matters; to provide an effective date; to repeal  
8 conflicting laws; and for other purposes.

9 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

10 **SECTION 1.**

11 Title 36 of the Official Code of Georgia Annotated, relating to local government, is amended  
12 by adding a new article at the end of Chapter 82, relating to bonds, to be designated Article  
13 11, to read as follows:

14 "ARTICLE 11

15 36-82-250.

16 As used in this article, the term:

17 (1) 'Counterparty' means the party entering into a qualified interest rate management  
18 agreement with the local governmental entity. A counterparty must be a bank, insurance  
19 company, or other financial institution duly qualified to do business in the state that  
20 either:

21 (A) Has, or whose obligations are guaranteed by an entity that has, at the time of  
22 entering into a qualified interest rate management agreement and for the entire term  
23 thereof, a long-term unsecured debt rating or financial strength rating in one of the top  
24 two ratings categories, without regard to any refinement or gradation of rating category

1 by numerical modifier or otherwise, assigned by any two of the following: Moody's  
2 Investors Service, Inc., Standard & Poors Ratings Service, a division of The  
3 McGraw-Hill Companies, Inc., Fitch, Inc., or such other nationally recognized ratings  
4 service approved by the governing body of the local governmental entity; or

5 (B) Has collateralized its obligations under a qualified interest rate management  
6 agreement in a manner approved by the local governmental entity.

7 (2) 'Debt' shall include all debt and revenue obligations that a local governmental entity  
8 is authorized to incur by law, including without limitation general obligation debt in the  
9 form of bonds or other obligations, revenue bonds and other forms of revenue  
10 obligations, and all other debt or revenue undertakings, including, but not limited to,  
11 bonds, notes, warrants, certificates or other evidences of indebtedness, or other  
12 obligations for borrowed money issued or to be issued by any local governmental entity.  
13 'Debt' includes any financing lease or installment purchase contracts of any local public  
14 authorities.

15 (3) 'Independent financial adviser' means a person or entity experienced in the financial  
16 aspects and risks of qualified interest rate management agreements that is retained by the  
17 local governmental entity to render advice with respect to a qualified interest rate  
18 management agreement. The independent financial adviser may not be the counterparty  
19 or an affiliate or agent of the counterparty on a qualified interest rate management  
20 agreement with respect to which the independent financial adviser is advising the local  
21 governmental entity.

22 (4) 'Interest rate management plan' means a written plan prepared or reviewed by an  
23 independent financial adviser with respect to qualified interest rate management  
24 agreements of the local governmental entity, which plan has been approved by the  
25 governing body of the local governmental entity.

26 (5) 'Lease or installment purchase contract' means multiyear lease, purchase, installment  
27 purchase, or lease purchase contracts within the meaning of Code Sections 20-2-506 and  
28 36-60-13 or substantially similar other or successor Code sections.

29 (6) 'Local governmental entity' means any governmental body as defined in paragraph  
30 (2) of Code Section 36-82-61, as amended; provided, however, that such term shall only  
31 include authorities which are local public authorities included in the definition thereof set  
32 forth in subparagraphs (C) and (D) of paragraph (2) of Code Section 36-82-61, as  
33 amended.

34 (7) 'Qualified interest rate management agreement' means an agreement, including a  
35 confirmation evidencing a transaction effected under a master agreement entered into by  
36 the local governmental entity in accordance with, and fulfilling the requirements of, Code  
37 Section 36-82-253, which agreement in the judgment of the local governmental entity is

1 designed to manage interest rate risk or interest cost of the local governmental entity on  
2 any debt or lease or installment purchase contract the local governmental entity is  
3 authorized to incur, including, but not limited to, interest rate swaps or exchange  
4 agreements, interest rate caps, collars, corridors, ceiling, floor, and lock agreements,  
5 forward agreements, swaptions, warrants, and other interest rate agreements which, in the  
6 judgment of the local governmental entity, will assist the local governmental entity in  
7 managing its interest rate risk or interest cost.

9 With respect to all or any portion of any debt or lease or installment purchase contract,  
10 either issued or anticipated to be issued by the local governmental entity, the local  
11 governmental entity may enter into, terminate, amend, or otherwise modify a qualified  
12 interest rate management agreement under such terms and conditions as the local  
13 governmental entity may determine, including, without limitation, provisions permitting  
14 the local governmental entity to pay to or receive from any counterparty any loss of  
15 benefits under such agreement upon early termination thereof or default under such  
16 agreement.

17 36-82-252.

18 (a) Prior to executing and delivering a qualified interest rate management agreement, the  
19 local governmental entity shall have adopted an interest rate management plan that  
20 includes:

21 (1) An analysis of the interest rate risk, basis risk, termination risk, credit risk,  
22 market-access risk, and other risks to the local governmental entity entering into qualified  
23 interest rate management agreements;

24 (2) The local governmental entity's procedure for approving and executing qualified  
25 interest rate management agreements;

26 (3) The local governmental entity's plan to monitor interest rate risk, basis risk,  
27 termination risk, credit risk, market-access risk, and other risks;

28 (4) The local governmental entity's procedure for maintaining current records of all  
29 qualified interest rate management agreements that have been approved and executed;  
30 and

31 (5) Such other provisions as may from time to time be required by the governing body  
32 of the local governmental entity, including but not limited to additional provisions due  
33 to changes in market conditions for qualified interest rate management agreements.

34 (b) The local governmental entity shall conduct an annual review of its interest rate  
35 management plan as to the adequacy of the procedures set forth in such plan for the

1 analysis and monitoring requirements set forth in subsection (a) of this Code section. A  
2 report summarizing the results of such review shall be submitted annually to the governing  
3 body of the local governmental entity. The requirements of this subsection shall not be  
4 construed as to require the review of any existing interest rate management plan by an  
5 independent financial adviser.

7 (a) Each qualified interest rate management agreement shall meet the following  
8 requirements:

9 (1) Subject to subsection (b) of this Code section, the maximum term, including any  
10 renewal periods, of any qualified interest rate management agreement may not exceed ten  
11 years unless such longer term has been approved by the governing body of the local  
12 governmental entity; provided, however, that in no case may the term of the qualified  
13 interest rate management agreement exceed the latest maturity date of the bonds, notes,  
14 or debt or lease or installment purchase contract referenced in the qualified interest rate  
15 management agreement;

16 (2) The local governmental entity shall enter into a qualified interest rate management  
17 agreement only with a counterparty meeting the requirements set forth in paragraph (1)  
18 of Code Section 36-82-250;

19 (3) Prior to the execution and delivery by the local governmental entity of any qualified  
20 interest rate management agreement, an interest rate management plan meeting the  
21 requirements of Code Section 36-82-252 must have been approved by the governing body  
22 of the local governmental entity and the governing body of the local governmental entity  
23 shall have been provided evidence that such qualified interest rate management  
24 agreement is in compliance with the existing interest rate management plan;

25 (4) Any qualified interest rate management agreement shall be payable only in the  
26 currency of the United States of America; and

27 (5) Unless otherwise approved by the governing body of the local governmental entity,  
28 the notional amount of any qualified interest rate management agreement shall not exceed  
29 the outstanding principal amount of the debt or the aggregate payments due under any  
30 lease or installment purchase contract to which such agreement relates.

31 (b) A qualified interest rate management agreement may renew from calendar year to  
32 calendar year and may provide for the payment of any fee related to a termination or a  
33 nonrenewal, so long as the following requirements are satisfied:

34 (1) Such qualified interest rate management agreement shall terminate absolutely at the  
35 close of the calendar year in which it was executed and at the close of each succeeding  
36 calendar year for which it may be renewed;

1 (2) Any such qualified interest rate management agreement may provide for automatic  
2 renewal unless positive action is taken by the local governmental entity to terminate such  
3 contract, or may provide for termination or renewal in some other manner not prohibited  
4 by law, which method of renewal or termination, in either case, shall be specified in the  
5 qualified interest rate management agreement; and

6 (3) Such qualified interest rate management agreement shall include a statement of the  
7 total obligation of the local governmental entity for the calendar year of execution and,  
8 if renewed, for the calendar year of renewal.

9 A qualified interest rate management agreement meeting the requirements of this  
10 subsection may also provide that the local governmental entity's obligations will terminate  
11 immediately and absolutely at such time as appropriated and other funds encumbered for  
12 payment by the local governmental entity pursuant to the terms of such qualified interest  
13 rate management agreement are no longer available to satisfy such obligations. The total  
14 obligation of the local governmental entity for the calendar year payable pursuant to a  
15 qualified interest rate management agreement may be stated in contingent but objective  
16 terms with respect to variable rate payments or termination payments, but in that event a  
17 qualified interest rate management agreement must provide that it will terminate  
18 immediately and absolutely at such time as appropriated and other funds encumbered for  
19 its payment are no longer available to satisfy the obligations of the local governmental  
20 entity under such agreement. A qualified interest rate management agreement executed  
21 under this subsection shall not be deemed to create a debt of the local governmental entity  
22 or otherwise obligate the payment of any sum beyond the calendar year of execution or, in  
23 the event of a renewal, beyond the calendar year of such renewal.

24 (c)(1) Any qualified interest rate management agreement of a local governmental entity  
25 may provide that it is an unconditional, limited recourse obligation of such local  
26 governmental entity payable from a specified revenue source.

27 (2) A local governmental entity may, in any qualified interest rate management  
28 agreement that constitutes a limited recourse obligation of the local governmental entity,  
29 pledge to the punctual payment of amounts due under the qualified interest rate  
30 management agreement revenues from a specified revenue source, which shall not  
31 include any taxes, including, without limitation, collateral derived from such revenue  
32 source or proceeds of the debt, including debt for future delivery, to which such qualified  
33 interest rate management agreement relates.

34 (d) A qualified interest rate management agreement that constitutes a limited recourse  
35 obligation shall not be payable from or charged upon any funds other than the revenue  
36 identified as the source of payment thereof, nor shall the local governmental entity entering  
37 into the same be subject to any pecuniary liability thereon. No counterparty under any such

1 qualified interest rate management agreement shall ever have the right to compel any  
2 exercise of the taxing power of the state or the local governmental entity to pay any amount  
3 due under any such qualified interest rate management agreement, nor to enforce payment  
4 thereof against any property of the state or local governmental entity, other than the  
5 specified revenue source; nor shall any such qualified interest rate management agreement  
6 constitute a charge, lien, or encumbrance, legal or equitable, upon any property of the state  
7 or local governmental entity, other than the specified revenue source. Every such qualified  
8 interest rate management agreement shall contain a recital setting forth the substance of this  
9 subsection.

10 (e) Any local governmental entity may enter into credit enhancement or liquidity  
11 agreements in connection with any qualified interest rate management agreement  
12 containing such terms and conditions as the governing body determines are necessary or  
13 desirable, provided that any such agreement has the same source of payment as the related  
14 qualified interest rate management agreement.

15 36-82-254.

16 The local governmental entity that has entered into a qualified interest rate management  
17 agreement shall include in its annual financial statements information with respect to each  
18 qualified interest rate management agreement it has authorized or entered into, including  
19 any information required pursuant to any statement issued by the Governmental  
20 Accounting Standards Board.

21 36-82-255.

22 When entering into any qualified interest rate management agreement authorized under this  
23 article, the agreement shall be governed by the laws of the State of Georgia, and  
24 jurisdiction over the local governmental entity in any matter concerning a qualified interest  
25 rate management agreement shall lie exclusively in the courts of the State of Georgia or in  
26 the applicable federal court having jurisdiction and located within the State of Georgia."

## 27 SECTION 2.

28 Chapter 17 of Title 50 of the Official Code of Georgia Annotated, relating to state  
29 government, is amended by adding a new article at the end of Chapter 17, relating to state  
30 debt, investment, and depositories, to be designated Article 5, to read as follows:

## "ARTICLE 5

50-17-100.

As used in this article, the term:

(1) 'Commission' means the Georgia State Financing and Investment Commission as defined in paragraph (1) of Code Section 50-17-21, as amended.

(2) 'Counterparty' means the party entering into a qualified interest rate management agreement with the state party. A counterparty must be a bank, insurance company, or other financial institution duly qualified to do business in the state that either:

(A) Has, or whose obligations are guaranteed by an entity that has, at the time of entering into a qualified interest rate management agreement and for the entire term thereof, a long-term unsecured debt rating or financial strength rating in one of the top two ratings categories, without regard to any refinement or gradation of rating category by numerical modifier or otherwise, assigned by any two of the following: Moody's Investors Service, Inc., Standard & Poors Ratings Service, a division of The McGraw-Hill Companies, Inc., Fitch, Inc., or such other nationally recognized ratings service approved by the commission; or

(B) Has collateralized its obligations under a qualified interest rate management agreement in a manner approved by the commission.

(3) 'Debt' shall include all debt and revenue obligations that a state party is authorized to incur by law, including without limitation general obligation debt in the form of bonds or other obligations, guaranteed revenue debt in the form of bonds or other obligations, revenue bonds and other forms of revenue obligations, and all other debt or revenue undertakings, including, but not limited to, bonds, notes, warrants, certificates or other evidences of indebtedness, or other obligations for borrowed money issued or to be issued by any state party. 'Debt' includes any financing lease or installment purchase contracts of any state authority.

(4) 'Independent financial adviser' means a person or entity experienced in the financial aspects and risks of qualified interest rate management agreements that is retained by the state party to render advice with respect to a qualified interest rate management agreement. The independent financial adviser may not be the counterparty or an affiliate or agent of the counterparty on a qualified interest rate management agreement with respect to which the independent financial adviser is advising the state party.

(5) 'Interest rate management plan' means a written plan prepared or reviewed by an independent financial adviser with respect to qualified interest rate management agreements of the state party.

1 (6) 'Lease or installment purchase contract' means multiyear lease, purchase, installment  
2 purchase, or lease purchase contracts within the meaning of Code Sections 50-5-64,  
3 50-5-65, and 50-5-77 or substantially similar other or successor Code sections.

4 (7) 'State party' means the state and any state authority.

5 (8) 'Qualified interest rate management agreement' means an agreement, including a  
6 confirmation evidencing a transaction effected under a master agreement, entered into by  
7 the state party in accordance with, and fulfilling the requirements of, Code Section  
8 50-17-101 which agreement in the judgment of the state party is designed to manage  
9 interest rate risk or interest cost of the state party on any debt or lease or installment  
10 purchase contract the state party is authorized to incur, including, but not limited to,  
11 interest rate swaps or exchange agreements, interest rate caps, collars, corridors, ceiling,  
12 floor, and lock agreements, forward agreements, swaptions, warrants, and other interest  
13 rate agreements which, in the judgment of the state party, will assist the state party in  
14 managing the interest rate risk or interest cost of the state or state authority.

15 (9) 'State authority' means any state authority as defined in paragraph (9) of Code Section  
16 50-17-21, as amended.

17 50-17-101.

18 (a) The commission is authorized to and shall establish guidelines, rules, or regulations  
19 with respect to the procedures for approving interest rate management plans and with  
20 respect to any requirements for qualified interest rate management agreements. Such  
21 guidelines, rules, and regulations shall apply to the interest rate management plans and  
22 qualified interest rate management agreements of any state party. Such guidelines, rules,  
23 and regulations shall not constitute a rule within the meaning of Chapter 13 of this title, the  
24 'Georgia Administrative Procedure Act,' including, without limitation, the term 'rule' as  
25 defined in paragraph (6) of Code Section 50-13-2 and used in Code Section 50-13-4.

26 (b) With respect to all or any portion of any debt or any lease or installment purchase  
27 contract, either issued or anticipated to be issued by the state party, the state party may  
28 enter into, terminate, amend, or otherwise modify a qualified interest rate management  
29 agreement under such terms and conditions as the state party may determine, including,  
30 without limitation, provisions permitting the state party to pay to or receive from any  
31 counterparty any loss of benefits under such agreement upon early termination thereof or  
32 default under such agreement.

33 (c) Payments received by a state party pursuant to the terms of a qualified interest rate  
34 management agreement shall not be deposited into the state general fund but shall be  
35 subject to disposition by the state party and applied in accord with the goals of managing  
36 interest rate risk and interest cost as set forth in the qualified interest rate management



1 agreement, any authorizing document for the debt or the lease or installment purchase  
2 contract to which such qualified interest rate management agreement relates, or such state  
3 party's interest rate management plan.

4 (d)(1) With respect to any qualified interest rate management agreement related to all or  
5 any portion of debt of a state party, the obligations of the state party contained in such  
6 qualified interest rate management agreement may be incurred as related or additional  
7 obligations of such debt and approved in the same manner as required for authorizing,  
8 approving, and issuing such debt to the extent not otherwise prohibited, limited, or  
9 impractical and consistent with any tax-exempt status of the related debt. If this power  
10 is exercised with respect to state debt, the obligations to pay a counterparty shall be  
11 subordinate to the obligations to pay holders of general obligation debt, guaranteed  
12 revenue debt, and all payments required under contracts entitled to the protection of the  
13 second paragraph of Paragraph I(a), Section VI, Article IX of the Constitution of 1976.

14 (2) When the obligations of the state party are not incurred as related or additional  
15 obligations pursuant to paragraph (1) of this subsection and the qualified interest rate  
16 management agreement relates to debt of a state authority, the qualified interest rate  
17 management agreement shall be on such terms and conditions as the state party and  
18 counterparty agree consistent with provisions of this article.

19 (3) When the obligations of the state party are not incurred as related or additional  
20 obligations pursuant to paragraph (1) of this subsection and the qualified interest rate  
21 management agreement relates to debt of the state or to a lease or installment purchase  
22 contract, the obligations of the state party contained in such qualified interest rate  
23 management agreement may renew from fiscal year to fiscal year and may provide for  
24 the payment of any fee related to a termination or a nonrenewal, so long as the following  
25 requirements are satisfied:

26 (A) Such qualified interest rate management agreement shall terminate absolutely at  
27 the close of the fiscal year in which it was executed and at the close of each succeeding  
28 fiscal year for which it may be renewed;

29 (B) Any renewal of such qualified interest rate management agreement shall require  
30 positive action taken by the state party or in such other manner not otherwise prohibited  
31 by law which method of renewal and termination, in either case, shall be specified in  
32 the qualified interest rate management agreement; and

33 (C) Such qualified interest rate management agreement shall include a statement of the  
34 total obligation of the state party for the fiscal year of execution and, if renewed, for the  
35 fiscal year of renewal.

36 A qualified interest rate management agreement meeting the requirements of this  
37 paragraph may also provide that the state's obligations will terminate immediately and

1 absolutely at such time as appropriated and other funds encumbered for payment by the  
2 state pursuant to the terms of such qualified interest rate management agreement are no  
3 longer available to satisfy such obligations. The total obligation of the state for the fiscal  
4 year payable pursuant to a qualified interest rate management agreement may be stated  
5 in contingent but objective terms with respect to variable rate payments or termination  
6 payments, but in that event a qualified interest rate management agreement must provide  
7 that it will terminate immediately and absolutely at such time as appropriated and other  
8 funds encumbered for its payment are no longer available to satisfy the obligations of the  
9 state under such agreement. A qualified interest rate management agreement executed  
10 under this paragraph shall not be deemed to create a debt of the state or otherwise  
11 obligate the payment of any sum beyond the fiscal year of execution or, in the event of  
12 a renewal, beyond the fiscal year of such renewal. When a qualified interest rate  
13 management agreement is executed under this paragraph or paragraph (1) of this  
14 subsection, the obligation of the state may be treated as an operating expense of the  
15 commission within the meaning of Paragraph VII of Section IV of Article VII of the  
16 Constitution and within the meaning of paragraph (2) of subsection (g) of Code Section  
17 50-17-22 and of subsection (b) of Code Section 50-17-27.

18 (e)(1) The obligations of a state party to pay a counterparty under a qualified interest rate  
19 management agreement with respect to debt may be paid from any lawful source, to the  
20 extent not otherwise prohibited, limited, or impractical and consistent with any tax  
21 exempt status of the related debt and in compliance with the Budget Act, including  
22 without limitation, as to the state, proceeds of general obligation debt, earnings on  
23 investments of proceeds of general obligation debt, appropriations of state and federal  
24 funds, and agency funds; and, as to any state authority, any funds of such state authority  
25 to the extent not otherwise prohibited, limited, or impractical and consistent with any tax  
26 exempt status of the related debt.

27 (2) The obligations of a state party to pay a counterparty under a qualified interest rate  
28 management agreement with respect to a lease or installment purchase contract may be  
29 paid from any lawful source, to the extent not otherwise prohibited, limited, or  
30 impractical and consistent with any tax-exempt status of the related lease or installment  
31 purchase agreement and in compliance with the Budget Act, including without limitation  
32 appropriations of state and federal funds and agency funds.

33 (f)(1) With respect to obligations of a state authority to pay a counterparty, any qualified  
34 interest rate management agreement of a state authority may provide that it is an  
35 unconditional, limited recourse obligation of such state authority payable from a specified  
36 revenue source.

1 (2) A state authority may, in any qualified interest rate management agreement that  
2 constitutes a limited recourse obligation of the state authority, pledge to the punctual  
3 payment of amounts due under the qualified interest rate management agreement  
4 revenues from a specified revenue source, which shall not include any taxes, including  
5 without limitation collateral derived from such revenue source or proceeds of the debt,  
6 including debt for future delivery, to which such qualified interest rate management  
7 agreement relates.

8 (3) A qualified interest rate management agreement that constitutes a limited recourse  
9 obligation shall not be payable from or charged upon any funds other than the revenue  
10 identified as the source of payment thereof, nor shall the state authority entering into the  
11 same be subject to any pecuniary liability thereon. No counterparty under any such  
12 qualified interest rate management agreement shall ever have the right to compel any  
13 exercise of the taxing power of the state or the state authority to pay any amount due  
14 under any such qualified interest rate management agreement, nor to enforce payment  
15 thereof against any property of the state or state authority, other than the specified  
16 revenue source; nor shall any such qualified interest rate management agreement  
17 constitute a charge, lien, or encumbrance, legal or equitable, upon any property of the  
18 state or state authority, other than the specified revenue source. Every such qualified  
19 interest rate management agreement shall contain a recital setting forth the substance of  
20 this paragraph.

21 (g)(1) The commission shall act for the state with respect to debt of the state and a  
22 qualified interest rate management agreement. However, upon authorization of the  
23 Governor, the Office of Treasury and Fiscal Services shall act as fiscal agent or provide  
24 other administrative services.

25 (2) A state authority shall act for itself with respect to an interest rate management plan,  
26 a qualified interest rate management agreement, and an independent financial advisor  
27 regarding the debt of the state authority subject, however, to the guidelines, rules, and  
28 regulations of the commission under subsection (a) of this Code section. Further, the  
29 interest rate management plan, a qualified interest rate management agreement, and  
30 retention of an independent financial advisor will be treated as financial advisory matters  
31 within the exclusive authority and jurisdiction of the commission under paragraph (1) of  
32 subsection (f) of Code Section 50-17-22 and will require specific commission approval,  
33 unless the commission otherwise directs in either the specific case or in general terms.  
34 Upon authorization of the Governor, the Office of Treasury and Fiscal Services shall act  
35 as fiscal agent or provide other administrative services for a qualified interest rate  
36 management agreement of the state authority.

1 (3) The agency responsible for payment shall act for the state with respect to a lease or  
2 installment purchase contract but only under the supervision and approval of the  
3 commission. Upon authorization of the Governor, the Office of Treasury and Fiscal  
4 Services shall act as fiscal agent or provide other administrative services.

5 50-17-102.

6 (a) Prior to executing and delivering a qualified interest rate management agreement, the  
7 state party shall have adopted an interest rate management plan that includes:

8 (1) An analysis of the interest rate risk, basis risk, termination risk, credit risk,  
9 market-access risk, and other risks to the state party entering into qualified interest rate  
10 management agreements;

11 (2) The state party's procedure for approving and executing qualified interest rate  
12 management agreements;

13 (3) The state party's plan to monitor interest rate risk, basis risk, termination risk, credit  
14 risk, market-access risk, and other risks; and

15 (4) Such other provisions as may from time to time be required by the commission,  
16 including but not limited to additional provisions due to changes in market conditions for  
17 qualified interest rate management agreements.

18 Any interest rate management plan adopted by the state shall be approved by the  
19 commission or by a designated officer of the commission and shall have been reviewed by  
20 an independent financial adviser approved by the commission.

21 (b) The state party shall conduct an annual review of its interest rate management plan as  
22 to the adequacy of the procedures set forth in such plan for the analysis and monitoring  
23 requirements set forth in subsection (a) of this Code section. A report summarizing the  
24 results of such review shall be submitted annually to the commission and, with respect to  
25 any interest rate management plan of a state authority, to the governing body of such state  
26 authority. The requirements of this subsection shall not be construed as to require the  
27 review of any existing interest rate management plan by an independent financial adviser.

29 (a) Each qualified interest rate management agreement shall meet the following  
30 requirements:

31 (1) The maximum term, including any renewal periods, of any qualified interest rate  
32 management agreement of the state may not exceed ten years unless such longer term has  
33 been approved by the commission. In addition to approval of the commission required  
34 by paragraph (2) of subsection (g) of Code Section 50-17-101, the maximum term,  
35 including any renewal periods, of any qualified interest rate management agreement of

1 a state authority may not exceed ten years unless such longer term has been approved by  
2 the governing body of the state authority. The foregoing provisions of this paragraph  
3 notwithstanding, in no case may the term of the qualified interest rate management

11 Code Section 50-17-102 must have been submitted to the commission and the  
12 commission shall have been provided evidence that such qualified interest rate  
13 management agreement is in compliance with the existing interest rate management plan.  
14 Prior to the execution and delivery by a state authority of any qualified interest rate  
15 management agreement, an interest rate management plan meeting the requirements of  
16 Code Section 50-17-102 must have been submitted to the governing body of the state  
17 authority and the governing body of the state authority shall have been provided evidence  
18 that such qualified interest rate management agreement is in compliance with the existing  
19 interest rate management plan.

20 (4) Any qualified interest rate management agreement shall be payable only in the  
21 currency of the United States of America.

22 (5) The notional amount of any qualified interest rate management agreement shall not  
23 exceed the outstanding principal amount of the debt or the aggregate payments due under  
24 any lease or installment purchase contract to which such agreement relates unless  
25 otherwise approved in writing by the commission for any qualified interest rate  
26 management agreement executed by the state or by the governing body of the state  
27 authority for any qualified interest rate management agreement executed by a state  
28 authority, subject to the approval of the commission required by paragraph (2) of  
29 subsection (g) of Code Section 50-17-101.

30 (b) Any state party may enter into credit enhancement or liquidity agreements in  
31 connection with any qualified interest rate management agreement containing such terms  
32 and conditions as the state party determines are necessary or desirable, provided that any  
33 such agreement has the same source of payment as the related qualified interest rate  
34 management agreement.

7 When entering into any qualified interest rate management agreement authorized under this  
8 article, the agreement shall be governed by the laws of the State of Georgia, and

11 applicable federal court having jurisdiction and located within the State of Georgia."

28 are dependent on the principal amount of the obligations incurred and are determined to  
29 be appropriate costs of the project or projects for which such obligations are incurred and  
30 are authorized to be paid from bond proceeds. The commission may but need not receive  
31 an appropriation for expenditures made for fees and expenses incurred in safeguarding  
32 and protecting public health, life, and property in connection with projects for which  
33 general obligation debt has been incurred."
