A BILL TO BE ENTITLED AN ACT

1 To amend an Act to amend, consolidate, and supersede the several Acts incorporating the 2 City of Colbert, approved February 14, 1950 (Ga. L. 1950, p. 2417), as amended, so as to 3 extensively revise the city charter; to provide for incorporation, boundaries, and powers of 4 the city; to provide for a governing authority of such city and the powers, duties, authority, 5 election, terms, vacancies, compensation, expenses, qualifications, prohibitions, conflicts of interest, and suspension and removal from office relative to members of such governing 6 7 authority; to provide for inquiries and investigations; to provide for oaths, organization, meetings, quorum, voting, rules, and procedures; to provide for ordinances and codes; to 8 9 provide for a mayor and mayor pro tempore and certain duties, powers, and other matters 10 relative thereto; to provide for administrative affairs and responsibilities; to provide for 11 boards, commissions, and authorities; to provide for a city attorney, a city clerk, and other 12 personnel and matters relating thereto; to provide for rules and regulations; to provide for a 13 municipal court and the judge or judges thereof and other matters relative to those judges; 14 to provide for the court's jurisdiction, powers, practices, and procedures; to provide for the 15 right of certiorari; to provide for elections; to provide for taxation, licenses, and fees; to 16 provide for franchises, service charges, and assessments; to provide for bonded and other 17 indebtedness; to provide for auditing, accounting, budgeting, and appropriations; to provide for city contracts and purchasing; to provide for the conveyance of property and interests 18 therein; to provide for bonds for officials; to provide for prior ordinances and rules, pending 19 20 matters, and existing personnel; to provide for penalties; to provide for definitions and 21 construction; to redesignate certain provisions; to provide for other matters relative to the 22 foregoing; to provide for effective dates; to repeal conflicting laws; and for other purposes.

1	SECTION 1.
1	An Act to amend, consolidate, and supersede the several Acts incorporating the City of

6	"ARTICLE I
7	POWERS
8	SECTION 1.10.
9	Name.
10	The City of Colbert, in Madison County, Georgia, is constituted and declared a body politic
11	and corporate under the name and style Colbert, Georgia, and by that name shall have
12	perpetual succession.
13	SECTION 1.11.
14	Corporate boundaries.
15	(a) The boundaries of this city shall be those existing on the earliest effective date in 2005
16	of the adoption of this charter with such alterations as may be made from time to time in the
17	manner provided by law. The boundaries of this city at all times shall be shown on a map,
18	a written description, or any combination thereof, to be retained permanently in the office of
19	the city clerk and to be designated, as the case may be: 'Official Map (or Description) of the
20	corporate limits of the City of Colbert, Georgia.' Photographic, typed, or other copies of such
21	map or description certified by the city clerk shall be admitted as evidence in all courts and
22	shall have the same force and effect as with the original map or description.
23	(b) The city council may provide for the redrawing of any such map by ordinance to reflect
24	lawful changes in the corporate boundaries. A redrawn map shall supersede for all purposes
25	the entire map or maps which it is designated to replace.
26	SECTION 1.12.
27	Powers and construction.
28	(a) This city shall have all powers possible for a city to have under the present or future
29	Constitution and laws of this state as fully and completely as though they were specifically

- 30 enumerated in this charter. This city shall have all the powers of self-government not
- 31 otherwise prohibited by this charter or by general law.

(b) The powers of this city shall be construed liberally in favor of the city. The specific
mention or failure to mention particular powers shall not be construed as limiting in any way
the powers of this city. These powers shall include, but not be limited to, the following:

- 4 (1) Animal regulations. To regulate and license or to prohibit the keeping or running at
 5 large of animals and fowl and to provide for the impoundment of same if in violation of
 6 any ordinance or lawful order; to provide for the disposition by sale, gift, or humane
 7 destruction of animals and fowl when not redeemed as provided by ordinance; and to
 8 provide punishment for violation of ordinances enacted under this charter;
- 9 (2) Appropriations and expenditures. To make appropriations for the support of the government of the city; to authorize the expenditure of money for any purposes 10 authorized by this charter and for any purpose for which a municipality is authorized by 11 12 the laws of the State of Georgia; and to provide for the payment of expenses of the city; (3) Building regulation. To regulate and to license the erection and construction of 13 buildings and all other structures; to adopt building, housing, plumbing, electrical, gas, 14 15 and heating and air-conditioning codes; and to regulate all housing and building trades; (4) Business regulation and taxation. To levy and to provide for collection of regulatory 16 17 fees and taxes on privileges, occupations, trades, and professions as authorized by Title 18 48 of the O.C.G.A. or such other applicable laws as are or may hereafter be enacted; to 19 permit and regulate the same; to provide for the manner and method of payment of such 20 regulatory fees and taxes; and to revoke such permits after due process for failure to pay 21 any city taxes or fees;
- (5) Condemnation. To condemn property, inside or outside the corporate limits of the
 city, for present or future use and for any corporate purpose deemed necessary by the
 governing authority, utilizing procedures enumerated in Title 22 of the O.C.G.A. or such
 other applicable laws as are now or may hereafter be enacted;
- 26 (6) Contracts. To enter into contracts and agreements with other governmental entities27 and with private persons, firms, and corporations;
- (7) Emergencies. To establish procedures for determining and proclaiming that an
 emergency situation exists within or outside the city and to make and carry out all
 reasonable provisions deemed necessary to deal with or meet such an emergency for the
 protection, safety, health, or well-being of the citizens of the city;
- (8) Environmental protection. To protect and preserve the natural resources,
 environment, and vital areas of the state through the preservation and improvement of air
 quality, the restoration and maintenance of water resources, the control of erosion and
 sedimentation, the management of solid and hazardous waste, and other necessary actions
 for the protection of the environment;

(9) Fire regulations. To fix and establish fire limits and from time to time to extend,
enlarge, or restrict the same; to prescribe fire safety regulations not inconsistent with
general law, relating to both fire prevention and detection and to fire fighting; and to
prescribe penalties and punishment for violations thereof;

5 (10) Garbage fees. To levy, fix, assess, and collect a garbage, refuse, and trash collection 6 and disposal and other sanitary service charge, tax, or fee for such services as may be 7 necessary in the operation of the city from all individuals, firms, and corporations 8 residing in or doing business in the city benefiting from such services; to enforce the 9 payment of such charges, taxes, or fees; and to provide for the manner and method of 10 collecting such service charges;

(11) General health, safety, and welfare. To define, regulate, and prohibit any act,
practice, conduct, or use of property which is detrimental to health, sanitation,
cleanliness, welfare, and safety of the inhabitants of the city and to provide for the
enforcement of such standards;

(12) Gifts. To accept or refuse gifts, donations, bequests, or grants from any source for
any purpose related to powers and duties of the city and the general welfare of its
citizens, on such terms and conditions as the donor or grantor may impose;

- (13) Health and sanitation. To prescribe standards of health and sanitation and to provide
 for the enforcement of such standards;
- (14) Jail sentences. To provide that persons given jail sentences in the municipal court
 may work out such sentences in any public works or on the streets, roads, drains, and
 other public property in the city; to provide for commitment of such persons to any jail;
 or to provide for commitment of such persons to any county work camp or county jail by
 agreement with the appropriate county officials;
- (15) Motor vehicles. To regulate the operation of motor vehicles and exercise control
 over all traffic, including parking upon or across the streets, roads, alleys, and walkways
 of the city;
- (16) Municipal agencies and delegation of power. To create, alter, or abolish
 departments, boards, offices, commissions, and agencies of the city and to confer upon
 such agencies the necessary and appropriate authority for carrying out all the powers
 conferred upon or delegated to the same;
- (17) Municipal debts. To appropriate and borrow money for the payment of debts of the
 city and to issue bonds for the purpose of raising revenue to carry out any project,
 program, or venture authorized by this charter or the laws of the State of Georgia;
- (18) Municipal property ownership. To acquire, dispose of, lease, and hold in trust or
 otherwise any real, personal, or mixed property, in fee simple or lesser interest, inside or
 outside the property limits of the city;

(19) Municipal property protection. To provide for the preservation and protection of
 property and equipment of the city and the administration and use of same by the public;
 and to prescribe penalties and punishment for violations thereof;

4 (20) Municipal utilities. To acquire, lease, construct, operate, maintain, sell, and dispose
5 of public utilities, including but not limited to a system of waterworks, sewers and drains,
6 sewage disposal, gas works, electric light plants, cable television and other
7 telecommunications, transportation facilities, public airports, and any other public utility;
8 and to fix the taxes, charges, rates, fares, fees, assessments, regulations, and penalties and
9 to provide for the withdrawal of service for refusal or failure to pay the same;

(21) Nuisance. To define a nuisance and provide for its abatement whether on public orprivate property;

(22) Penalties. To provide penalties for violation of any ordinances adopted pursuant to
the authority of this charter and the laws of the State of Georgia;

(23) Planning and zoning. To provide comprehensive city planning for development by
zoning; and to provide subdivision regulation and the like as the city council deems
necessary and reasonable to ensure a safe, healthy, and esthetically pleasing community;
(24) Police and fire protection. To exercise the power of arrest through duly appointed
police officers and to establish, operate, or contract for a police and a fire-fighting
agency;

(25) Public hazards; removal. To provide for the destruction and removal of any building
or other structure which is or may become dangerous or detrimental to the public;

22 (26) Public improvements. To provide for the acquisition, construction, building, operation, and maintenance of public ways, parks and playgrounds, public grounds, 23 recreational facilities, cemeteries, markets and market houses, public buildings, libraries, 24 25 sewers, drains, sewage treatment, waterworks, electrical systems, gas systems, other 26 public utilities, public housing, airports, hospitals, terminals, docks, parking facilities, and charitable, cultural, educational, recreational, conservation, sport, curative, corrective, 27 detentional, penal, and medical institutions, agencies, and facilities; and to provide any 28 29 other public improvements, inside or outside the corporate limits of the city; to regulate the use of public improvements; and, for such purposes, property may be acquired by 30 condemnation under Title 22 of the O.C.G.A. or such other applicable laws as are now 31 32 or may hereafter be enacted;

33 (27) Public peace. To provide for the prevention and punishment of drunkenness, riots,
34 and public disturbances;

(28) Public transportation. To organize and operate or contract for such public
 transportation systems as are deemed beneficial;

(29) Public utilities and services. To grant franchises or make contracts for or impose
taxes on public utilities and public service companies and to prescribe the rates, fares,
regulations, and standards and conditions of service applicable to the service to be
provided by the franchise grantee or contractor, insofar as not in conflict with valid
regulations of the Georgia Public Service Commission;

6 (30) Regulation of roadside areas. To prohibit or regulate and control the erection, 7 removal, and maintenance of signs, billboards, trees, shrubs, fences, buildings, and any 8 and all other structures or obstructions upon or adjacent to the rights of way of streets and 9 roads or within view thereof, within or abutting the corporate limits of the city; and to 10 prescribe penalties and punishment for violation of such ordinances;

(31) Retirement. To provide and maintain a retirement plan for officers and employeesof the city;

(32) Roadways. To lay out, open, extend, widen, narrow, establish or change the grade
of, abandon or close, construct, pave, curb, gutter, adorn with shade trees, or otherwise
improve, maintain, repair, clean, prevent erosion of, and light the roads, alleys, and
walkways within the corporate limits of the city; and to grant franchises and rights of way
throughout the streets and roads and over the bridges and viaducts for the use of public
utilities; and to require real estate owners to repair and maintain in a safe condition the
sidewalks adjoining their lots or lands and to impose penalties for failure to do so;

(33) Sewer fees. To levy a fee, charge, or sewer tax as necessary to assure the acquiring,
constructing, equipping, operating, maintaining, and extending of a sewage disposal plant
and sewerage system and to levy on those to whom sewers and sewerage systems are
made available a sewer service fee, charge, or sewer tax for the availability or use of the
sewers; to provide for the manner and method of collecting such service charges and for
enforcing payment of the same; and to charge, impose, and collect a sewer connection fee
or fees to those connected with the system;

(34) Solid waste disposal. To provide for the collection and disposal of garbage, rubbish,
and refuse and to regulate the collection and disposal of garbage, rubbish, and refuse by
others; and to provide for the separate collection of glass, tin, aluminum, cardboard,
paper, and other recyclable materials and to provide for the sale of such items;

(35) Special areas of public regulation. To regulate or prohibit junk dealers, pawn shops,
the manufacture, sale, or transportation of any intoxicating liquors, alcoholic beverages,
and the use of firearms; to regulate the transportation, storage, and use of combustible,
explosive, and inflammable materials, the use of lighting and heating equipment, and any
other business or situation which may be dangerous to persons or property; to regulate
and control the conduct of peddlers and itinerant traders, theatrical performances,

1 exhibitions, and shows of any kind, by taxation or otherwise; and to license, tax, regulate, 2 or prohibit professional fortunetelling, palmistry, adult bookstores, and massage parlors; 3 (36) Special assessments. To levy and provide for the collection of special assessments 4 to cover the costs for any public improvements; 5 (37) Taxes: ad valorem. To levy and provide for the assessment, valuation, revaluation, 6 and collection of taxes on all property subject to taxation; (38) Taxes: other. To levy and collect such other taxes as may be allowed now or in the 7 8 future by law; 9 (39) Taxicabs. To regulate and license vehicles operated for hire in the city; to limit the 10 number of such vehicles; to require the operators thereof to be licensed; to require public liability insurance on such vehicles in the amounts to be prescribed by ordinance; and to 11 12 regulate the parking of such vehicles; (40) Urban redevelopment. To organize and operate an urban redevelopment program; 13 14 and 15 (41) Other powers. To exercise and enjoy all other powers, functions, rights, privileges, and immunities necessary or desirable to promote or protect the safety, health, peace, 16 17 security, good order, comfort, convenience, or general welfare of the city and its 18 inhabitants; and to exercise all implied powers necessary or desirable to carry into 19 execution all powers granted in this charter as fully and completely as if such powers 20 were fully stated in this charter; and to exercise all powers now or in the future authorized 21 to be exercised by other municipal governments under other laws of the State of Georgia; 22 and no listing of particular powers in this charter shall be held to be exclusive of others, 23 nor restrictive of general words and phrases granting powers, but shall be held to be in addition to such powers unless expressly prohibited to municipalities under the 24 25 Constitution or applicable laws of the State of Georgia.

SECTION 1.13.

27 Exercise of powers.

All powers, functions, rights, privileges, and immunities of the city, its officers, agencies, or employees shall be carried into execution as provided by this charter. If this charter makes no provision, such shall be carried into execution as provided by ordinance or as provided by pertinent laws of the State of Georgia.

1	ARTICLE II
2	GOVERNMENT STRUCTURE
3	SECTION 2.10.
4	City council creation; number; election.

5 The legislative authority of the government of this city, except as otherwise specifically 6 provided in this charter, shall be vested in a city council to be composed of a mayor and four 7 councilmembers. The city council established in this charter shall in all respects be a 8 successor to and continuation of the city governing authority under prior law. Those persons 9 serving as members of the city council on the effective date of this charter shall serve the 10 remainder of their terms in office and until their successors are elected and qualified. The 11 mayor and councilmembers shall be elected in the manner provided by this charter.

12 **SECTION 2.11.** 13 City councilmembers; 14 terms and qualifications for office. 15 The members of the city council shall serve for terms of two years and until their respective 16 successors are elected and qualified. The term of office of each member of the city council 17 shall begin on the first Monday of January immediately following the election of such 18 member. No person shall be eligible to serve as mayor or councilmember unless that person 19 shall have been a resident of the city for 12 months prior to the date of the election of mayor 20 or members of the city council; each shall continue to reside therein during that person's 21 period of service and to be registered and qualified to vote in municipal elections of this city.

SECTION 2.12.

Vacancy; filling of vacancies; suspensions.

(a) Vacancies—The office of mayor or councilmember shall become vacant upon such person's failing or ceasing to reside in the city or upon the occurrence of any event specified by the Constitution, Title 45 of the O.C.G.A., or such other applicable laws as are or may hereafter be enacted.

(b) Filling of vacancies—A vacancy in the office of mayor or councilmember shall be filled 29 for the remainder of the unexpired term, if any, by appointment if less than 12 months remain in the unexpired term, otherwise by an election as provided for in Section 5.14 of this charter 30 31 and Titles 21 and 45 of the O.C.G.A. or such other laws as are or may hereafter be enacted. 32 (c) Suspension—Upon the suspension from office of mayor or councilmember in any manner authorized by the general laws of the State of Georgia, the city council or those 33

1	remaining shall appoint a successor for the duration of the suspension. If the suspension
2	becomes permanent, then the office shall become vacant and shall be filled for the remainder
3	of the unexpired term, if any, as provided for in this charter.
4	SECTION 2.13.
5	Compensation and expenses.
6	The mayor and councilmembers shall receive compensation and expenses for their services
7	as provided by ordinance.
8	SECTION 2.14.
9	Holding other office;
10	voting when personally interested.
11	(a) Elected and appointed officers of the city are trustees and servants of the residents of the
12	city and shall act in a fiduciary capacity for the benefit of such residents.
13	(b) Except as authorized by law, no councilmember nor the mayor shall hold any other city
14	office or city employment during the term for which that person was elected.
15	(c) No councilmember nor the mayor shall vote upon, sign, or veto any ordinance,
16	resolution, contract, or other matter in which that person is financially interested.
17	SECTION 2.15.
18	Inquiries and investigations.
19	Following the adoption of an authorizing resolution, the city council may make inquiries and
20	investigations into the affairs of the city and conduct of any department, office, or agency
21	thereof and for this purpose may subpoena witnesses, administer oaths, take testimony, and
22	require the production of evidence. Any person who fails or refuses to obey a lawful order
23	issued in the exercise of these powers by the city council shall be punished as may be
24	provided by ordinance.
25	SECTION 2.16.
26	General power and authority of the city council.
27	Except as otherwise provided by law or this charter, the city council shall be vested with all
28	the powers of government of this city.

1	SECTION 2.17.
2	Organizational meetings.
3	The city council shall hold an organizational meeting on the first Monday of January in each
4	year. The meeting shall be called to order by the city clerk and the oath of office shall be
5	administered to the newly elected members as follows:
6	'I do solemnly (swear) (affirm) that I will faithfully perform the duties of (mayor)
7	(councilmember) of this city and that I will support and defend the charter thereof as well
8	as the Constitution and laws of the State of Georgia and the United States of America.'
9	SECTION 2.18.
10	Meetings.
11	(a) The city council shall hold regular meetings at such times and places as shall be
12	prescribed by ordinance.
13	(b) Special meetings of the city council may be held on call of the mayor or three members
14	of the city council. Notice of such special meeting shall be served on all other members
15	personally, or by telephone personally, at least 48 hours in advance of the meeting. Such
16	notice to councilmembers shall not be required if the mayor and all councilmembers are
17	present when the special meeting is called. Such notice of any special meeting may be
18	waived by a councilmember in writing before or after such a meeting and attendance at the
19	meeting shall also constitute a waiver of notice on any business transacted in such
20	councilmember's presence. Only the business stated in the call may be transacted at the
21	special meeting.
22	(c) All meetings of the city council shall be public to the extent required by law, and notice
23	to the public of special meetings shall be made as fully as is reasonably possible as provided
24	by Code Section 50-14-1 of the O.C.G.A. or other such applicable laws as are or may
25	hereafter be enacted.
26	SECTION 2.19.
27	Rules of procedure.
28	(a) The city council shall adopt its rules of procedure and order of business consistent with
29	the provisions of this charter and shall provide for keeping of a journal of its proceedings,
30	which shall be a public record.
31	(b) All committees and committee chairpersons and officers of the city council shall be
32	appointed by the mayor and shall serve at the pleasure of the mayor. The mayor shall have
33	the power to appoint new members to any committee at any time.

1	SECTION 2.20.
2	Quorum; voting.
3	Three councilmembers shall constitute a quorum and shall be authorized to transact business
4	of the city council. Voting on the adoption of ordinances shall be by voice vote and the vote
5	shall be recorded in the journal, but any councilmember shall have the right to request a
6	roll-call vote and such vote shall be recorded in the journal. Except as otherwise provided
7	in this charter, the affirmative vote of three councilmembers or in case of a tie two
8	councilmembers and the mayor shall be required for the adoption of any ordinance,
9	resolution, or motion. An abstention shall be counted as an affirmative vote. On all questions
10	before the city council, the mayor, or mayor pro tempore if he or she be presiding, shall be
11	entitled to vote only in the case of a tie.
12	SECTION 2.21.
13	Ordinance form; procedures.
14	(a) Every proposed ordinance should be introduced in writing and in the form required for
15	final adoption. No ordinance shall contain a subject which is not expressed in its title. The
16	enacting clause shall be 'It is hereby ordained by the governing authority of the City of
17	Colbert' and every ordinance shall so begin.
18	(b) An ordinance may be introduced by any councilmember and be read at a regular or
19	special meeting of the city council. Ordinances shall be considered and adopted or rejected
20	by the city council in accordance with the rules which it shall establish. Upon introduction
21	of any ordinance, the clerk shall as soon as possible distribute a copy to the mayor and to
22	each councilmember and shall file a reasonable number of copies in the office of the clerk
23	and at such other public places as the city council may designate.
24	SECTION 2.22.
25	Action requiring an ordinance.
26	Acts of the city council which have the force and effect of law shall be enacted by ordinance.
27	SECTION 2.23.
28	Emergencies.
29	(a) To meet a public emergency affecting life, health, property, or public peace, the city
30	council may convene on call of the mayor or three councilmembers and may promptly adopt
31	an emergency ordinance, but such ordinance may not levy taxes; grant, renew, or extend a
32	franchise; regulate the rate charged by any public utility for its services; or authorize the
33	borrowing of money except for loans to be repaid within 30 days. An emergency ordinance
34	shall be introduced in the form prescribed for ordinances generally, except that it shall be

1 plainly designated as an emergency ordinance and shall contain, after the enacting clause, 2 a declaration stating that an emergency exists and describing the emergency in clear and 3 specific terms. An emergency ordinance may be adopted, with or without amendment, or 4 rejected at the meeting at which it is introduced, but the affirmative vote of at least three 5 councilmembers or in case of a tie two councilmembers and the mayor shall be required for adoption. It shall become effective upon adoption or at such later time as it may specify. 6 7 Every emergency ordinance shall automatically stand repealed 30 days following the date 8 upon which it was adopted, but this shall not prevent reenactment of the ordinance in the 9 manner specified in this section if the emergency still exists. An emergency ordinance may 10 also be repealed by adoption of a repealing ordinance in the same manner specified in this 11 section for adoption of emergency ordinances. 12 (b) Such meetings shall be open to the public to the extent required by law and notice to the

public of emergency meetings shall be made as fully as is reasonably possible in accordance
with Code Section 50-14-1 of the O.C.G.A. or such other applicable laws as are or may

15 hereafter be enacted.

SECTION 2.24.

Codes of technical regulations.

18 (a) The city council may adopt any standard code of technical regulations by reference 19 thereto in an adopting ordinance. The procedure and requirements governing such adopting 20 ordinance shall be as prescribed for ordinances generally except that: (1) the requirements 21 of subsection (b) of Section 2.21 of this charter for distribution and filing of copies of the 22 ordinance shall be construed to include copies of any code of technical regulations, as well as the adopting ordinance; and (2) a copy of each adopted code of technical regulations, as 23 24 well as the adopting ordinance, shall be authenticated and recorded by the clerk pursuant to 25 Section 2.25 of this charter. (b) Copies of any adopted code of technical regulations shall be made available by the clerk 26

27 for inspection by the public.

SECTION 2.25.

- 29 Signing; authenticating;
- 30 recording; codification; printing.

31 (a) The clerk shall authenticate by the clerk's signature and record in full in a properly32 indexed book kept for that purpose all ordinances adopted by the city council.

33 (b) The city council shall provide for the preparation of a general codification of all the

34 ordinances of the city having the force and effect of law. The general codification shall be

35 adopted by the city council by ordinance and shall be published promptly, together with all

1 amendments thereto and such codes of technical regulations and other rules and regulations

2 as the city council may specify. This compilation shall be known and cited officially as 'The

Code of the City of Colbert, Georgia.' Copies of the code shall be furnished to all officers,
departments, and agencies of the city and made available for purchase by the public at a
reasonable price as fixed by the city council.

(c) The city council shall cause each ordinance and each amendment to this charter to be 6 7 printed promptly following its adoption, and the printed ordinances and charter amendments shall be made available for purchase by the public at reasonable prices to be fixed by the city 8 9 council. Following publication of the first code under this charter and at all times thereafter, 10 the ordinances and charter amendments shall be printed in substantially the same style as the code currently in effect and shall be suitable in form for incorporation therein. The city 11 12 council shall make such further arrangements as deemed desirable with reproduction and 13 distribution of any current changes in or additions to codes of technical regulations and other rules and regulations included in the code. 14

SECTION 2.26.

Election of mayor; forfeiture; compensation. The mayor shall be elected and serve for a term of two years and until the mayor's successor is elected and qualified. The mayor shall be a qualified elector of this city and shall have been a resident of this city for 12 months immediately preceding the mayor's election. The mayor shall continue to reside in this city during the period of the mayor's service. The mayor shall forfeit that office on the same grounds and under the same procedure as for councilmembers. The compensation of the mayor shall be established in the same manner as for councilmembers.

- 1 (3) Exercise supervision over all executive and administrative work of the city and 2 provide for the coordination of administrative activities; (4) Prepare and submit to the councilmembers a recommended operating budget and 3 4 capital budget; 5 (5) Submit to the councilmembers at least once a year a statement covering the financial conditions of the city and from time to time such other information as the 6 7 councilmembers may request; 8 (6) Recommend to the councilmembers such measures relative to the affairs of the city, 9 improvement of the government, and promotion of the welfare of its inhabitants as the 10 mayor may deem expedient; (7) Call special meetings of the councilmembers as provided for in subsection (b) of 11 12 Section 2.18 of this charter; 13 (8) Approve or disapprove ordinances as provided in Section 2.29 of this charter; (9) Provide for an annual audit of all accounts of the city; 14 15 (10) Require any department or agency of the city to submit written reports whenever 16 the mayor deems it expedient; (11) Perform such other duties as may be required by law, this charter, or ordinance; 17 18 (12) Participate in the discussion of all matters brought before the councilmembers; and 19 (13) Sign as a matter of course all written contracts, ordinances, and other instruments executed by the city which by law are required to be in writing. 20 21 **SECTION 2.29.** 22 Submission of ordinances to the mayor; veto power. 23 (a) Every ordinance adopted by the councilmembers shall be presented promptly by the city 24 clerk to the mayor after its adoption. 25 (b) The mayor, within ten calendar days of receipt of an ordinance, shall return it to the city clerk with or without the mayor's approval or with the mayor's disapproval. If the city council fails to adopt the budget 12 by said date, the amounts appropriated for operation for the then current fiscal year shall be 13 14 deemed adopted for the ensuing fiscal year on a month-to-month basis, with all items prorated accordingly, until such time as the city council adopts a budget for the ensuing fiscal 15 year. Adoption of the budget shall take the form of an appropriations ordinance setting out 16 17 the estimated revenues in detail by sources and making appropriations according to fund and 18 by organizational unit, purpose, or activity as set out in the budget preparation ordinance 19 adopted pursuant to Section 6.24 of this charter. 20 (c) The amount set out in the adopted operating budget for each organizational unit shall 21 constitute the annual appropriation for such, and no expenditure shall be made or 22 encumbrance created in excess of the otherwise unencumbered balance of the appropriations 23 or allotment thereof to which it is chargeable.

SECTION 6.27.

Levy of taxes.

The city council shall levy by ordinance such taxes as are necessary. The taxes and tax rates set by such ordinance shall be such that reasonable estimates of revenues from such levy shall at least be sufficient, together with other anticipated revenues, fund balances, and applicable reserves, to equal the total amount appropriated for each of the several funds set forth in the annual operating budget for defraying the expenses of the general government of this city.

Sale and lease of property.

(a) The city council may sell and convey or lease any real or personal property owned orheld by the city for governmental or other purposes as now or hereafter provided by law.

13 (b) The city council may quitclaim any rights it may have in property not needed for public

14 purposes upon report by the mayor and adoption of a resolution, both finding that the

15 property is not needed for public or other purposes and that the interest of the city has no

16 readily ascertainable monetary value.

17 (c) Whenever in opening, extending, or widening any street, avenue, alley, or public place 18 of the city a small parcel or tract of land is cut off or separated by such work from a larger 19 tract or boundary of land owned by the city, the city council may authorize the mayor to sell 20 and convey said cut-off or separated parcel or tract of land to an abutting or adjoining 21 property owner or owners where such sale and conveyance facilitates the highest and best 22 use of the abutting owner's property. Included in the sales contract shall be a provision for 23 the rights of way of said street, avenue, alley, or public place. Each abutting property owner 24 shall be notified of the availability of the property and given the opportunity to purchase said property under such terms and conditions as set out by ordinance. All deeds and 25 conveyances heretofore and hereafter so executed and delivered shall convey all title and 26 27 interest the city has in such property, notwithstanding the fact that no public sale after advertisement was or is hereafter made. 28
