A BILL TO BE ENTITLED AN ACT

- 1 To create the DeKalb County Court Technology Fund; to authorize the imposition and
- 2 collection of a technology fee for the filing of certain cases and the imposition of surcharges
- 3 to certain fines; to specify the uses to which such fees and surcharges may be put; to provide
- 4 for the auditing and accounting for such fund; to provide for a supervising board for such
- 5 fund and the membership, composition, authority, powers, and duties thereof; to provide for
- 6 related matters; to provide an effective date and automatic repeal; to repeal conflicting laws;
- 7 and for other purposes.

8 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

9 **SECTION 1.**

10 The DeKalb County Court Technology Fund is hereby established.

11 SECTION 2.

- 12 The clerk of the State Court of DeKalb County is authorized and shall be entitled to charge
- 13 a surcharge of \$5.00 to each fine imposed in each citation or accusation for which a
- 14 defendant is found guilty or enters a plea of guilty, nolo contendere, or other plea resulting
- in the imposition of a fine in the State Court of DeKalb County. Such surcharges shall be
- deposited by the clerk in the DeKalb County Court Technology Fund.

SECTION 3.

- 18 The clerk of the Recorders Court of DeKalb County is authorized and shall be entitled to
- 19 charge and collect a surcharge of \$5.00 to each fine imposed in each citation for which a
- 20 defendant is found guilty or enters a plea of guilty, nolo contendere, or other plea resulting
- 21 in the imposition of a fine in the Recorders Court of DeKalb County. Such surcharges shall
- be deposited by the clerk in the DeKalb County Court Technology Fund.

SECTION 4.

2 The clerk of the State Court of DeKalb County shall establish an account designated as the

- 3 DeKalb County Court Technology Fund in the same manner as the clerk establishes other
- 4 accounts of his or her office. The clerk shall:
- 5 (1) Maintain accurate records of all funds collected or imposed in accordance with this
- 6 Act;
- 7 (2) Reconcile said account in the same manner as all other accounts supervised by the
- 8 clerk;
- 9 (3) Be subject to the same audit requirements as all other accounts held by the clerk; and
- 10 (4) Provide the Supervising Board of the DeKalb County Court Technology Fund with
- an annual report of all expenditures and collections of the DeKalb County Court
- Technology Fund.

SECTION 5.

- 14 There is created the Supervising Board of the DeKalb County Court Technology Fund which
- shall consist of five members. One member shall be a judge of the State Court of DeKalb
- 16 County selected by majority vote of the active judges of the State Court of DeKalb County,
- one member shall be a judge of the Magistrate Court of DeKalb County selected by majority
- vote of the active judges of the Magistrate Court of DeKalb County, one member shall be a
- 19 judge of the Recorders Court of DeKalb County selected by majority vote of the active
- 20 judges of the Recorders Court of DeKalb County, one member shall be the clerk of the State
- 21 Court of DeKalb County or his or her designee, and one member shall be the director of
- 22 information systems for DeKalb County. Each member selected to serve on the board shall
- 23 serve at the pleasure of the body or individual making such selection.

SECTION 6.

- 25 The Supervising Board of the DeKalb County Court Technology Fund shall have the sole
- 26 authority to direct the clerk to expend funds for technology for the courts in DeKalb County
- 27 and may authorize the clerk to make reasonable expenditures for authorized projects from
- 28 the fund, as necessary. In no case shall the fund be used for salaries or benefits for full-time
- 29 personnel, but may be used to provide for temporary technical design and programming
- 30 assistance on a case-by-case basis including payments for services in the design and
- 31 implementation of systems to share information by and between the courts. Each such
- 32 expenditure shall be documented by the clerk in a manner consistent with expenditures made
- 33 by the clerk in other court related accounts.

SECTION 7.

- 2 The first meeting of the supervising board shall be called by the clerk at which meeting the
- 3 board shall select from its members a chairperson of the board who shall call meetings as
- 4 necessary for the proper operation of the board. The supervising board shall meet no less
- 5 than once each year to accept and review the annual report of the fund from the clerk but may
- 6 meet, at the board's discretion, without public notice and with no less than three members
- 7 in attendance.

8 SECTION 8.

- 9 Moneys collected and deposited into the DeKalb County Court Technology Fund shall be
- 10 used to supplement the funds appropriated to the offices of the clerk of the Superior Court
- of DeKalb County, the State Court of DeKalb County, the Magistrate Court of DeKalb
- 12 County, and other courts in the DeKalb County court system, but shall not be used to
- 13 supplant those funds appropriated by the DeKalb County Board of Commissioners or the
- 14 DeKalb County government.

SECTION 9.

- 16 This Act shall become effective on July 1, 2005, and shall be repealed by operation of law
- 17 on June 30, 2006.

18 **SECTION 10.**

19 All laws and parts of laws in conflict with this Act are repealed.
