A BILL TO BE ENTITLED

AN ACT

1 To amend an Act creating the Board of Commissioners of Jeff Davis County, approved
 2 March 25, 1958 (Ga. L. 1958, p. 3288), as amended, so as to change the description of the
 3 commissioner districts; to provide for definitions and inclusions; to provide for continuation
 4 in office of current members; to provide for election and terms of office of subsequent
 5 members; to provide for submission of this Act for approval under the federal Voting Rights
 6 Act of 1965, as amended; to provide for effective dates; to repeal conflicting laws; and for
 7 other purposes.

8 **BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:**

9 **SECTION 1.**

10 An Act creating the Board of Commissioners of Jeff Davis County, approved March 25,
 11 1958 (Ga. L. 1958, p. 3288), as amended, is amended by striking subsection (a) of Section
 12 1A of said Act and inserting in lieu thereof the following:

13 "(a)(1) The Board of Commissioners of Jeff Davis County as it exists immediately prior
 14 to January 1, 2006, is continued in existence but on and after January 1, 2006, shall be
 15 constituted as provided in this Act. The Board of Commissioners of Jeff Davis County
 16 so continued and constituted, sometimes referred to in this Act as the 'board,' shall
 17 continue to have the powers, duties, rights, obligations, and liabilities of that board as
 18 existed immediately prior to January 1, 2006, and shall be subject to all constitutional and
 19 statutory provisions relating to boards of county commissioners.

20 (2) Those members of the Board of Commissioners of Jeff Davis County who are
 21 serving as such immediately prior to January 1, 2006, and any person selected to fill a
 22 vacancy in any such office shall continue to serve as such members until the regular
 23 expiration of their respective terms of office and upon the election and qualification of
 24 their respective successors. On and after January 1, 2006, the Board of Commissioners
 25 of Jeff Davis County shall consist of five members all of whom shall be elected from
 26 commissioner districts described in paragraph (3) of this subsection. Commissioner
 27 Districts 1, 2, 3, 4, and 5 as they exist immediately prior to January 1, 2006, shall

1 continue to be designated as Commissioner Districts 1, 2, 3, 4, and 5, respectively, but
2 as newly described under this Act, and on and after January 1, 2006, such members of the
3 board serving from those former commissioner districts shall be deemed to be serving
4 from and representing their respective districts as newly described under this Act.

5 (3) For purposes of electing members of the board of commissioners, Jeff Davis County
6 is divided into five commissioner districts. One member of the board shall be elected
7 from each such district by majority vote of the qualified voters residing within such
8 commissioner district. The five commissioner districts shall be and correspond to those
9 five numbered districts described in and attached to and made a part of this Act and
10 further identified as Plan Name: jeffdccsbw3 Plan Type: Local User: staff
11 Administrator: Jeff Davis.

12 (4) When used in such attachment, the terms 'Tract' and 'BG' (Block Group) shall mean
13 and describe the same geographical boundaries as provided in the report of the Bureau
14 of the Census for the United States decennial census of 2000 for the State of Georgia.
15 The separate numeric designations in a Tract description which are underneath a 'BG'
16 heading shall mean and describe individual Blocks within a Block Group as provided in
17 the report of the Bureau of the Census for the United States decennial census of 2000 for
18 the State of Georgia. Any part of Jeff Davis County which is not included in any such
19 district described in that attachment shall be included within that district contiguous to
20 such part which contains the least population according to the United States decennial
21 census of 2000 for the State of Georgia. Any part of Jeff Davis County which is
22 described in that attachment as being in a particular district shall nevertheless not be
23 included within such district if such part is not contiguous to such district. Such
24 noncontiguous part shall instead be included within that district contiguous to such part
25 which contains the least population according to the United States decennial census of
26 2000 for the State of Georgia. Except as otherwise provided in the description of any
27 commissioner district, whenever the description of such district refers to a named city,
28 it shall mean the geographical boundaries of that city as shown on the census map for the
29 United States decennial census of 2000 for the State of Georgia."

30 SECTION 2.

31 Said Act is further amended by striking Section 2A, relating to commissioner districts, in its
32 entirety.
