A BILL TO BE ENTITLED AN ACT

- 1 To amend Article 5 of Chapter 12 of Title 44 of the Official Code of Georgia Annotated, the
- 2 "Disposition of Unclaimed Property Act," so as to provide for an alternative method of
- 3 disposition with respect to certain dividends or capital credits which are presumed
- 4 abandoned; to provide for definitions; to provide for procedures; to provide an effective date;
- 5 to repeal conflicting laws; and for other purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 SECTION 1.

- 8 Article 5 of Chapter 12 of Title 44 of the Official Code of Georgia Annotated, the
- 9 "Disposition of Unclaimed Property Act," is amended by adding a new Code section at the
- 10 end thereof, to be designated Code Section 44-12-236, to read as follows:
- 11 "44-12-236.
- 12 (a) As used in the Code section, the term:
- 13 (1) 'Approved uses' means:
- (A) Donated to an Internal Revenue Code Section 501(c)(3) organization serving in the electric membership corporation's service area;
- 16 (B) Used in support of education in the electric membership corporation's service area; 17 or
- 18 (C) Used for economic development purposes in the electric membership corporation's service area.
- 20 (2) 'Electric membership corporation's service area' means any county in which the
- 21 electric membership corporation provides electric service and any county adjacent
- thereto.
- 23 (b) All patronage dividends or capital credits presumed abandoned pursuant to this article
- in a given calendar year that are held by an electric membership corporation organized and
- operating pursuant to Article 4 of Chapter 3 of Title 46 may, in lieu of payment of delivery

to the commissioner pursuant to this article, be donated for approved uses if the electric

- 2 membership corporation has:
- 3 (1) Maintained for at least six months on the electric membership corporation's website
- 4 or on a public posting in the electric membership corporation's main office a list of the
- 5 names and last known addresses of all owners of property held by the electric
- 6 membership corporation which has been presumed abandoned, together with instructions
- 7 on how to claim such property; and
- 8 (2) Published in the legal organ in the county in which the electric membership
- 9 corporation's main office is located notice of the last date to claim property that has been
- presumed abandoned. Such notice shall be published within three to six months prior to
- the last date to claim the property and shall state that the names of the owners may be
- found at the electric membership corporation's website or the main office."

13 SECTION 2.

- 14 This Act shall become effective upon its approval by the Governor or upon its becoming law
- 15 without such approval.

SECTION 3.

17 All laws and parts of laws in conflict with this Act are repealed.
