**A BILL TO BE ENTITLED
AN ACT**

1 To amend Title 2 of the Official Code of Georgia Annotated, relating to agriculture; Title 8
2 of the Official Code of Georgia Annotated, relating to buildings; Title 15 of the Official Code
3 of Georgia Annotated, relating to courts; Title 17 of the Official Code of Georgia Annotated,
4 relating to criminal procedure; Title 20 of the Official Code of Georgia Annotated, relating
5 to education; Title 26 of the Official Code of Georgia Annotated, relating to food, drugs, and
6 cosmetics; Title 28 of the Official Code of Georgia Annotated, relating to the General
7 Assembly; Title 35 of the Official Code of Georgia Annotated, relating to law enforcement;
8 Title 40 of the Official Code of Georgia Annotated, relating to motor vehicles; Title 43 of
9 the Official Code of Georgia Annotated, relating to professions; Title 45 of the Official Code
10 of Georgia Annotated, relating to public officers; Title 49 of the Official Code of Georgia
11 Annotated, relating to social services; and Title 50 of the Official Code of Georgia
12 Annotated, relating to state government, so as to provide for the comprehensive revision of
13 provisions regarding state budgeting; to revise and change duties and responsibilities of
14 budget units; to provide for the transfer of the duties and responsibilities of the Legislative
15 Budget Office and legislative budget offices; to provide for the powers, duties, and
16 responsibilities of the Senate Budget Office and the House Budget Office; to revise and
17 change terminology regarding budget unit object class; to revise and change certain
18 provisions regarding powers of the Lieutenant Governor; to repeal provisions regarding the
19 Budgetary Responsibility and Oversight Committee; to provide for related matters; to
20 provide an effective date; to repeal conflicting laws; and for other purposes.

21 **BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:**

22 **PART I**
23 **SECTION 1.**

24 Title 2 of the Official Code of Georgia Annotated, relating to agriculture, is amended by
25 striking Code Section 2-18-4, relating to the attachment of the Georgia Tobacco Community

1 Development Board for administrative purposes to the Office of Planning and Budget, and
 2 inserting in its place a new Code Section 2-18-4 to read as follows:

3 "2-18-4.

4 The board is attached to the Office of Planning and Budget for administrative purposes.
 5 Without limitation, the office shall provide such staff and other services as the board may
 6 need for its functions. ~~Without detracting from the status of the board as a budget unit, the~~
 7 The Office of Planning and Budget may expend its funds for purposes of the board as if
 8 such funds were appropriated directly to the board."

9 **SECTION 2.**

10 Title 20 of the Official Code of Georgia Annotated, relating to education, is amended by
 11 striking Code Section 20-1A-1, relating to creation of the Department of Early Care and
 12 Learning, and inserting in its place a new Code Section 20-1A-1 to read as follows:

13 "20-1A-1.

14 The Department of Early Care and Learning is created as a department of the executive
 15 branch of state government and shall have the duties, responsibilities, functions, powers,
 16 and authority set forth in this chapter and otherwise provided by law. The Department of
 17 Early Care and Learning is the successor to the Office of School Readiness and shall have
 18 the duties, responsibilities, functions, powers, authority, employees, office equipment,
 19 furniture, and other assets formerly held by the Office of School Readiness. ~~The~~
 20 ~~Department of Early Care and Learning shall be a separate budget unit."~~

21 **SECTION 3.**

22 Said title is further amended by striking subsection (a) of Code Section 20-3-82, relating to
 23 the Georgia Eminent Scholars Trust Fund, and inserting in its place a new subsection (a) to
 24 read as follows:

25 "(a) There is created the Georgia Eminent Scholars Endowment Trust Fund. The board of
 26 regents shall serve as trustees of such fund. ~~The fund shall be a budget unit for the purpose~~
 27 ~~of appropriations of state funds as provided for in Part 1 of Article 4 of Chapter 12 of Title~~
 28 ~~45."~~

29 **SECTION 4.**

30 Said title is further amended by striking subsection (b) of Code Section 20-3-231, relating
 31 to the purpose of the Georgia Student Finance Commission, and inserting in its place a new
 32 subsection (b) to read as follows:

33 "(b) *Purpose of commission.* The purpose of the commission shall be to help improve the
 34 higher educational opportunities of citizens and persons in this state by serving as an

1 agency ~~and budget unit~~ within the executive branch of state government for the purpose of
 2 carrying out and effectuating the powers, duties, and functions set forth in this part."

3 **SECTION 5.**

4 Said title is further amended by striking subsection (a) of Code Section 20-3-233, relating
 5 to the creation of the Georgia Student Finance Commission, and inserting in its place a new
 6 subsection (a) to read as follows:

7 "(a) There is created within the executive branch of state government a commission to be
 8 known as the Georgia Student Finance Commission. The commission shall be an agency
 9 of the state ~~and a budget unit thereof.~~"

10 **SECTION 6.**

11 Said title is further amended by striking subsection (a) of Code Section 20-3-250.5, relating
 12 to administration of the Nonpublic Postsecondary Education Commission, and inserting in
 13 its place a new subsection (a) to read as follows:

14 "(a) The commission shall be assigned to the Georgia Student Finance Commission for
 15 administrative purposes only. ~~The commission shall be a budget unit of the executive~~
 16 ~~branch of the state government.~~"

17 **SECTION 7.**

18 Title 26 of the Official Code of Georgia Annotated, relating to food, drugs, and cosmetics,
 19 is amended by striking subsection (a) of Code Section 26-4-29, relating to the Georgia Drugs
 20 and Narcotics Agency, and inserting in its place a new subsection (a) to read as follows:

21 "(a) The agency created in 1908 as the Office of the Chief Drug Inspector and known as
 22 the Georgia Drugs and Narcotics Agency since 1976 is continued in existence as the
 23 Georgia Drugs and Narcotics Agency. ~~This agency shall be a budget unit as defined under~~
 24 ~~Code Section 45-12-7; provided, however, that the~~ The agency shall be assigned for
 25 administrative purposes only, as defined in Code Section 50-4-3, to the office of the
 26 Secretary of State. The Georgia Drugs and Narcotics Agency is authorized by this Code
 27 section to enforce the drug laws of this state. The board shall appoint a director who shall
 28 be charged with supervision and control of such agency. The agency shall employ the
 29 number of personnel deemed necessary to properly protect the health, safety, and welfare
 30 of the citizens of this state. Such personnel shall be pharmacists registered in this state
 31 when employed as either special agents or the deputy director."

SECTION 8.

1
2 Title 35 of the Official Code of Georgia Annotated, relating to law enforcement, is amended
3 by striking Code Section 35-6A-9, relating to the Criminal Justice Coordinating Council, and
4 inserting in its place a new Code Section 35-6A-9 to read as follows:

5 "35-6A-9.

6 The council shall prepare a budget request in the same manner as any such request would
7 be prepared by a budget unit under Part 1 of Article 4 of Chapter 12 of Title 45, the 'Budget
8 Act,' and a separate appropriation shall be provided for the council in the general
9 appropriations Act. The council is authorized to accept and use gifts, grants, and donations
10 for the purpose of carrying out this chapter. The council is also authorized to accept and
11 use property, both real and personal, and services, for the purpose of carrying out this
12 chapter. Any funds, property, or services received as gifts, grants, or donations shall be
13 kept separate and apart from any funds received by the Office of Planning and Budget; and
14 such funds, property, or services so received by gifts, grants, or donations shall be the
15 property and funds of the council and, as such, shall not lapse at the end of each fiscal year
16 but shall remain under the control and subject to the direction of the council to carry out
17 this chapter."

SECTION 9.

18
19 Title 40 of the Official Code of Georgia Annotated, relating to motor vehicles, is amended
20 by striking subsection (a) of Code Section 40-16-7, relating to the budget of the Department
21 of Motor Vehicle Safety, and inserting in its place a new subsection (a) to read as follows:

22 "(a) ~~The department shall be a budget unit to which funds may be appropriated as provided~~
23 ~~in the 'Budget Act,' Part 1 of Article 4 of Chapter 12 of Title 45.~~ The department shall be
24 an independent and distinct department of state government. The duties of the department
25 shall be performed by that department and not by any other agency of state government,
26 and the department shall not perform the duties of any other agency of state government.
27 The position of commissioner of motor vehicle safety shall be a separate and distinct
28 position from any other position in state government. The duties of the commissioner shall
29 be performed by the commissioner and not by any other officer of state government, and
30 the commissioner shall not perform the duties of any other officer of state government."

SECTION 10.

31
32 Title 43 of the Official Code of Georgia Annotated, relating to professions, is amended by
33 repealing its entirety subsection (l) of Code Section 43-1-2, relating to the director of the
34 professional licensing boards division of the office of the Secretary of State, which reads as
35 follows:

1 "(l) Funding for the office of the division director and the various professional licensing
 2 boards served by such office shall be contained in a common budget unit as defined in Part
 3 1 of Article 4 of Chapter 12 of Title 45, the 'Budget Act.'"

4 **SECTION 11.**

5 Said title is further amended by striking subsection (g) of Code Section 43-40-2, relating to
 6 the Georgia Real Estate Commission, and inserting in its place a new subsection (g) to read
 7 as follows:

8 "~~(g) The commission shall be a budget unit as defined in Part 1 of Article 4 of Chapter 12~~
 9 ~~of Title 45, the 'Budget Act'; provided, however, that the commission shall be assigned for~~
 10 administrative purposes only to the office of the Secretary of State."

11 **SECTION 12.**

12 Title 45 of the Official Code of Georgia Annotated, relating to public officers, is amended
 13 by striking Code Section 45-5-7, relating to hearing of complaints against budget unit
 14 employees, and inserting in its place a new Code Section 45-5-7 to read as follows:

15 "45-5-7.

16 Upon information being received that any individual employed by the state government is
 17 guilty or is alleged to be guilty of irregularities, misconduct, malpractice, malfeasance,
 18 misfeasance, incompetence, incapability, or inefficiency in the conduct of his or her official
 19 duties, the head of the ~~budget unit~~, department; or agency employing said person shall be
 20 notified of such charges; and if the head of the ~~budget unit~~, department; or agency takes the
 21 position that the charges are unfounded and fails or refuses to discharge the individual
 22 against whom the complaint is lodged, it shall be the duty of the Governor to hear the
 23 complaint and if, in his or her opinion, the facts sustain the truth of the accusation, the
 24 individual shall stand discharged from state service. Nothing in this Code section shall
 25 affect the tenure of office of the elected officials of this state, nor the tenure of office of
 26 appointed officials of this state who have been confirmed by the Senate as required by law,
 27 nor the tenure of office of those employees who are subject to merit system laws and rules
 28 and regulations."

29 **SECTION 13.**

30 Said title is further amended by striking subsection (a) of Code Section 45-12-72, relating
 31 to the Office of Planning and Budget, and inserting in its place a new subsection (a) to read
 32 as follows:

33 "(a) There is established in the office of the Governor the Office of Planning and Budget
 34 ~~as a separate budget unit~~ for the purpose of promoting economy and efficiency in the fiscal

1 management of the state government. The Governor shall be ex officio director of the
2 budget."

3 **SECTION 14.**

4 Title 49 of the Official Code of Georgia Annotated, relating to social services, is amended
5 by striking subsection (b) of Code Section 49-5-135, relating to the Children and Youth
6 Coordinating Council, and inserting in its place a new subsection (b) to read as follows:

7 "(b) The council shall prepare a budget request ~~in the same manner as any such request~~
8 ~~would be prepared by a budget unit~~ in accordance with Part 1 of Article 4 of Chapter 12
9 of Title 45, the 'Budget Act,' and a separate appropriation shall be provided for the council
10 in the General Appropriations Act. The council is authorized to accept and use gifts, grants,
11 and donations for the purpose of carrying out this article. The council is also authorized to
12 accept and use property, both real and personal, and services for the purpose of carrying
13 out this article. Any funds, property, or services received as gifts, grants, or donations shall
14 be kept separate and apart from any funds received by the Office of Planning and Budget;
15 and such funds, property, or services so received by gifts, grants, or donations shall be the
16 property and funds of the council and, as such, shall not lapse at the end of each fiscal year
17 but shall remain under the control of and subject to the direction of the council to carry out
18 this article."

19 **SECTION 15.**

20 Said title is further amended by striking subsection (n) of Code Section 49-5-273, relating
21 to creation of PeachCare, and inserting in its place a new subsection (n) to read as follows:

22 "(n) There shall be created a ~~separate budget unit 'C'~~ and a separate appropriation in the
23 department for the purpose of carrying out the provisions of this article."

24 **SECTION 16.**

25 Title 50 of the Official Code of Georgia Annotated, relating to state government, is amended
26 by striking paragraph (1) of subsection (g) of Code Section 50-17-22, relating to the State
27 Financing and Investment Commission, and inserting in its place a new paragraph (1) to read
28 as follows:

29 "(1) The commission is ~~designated a budget unit and~~ shall be subject to Part 1 of Article
30 4 of Chapter 12 of Title 45, the 'Budget Act.'"

31 **SECTION 17.**

32 Said title is further amended by striking paragraph (2) of subsection (c) of Code Section
33 50-27-13, relating to lottery proceeds, and inserting in its place a new paragraph (2) to read
34 as follows:

1 "(2) In the budget report the Governor shall further make specific recommendations as
 2 to the education programs and purposes for which appropriations should be made from
 3 the Lottery for Education Account. The General Assembly shall appropriate from the
 4 Lottery for Education Account by specific reference to it, or by reference to 'lottery
 5 proceeds.' All appropriations of lottery proceeds to any particular budget unit shall be
 6 ~~made together in a separate part entitled,~~ identified, administered, and accounted for
 7 separately as a distinct ~~budget unit for lottery proceeds~~ program. Such appropriations
 8 shall otherwise be made in the manner required by law for appropriations."

9 **PART II**
 10 **SECTION 18.**

11 Title 28 of the Official Code of Georgia Annotated, relating to the General Assembly, is
 12 amended by striking Code Section 28-5-25, relating to joint meetings of the fiscal affairs
 13 subcommittees, and inserting in its place a new Code Section 28-5-25 to read as follows:

14 "28-5-25.

15 The fiscal affairs subcommittees shall meet jointly as one committee at least once each
 16 quarter, or more often, at the call of the Governor, for the purpose of reviewing and
 17 approving budget unit ~~object class~~ program transfers recommended by the Governor. Such
 18 transfers shall not be made without the approval of at least 11 members of such
 19 subcommittees sitting jointly. No funds whatsoever shall be transferred for use in
 20 commencing any new program or activity which does not currently have an appropriation
 21 or which would require operating funds or capital outlay funds beyond the biennium in
 22 which such transfer is made."

23 **SECTION 19.**

24 Title 45 of the Official Code of Georgia Annotated, relating to public officers, is amended
 25 by striking paragraph (10) of Code Section 45-12-71, relating to definitions regarding the
 26 Office of Planning and Budget, and inserting in its place a new paragraph (10) to read as
 27 follows:

28 "(10) 'Budget unit' means a department, institution, agency, or other unit of organization
 29 for which separate appropriations are made. Each specified section of the General
 30 Appropriations Act is a budget unit."

SECTION 20.

Said title is further amended by striking paragraphs (5) and (6) of Code Section 45-12-75, relating to the budget report, and inserting in their place new paragraphs (5) and (6) to read as follows:

"(5) Detailed comparative statements of expenditures and requests for appropriations by funds, budget units, and ~~budget classes~~ programs, showing the expenditures for each of the two fiscal years last concluded, the budget of the current year, and the Governor's recommendations for appropriations for each budget unit and program for the next fiscal year. Following the lists of actual and proposed expenditures of each budget unit and program there shall be a brief explanation of the functions of the unit and program and comments on its policies and plans and on any considerable differences among the amounts expended and the amounts recommended, with such descriptive, quantitative, comparative, and other data as to work done, unit costs, and like information as is considered necessary or desirable. ~~In connection with each budget class of~~ For capital outlays involving construction projects to be completed in two or more fiscal years, there shall be shown the total estimated cost of each such project and the amount thereof recommended to be appropriated and expended in each ensuing fiscal year until completion of the project. Capital outlay needs shall be projected for a period that is consistent with each organization's approved strategic plan as summarized in the budget;

(6) A summary statement of the cash resources estimated to be available at the beginning of the next fiscal year and the estimated cash receipts of the fiscal year as compared with the total recommended amounts of appropriation for all ~~budget classes~~ programs for the year and, if the total of the recommended expenditures exceeds the total of the estimated resources, recommendations as to how the deficiency is to be met and estimates of receipts from any proposed additional revenues;"

SECTION 21.

Said title is further amended by striking subsection (d) of Code Section 45-12-80, relating to financial plans regarding the Appropriations Act, and inserting in its place a new subsection (d) to read as follows:

"(d) The annual operating budget for each budget unit shall be submitted for approval to the Office of Planning and Budget by May 31 of the fiscal year preceding the effective date; shall be submitted on forms and in the format as determined by the Office of Planning and Budget; and shall conform to approved appropriations Acts. The total annual operating budget, including such schedules and supplementary information as may be required by the Office of Planning and Budget, shall be considered the financial plan for the budget unit. The various schedules included in the annual operating budget shall govern the approved

1 expenditures for the ~~applicable object class~~ program and shall ensure that these
 2 expenditures conform to both the letter and the intent of approved appropriations Acts. The
 3 Governor through the Office of Planning and Budget shall direct to be made such changes
 4 in the submitted annual operating budget as the Governor deems necessary to bring the
 5 annual operating budget into conformity with approved appropriations Acts."

6 **SECTION 22.**

7 Said title is further amended by striking Code Section 45-12-90, relating to disposition of
 8 appropriations, and inserting in its place a new Code Section 45-12-90 to read as follows:
 9 "45-12-90.

10 In the event that any duties; and purposes; ~~and objects~~ for which appropriations are made
 11 shall be transferred to a budget unit other than that to which appropriated, the
 12 appropriations for such duties; and purposes; ~~and objects~~ shall be made available, subject
 13 to this part, to such budget unit or budget units to which the duties; and purposes; ~~and~~
 14 ~~objects~~ are transferred. Should the appropriation to be transferred not be shown in the
 15 appropriation Act as a separate and identifiable item, the amount to be transferred shall be
 16 decided by the Office of Planning and Budget in accordance with the detailed estimates or
 17 other information embodied in the budget report."

18 **SECTION 23.**

19 Said title is further amended by striking subsections (a) and (b) of Code Section 45-12-78,
 20 relating to submission of annual budget estimates, and inserting in their place new
 21 subsections (a) and (b) to read as follows:

22 "(a) Not later than September 1 of each year, the head of each budget unit, other than the
 23 General Assembly and the judiciary, shall submit to the Office of Planning and Budget
 24 estimates of the financial requirements of the budget unit for the next fiscal year, on the
 25 forms and in the manner prescribed by the Office of Planning and Budget, with such
 26 explanatory data as is required by the Office of Planning and Budget. Such submission
 27 shall utilize such ~~budget classes~~ programs and be within such expenditure parameters as
 28 may be established by the Governor. The head of a budget unit also may submit such
 29 additional data as is helpful. The estimates so submitted shall bear the approval of the
 30 board or commission of each budget unit for which a board or commission is constituted.

31 (b) Except as otherwise provided in this subsection, the budget estimates for the General
 32 Assembly, including all the legislative agencies, ~~shall be prepared by the Speaker of the~~
 33 ~~House of Representatives and the President of the Senate and such other legislative officers~~
 34 ~~as appropriate and~~ shall be submitted to the director of the budget at the same time as other
 35 budget estimates are submitted. The Department of Audits and Accounts, for the purpose

1 of this part, is a legislative agency and shall be construed in all respects as such; and the
 2 budget estimate for said department shall be prepared by the state auditor and shall be
 3 included in the budget report without revision and shall not be subject to review or control
 4 by the Office of Planning and Budget. The director of the Office of Treasury and Fiscal
 5 Services shall assist in the preparation of these budget estimates, if requested. ~~Effective~~
 6 ~~with the budget estimates for the fiscal year beginning July 1, 1985, the~~ The budget
 7 estimates for the Senate, the office of the Lieutenant Governor, and the office of the
 8 Secretary of the Senate shall be prepared by the Senate; the budget estimates for the House
 9 of Representatives, the office of the Speaker of the House of Representatives, and the
 10 office of the Clerk of the House of Representatives shall be prepared by the House of
 11 Representatives; and the budget estimates for the Office of Legislative Counsel; and the
 12 Office of Legislative Fiscal Officer, ~~and the Office of Legislative Budget Analyst~~ shall be
 13 prepared by the Legislative Services Committee. All of such budget estimates shall include
 14 such ~~object classes~~ programs as the Legislative Services Committee shall determine, and
 15 transfers of funds may be made between such ~~object classes~~ programs. Funds may also be
 16 transferred ~~between~~ across programs within the Senate, ~~the office of the Lieutenant~~
 17 ~~Governor, and the office of the Secretary of the Senate.~~ Funds may also be transferred
 18 ~~between~~ across programs within the House of Representatives, ~~the office of the Speaker~~
 19 ~~of the House of Representatives, and the office of the Clerk of the House of~~
 20 ~~Representatives.~~ Funds may also be transferred between the Office of Legislative Counsel;
 21 and the Office of Legislative Fiscal Officer, ~~and the Office of Legislative Budget Analyst."~~

22 PART III

23 SECTION 24.

24 Title 45 of the Official Code of Georgia Annotated, relating to public officers, is amended
 25 by striking Code Section 45-12-82, relating to filing of periodic work programs, and inserting
 26 in its place a new Code Section 45-12-82 to read as follows:

27 "45-12-82.

28 The Governor, through the Office of Planning and Budget, shall require each budget unit,
 29 other than those of the legislative branch and the judicial branch, to file periodic work
 30 programs with the Office of Planning and Budget at such time as the Office of Planning
 31 and Budget shall direct. As provided in Code Section 45-12-83, no allotment of funds shall
 32 be approved for any budget unit until such budget unit has filed a periodic work program
 33 with the Office of Planning and Budget and the periodic work program has been approved
 34 by the Governor. The work program shall be presented on forms prescribed by the Office
 35 of Planning and Budget and shall contain such information as the Governor, through the

1 Office of Planning and Budget, may require. The work program shall include the amount
 2 of the portion of the appropriation required for the period's expenditures based on the
 3 budget prepared as provided in this part. Periodic work programs may be amended from
 4 time to time in such manner as the Office of Planning and Budget may require. A duplicate
 5 copy of all of the periodic work programs and any amendments thereto shall be filed
 6 simultaneously with the Office of Planning and Budget, the director of the Office of
 7 Treasury and Fiscal Services, the state auditor, ~~the Comptroller General, and the Office of~~
 8 ~~Legislative Budget Analyst~~ the Senate Budget Office, and the House Budget Office."

9 **SECTION 25.**

10 Title 8 of the Official Code of Georgia Annotated, relating to buildings, is amended by
 11 striking Code Section 8-2-144, relating to accounting of certain fees by the Commissioner
 12 of Insurance, and inserting in its place a new Code Section 8-2-144 to read as follows:

13 "8-2-144.

14 The Commissioner of Insurance shall file a report on or before December 15 of each year
 15 accounting for all fees received by the Commissioner under this part and Part 3 of this
 16 article for the preceding 12 month period and for the actual costs of the inspection
 17 programs under this part and Part 3 of this article for the preceding 12 month period. Such
 18 report shall be provided to the chairpersons of the House Appropriations Committee, the
 19 Senate Appropriations Committee, the House Governmental Affairs Committee, and the
 20 Senate Regulated Industries and Utilities Committee, the director of the Office of Planning
 21 and Budget, ~~and the director of the Legislative~~ Senate Budget Office, and the director of
 22 the House Budget Office."

23 **SECTION 26.**

24 Title 15 of the Official Code of Georgia Annotated, relating to courts, is amended by striking
 25 subsection (a) of Code Section 15-6-77.4, relating to certain additional divorce case filing
 26 fees, and inserting in its place a new subsection (a) to read as follows:

27 "(a) In addition to any fees required in Code Sections 15-6-77, 15-6-77.2, 15-6-77.3, and
 28 47-14-51, for filing each divorce case, the clerk of superior court shall charge an additional
 29 fee of \$5.00. Each clerk of the superior court shall collect the additional fees for divorce
 30 cases as provided in this Code section and shall pay such moneys over to the Georgia
 31 Superior Court Clerks' Cooperative Authority by the last day of the month there following,
 32 to be deposited by the authority into the general treasury. The authority shall, on a quarterly
 33 basis, make a report and accounting of all funds collected pursuant to this Code section and
 34 shall submit such report and accounting to the Office of Planning and Budget, the

 30 initiatives, and systems to improve service delivery to be funded through the technology
 31 empowerment fund. Such projects shall demonstrate, to the satisfaction of the chief
 32 information officer, reduced costs through the use of technology. In identification and
 33 selection of such projects, initiatives, and systems, the chief information officer shall give
 34 priority to those which provide demonstrable cost savings and improved service delivery
 35 on a recurring basis through the employment of technology and training. Eligible projects,

1 initiatives, and systems to receive disbursements from the technology empowerment fund
 2 may be selected from agency budget requests. Quarterly reports of the operations of the
 3 technology empowerment fund shall be required to be made to the board, the Office of
 4 Planning and Budget, and the ~~Legislative~~ Senate Budget Office, and the House Budget
 5 Office to ensure proper oversight and accountability.

6 (c) Each project or initiative developed and supported from the technology empowerment
 7 fund shall employ technology that is compatible with the architecture and standards
 8 established by the authority and shall be accounted for by a discrete account established for
 9 the individual project or initiative item in the operating budget and capital budget.

10 (d) A steering committee composed of the chairperson of the House Appropriations
 11 Committee or his or her designee from among the membership of the committee, the
 12 chairperson of the Senate Appropriations Committee or his or her designee from among
 13 the membership of the committee, the director of the Office of Planning and Budget, ~~the~~
 14 ~~legislative budget analyst~~ the House Budget Office, the Senate Budget Office, the state
 15 auditor, and a representative from the Governor's office shall advise and consult with the
 16 chief information officer regarding initiatives to receive funding from the technology
 17 empowerment fund and shall receive quarterly reports from the chief information officer
 18 as to the status of funded projects."

19 SECTION 47.

20 Said title is further amended in Code Section 50-34-17, relating to the OneGeorgia Authority
 21 Overview Committee, by striking subsection (a) and inserting in its place a new subsection
 22 (a) to read as follows:

23 "(a) There is established the OneGeorgia Authority Overview Committee to be composed
 24 of one member of the House of Representatives to be appointed by the Speaker of the
 25 House of Representatives, one member of the Senate to be appointed by the President of
 26 the Senate, the director of the Senate Budget Office or his or her designee, the director of
 27 the House Budget Office or his or her designee, and two members of the General Assembly
 28 to be appointed by the Governor, ~~and the director of the Legislative Budget Office~~. The
 29 legislative members shall serve for terms as members of the committee concurrent with
 30 their terms of office as members of the General Assembly. The first members of the
 31 committee shall be appointed by not later than July 1, 2000. Thereafter, their successors
 32 shall be appointed during the first 30 days of each regular legislative session which is held
 33 immediately following the election of members of the General Assembly."

PART IV**SECTION 48.**

Title 28 of the Official Code of Georgia Annotated, relating to the General Assembly, is amended by repealing in its entirety Code Section 28-5-5, relating to the Budgetary Responsibility Oversight Committee, which reads as follows:

"28-5-5.

(a) There is created the Budgetary Responsibility Oversight Committee which shall be composed of six members of the House of Representatives appointed by the Speaker of the House of Representatives and six members of the Senate appointed by the President of the Senate. The members of such committee shall be selected within ten days after the convening of the General Assembly in each odd-numbered year and shall serve until their successors are appointed.

(b) The Speaker of the House of Representatives shall appoint a member of the committee to serve as chairperson and the President of the Senate shall appoint members of the committee to serve as vice chairperson and secretary during each even-numbered year. The President of the Senate shall appoint a member of the committee to serve as chairperson and the Speaker of the House of Representatives shall appoint members to serve as vice chairperson and secretary during each odd-numbered year. Such committee shall meet at least six times each year and, upon the call of the chairperson, at such additional times as deemed necessary by the chairperson.

(c) It shall be the duty of such committee to consult with the Governor and the Office of Planning and Budget concerning the development and implementation of the strategic planning process, the development of outcome measures for program evaluation, and the implementation of related actions.

(d) It shall be the duty of such committee to review and evaluate the following:

- (1) Information on new programs submitted in accordance with Code Section 45-12-88;
- (2) The continuation budget report submitted in accordance with Code Section 45-12-75.1;
- (3) The strategic plans for the state and individual departments submitted by the Office of Planning and Budget;
- (4) Program evaluation reports submitted in accordance with Code Section 45-12-178;
- (5) Information or reports to be submitted by the Office of Planning and Budget identifying moneys received and purposes for which moneys are expended in any case in which the receipt or expenditure is not contemplated by an appropriations Act; and
- (6) Such other information or reports as deemed necessary by such committee.

1 (e) The Office of Planning and Budget and the head of each budget unit shall cooperate
2 with such committee and provide such information or reports as requested by the
3 committee for the performance of its functions.

4 (f) The committee shall make an annual report of its activities and findings to the
5 membership of the General Assembly and the Governor within one week of the convening
6 of each regular session of the General Assembly. The chairperson of the committee shall
7 deliver written executive summaries of such report to the members of the General
8 Assembly prior to the adoption of the General Appropriations Act each year.

9 (g) The members of the committee shall receive the allowances authorized for legislative
10 members of legislative committees. The funds necessary to pay such allowances shall
11 come from funds appropriated to the House of Representatives and the Senate.

12 (h) The committee shall be authorized to request that a performance audit be conducted
13 for any department which the committee deems necessary."

14 **SECTION 49.**

15 Title 45 of the Official Code of Georgia Annotated, relating to public officers, is amended
16 by repealing in its entirety Code Section 45-12-75.1, relating to the annual continuation
17 budget report, which reads as follows:

18 "45-12-75.1.

19 (a) On or before October 1 of 1994 and each year thereafter, the Governor, through the
20 Office of Planning and Budget, shall prepare and submit to the Budgetary Responsibility
21 Oversight Committee a continuation budget report. On or before May 1 of 1994 and every
22 year thereafter, the Governor, through the Office of Planning and Budget, shall consult and
23 coordinate with the chairperson of the Budgetary Responsibility Oversight Committee to
24 develop a list of agencies and programs in agencies which will be included in the
25 continuation budget report for the year. Each state department shall be included in the
26 continuation budget report not less than once every five years. The continuation budget
27 report shall contain a detailed analysis of the funds necessary to provide services in the
28 current fiscal year for each state agency and program examined. Such report shall address
29 all programs and shall include a description of the purposes and accomplishments of the
30 programs.

31 (b) The committee shall consider the budget report prepared pursuant to this Code section
32 in conjunction with the audit report prepared pursuant to paragraph (4) of Code Section
33 50-6-24.

34 (c) The committee shall submit to the membership of the General Assembly within one
35 week of the convening of each regular session of the General Assembly a list of all

1 programs included in the continuation budget report for each department examined as well
2 as actions recommended, if any, by the committee.

3 (d) It is the intent of this Code section to examine all state departments not less than once
4 every five years."

5
6 **SECTION 50.**

7 Said title is further amended by striking Code Section 45-12-88, relating to information
8 required to be furnished to the Budgetary Responsibility Oversight Committee, and inserting
9 in its place a new Code Section 45-12-88 to read as follows:

10 "45-12-88.

11 ~~When any budget unit has plans to institute any new program, it shall be the duty of the~~
12 ~~head of such unit to furnish to the Budgetary Responsibility Oversight Committee, on~~
13 ~~September 1 prior to the convening date of the session at which appropriations to finance~~
14 ~~such program are to be sought, a description of the program, the reason for seeking to~~
15 ~~institute such program, the operating procedure of such program, the manner in which it~~
16 ~~conforms to the organization's strategic plan as well as the state strategic plan, the extent~~
17 ~~to which the facilities and staff to implement or provide the program will be decentralized,~~
18 ~~and any other information which would be helpful to the members of the committee in~~
19 ~~determining whether or not to appropriate funds therefor. The members shall also be~~
20 ~~furnished with the projected cost to implement the program fully. Reserved."~~

21 **SECTION 51.**

22 Said title is further amended by striking subsection (b) of Code Section 45-12-175, relating
23 to preparation of long-range development plans, and inserting in its place a new subsection
24 (b) to read as follows:

25 "(b) The Office of Planning and Budget shall cause to be prepared and coordinate the
26 development of strategic plans by departments, boards, bureaus, commissions, institutions,
27 authorities, and other agencies to ensure that the state-wide directions are met. The Office
28 of Planning and Budget shall:

29 (1) Ensure that the focus of the various plans do not conflict with the general state goals;

30 (2) Offer assistance to the various departments, boards, bureaus, commissions,
31 institutions, authorities, and other agencies of state government in the design and
32 execution of their programs and be the coordinating agency for the separate department
33 or agency proposals; and

34 (3) Phase in implementation by the various departments, boards, bureaus, commissions,
35 institutions, authorities, and other agencies of state government. ~~By September 1 of 1993~~
36 ~~and each year thereafter until all departments, boards, bureaus, commissions, institutions,~~

1 ~~authorities, and other agencies have initiated strategic planning, the Office of Planning~~
 2 ~~and Budget shall notify the Budgetary Responsibility Oversight Committee as to which~~
 3 ~~departments, boards, bureaus, commissions, institutions, authorities, and other agencies~~
 4 ~~will initiate strategic planning in the coming year; and~~

5 ~~(4) Present such strategic plans, in cooperation with the affected department, board,~~
 6 ~~bureau, commission, institution, authority, or other agency, to the Budgetary~~
 7 ~~Responsibility Oversight Committee."~~

8 **SECTION 52.**

9 Said title is further amended by repealing in its entirety Code Section 45-12-178, relating to
 10 certain review of state programs and functions, which reads as follows:

11 "45-12-178.

12 (a) It is the intent of the Governor and the General Assembly that taxpayers' money be
 13 spent in the most effective and efficient manner possible in order to obtain the maximum
 14 benefit from such expenditures. In furtherance of this objective, the Governor, through the
 15 Office of Planning and Budget, shall assist the General Assembly in establishing an
 16 ongoing review and evaluation of all programs and functions in state government.

17 (b) The chairperson of the Budgetary Responsibility Oversight Committee shall maintain
 18 a list of those programs for which the committee is requesting evaluations. The chairperson
 19 shall provide the list, and any subsequent revisions to the list, to the director of the
 20 Governor's Office of Planning and Budget and to the state auditor.

21 (c) The Office of Planning and Budget, the Department of Audits and Accounts, and the
 22 Research Office of the Budgetary Responsibility Oversight Committee shall undertake and
 23 complete evaluations on as many of those requested programs as resources will permit. The
 24 Office of Legislative Budget Analyst, the Board of Regents of the University System of
 25 Georgia, and all other state agencies are authorized and directed to provide assistance to
 26 the Office of Planning and Budget, the Department of Audits and Accounts, and the
 27 Research Office of the Budgetary Responsibility Oversight Committee, as requested, in the
 28 performance of these evaluations. The Office of Planning and Budget, the Department of
 29 Audits and Accounts, and the Research Office of the Budgetary Responsibility Oversight
 30 Committee are also authorized to contract with private contractors to perform, or assist in
 31 the performance of, these evaluations.

32 (d) The Office of Planning and Budget, the Department of Audits and Accounts, and the
 33 Research Office of the Budgetary Responsibility Oversight Committee shall report to the
 34 Budgetary Responsibility Oversight Committee on the results of program evaluations as
 35 such evaluations are completed. Such reports shall include:

1 (1) Appropriate background information on the affected program, including how and
 2 why it was initiated, its functions, what group it serves, how it is organized structurally
 3 and geographically, what are its staff size and composition, and what is its workload;

4 (2) Financial information including the source and amounts of funding and unit costs,
 5 where applicable;

6 (3) A description of the program's mission, goals, and objectives and an assessment of
 7 the extent to which the program has performed in comparison;

8 (4) Comparisons with other applicable public and private entities as to their experiences,
 9 service levels, costs, and staff resources required;

10 (5) Recommendations concerning the program, including whether it should be continued
 11 as it is currently operated, continued with identified steps to remediate deficiencies or
 12 institute improvements, or discontinued. Consideration should also be given to possible
 13 privatization or consolidation with other similar programs;

14 (6) Information describing the locations at which the program is operated and
 15 administered and the extent to which the operation and administration could be
 16 decentralized; and

17 (7) Such other information as is identified as appropriate.

18 (e) It is the intent of the General Assembly that all programs be evaluated at least every
 19 ten years.

20 (f) Department heads shall respond, in writing, within 90 days of the receipt of the report
 21 to recommendations and findings by the Office of Planning and Budget or the Department
 22 of Audits and Accounts setting forth in detail the action to be taken by said department to
 23 address the recommendations and findings. Said written response shall be made to the
 24 Office of Planning and Budget, the Department of Audits and Accounts, and the Budgetary
 25 Responsibility Oversight Committee.

26 (g) The Research Office of the Budgetary Responsibility Oversight Committee shall verify
 27 with state departments the implementation of the departments' plans set forth in their 90
 28 day responses as submitted in accordance with subsection (f) of this Code section. The
 29 Research Office shall inform the Budgetary Responsibility Oversight Committee about
 30 each department's progress at reasonable intervals."

31 **PART V**

32 **SECTION 53.**

33 This Act shall become effective upon its approval by the Governor or upon its becoming law
 34 without such approval.
