

House Bill 987

**A BILL TO BE ENTITLED
AN ACT**

1 To amend Code Section 15-11-28 of the Official Code of Georgia Annotated, relating to
2 jurisdiction of juvenile court, so as to provide the juvenile court with concurrent jurisdiction
3 for adoption proceedings under certain circumstances; to amend Chapter 8 of Title 19 of the
4 Official Code of Georgia Annotated, relating to adoption, to correct cross-references; to
5 provide for related matters; to repeal conflicting laws; and for other purposes.

6 **BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:**

7 **SECTION 1.**

8 Code Section 15-11-28 of the Official Code of Georgia Annotated, relating to jurisdiction
9 of juvenile court, is amended by adding a new subsection to the end of the Code Section to
10 read as follows:

11 "(f) *Concurrent jurisdiction as to adoption petitions.* The juvenile court shall have
12 concurrent jurisdiction to hear an adoption petition filed in accordance with Chapter 8 of
13 Title 19, provided that the juvenile court has previously entered:
14 (1) An order terminating parental rights in such case; or
15 (2) An unexpired order finding a child deprived and a parent has voluntarily surrendered
16 his or her parental rights in accordance with Code Section 19-8-4, 19-8-5, 19-8-6, or
17 19-8-7."

18 **SECTION 2.**

19 Chapter 8 of Title 19 of the Official Code of Georgia Annotated, relating to adoption, is
20 amended by striking subsection (a) of Code Section 19-8-2, relating to jurisdiction and venue
21 of adoption proceedings, and inserting in lieu thereof the following:

22 "(a) The superior courts of the several counties shall have exclusive jurisdiction in all
23 matters of adoption, except such jurisdiction as may be granted to the juvenile courts by
24 delegation from the superior court or as allowed pursuant to subsection (f) of Code Section
25 15-11-28."

SECTION 3.

Said chapter is further amended by striking subsection (a) of Code Section 19-8-13, relating to petitions for adoption, and inserting in lieu thereof the following:

"(a) The petition for adoption, duly verified, together with one conformed copy thereof, ~~must shall~~ be filed with the clerk of the ~~superior~~ court having jurisdiction and shall conform to the following guidelines:"

SECTION 4.

Said chapter is further amended by striking subsection (c) of Code Section 19-8-20, relating to adoption certificates, and inserting in lieu thereof the following:

"(c) The adoption certificate shall be in substantially the following form:

SECTION 5.

Said chapter is further amended by striking subsection (c) of Code Section 19-8-26, relating to how surrender of parental rights forms are executed, and inserting in lieu thereof the following:

"(c) The surrender of rights by a parent or guardian pursuant to paragraph (1) of subsection (e) of Code Section 19-8-5 shall conform substantially to the following form:

SURRENDER OF RIGHTS**FINAL RELEASE FOR ADOPTION****NOTICE TO PARENT OR GUARDIAN:**

This is an important legal document and by signing it you are surrendering all of your right, title, and claim to the child identified herein, so as to facilitate the child's placement for adoption. You are to receive a copy of this document and as explained

1 below have the right to withdraw your surrender within ten days from the date you sign
2 it.

3 _____
4 I, the undersigned, being solicitous that my (male) (female) child, born (insert name of
5 child), on (insert birthdate of child), should receive the benefits and advantages of a
6 good home, to the end that (she) (he) may be fitted for the requirements of life, consent
7 to this surrender.

8 I, the undersigned, (insert relationship to child) of the aforesaid child, do hereby
9 surrender the child to (insert name, surname not required, of each person to whom
10 surrender is made), PROVIDED each such person is named as petitioner in a petition
11 for adoption of the child filed in accordance with Chapter 8 of Title 19 of the Official
12 Code of Georgia Annotated within 60 days from the date hereof. Furthermore, I
13 promise not to interfere in the management of the child in any respect whatever; and,
14 in consideration of the benefits guaranteed by (insert name, surname not required, of
15 each person to whom surrender is made) in thus providing for the child, I do relinquish
16 all right, title, and claim to the child herein named, it being my wish, intent, and
17 purpose to relinquish absolutely all parental control over the child.

18 It is also my wish, intent, and purpose that if each such person is not named as
19 petitioner in a petition for adoption as provided for above within the 60 day period,
20 other than for excusable neglect, or, if said petition for adoption is filed within 60 days
21 but the adoption action is dismissed with prejudice or otherwise concluded without an
22 order declaring the child to be the adopted child of each such person, then I do hereby
23 surrender the child as follows:

24 (Mark one of the following as chosen)

25 _____ I wish the child returned to me, and I expressly acknowledge that this provision
26 applies only to the limited circumstance that the child is not adopted by the person or
27 persons designated herein and further that this provision does not impair the validity,
28 absolute finality, or totality of this surrender under any circumstance other than the
29 failure of the designated person or persons to adopt the child and that no other
30 provision of this surrender impairs the validity, absolute finality, or totality of this
31 surrender once the revocation period has elapsed; or

32 _____ I surrender the child to (insert name of designated licensed child-placing
33 agency), a licensed child-placing agency, for placement for adoption; or

34 _____ I surrender the child to the Department of Human Resources, as provided by
35 subsection (k) of Code Section 19-8-5, for placement for adoption; and (insert name
36 of designated licensed child-placing agency) or the Department of Human Resources

1 may petition the ~~superior~~ (insert level of court) court for custody of the child in
2 accordance with the terms of this surrender.

3 Furthermore, I hereby agree that the child is to be adopted either by each person named
4 above or by any other such person as may be chosen by the (insert name of designated
5 licensed child-placing agency) or the Department of Human Resources and I do
6 expressly waive any other notice or service in any of the legal proceedings for the
7 adoption of the child.

8 Furthermore, I understand that under Georgia law an agent appointed by the court is
9 required to conduct an investigation and render a report to the court in connection with
10 the legal proceeding for the legal adoption of the child and I hereby agree to cooperate
11 fully with such agent in the conduct of this investigation.

12 Furthermore, I hereby certify that I have received a copy of this document and that I
13 understand I may only withdraw this surrender by giving written notice, delivered in
14 person or mailed by registered mail or statutory overnight delivery, to (insert name and
15 address of agent of each person to whom surrender is made) within ten days from the
16 date hereof; that the ten days shall be counted consecutively beginning with the day
17 immediately following the date hereof; however, if the tenth day falls on a Saturday,
18 Sunday, or legal holiday then the last day on which the surrender may be withdrawn
19 shall be the next day that is not a Saturday, Sunday, or legal holiday; and I understand
20 that it may NOT be withdrawn thereafter.

21 Furthermore, I hereby certify that I have not been subjected to any duress or undue
22 pressure in the execution of this surrender document and do so freely and voluntarily.
