

Senate Bill 411

A BILL TO BE ENTITLED
AN ACT

1 To amend Article 1 of Chapter 18 of Title 45 of the Official Code of Georgia Annotated,
2 relating to the state employees' health insurance plan, so as to create a joint committee of the
3 General Assembly to be known as the Joint Committee to Study the State Health Care
4 Benefit Plan; to provide for membership; to provide for quarterly meetings; to provide for
5 a series of public meetings across the state; to provide for the Governor and the Department
6 of Community Health to contract for a state-by-state survey and analysis of state health care
7 plans; to provide for automatic repeal; to create a State Health Benefit Plan Advisory
8 Committee; to provide for an effective date; to repeal conflicting laws; and for other
9 purposes.

10 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

11 **SECTION 1.**

12 Article 1 of Chapter 18 of Title 45 of the Official Code of Georgia Annotated, relating to the
13 state employees' health insurance plan, is amended by adding new Code sections to read as
14 follows:

15 "45-18-19.1.

16 (a) There is created as a joint committee of the General Assembly the Joint Committee to
17 Study the State Health Care Benefit Plan. The members shall be named by the Speaker of
18 the House of Representatives, the President Pro Tempore of the Senate, the Governor, the
19 Georgia Association of Educators, the Georgia Association of Educational Leaders, the
20 Georgia Retired Educators Association, the Georgia School Board Association, the Georgia
21 School Superintendents Association, and the Professional Association of Georgia
22 Educators. The members of the committee shall be appointed no later than May 1, 2006.

23 (b) The committee shall meet quarterly through 2006 and issue a final report no later than
24 December 31, 2006, with findings and recommendations to be acted upon during the 2007
25 session of the General Assembly.

1 (c) The committee shall hold a series of public meetings across the state to hear from
 2 citizens, providers, and others on their views of the status of the current plan and their
 3 suggestions for plan improvements with regard to access, quality of service, and plan costs.

4 (d) The Governor and the Department of Community Health will contract with a Georgia
 5 school of public policy for a state-by-state survey and analysis of innovative state health
 6 care plans across the nation with emphasis on cost, access, and quality. This study will be
 7 conducted during 2006 and the school will make quarterly reports and presentations of its
 8 findings at each of the committee meetings. A final report with summary
 9 recommendations will be made by the school to the Governor and the legislature no later
 10 than December 31, 2006.

11 (e) The committee shall stand abolished and this Code section shall be automatically
 12 repealed on December 31, 2006.

13 45-18-20.

14 (a) There is created and established a State Health Benefit Plan Advisory Committee
 15 composed of 15 members to be appointed as follows:

16 (1) Five members shall be appointed by the Governor;

17 (2) Five members shall be appointed by the President Pro Tempore of the Senate; and

18 (3) Five members shall be appointed by the Speaker of the House of Representatives.

19 (b) The members of the committee shall be educators and state employees who are covered
 20 by the plan. All vacancies shall be filled for the unexpired term by the original appointing
 21 official. Members shall serve for terms of four years and shall be eligible for successive
 22 appointments by an appointing official. The committee shall meet quarterly.

23 (c) The members of the committee shall serve without compensation.

24 (d) The committee shall be involved in all state health benefit plan policy-making
 25 activities, including, but not limited to, plan administration, plan design, plan changes,
 26 qualitative reviews of plan service, scope of services, and networks.

27 (e) The committee shall first recommend plan changes to the Governor and the legislature
 28 and the Department of Community Health no later than December 31, 2006, and no later
 29 than December 31 annually thereafter."

30 SECTION 2.

31 This Act shall become effective upon its approval by the Governor or upon its becoming law
 32 without such approval.

33 SECTION 3.

34 All laws and parts of laws in conflict with this Act are repealed.
