

Senate Bill 437

A BILL TO BE ENTITLED  
AN ACT

1 To amend Part 2 of Article 6 of Chapter 2 of Title 20 of the Official Code of Georgia  
2 Annotated, relating to competencies and core curriculum for elementary and secondary  
3 students under the "Quality Basic Education Act," so as to authorize the State Board of  
4 Education to develop and adopt a curriculum for a state funded elective course consisting of  
5 a nonsectarian, nonreligious academic study of the Bible and its influence on literature, art,  
6 music, culture, and politics; to provide for implementation by a local board of education; to  
7 provide for related matters; to repeal conflicting laws; and for other purposes.

8 **BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:**

9 **SECTION 1.**

10 Part 2 of Article 6 of Chapter 2 of Title 20 of the Official Code of Georgia Annotated,  
11 relating to competencies and core curriculum for elementary and secondary students under  
12 the "Quality Basic Education Act," is amended by adding at the end thereof a new Code  
13 section to read as follows:

14 "20-2-148.

15 (a) The State Board of Education is authorized to approve a curriculum for an elective  
16 state funded course consisting of a nonsectarian, nonreligious academic study of the Bible  
17 and its influence on literature, art, music, culture, and politics. The curriculum and  
18 associated textbook shall meet academic rigor and standards of the State Board of  
19 Education in the same manner as required for approval of any other elective course and  
20 textbook approved by the state board and shall meet the requirements of the Constitutions  
21 of the United States and the State of Georgia. The course provided for in this Code section  
22 shall:

23 (1) Be taught in an objective and nondevotional manner with no attempt made to  
24 indoctrinate students as to either the truth or falsity of the biblical materials or texts from  
25 other religious or cultural traditions;

- 1 (2) Not include teaching of religious doctrine or sectarian interpretation of the Bible or  
2 of texts from other religious or cultural traditions; and
- 3 (3) Not disparage or encourage a commitment to a set of religious beliefs.
- 4 (b) A local board of education that elects to offer a course and utilize an associated  
5 textbook approved in accordance with subsection (a) of this Code section shall implement  
6 such course in accordance with the Constitutions of the United States and the State of  
7 Georgia, including the manner in which the course is taught in the classroom and the  
8 assignment by the local board of education of the individual teaching the course. The  
9 individual assigned to teach the course shall meet all certification requirements and all  
10 other provisions of this chapter relating to personnel employed by local units of  
11 administration. In addition, no person shall be assigned to teach such course based in  
12 whole or in part on any religious test, profession of faith or lack of faith, prior or present  
13 religious affiliation or lack of affiliation, or criteria involving particular beliefs or lack of  
14 beliefs about the Bible."

15 **SECTION 2.**

16 All laws and parts of laws in conflict with this Act are repealed.
