- 11 days later on April 10, 2004, while serving as a gunner on an Humvee, was killed in action

- WHEREAS, Justin has been awarded the Bronze Star, Purple Heart, National Defense
  Ribbon, Global War on Terrorism Service Medal, Global War on Terrorism Expeditionary
  Medal, and the Good Citizenship Award by the National Society of the Sons of the American
