A RESOLUTION

- 1 Honoring the life and accomplishments of Stephen J. Schmidt, Sr., and dedicating the
- 2 Stephen J. Schmidt, Sr., Memorial Highway; and for other purposes.
- 3 WHEREAS, news of the passing of Stephen J. Schmidt, Sr., was received by members of the
- 4 Oglethorpe University community with much sorrow; and
- 5 WHEREAS, during World War II he was a B-29 pilot in the Pacific theater where he flew
- 6 15 missions and named his plane the "Stormy Petrel"; and
- 7 WHEREAS, he owned Dixie Seal & Stamp Company; was a stockholder in the Atlanta
- 8 Crackers and a founding member of the Braves 400 Club; and was inducted into the Georgia
- 9 Sports Hall of Fame in 1992; and
- 10 WHEREAS, he was a member of the Oglethorpe University class of 1940 and was a loyal
- alumnus, Trustee Emeritus, and true friend to the Oglethorpe University Community; and
- 12 WHEREAS, he and his wife, Jeanne Fuller Schmidt, class of 1942, had been an integral part
- of the university for over 65 years; and
- 14 WHEREAS, Steve became an Oglethorpe Trustee in 1963 and served as chair from 1970
- until 1989, and he was awarded an honorary doctorate in 1986; and
- 16 WHEREAS, visible reminders of the Schmidt family's great contributions to Oglethorpe
- 17 University include the Schmidt Residence Hall, the Schmidt Center, and the Schmidt
- 18 Endowed Scholarship; and
- 19 WHEREAS, Stephen J. Schmidt, Sr., was known as "Mr. Oglethorpe" and it is only fitting
- and proper that this man of vision and significance be honored by dedicating a portion of the
- 21 highway bordering his beloved university in his honor.

- 2 GEORGIA that that portion of SR 141 from its intersection with Hermance Drive to its
- 3 intersection with Lanier Drive in DeKalb County is dedicated as the Stephen J. Schmidt, Sr.,
- 4 Memorial Highway.
- 5 BE IT FURTHER RESOLVED that the Department of Transportation is authorized and
- 6 directed to erect and maintain appropriate signs dedicating the Stephen J. Schmidt, Sr.,
- 7 Memorial Highway.
- 8 BE IT FURTHER RESOLVED that the Secretary of the Senate is authorized and directed
- 9 to transmit appropriate copies of this resolution to his wife, Jeanne Fuller Schmidt, and to the
- 10 Department of Transportation.
