- 17 Division, 1st and 82nd Field Artillery serving in Iraq; and
- 18 WHEREAS, Justin was born on June 25, 1981, in Portsmouth, Virginia, and moved to Rome,
- 19 Georgia, when he was four years old; and
- 20 WHEREAS, he attended West Central Elementary and Glenwood Elementary schools and
- 21 graduated from Armuchee High in 2000; and
- WHEREAS, he joined the United States Army in January, 2002, in reaction to the attacks on
- 23 the United States on September 11, 2001; and
- 24 WHEREAS, SPC Justin W. Johnson arrived in Baghdad, Iraq, on March 30, 2004, and 12
- 25 days later on April 10, 2004, while serving as a gunner on an Humvee, was killed in action
- 26 when his patrol was hit by a roadside bomb; and
- 27 WHEREAS, Justin has been awarded the Bronze Star, Purple Heart, National Defense
- 28 Ribbon, Global War on Terrorism Service Medal, Global War on Terrorism Expeditionary

- 3 WHEREAS, Reverend Jones was active in his community as the PTA President of Clara
