A BILL TO BE ENTITLED AN ACT

To amend Part 7 of Article 7 of Chapter 3 of Title 20 of the Official Code of Georgia
Annotated, relating to HOPE scholarships and grants, so as to change certain eligibility
requirements relating to HOPE teacher's scholarships; to provide for related matters; to
repeal conflicting laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

6	SECTION 1.
7	Part 7 of Article 7 of Chapter 3 of Title 20 of the Official Code of Georgia Annotated,
8	relating to HOPE scholarships and grants, is amended by striking subsection (a) of Code
9	Section 20-3-519.8, relating to HOPE teacher's scholarships, and inserting in lieu thereof the
10	following:
11	"(a) To be eligible for a HOPE teacher's scholarship, a student shall:
12	(1) Meet the residency requirements by:
13	(A) In the case of a student attending a unit of the University System of Georgia,
14	meeting the requirements to be eligible for in-state tuition under the policy set by the
15	board of regents; or
16	(B) In the case of a student attending an eligible private postsecondary institution,
17	being classified as a legal resident of Georgia for the purposes of a tuition equalization
18	grant;
19	(2) Be admitted into graduate school and into an advanced degree or approved teacher
20	education program in a critical shortage field of study leading to certification or into an
21	advanced degree program in education;
22	(3) Be one of the following:
23	(A) A teacher working in a public or private accredited school in Georgia who has a
24	baccalaureate degree and is seeking an advanced degree in his or her current field
25	which is a critical shortage field or in a new critical shortage field;

1	(B) An individual with a baccalaureate degree who is seeking an advanced degree in
2	a critical shortage field;
3	(C) An individual with a baccalaureate degree in a critical shortage field who is
4	seeking an advanced degree in education;
5	(C)(D) An individual with a master's degree in a critical shortage field who is seeking
6	certification as a specialist or a doctorate in his or her current critical shortage field;
7	(D)(E) An individual with a master's degree in a field which is not a critical shortage
8	field who is seeking an advanced degree in a critical shortage field;
9	(E)(F) An individual who has certification as a specialist in a critical shortage field
10	who is seeking a doctorate in his or her current critical shortage field; or
11	(F)(G) A teacher working in a public or private accredited school in Georgia who is
12	seeking to complete an approved program in a critical shortage field for which degree
13	programs are not generally offered; and
14	(4) Agree to teach in his or her critical shortage field in a public school in Georgia at the
15	preschool, elementary, middle, or secondary level for one academic year for each
16	\$2,500.00 in HOPE teacher scholarship funds awarded and sign a promissory note that
17	stipulates the cash repayment obligation incurred if the teaching service is not fulfilled."
