A BILL TO BE ENTITLED  
AN ACT

1 To provide a comprehensive revision, modernization, and reform of the laws of this state  
2 relating to operating motor vehicles while under the influence of alcohol, drugs, or other  
3 substances; to amend Title 40 of the Official Code of Georgia Annotated, relating to motor  
4 vehicles and traffic, so as to provide legislative intent; to prohibit the operation of motor  
5 vehicles in this state while under the influence of alcohol, drugs, or other substances; to  
6 provide for implied consent to chemical testing; to provide definitions; to provide for  
7 chemical testing of persons suspected of driving under the influence of alcohol, drugs, or  
8 other substances; to provide for the procedures to obtain and perform such tests; to provide  
9 for the administration of certain warnings with regard to such tests; to provide for  
10 independent tests under certain circumstances; to provide for certain qualifications of persons  
11 performing such tests and certain instruments used in such tests; to provide for the admission  
12 into evidence of the results of such tests and such certifications of testing instruments; to  
13 provide for certain immunities; to provide for certain disclosures; to provide for the taking  
14 of the driver's license of a person suspected of operating a motor vehicle while under the  
15 influence of alcohol, drugs, or other substances in certain circumstances; to provide for  
16 temporary driving permits under certain circumstances; to provide for certain reports by law  
17 enforcement officers and courts; to provide for the suspension and revocation of drivers'  
18 licenses under certain circumstances; to provide for procedures for such suspensions and  
19 revocations; to provide for hearings in certain circumstances; to provide for reinstatement of  
20 drivers' licenses under certain circumstances; to provide for compensation for law  
21 enforcement officers for attending hearings; to provide for sanctions and penalties for  
22 operating motor vehicles in this state while under the influence of alcohol, drugs, or other  
23 substances; to prohibit the operation of a school bus while under the influence of alcohol,  
24 drugs, or other substances; to prohibit the operation of a motor vehicle while under the  
25 influence of alcohol, drugs, or other substances when transporting a child under the age of  
26 14 years; to provide for the admissibility of certain evidence; to provide that legal entitlement  
27 to use alcohol, marijuana, or other drugs shall not constitute a defense; to provide that certain  
28 pleas shall constitute prior convictions for sentencing purposes; to provide for the adoption

1 of such laws by ordinance by political subdivisions; to provide for the discretion of the court  
 2 to accept certain pleas; to provide for the publication of the photographs and fact of  
 3 conviction for certain offenders; to provide for the seizure and forfeiture of certain vehicles  
 4 operated by certain violators; to provide for related matters; to amend various provisions of  
 5 the Official Code of Georgia Annotated, so as to conform such provisions to the provisions  
 6 of this Act; to provide for the applicability and effect of this Act; to provide an effective date;  
 7 to repeal conflicting laws; and for other purposes.

8 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

9 **PART I.**  
 10 **SECTION 1-1.**

11 Title 40 of the Official Code of Georgia Annotated, relating to motor vehicles and traffic, is  
 12 amended by adding a new Code Section 40-1-8 to read as follows:

13 "40-1-8.

14 (a) The State of Georgia considers that any person who drives or is in actual physical  
 15 control of any vehicle in violation of the laws of this state by consuming a prohibited level  
 16 of alcohol or by consuming any other drug constitutes a direct and immediate threat to the  
 17 welfare and safety of the general public.

18 (b) Any person who operates a motor vehicle upon the highways or elsewhere throughout  
 19 this state shall be deemed to have given consent to a chemical test or tests of his or her  
 20 blood, breath, urine, or other bodily substance for the purpose of determining the presence  
 21 of alcohol or any other drug.

22 (c) Any person who is dead, unconscious, or otherwise in a condition rendering such  
 23 person incapable of refusal shall be deemed not to have withdrawn the consent provided  
 24 by subsection (b) of this Code section, and the chemical test or tests of his or her blood,  
 25 breath, urine, or other bodily substance may be administered as provided in Article 9 of  
 26 Chapter 5 of this title."

27 **SECTION 1-2.**

28 Said title is further amended by adding a new Article 9 to Chapter 5, relating to drivers'  
 29 licenses, to read as follows:

## "ARTICLE 9

40-5-200.

As used in this article, the term:

(1) 'Adequate breath sample' means a breath sample sufficient to cause the breath-testing instrument to produce a printed alcohol concentration analysis.

(2) 'Law enforcement officer' means any peace officer, jail officer, juvenile correctional officer, or law enforcement support personnel, as such terms are defined by Code Section 35-8-2, or any individual possessing a valid permit issued by the Division of Forensic Sciences of the Georgia Bureau of Investigation to administer breath tests.

(3) 'Medical facility' means a hospital, clinical laboratory, medical clinic, or similar medical institution.

40-5-201.

A law enforcement officer is authorized to obtain one or more chemical tests of a person's blood, breath, urine, or other bodily substance for the purpose of determining the presence of alcohol or any other drug if there are reasonable grounds to believe that such person operated or was in actual physical control of a motor vehicle in violation of any of the provisions of Part 2 of Article 15 of Chapter 6 of this title. The law enforcement officer shall designate which test or tests shall be administered.

40-5-202.

(a) Prior to the administration of chemical tests to a person pursuant to this article, the implied consent notice as provided in subsection (c) of this Code section shall be read to such person.

(b) The notices provided in subsections (c) and (d) of this Code section shall be read in their entirety but need not be read exactly so long as the substance of the notice remains unchanged. If such notice is used to advise a person of his or her rights regarding the administration of chemical testing, such person shall be deemed to have been properly advised of his or her rights under this Code section. The informing of or failure to inform the accused person concerning the implied consent law shall not affect the admissibility of such results in any case, including a prosecution for a violation of Part 2 of Article 15 of Chapter 6 of this title. The informing of an accused person concerning the implied consent law shall only have application to and be relevant at a hearing concerning revocation of the driver's license of said person for a violation of the implied consent law.

(c) At the time a chemical test or tests are requested, the following implied consent notice shall be read to the person:

1 'Georgia law requires you to submit to state administered chemical tests of your blood,  
2 breath, urine, or other bodily substance for the purpose of determining if you are  
3 operating a motor vehicle under the influence of alcohol or drugs or with a prohibited  
4 substance in your body. If you submit to this testing, the results may be used against you  
5 in a court of law or in an administrative proceeding. If you refuse to submit to this  
6 testing, your Georgia driver's license or privilege to drive on the highways of this state  
7 may be suspended for a minimum period of one year and your refusal may be used as  
8 evidence against you. If you submit to the state's testing, you are entitled to additional  
9 chemical tests of your blood, breath, urine, or other bodily substance at your own expense  
10 and from qualified personnel of your own choosing. Will you submit to the state  
11 administered testing under the implied consent law?'

12 (d) In addition to the implied consent notice, if the person is driving, operating, or in  
13 physical control of a commercial motor vehicle, the following notice shall be read:

14 'If you submit to testing and the results indicate the presence of any alcohol, you will also  
15 be issued an out-of-service order and will be prohibited from operating a commercial  
16 motor vehicle for 24 hours. If the results indicate an alcohol concentration of 0.04 grams  
17 or more, you will be disqualified from operating a commercial motor vehicle for a  
18 minimum period of one year.'

19 (e) If the person submits to the state administered test or tests, such person may have a  
20 qualified person of such person's choosing administer chemical tests in addition to any  
21 tests administered at the direction of a law enforcement officer. The justifiable failure or  
22 inability to obtain an additional test shall not preclude the admission of evidence relating  
23 to the test or tests taken at the direction of a law enforcement officer.

24 (f) If the person refuses to submit to the state administered test authorized by this Code  
25 section, nothing in this article shall be deemed to preclude the acquisition or admission of  
26 such evidence by any means authorized by the Constitution or laws of this state or of the  
27 United States.

28 (g) Upon the request of the person who shall submit to a chemical test or tests designated  
29 by a law enforcement officer, a copy of the results of the test or tests shall be made  
30 available to such person or such person's attorney.

31 40-5-203.

32 (a) Any test authorized by Code Section 40-5-201 shall be performed according to  
33 methods approved by the Division of Forensic Sciences of the Georgia Bureau of  
34 Investigation.

35 (b) Any test of a person's breath shall be performed on a machine approved by the  
36 Division of Forensic Sciences of the Georgia Bureau of Investigation which machine shall

1 be operated with all its electronic and operating components prescribed by its manufacturer  
2 properly attached and in good working order. Such test shall be performed by an  
3 individual possessing a valid permit issued by the Division of Forensic Sciences for such  
4 purpose.

5 (c) The Division of Forensic Sciences of the Georgia Bureau of Investigation shall approve  
6 satisfactory techniques or methods to ascertain the qualifications and competence of  
7 individuals to conduct analyses and to issue permits, along with requirements for properly  
8 operating and maintaining any testing instruments, and to issue certificates certifying that  
9 instruments have met those requirements, which certificates and permits shall be subject  
10 to termination or revocation at the discretion of the Division of Forensic Sciences.

11 (d) In all cases where a law enforcement officer designates breath testing, two sequential  
12 breath samples shall be requested for the testing of alcohol concentration. For either or  
13 both of these sequential samples to be admissible in the state's or plaintiff's case-in-chief,  
14 the readings shall not differ from each other by an alcohol concentration of greater than  
15 0.020 grams and the lower of the two results shall be determinative for accusation and  
16 indictment purposes and administrative license suspension purposes. No more than two  
17 sequential series of a total of two adequate breath samples each shall be requested by the  
18 law enforcement officer. A refusal to give an adequate sample or samples on any  
19 subsequent breath, blood, urine, or other bodily substance test shall not affect the  
20 admissibility of the results of any prior samples.

21 40-5-204.

22 (a) Each time an approved breath-testing instrument is inspected, the inspector shall  
23 prepare a certificate which shall be signed under oath by the inspector and which shall  
24 include the following language:

25 "This breath-testing instrument (serial no. \_\_\_\_\_) was thoroughly inspected,  
26 tested, and standardized by the undersigned on (date \_\_\_\_\_) and all of its  
27 electronic and operating components prescribed by its manufacturer are properly attached  
28 and are in good working order.'

29 (b) When properly prepared and executed, as prescribed in this Code section, the  
30 certificate shall, notwithstanding any other provision of law, be self-authenticating, shall  
31 be admissible in any court of law, and shall satisfy the requirements of this Code section  
32 and Code Section 40-5-203.

33 40-5-205.

34 (a) In all cases where a law enforcement officer designates blood testing pursuant to Code  
35 Section 40-5-202 for the purpose of determining the alcohol or other drug content, the

1 sample may be drawn by a physician, physician's assistant, qualified technician, chemist,  
2 registered nurse, licensed practical nurse, medical technologist, medical laboratory  
3 technician, emergency medical technician, certified paramedic, phlebotomist, or other  
4 personnel trained to draw blood.

5 (b) For the purpose of establishing that a person was qualified to draw blood at the time  
6 the blood was drawn, the following shall be admissible as evidence:

7 (1) Certification by the office of the Secretary of State or by the Department of Human  
8 Resources that a person who drew blood was licensed or certified in accordance with the  
9 laws, rules, or regulations of this state;

10 (2) Records of a medical facility or employer, which records are duly certified by the  
11 custodian of such records as provided by Code Section 24-7-8, that certify that the person  
12 who drew the blood was properly trained and authorized to draw blood as an employee  
13 of the medical facility or employer;

14 (3) Testimony, under oath, of the person who drew the blood; or

15 (4) Testimony, under oath, of the supervisor of the person who drew the blood or the  
16 medical records custodian that the person who drew the blood was properly trained and  
17 authorized to draw blood as an employee of the medical facility or employer.

18 (c) A medical facility, physician, physician's assistant, qualified technician, chemist,  
19 registered nurse, licensed practical nurse, medical technologist, medical laboratory  
20 technician, emergency medical technician, certified paramedic, phlebotomist, or other  
21 personnel trained to draw blood; or a duly licensed clinical laboratory director, supervisor,  
22 technologist, technician, or employer thereof; or other person assisting a law enforcement  
23 officer shall not incur any civil, criminal, or administrative liability as a result of the  
24 withdrawal of a blood specimen pursuant to generally accepted medical practices when  
25 requested in writing by a law enforcement officer or directed by a court of competent  
26 jurisdiction, regardless of whether the subject resisted administration of the test.  
27 Notwithstanding any other provision of law, obtaining a blood sample pursuant to this  
28 article shall not constitute the practice of medicine or any other profession relating to health  
29 care which is regulated, licensed, or certified by the state.

30 (d) No privilege shall exist with regard to the disclosure by medical personnel to a law  
31 enforcement officer or prosecuting attorney of the results of a chemical test of a person's  
32 blood, breath, urine, or other bodily substance for the purpose of determining the alcohol  
33 or drug content of a person's blood irrespective of whether such test was done at the  
34 request of a treating physician, other medical personnel, or a law enforcement officer.

1 40-5-206.

2 (a) Whenever any resident or nonresident person is charged with a violation of Part 2 of  
3 Article 15 of Chapter 6 of this title, the law enforcement officer shall take the driver's  
4 license of the person so charged. The driver's license shall be attached to the court's copy  
5 of the uniform traffic citation and complaint form and shall be forwarded to the court  
6 having jurisdiction of the offense. A copy of the uniform traffic citation and complaint  
7 form shall be forwarded, within ten days of issue, to the department. Taking the driver's  
8 license as required in this Code section shall not prohibit any law enforcement officer or  
9 agency from requiring any cash bond authorized by Article 1 of Chapter 6 of Title 17.

10 (b) At the time the law enforcement officer takes the driver's license, the officer shall issue  
11 a temporary driving permit to the person as follows:

12 (1) If the driver refuses to submit to a test or tests to determine the presence of alcohol  
13 or drugs as required by this article, the officer shall issue a 30 day temporary driving  
14 permit;

15 (2) If the driver's license is required to be suspended under Code Section 40-5-208, the  
16 officer shall issue a 30 day temporary driving permit; or

17 (3) If the test or tests administered pursuant to this article indicate an alcohol  
18 concentration less than the level for an administrative suspension of the license pursuant  
19 to Code Section 40-5-208 but there are reasonable grounds to believe that the person  
20 violated Code Section 40-6-410, the officer shall issue a 180 day temporary driving  
21 permit.

22 (c) A temporary driving permit issued pursuant to subsection (b) of this Code section shall  
23 be valid for the stated period or until the person's driving privilege is suspended or revoked  
24 under any provision of this title. The department, at its sole discretion, may delay the  
25 expiration date of the temporary driving permit, but in no event shall this delay extend  
26 beyond the date when such person's driving privilege is suspended or revoked under any  
27 provision of this title. The department shall by rules and regulations establish the  
28 conditions under which the expiration of the temporary driving permit may be delayed.

29 (d)(1) If the person is convicted of violating or enters a plea of nolo contendere to a  
30 violation of any of the provisions of Part 2 of Article 15 of Chapter 6 of this title, the  
31 court shall, within ten days, forward the person's driver's license and the record of the  
32 disposition of the case to the department. If such person is in possession of a temporary  
33 driving permit issued pursuant to subsection (b) of this Code section, the court shall also  
34 require the person to surrender such temporary driving permit instanter.

35 (2) If the person is not convicted of violating or does not enter a plea of nolo contendere  
36 to a violation of any of the provisions of Part 2 of Article 15 of Chapter 6 of this title and  
37 the court is in possession of the driver's license, the court shall return the driver's license

1 to the person unless the license is in suspension for any other offense, in which case the  
2 court shall forward the license to the department for disposition.

3 40-5-207.

4 (a) A law enforcement officer shall submit a report to the department if:

5 (1) A person submits to a chemical test upon the request of a law enforcement officer  
6 and the test results indicate that a suspension or disqualification is required under this  
7 article; or

8 (2) A person refuses to submit to a chemical test designated by a law enforcement officer  
9 as provided in this article.

10 (b) A report submitted pursuant to subsection (a) of this Code section shall be in writing,  
11 signed by a law enforcement officer and in such form as the department shall prescribe.  
12 Such report may be submitted electronically in accordance with Chapter 12 of Title 10, the  
13 'Georgia Electronic Records and Signatures Act.' The signature of the officer, whether  
14 actual or electronic, shall be considered an attestation of the officer that the facts contained  
15 therein are true and correct.

16 (c) A law enforcement officer, acting on behalf of the department, shall personally serve  
17 the notice of intention to suspend or disqualify the license of the arrested person or other  
18 person refusing such test on such person at the time of the person's refusal to submit to a  
19 test or at the time at which such a test indicates that suspension or disqualification is  
20 required under Code Section 40-5-208.

21 (d) The law enforcement officer shall forward the person's driver's license to the  
22 department along with the notice of intent to suspend or disqualify and the report required  
23 by subsections (a) and (b) of this Code section within ten calendar days after the date of the  
24 arrest of such person. This subsection shall not apply to any person issued a 180 day  
25 temporary permit pursuant to subsection (b) of Code Section 40-5-206. The failure of the  
26 officer to transmit the report required by this Code section within ten calendar days shall  
27 not prevent the department from accepting such report and utilizing it in the suspension of  
28 a driver's license as provided in this article.

29 40-5-208.

30 (a) Upon the receipt of the report of the law enforcement officer, the department shall  
31 suspend the person's driver's license, permit, or nonresident operating privilege pursuant  
32 to Code Section 40-5-209 if:

33 (1) The person submitted to a chemical test at the request of a law enforcement officer  
34 and the test results indicated that:

35 (A) The person had an alcohol concentration of 0.08 grams or more;

1 (B) The person had an alcohol concentration of 0.02 grams or more and the person was  
2 under the age of 21; or

3 (C) The person had an alcohol concentration of 0.04 grams or more and the person was  
4 operating or was in actual physical control of a moving commercial motor vehicle; or

5 (2) The person refused to submit to the chemical test requested by a law enforcement  
6 officer.

7 (b) If notice has not been given by a law enforcement officer pursuant to Code Section  
8 40-5-203, the department, upon receipt of the report of such officer, shall suspend the  
9 person's driver's license, permit, or nonresident operating privilege or disqualify such  
10 person from operating a motor vehicle and, by regular mail, at the last known address,  
11 notify such person of such suspension or disqualification. The notice shall inform the  
12 person of the grounds of suspension or disqualification, the effective date of the suspension  
13 or disqualification, and the right to review. The notice shall be deemed received three days  
14 after mailing.

15 (c) The period of suspension provided for in this Code section shall be for a minimum  
16 period of one year; provided, however, that such suspension shall be subject to review as  
17 provided in this chapter. If the person was operating or in actual physical control of a  
18 commercial motor vehicle, the department shall disqualify the person from operating a  
19 commercial motor vehicle and shall suspend the person's driver's license, permit, or  
20 nonresident operating privilege, subject to review as provided for in this chapter.

21 (d) If the person is a resident without a driver's license, commercial driver's license, or  
22 permit to operate a motor vehicle in this state, the department shall deny issuance of a  
23 license or permit to such person for the same period provided in subsection (c) of this Code  
24 section for suspension of a license or permit or disqualification to operate a commercial  
25 motor vehicle, subject to review as provided for in this chapter.

26 (e) Any driver's license required to be suspended under the provisions of this Code section  
27 shall be suspended subject to the following terms and conditions:

28 (1) Upon the first suspension pursuant to this Code section within the previous five  
29 years, as measured from the dates of previous arrests for which a suspension was  
30 obtained to the date of the current arrest for which a suspension is obtained, the period  
31 of suspension shall be for one year. Not sooner than 30 days following the effective date  
32 of suspension, the person may apply to the department for reinstatement of his or her  
33 driver's license. Such license shall be reinstated if such person submits proof of  
34 completion of a DUI Alcohol or Drug Use Risk Reduction Program and pays a  
35 restoration fee of \$210.00, or \$200.00 when such reinstatement is processed by mail,  
36 unless such conviction was a recidivist conviction in which case the restoration fee shall  
37 be \$510.00, or \$500.00 when processed by mail. A driver's license suspended pursuant

1 to this Code section shall not become valid and shall remain suspended until such person  
2 submits proof of completion of a DUI Alcohol or Drug Use Risk Reduction Program and  
3 pays the prescribed restoration fee;

4 (2) Upon the second suspension pursuant to this Code section within five years, as  
5 measured from the dates of previous arrests for which suspensions were obtained to the  
6 date of the current arrest for which a suspension is obtained, the period of suspension  
7 shall be for three years. The person shall be eligible to apply to the department for  
8 license reinstatement not sooner than 18 months following the effective date of  
9 suspension. Such license shall be reinstated if such person submits proof of completion  
10 of a DUI Alcohol or Drug Use Risk Reduction Program and pays a restoration fee of  
11 \$210.00, or \$200.00 when such reinstatement is processed by mail, unless such  
12 conviction was a recidivist conviction in which case the restoration fee shall be \$510.00,  
13 or \$500.00 when processed by mail. A driver's license suspended pursuant to this Code  
14 section shall not become valid and shall remain suspended until such person submits  
15 proof of completion of a DUI Alcohol or Drug Use Risk Reduction Program and pays the  
16 prescribed restoration fee; and

17 (3) Upon the third or subsequent suspension pursuant to this Code section within five  
18 years, as measured from the dates of previous arrests for which suspensions were  
19 obtained to the date of the current arrest for which a suspension is obtained, the period  
20 of suspension shall be for five years. A driver's license suspended pursuant to this Code  
21 section shall not become valid and shall remain suspended until such person submits  
22 proof of completion of a DUI Alcohol or Drug Use Risk Reduction Program and pays the  
23 prescribed restoration fee. The driver may apply for a probationary license pursuant to  
24 Code Section 40-5-58 after the expiration of two years from the effective date of  
25 suspension.

26 (f) An administrative license suspension pursuant to this Code section shall be counted  
27 toward fulfillment of any period of suspension subsequently imposed as a result of a  
28 conviction of violating Code Section 40-6-410, 40-6-411, 40-6-412, or 40-6-413 which  
29 arises out of the same violation for which the administrative license suspension was  
30 imposed. An administrative license suspension pursuant to this Code section shall run  
31 concurrently with any revocation of such driver's license pursuant to a subsequent  
32 determination that such person is a habitual violator.

33 (g) In all cases in which the department may return a license to a driver prior to the  
34 termination of the full period of suspension, the department may require such tests of  
35 driving skill and knowledge as it determines to be proper, and the department's discretion  
36 shall be guided by the driver's past driving record and performance. The driver shall pay  
37 a restoration fee of \$210.00, or \$200.00 when processed by mail.

1 (h) Any other provision of law to the contrary notwithstanding, a driver with no previous  
 2 conviction for a violation of Code Section 40-6-410, 40-6-411, 40-6-412, or 40-6-413  
 3 within the previous five years, as measured from the dates of previous arrests for which  
 4 convictions were obtained to the date of the current arrest, during the period of  
 5 administrative suspension contemplated under this article, shall be entitled to a limited  
 6 driving permit as provided in Code Section 40-5-64.

7 40-5-209.

8 (a)(1) A person whose driver's license is suspended or a person who is disqualified from  
 9 operating a commercial motor vehicle pursuant to this article shall request, in writing, a  
 10 hearing within ten business days from the date of personal notice or receipt of notice sent  
 11 by certified mail or statutory overnight delivery, return receipt requested, or the right to  
 12 said hearing shall be deemed waived. Within 30 days after receiving a written request  
 13 for a hearing, the department shall hold a hearing as provided in Chapter 13 of Title 50,  
 14 the 'Georgia Administrative Procedure Act.' The hearing shall be recorded.

15 (2) The scope of the hearing shall be limited to the following issues:

16 (A) Whether the law enforcement officer had reasonable grounds to believe the person  
 17 was driving or in actual physical control of a moving motor vehicle while under the  
 18 influence of alcohol, a drug, or any combination thereof or had a prohibited substance  
 19 in his or her body;

20 (B) Whether the law enforcement officer requested the person to submit to a state  
 21 administered chemical test;

22 (C) Whether at the time of the request for the test or tests the officer informed the  
 23 person of the person's implied consent rights and the consequence of submitting or  
 24 refusing to submit to such test; and

25 (D)(i) Whether the person refused the test; or

26 (ii)(I) Whether a test or tests were administered and the results indicated an alcohol  
 27 concentration of 0.08 grams or more or, for a person under the age of 21, an alcohol  
 28 concentration of 0.02 grams or more or, for a person operating or having actual  
 29 physical control of a commercial motor vehicle, an alcohol concentration of 0.04  
 30 grams or more; and

31 (II) Whether the test or tests were properly administered by an individual  
 32 possessing a valid permit issued by the Division of Forensic Sciences of the Georgia  
 33 Bureau of Investigation on an instrument approved by the Division of Forensic  
 34 Sciences or a test conducted by the Division of Forensic Sciences, including  
 35 whether the machine at the time of the test was operated with all its electronic and  
 36 operating components prescribed by its manufacturer properly attached and in good

1 working order. A copy of the operator's permit showing that the operator has been  
2 trained on the particular type of instrument used and one of the original copies of  
3 the test results or, where the test is performed by the Division of Forensic Sciences,  
4 a copy of the crime lab report shall satisfy the requirements of this subparagraph.

5 (3) The hearing officer shall, within five calendar days after such hearing, forward a  
6 decision to the department to rescind or sustain the driver's license suspension or  
7 disqualification. If no hearing is requested within ten business days as specified in  
8 paragraph (1) of this subsection, and the failure to request such hearing is due in whole  
9 or in part to the reasonably avoidable fault of the person, the right to a hearing shall have  
10 been waived. The request for a hearing shall not stay the suspension of the driver's  
11 license; provided, however, that if the hearing is timely requested and is not held before  
12 the expiration of the temporary permit and the delay is not due in whole or in part to the  
13 reasonably avoidable fault of the person, the suspension shall be stayed until such time  
14 as the hearing is held and the hearing officer's decision is made.

15 (4) In the event the person is acquitted of a violation of Code Section 40-6-410,  
16 40-6-411, 40-6-412, or 40-6-413 or such charge is initially disposed of other than by a  
17 conviction or plea of nolo contendere, then the suspension shall be terminated and deleted  
18 from the driver's license record. An accepted plea of nolo contendere shall be entered  
19 on the driver's license record and shall be considered and counted as a conviction for  
20 purposes of any future violations of Code Section 40-6-410, 40-6-411, 40-6-412, or  
21 40-6-413. In the event of an acquittal or other disposition other than by a conviction or  
22 plea of nolo contendere, the driver's license restoration fee shall be promptly returned by  
23 the department to the licensee.

24 (b) If the suspension is sustained after such a hearing, the person whose license has been  
25 suspended under this Code section shall have a right to file for a judicial review of the  
26 department's final decision, as provided in Chapter 13 of Title 50, the 'Georgia  
27 Administrative Procedure Act.' While such appeal is pending, the order of the department  
28 shall not be stayed.

29 40-5-210.

30 (a) Subject to the limitations of this subsection, any law enforcement officer who attends  
31 a hearing provided for by Code Section 40-5-209 for the purpose of giving testimony  
32 relative to the subject of such hearing shall be compensated in the same amount as is  
33 authorized as per diem for law enforcement officers pursuant to Code Section 24-10-27 for  
34 each day's attendance at such hearing. In the event a law enforcement officer gives  
35 testimony at two or more different hearings on the same day, such officer shall receive only  
36 \$20.00 for attendance at all hearings.

1 (b) The compensation provided for in this Code section shall not be paid to any law  
 2 enforcement officer who is on regular duty or who is on a lunch or other break from regular  
 3 duty at the time the officer attends any such hearing. The compensation provided for by  
 4 this Code section shall be paid to the law enforcement officer by the department from  
 5 department funds at such time and in such manner as the commissioner shall provide by  
 6 rule.

7 (c) A law enforcement officer requesting compensation pursuant to this Code section shall  
 8 submit a request for payment in such form as the commissioner shall prescribe by rule.  
 9 Such form shall be signed by the officer, attesting that the officer:

10 (1) Appeared at the implied consent hearing as a witness or complainant on the date and  
 11 time shown in the request;

12 (2) Was not on regular duty at the time of attending the hearing; and

13 (3) Has not received and will not receive compensation from such officer's regular  
 14 employer for attending the hearing.

15 (d) A request for compensation shall be certified by the hearing officer who presided at the  
 16 hearing for which compensation is requested."

### 17 **SECTION 1-3.**

18 Said title is further amended by redesignating the existing provisions of Article 15 of  
 19 Chapter 6, relating to serious traffic offenses, as Part 1 and inserting a new Part 2 to read as  
 20 follows:

#### 21 "Part 2

22 40-6-410.

23 A person commits the offense of driving under the influence if such person drives or is in  
 24 actual physical control of any moving vehicle while:

25 (1) Under the influence of alcohol to the extent that it is less safe for the person to drive;

26 (2) Under the influence of any drug or marijuana to the extent that it is less safe for the  
 27 person to drive;

28 (3) Under the intentional influence of any glue, aerosol, or other toxic vapor to the extent  
 29 that it is less safe for the person to drive; or

30 (4) Under the combined influence of any two or more of the substances specified in  
 31 paragraphs (1) through (3) of this Code section to the extent that it is less safe for the  
 32 person to drive.

1 40-6-411.

2 A person commits the offense of driving with a prohibited substance in his or her body if  
3 such person drives or is in actual physical control of any moving vehicle and such person  
4 has:

5 (1) At any time within three hours after having driven or been in actual physical control  
6 of any moving vehicle, an alcohol concentration of 0.08 grams or more in such person's  
7 blood, breath, urine, or other bodily substance from alcohol consumed before or while  
8 driving or being in actual physical control of such motor vehicle; or

9 (2) Any amount of a Schedule I controlled substance, as defined in Code Section  
10 16-13-25, present in such person's blood, urine, or other bodily substance, including the  
11 metabolites and derivatives of such controlled substances, without regard to whether any  
12 alcohol is present in the person's breath or blood.

13 40-6-412.

14 A person commits the offense of driving a commercial motor vehicle with a prohibited  
15 substance in his or her body if such person drives or is in actual physical control of a  
16 commercial motor vehicle and has, at any time within three hours after having driven or  
17 been in actual physical control of such commercial motor vehicle, an alcohol concentration  
18 of 0.04 grams or more in such person's blood, breath, urine, or other bodily substance.

19 40-6-413.

20 A person commits the offense of underage driving with a prohibited substance in his or her  
21 body if a person under 21 years of age drives or is in actual physical control of any moving  
22 vehicle and has, at any time within three hours of driving or being in physical control of  
23 such motor vehicle, an alcohol concentration of 0.02 grams or more in such person's blood,  
24 breath, urine, or other bodily substance from alcohol consumed before or while driving or  
25 being in actual physical control of such motor vehicle.

26 40-6-414.

27 (a) Unless otherwise provided in this part, any person convicted of any violation of Code  
28 Sections 40-6-410 through 40-6-413 shall be punished as follows:

29 (1) For a first conviction with no conviction of and no plea of nolo contendere accepted  
30 to a charge of violating this Code section within the previous five years, as measured  
31 from the dates of previous arrests for which convictions were obtained or pleas of nolo  
32 contendere were accepted to the date of the current arrest for which a conviction is  
33 obtained or a plea of nolo contendere is accepted, such person shall be guilty of a  
34 misdemeanor and shall be punished as follows:

1 (A) A fine of not less than \$300.00 nor more than \$1,000.00, which fine shall not,  
2 except as provided in subsection (f) of this Code section, be subject to suspension, stay,  
3 or probation;

4 (B) A period of imprisonment of not less than ten days nor more than 12 months,  
5 which period of imprisonment may, at the sole discretion of the judge, be suspended,  
6 stayed, or probated; provided, however, that, if the offender's alcohol concentration at  
7 the time of the offense was 0.08 grams or more, the judge may suspend, stay, or probate  
8 all but 24 hours of any term of imprisonment imposed under this subparagraph;

9 (C) Not less than 40 hours of community service; provided, however, that, for a  
10 conviction for violation of Code Section 40-6-413 where the person's alcohol  
11 concentration at the time of the offense was less than 0.08 grams, the period of  
12 community service shall be not less than 20 hours;

13 (D) Completion of a DUI Alcohol or Drug Use Risk Reduction Program approved by  
14 the Department of Driver Services. The sponsor of any such program shall provide  
15 written notice of such approval to the person upon enrollment in the program; and

16 (E) If the defendant is sentenced to a period of imprisonment for less than 12 months,  
17 a period of probation of 12 months less any days during which the defendant is actually  
18 incarcerated;

19 (2) For the second conviction within a five-year period of time, as measured from the  
20 dates of previous arrests for which convictions were obtained or pleas of nolo contendere  
21 were accepted to the date of the current arrest for which a conviction is obtained or a plea  
22 of nolo contendere is accepted, such person shall be guilty of a misdemeanor and shall  
23 be punished as follows:

24 (A) A fine of not less than \$600.00 nor more than \$1,000.00, which fine shall not,  
25 except as provided in subsection (f) of this Code section, be subject to suspension, stay,  
26 or probation;

27 (B) A period of imprisonment of not less than 90 days nor more than 12 months. The  
28 judge shall probate at least a portion of such term of imprisonment, in accordance with  
29 subparagraph (F) of this paragraph, thereby subjecting the offender to the provisions  
30 of Article 7 of Chapter 8 of Title 42 and to such other terms and conditions as the judge  
31 may impose; provided, however, that the offender shall be required to serve not less  
32 than 72 hours of actual incarceration;

33 (C) Not less than 30 days of community service;

34 (D) Completion of a DUI Alcohol or Drug Use Risk Reduction Program approved by  
35 the Department of Driver Services. The sponsor of any such program shall provide  
36 written notice of such approval to the person upon enrollment in the program;

1 (E) Undergoing a clinical evaluation as defined in Code Section 40-5-1 and, if  
2 indicated by such evaluation, completion of a substance abuse treatment program as  
3 defined in Code Section 40-5-1; and

4 (F) A period of probation of 12 months less any days during which the defendant is  
5 actually incarcerated; or

6 (3) For the third or subsequent conviction within a five-year period of time, as measured  
7 from the dates of previous arrests for which convictions were obtained or pleas of nolo  
8 contendere were accepted to the date of the current arrest for which a conviction is  
9 obtained or a plea of nolo contendere is accepted, such person shall be guilty of a  
10 misdemeanor of a high and aggravated nature and shall be punished as follows:

11 (A) A fine of not less than \$1,000.00 and not more than \$5,000.00, which fine shall  
12 not, except as provided in subsection (f) of this Code section, be subject to suspension,  
13 stay, or probation;

14 (B) A mandatory period of imprisonment of not less than 120 days nor more than 12  
15 months. The judge shall probate at least a portion of such term of imprisonment, in  
16 accordance with subparagraph (F) of this paragraph, thereby subjecting the offender to  
17 the provisions of Article 7 of Chapter 8 of Title 42 and to such other terms and  
18 conditions as the judge may impose; provided, however, that the offender shall be  
19 required to serve not less than 15 days of actual incarceration;

20 (C) Not less than 30 days of community service;

21 (D) Completion of a DUI Alcohol or Drug Use Risk Reduction Program approved by  
22 the Department of Driver Services. The sponsor of any such program shall provide  
23 written notice of such approval to the person upon enrollment in the program;

24 (E) Undergoing a clinical evaluation as defined in Code Section 40-5-1 and, if  
25 indicated by such evaluation, completion of a substance abuse treatment program as  
26 defined in Code Section 40-5-1; and

27 (F) A period of probation of 12 months less any days during which the defendant is  
28 actually incarcerated.

29 (b) For the purpose of imposing a sentence under subsection (a) of this Code section, a  
30 plea of nolo contendere or an adjudication of delinquency based on a violation of Code  
31 Sections 40-6-410 through 40-6-413 shall constitute a conviction.

32 (c) When a defendant has been convicted of violating, by a single transaction, more than  
33 one of the provisions of Code Sections 40-6-410 through 40-6-413, the court shall merge  
34 such offenses for the purpose of sentencing and such offenses shall be treated as a single  
35 conviction for the purposes of this Code section and Code Section 40-5-58.

36 (d)(1) If the payment of the fine required under subsection (a) of this Code section will  
37 impose an economic hardship on the defendant, the judge, at his or her sole discretion,

1 may order the defendant to pay such fine in installments and such order may be enforced  
2 through a contempt proceeding or a revocation of any probation otherwise authorized by  
3 this Code section.

4 (2) In the sole discretion of the judge, he or she may suspend up to one-half of the fine  
5 imposed under paragraph (2) or (3) of subsection (a) of this Code section for a second or  
6 subsequent conviction conditioned upon the defendant's undergoing treatment in a  
7 substance abuse treatment program as defined in Code Section 40-5-1.

8 (e) Any person convicted of violating Code Section 40-6-412 shall, in addition to any  
9 disqualification resulting under Article 7 of Chapter 5 of this title, the 'Uniform  
10 Commercial Driver's License Act,' be fined as provided in subsection (a) of this Code  
11 section.

12 (f)(1) In any case where a person is sentenced to a period of imprisonment pursuant to  
13 this Code section for a violation of Code Section 40-6-413, it is within the authority and  
14 discretion of the sentencing judge in cases involving the first such violation to allow the  
15 sentence to be served on weekends by weekend confinement or during the nonworking  
16 hours of the defendant. A weekend shall commence and shall end in the discretion of the  
17 sentencing judge, and the nonworking hours of the defendant shall be determined in the  
18 discretion of the sentencing judge; provided, however, that the judge shall retain plenary  
19 control of the defendant at all times during the sentence period. Confinement during the  
20 nonworking hours of a defendant during any day may be counted as serving a full day of  
21 the sentence.

22 (2) Any confinement of a person pursuant to a sentence to a period of imprisonment for  
23 a violation of Code Section 40-6-413 shall be served in a county jail; provided, however,  
24 that, for the first such violation, such person shall be kept segregated from all offenders  
25 other than those confined for violating such Code section.

26 40-6-415.

27 (a) A person commits the offense of endangering a child by driving under the influence  
28 of alcohol or drugs if such person drives or is in actual physical control of any moving  
29 vehicle while in violation of Code Section 40-6-410, 40-6-411, 40-6-412, or 40-6-413  
30 while transporting a child under the age of 14 years.

31 (b) Any person convicted of a violation of this Code section shall be punished as provided  
32 in subsection (d) of Code Section 16-12-1, relating to the offense of contributing to the  
33 delinquency, unruliness, or deprivation of a child.

34 (c) Any violation of this Code section shall be considered a separate offense.

1 40-6-416.

2 (a) A school bus driver licensed pursuant to Article 7 of Chapter 5 of this title shall, upon  
3 a conviction of a violation of Code Section 40-6-410, 40-6-411, 40-6-412, or 40-6-413  
4 while driving a school bus, be punished by imprisonment for a period of not less than one  
5 year nor more than five years or by a fine of not less than \$1,000.00 nor more than  
6 \$5,000.00, or both.

7 (b) Any violation of this Code section shall be considered a separate offense.

8 40-6-417.

9 (a) Except as provided in subsection (b) of this Code section, upon the trial of any civil or  
10 criminal action or proceeding arising out of acts alleged to have been committed by any  
11 person in violation of this part, the amount of alcohol in the person's blood at the time  
12 alleged, as shown by chemical analysis of the person's blood, urine, breath, or other bodily  
13 substance, may give rise to inferences as follows:

14 (1) If there was at that time an alcohol concentration of 0.05 grams or less, the trier of  
15 fact in its discretion may infer therefrom that the person was not under the influence of  
16 alcohol, as prohibited by paragraphs (1) and (4) of Code Section 40-6-410;

17 (2) If there was at that time an alcohol concentration in excess of 0.05 grams but less  
18 than 0.08 grams, such fact shall not give rise to any inference that the person was or was  
19 not under the influence of alcohol, as prohibited by paragraphs (1) and (4) of Code  
20 Section 40-6-410, but such fact may be considered by the trier of fact with other  
21 competent evidence in determining whether the person was under the influence of  
22 alcohol, as prohibited by paragraphs (1) and (4) of Code Section 40-6-410; or

23 (3) If there was at that time an alcohol concentration of 0.08 grams or more, the trier of  
24 fact in its discretion may infer therefrom that the person was under the influence of  
25 alcohol, as prohibited by paragraphs (1) and (4) of Code Section 40-6-410.

26 (b)(1) In any civil or criminal action or proceeding arising out of acts alleged to have  
27 been committed in violation of paragraph (1) of Code Section 40-6-411, if there was at  
28 that time or within three hours after driving or being in actual physical control of a  
29 moving vehicle from alcohol consumed before such driving or being in actual physical  
30 control ended an alcohol concentration of 0.08 or more grams in the person's blood,  
31 breath, urine, or other bodily substance, the person shall be in violation of paragraph (1)  
32 of Code Section 40-6-411.

33 (2) In any civil or criminal action or proceeding arising out of acts alleged to have been  
34 committed by any person in violation of Code Section 40-6-412, if there was at that time  
35 or within three hours after driving or being in actual physical control of a moving vehicle  
36 from alcohol consumed before such driving or being in actual physical control ended an

1 alcohol concentration of 0.04 grams or more in the person's blood, breath, urine, or other  
2 bodily substance, the person shall be in violation of Code Section 40-6-412.

3 (3) In any civil or criminal action or proceeding arising out of acts alleged to have been  
4 committed by any person in violation of Code Section 40-6-413, if there was at that time  
5 or within three hours after driving or being in actual physical control of a moving vehicle  
6 from alcohol consumed before such driving or being in actual physical control ended an  
7 alcohol concentration of 0.02 grams or more in the person's blood, breath, urine, or other  
8 bodily substance, the person shall be in violation of Code Section 40-6-413.

9 (c) In any civil or criminal action or proceeding arising out of acts alleged to have been  
10 committed by any person in violation of Code Section 40-6-410, the refusal of the  
11 defendant to submit to a chemical analysis of his or her blood, breath, urine, or other bodily  
12 substance, or the failure to provide an adequate sample, shall be admissible in evidence  
13 against the person. The trier of fact, in its discretion, may infer from such refusal that any  
14 test given would have shown the presence of alcohol, drugs, or other prohibited substances.

15 40-6-418.

16 The fact that any person charged with violating any of the provisions of this part is or has  
17 been legally entitled to use alcohol, marijuana, or a drug shall not constitute a defense  
18 against any charge of violating this part.

19 40-6-419.

20 (a) Any conviction of or plea of nolo contendere to a violation of any local ordinance  
21 adopted pursuant to Article 14 of this chapter, which ordinance adopts the provisions of  
22 this part, shall be deemed to be a prior conviction under this part.

23 (b) Any conviction of or plea of nolo contendere to a violation of former Code Section  
24 40-6-391, or any local ordinance adopted pursuant to Article 14 of this chapter, which  
25 ordinance adopted the provisions of former Code Section 40-6-391, shall be deemed to be  
26 a prior conviction under this part.

27 (c) Any conviction of or plea of nolo contendere to a violation of any previously or  
28 currently existing law of this state or its political subdivisions or authorities; of the United  
29 States or its territories, dominions, and possessions; or of the several states or the political  
30 subdivisions of such states which, at the time such violation occurred, was the same or  
31 substantially conformed to the laws of this state shall be deemed to be a prior conviction  
32 under this part. For the purposes of this part, a conviction or plea of nolo contendere in a  
33 tribal court shall be deemed to be conviction by a court of the United States.

1 40-6-420.

2 (a) The decision to accept a plea of nolo contendere to a charge of violating the provisions  
3 of this part shall be at the sole discretion of the judge; but, if such plea is accepted, the  
4 penalties provided for in Code Section 40-6-414 shall be imposed; provided, however, that  
5 no such plea of nolo contendere shall be accepted if the person is charged with violating  
6 the provisions of Code Section 40-6-410, 40-6-411, 40-6-412, or 40-6-413 and had an  
7 alcohol concentration of more than 0.15 grams at any time within three hours after driving  
8 or being in control of any moving vehicle from alcohol consumed before such driving or  
9 being in control ended.

10 (b) If the defendant has not been convicted of or had a plea of nolo contendere accepted

16 accepted and setting forth the facts and special circumstances necessary to enable the  
17 judge to determine that accepting such plea is in the best interest of justice; and

18 (2) The judge has reviewed the defendant's driving records that are on file with the  
19 Department of Driver Services.

20 (c) The judge, as part of the record of the disposition of the charge, shall set forth, under  
21 seal of the court, his or her reasons for accepting the plea of nolo contendere.

22 (d) The record of the disposition of the case, including the ruling required in subsection (c)  
23 of this Code section, shall be forwarded to the Department of Driver Services within ten  
24 days after disposition.

25 (e) If a plea of nolo contendere is accepted under the conditions set forth in subsection (b)  
26 of this Code section, the defendant's driver's license shall be forwarded to the Department  
27 of Driver Services as provided in subsection (c) of Code Section 40-5-206.

28 40-6-421.

29 The provisions of Code Section 17-10-3, relating to general punishment for misdemeanors  
30 including traffic offenses, and the provisions of Article 3 of Chapter 8 of Title 42, relating  
31 to probation of first offenders, shall not apply to any person convicted or adjudicated of  
32 violating any provision of this article.

33 40-6-422.

34 (a) Notwithstanding the limits set forth in any municipal charter, any municipal court of  
35 any municipality shall be authorized to impose the punishments provided for in Code

1 Section 40-6-414 upon a conviction of violating Code Sections 40-6-410 through 40-6-413  
2 or upon a conviction of violating any ordinance adopting the provisions of this article.

3 (b) Any court authorized to hear cases involving violations of Code Sections 40-6-410  
4 through 40-6-413 shall be authorized to exercise the power to probate, suspend, or stay any  
5 sentence imposed. Such power shall, however, be limited to the conditions and limitations  
6 imposed by Code Section 40-6-414.

7 40-6-423.

8 (a) In addition to any other provisions of law, the clerk of the court in which a person is  
9 convicted a second or subsequent time of a violation of this article within five years, as  
10 measured from the dates of previous arrests for which convictions were obtained or pleas  
11 of nolo contendere were accepted to the date of the current arrest for which a conviction  
12 is obtained or a plea of nolo contendere is accepted, shall cause to be published a notice of  
13 conviction for each such person convicted. Such notices of conviction shall be published  
14 in the manner of legal notices in the legal organ of the county in which such person resides  
15 or, in the case of nonresidents, in the legal organ of the county in which the person was  
16 convicted. Such notice of conviction shall be one column wide by two inches long and

26 (c) The clerk of the court, the publisher of any legal organ which publishes a notice of  
27 conviction, and any other person involved in the publication of an erroneous notice of  
28 conviction shall be immune from civil or criminal liability for such erroneous publication,  
29 provided that such publication was made in good faith.

30 40-6-424.

31 Upon the trial of any civil or criminal action or proceeding arising out of acts alleged to  
32 have been committed by any person in violation of this part, evidence of the amount of  
33 alcohol or drug in a person's blood, urine, breath, or other bodily substance obtained in  
34 accordance with the provisions of this part shall be admissible.

1 40-6-425.

2 (a) Except as provided in this Code section, any motor vehicle operated by a person who  
3 has been declared a habitual violator for three violations of any of the provisions of this  
4 part and whose license has been revoked is declared to be contraband and subject to  
5 forfeiture to the state, as provided in this Code section.

6 (b) Any motor vehicle subject to forfeiture under subsection (a) of this Code section shall  
7 be seized upon determination by any peace officer or law enforcement agency of this state  
8 or any political subdivision thereof who has the power to make arrests and whose duty it  
9 is to enforce this part that said motor vehicle is contraband as provided in subsection (a)  
10 of this Code section. When a motor vehicle is seized pursuant to this Code section, the  
11 peace officer seizing the same shall report the fact of seizure, within 20 days thereof, to the  
12 district attorney of the judicial circuit having jurisdiction in the county where the seizure  
13 was made.

14 (c) In any action under this Code section, the court may enter such restraining orders or  
15 take other appropriate action, including acceptance of performance bonds, in connection  
16 with any interest in the motor vehicle that is subject to forfeiture.

17 (d) Within 60 days of the date of the seizure of a motor vehicle pursuant to this Code  
18 section, the district attorney shall initiate a forfeiture proceeding as provided in Code  
19 Section 16-13-49. If the state fails to initiate forfeiture proceedings against property seized  
20 for forfeiture by notice of pending forfeiture within the time limits specified in this  
21 subsection and subsection (b) of this Code section, the property must be released on the  
22 request of an owner or interest holder, pending further proceedings pursuant to this Code  
23 section, unless the property is being held as evidence.

24 (e) An owner or interest holder, as defined by subsection (a) of Code Section 16-13-49,  
25 may establish as a defense to the forfeiture of property which is subject to forfeiture under  
26 this Code section the applicable provisions of subsection (e) or (f) of Code Section  
27 16-13-49.

28 (f) Property which is forfeited pursuant to this Code section shall be disposed of as  
29 provided in Code Section 16-13-49.

30 (g) The proceeds arising from such sale shall be deposited into the general treasury of the  
31 state or any other governmental unit whose law enforcement agency it was that originally  
32 seized the motor vehicle. It is the intent of the General Assembly that, where possible,  
33 proceeds deposited into the state treasury should be used and that proceeds vested in any  
34 local governmental unit shall be applied to fund alcohol or drug treatment, rehabilitation,  
35 and prevention and education programs, after making the necessary expenditures for:

- 36 (1) Any cost incurred in the seizure;  
37 (2) The costs of the court and its officers; and

1 (3) Any costs incurred in the storage, advertisement, maintenance, or care of the motor  
2 vehicle.

3 (h) In any case where a motor vehicle which is the only family vehicle is determined to be

**SECTION 2-8.**

(3) Records of all accident reports and abstracts of court records of convictions of any offense listed in subsection (a) of Code Section 40-5-54, Code Section 40-6-10, driving on a suspended license in violation of Code Section 40-5-121, administrative license suspension pursuant to ~~Code Sections 40-5-67 through 40-5-67.2~~ Article 9 of this chapter, Code Section 40-5-75, Chapter 9 of this title, the 'Motor Vehicle Safety Responsibility Act,' and Chapter 34 of Title 33, the 'Georgia Motor Vehicle Accident Reparations Act,' any felony offense under this title, any offense committed while operating a commercial motor vehicle, serious traffic offenses, or other offenses requiring the assessment of points on the driving record that are received by it under the laws of this state and in connection therewith maintain convenient records or make suitable notations in order that an individual record of each licensee showing the convictions of such licensee and the traffic accidents in which such licensee has been involved shall be readily ascertainable and available for the consideration of the department upon any application for renewal of license and at other suitable times. For purposes of issuing a driver's operating record to the public as provided in this Code section, the period of calculation for compilation of such report shall be determined by the date of arrest."

"(c)(1) The driver's record provided by the department shall include an enumeration of any accidents in which the individual was convicted of a moving traffic violation, such moving traffic violation convictions, and information pertaining to financial

1 responsibility. The department shall furnish a driver's operating record or personal  
2 information from a driver's record under the following circumstances:

3 (A) With the written instructions and consent of the driver upon whom the operating  
4 record has been made and compiled;

5 (B)(i) Pursuant to a written request or a request made in accordance with a contract  
6 with the Georgia Technology Authority for immediate on-line electronic furnishing  
7 of information, for use by any insurer or insurance support organization, or by a

(a) As used in this Code section, 'habitual violator' means any person who has been arrested and convicted within the United States three or more times within a five-year period of time, as measured from the dates of previous arrests for which convictions were obtained to the date of the most recent arrest for which a conviction was obtained, of:

(1) Committing any offense covered under Code Section 40-5-54 or ~~Code Sections 40-6-391 through 40-6-395~~ Part 2 of Article 15 of Chapter 6 of this title or violating a federal law or regulation or the law of any state or a valid municipal or county ordinance substantially conforming to any offense covered under Code Section 40-5-54 or ~~Code Sections 40-6-391 through 40-6-395~~ Part 2 of Article 15 of Chapter 6 of this title; or

(2) Singularly or in combination, any of the offenses described in paragraph (1) of this subsection.

(b) When the records of the department disclose that any person has been arrested and convicted of a violation of Chapter 6 of this title, or of a valid local ordinance adopted pursuant thereto, of an offense occurring on or after January 1, 1976, which record of arrest and conviction, when taken with and added to previous arrests and convictions of such person as contained in the files of the department, reveals that such person is a habitual violator as defined in subsection (a) of this Code section, the department shall forthwith notify such person that upon the date of notification such person has been declared by the department to be a habitual violator, and that henceforth it shall be unlawful for such habitual violator to operate a motor vehicle in this state unless otherwise provided in this Code section. Notice shall be given by certified mail or statutory overnight delivery, with return receipt requested; or, in lieu thereof, notice may be given by personal service upon such person. In the event that at the time of determination the habitual violator had been issued a driver's license, such license shall be revoked by such notice and shall be surrendered to the department within ten days of notification of such determination. For the purposes of this chapter, notice given by certified mail or statutory overnight delivery with return receipt requested mailed to the person's last known address shall be prima-facie evidence that such person received the required notice. In addition to the procedure set forth in this subsection, the sentencing judge or prosecutor in a conviction which conviction classifies the defendant as a habitual violator may, at the time of sentencing, declare such defendant to be a habitual violator. The judge or prosecutor shall, when declaring a defendant to be a habitual violator, then give personal notice to such defendant on forms provided by the department that henceforth it shall be unlawful for such habitual

1 violator to operate a motor vehicle in this state unless otherwise provided in this Code  
2 section. The judge or prosecutor, as the case may be, shall within three days forward to the  
3 department the order declaring that the defendant is a habitual violator, the notice of

11 of Chapter 6 of Title 40 who is sentenced to probation or a suspended sentence by a  
12 municipal, magistrate, probate, recorder's, mayor's, state, or superior court shall also be  
13 required by the court to pay a one-time fee of \$25.00. The clerk of court, or if there is no  
14 clerk the person designated to collect fines, fees, and forfeitures for such court, shall  
15 collect such fee and remit the same not later than the last day of the month after such fee  
16 is collected to the Georgia Superior Court Clerks' Cooperative Authority for deposit into  
17 the general fund of the state treasury."

18 **SECTION 2-51.**

19 Said title is further amended by striking subsection (a) of Code Section 42-8-111, relating  
20 to court ordered installation of ignition interlock devices, and inserting in lieu thereof a new  
21 subsection (a) to read as follows:

22 "(a) In addition to any other provision of probation, upon a second or subsequent  
23 conviction of a resident of this state for violating ~~Code Section 40-6-391~~ Part 2 of Article  
24 15 of Chapter 6 of Title 40 within five years, as measured from the dates of previous arrests  
25 for which convictions were obtained to the date of the current arrest for which a conviction  
26 is obtained, for which such person is granted probation, the court shall order as conditions  
27 of probation that:

28 (1) Such person shall have installed and shall maintain in each motor vehicle registered  
29 in such person's name throughout the applicable six-month period prescribed by  
30 subsection (b) of Code Section 42-8-112 a functioning, certified ignition interlock device,  
31 unless the court exempts the person from the requirements of this paragraph based upon  
32 the court's determination that such requirements would subject the person to undue  
33 financial hardship; and

34 (2) Such person shall have installed and shall maintain in any other motor vehicle to be  
35 driven by such person during the applicable six-month period prescribed by

1 subsection (b) of Code Section 42-8-112 a functioning, certified ignition interlock device,  
 2 and such person shall not during such six-month period drive any motor vehicle  
 3 whatsoever that is not so equipped.

4 For the purposes of this subsection, a plea of nolo contendere shall constitute a conviction;  
 5 and a conviction of any offense under the law of another state or territory substantially  
 6 conforming to any offense under ~~Code Section 40-6-391~~ Part 2 of Article 15 of Chapter 6  
 7 of Title 40 shall be deemed a conviction of violating said ~~Code section part.~~"

#### 8 **SECTION 2-52.**

9 Said title is further amended by striking paragraphs (2) and (3) of subsection (b) of Code  
 10 Section 42-8-112, relating to proof of compliance required for reinstatement of certain  
 11 drivers' licenses and for obtaining probationary license, and inserting in lieu thereof new  
 12 paragraphs (2) and (3) to read as follows:

13 "(2) If the person subject to court ordered use of an ignition interlock device as a  
 14 condition of probation is authorized under Code Section 40-5-63 or ~~40-5-67.2~~ Article 9  
 15 of Chapter 5 of Title 40 to apply for reinstatement of his or her driver's license during the  
 16 period of suspension, such person shall, prior to applying for reinstatement of the license,  
 17 have an ignition interlock device installed and shall maintain such ignition interlock  
 18 device in a motor vehicle or vehicles to the extent required by subsection (a) of Code  
 19 Section 42-8-111 for a period of six months running concurrently with that of an ignition  
 20 interlock device limited driving permit, which permit shall not be issued until such person  
 21 submits to the department proof of completion of a DUI Alcohol or Drug Use Risk  
 22 Reduction Program, proof of having undergone any clinical evaluation and of having  
 23 enrolled in any substance abuse treatment program required by Code Section 40-5-63.1,  
 24 and proof of installation of an ignition interlock device on a vehicle or vehicles to the  
 25 extent required by subsection (a) of Code Section 42-8-111. Such a person may apply  
 26 for and be issued an ignition interlock device limited driving permit at the end of 12  
 27 months after the suspension of the driver's license. At the expiration of such six-month  
 28 ignition interlock device limited driving permit, the driver may, if otherwise qualified,  
 29 apply for reinstatement of a regular driver's license upon payment of the fee provided in  
 30 Code Section 40-5-25.

31 (3) If the person subject to court ordered use of an ignition interlock device as a  
 32 condition of probation is authorized under Code Section 40-5-58 or ~~under Code Section~~  
 33 ~~40-5-67.2~~ Article 9 of Chapter 5 of Title 40 to obtain a habitual violator's probationary  
 34 license, such person shall, if such person is a habitual violator as a result of two or more  
 35 convictions for driving under the influence of alcohol or drugs, have an ignition interlock  
 36 device installed and maintained in a motor vehicle or vehicles to the extent required by

1 subsection (a) of Code Section 42-8-111 for a period of six months following issuance  
2 of the probationary license, and such person shall not during such six-month period drive  
3 any motor vehicle that is not so equipped, all as conditions of such probationary license.  
4 Following expiration of such six-month period with no violation of the conditions of the  
5 probationary license, the person may apply for a habitual violator probationary license  
6 without such ignition interlock device condition."

7 **PART III**

8 **SECTION 3-1.**

9 (a) The passage of this Act shall not abate or affect any prosecution or administrative  
10 proceedings against any person for violations of the law as it existed immediately prior to the  
11 effective date of this Act. Such prosecutions and administrative proceedings shall continue  
12 to be governed by the provisions of law in effect immediately prior to the effective date of  
13 this Act.

14 (b) The passage of this Act shall not affect any suspensions, revocations, or other  
15 administrative sanctions regarding drivers' licenses and the ability to operate a motor vehicle  
16 in this state that were in existence immediately prior to the effective date of this Act. Such  
17 suspensions, revocations, and other administrative sanctions shall remain in full force and  
18 effect.

19 (c) The passage of this Act shall not affect any sentence imposed by any court upon any  
20 person for violations of the law as it existed immediately prior to the effective date of this  
21 Act. Such sentences shall remain in full force and effect.

22 **SECTION 3-2.**

23 This Act shall become effective on July 1, 2006, and shall apply to all violations committed  
24 on and after such date.

25 **SECTION 3-3.**

26 All laws and parts of laws in conflict with this Act are repealed.
