A BILL TO BE ENTITLED AN ACT

1 To amend Chapter 6 of Title 28 of the Official Code of Georgia Annotated, relating to 2 interstate cooperation, so as to change certain provisions relating to the membership of the 3 Georgia Commission on Interstate Cooperation; to define a certain term; to provide for 4 allowances; to change certain provisions relating to functions of the Georgia Commission on 5 Interstate Cooperation; to change certain provisions relating to a declaration that the Council of State Governments, Council of State Governments-Clairmont Road, L.L.C., and Southern 6 7 Legislative Conference are joint governmental agencies of this state; to provide that certain 8 organizations are joint governmental agencies of this state; to repeal conflicting laws; and 9 for other purposes.

10 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

SECTION 1.

12 Chapter 6 of Title 28 of the Official Code of Georgia Annotated, relating to interstate 13 cooperation, is amended by striking Code Section 28-6-2, relating to creation and 14 membership of the Georgia Commission on Interstate Cooperation, and inserting in lieu 15 thereof the following:

16 "28-6-2.

17 (a) There is established the Georgia Commission on Interstate Cooperation. The18 commission shall be composed of 15 regular members:

- 19 (1) The five members of the Senate Committee on Interstate Cooperation;
- 20 (2) The five members of the House Committee on Interstate Cooperation; and
- 21 (3) The five members of the Governor's Committee on Interstate Cooperation.
- (b) <u>The chairperson of the Senate Committee on Interstate Cooperation and the</u>
 <u>chairperson of the House Committee on Interstate Cooperation shall be cochairpersons of</u>
 <u>the commission.</u>
- <u>(c)</u> The Governor, the President of the Senate, and the Speaker of the House of
 Representatives shall be ex officio honorary nonvoting members of this commission. The

SECTION 2.

4 Said chapter is further amended by inserting following Code Section 28-6-1 a new Code
5 section to read as follows:

6 "28-6-1.1.

7 As used in this chapter, the term 'nonpartisan legislative organization' means an

8 organization whose membership is limited to legislators and which does not align itself

9 with and is not funded by a political party."

SECTION 3.

11 Said chapter is further amended by striking Code Section 28-6-3, relating to functions of the

12 Georgia Commission on Interstate Cooperation, and inserting in lieu thereof the following:

13 "28-6-3.

14 It shall be the function of the commission to:

(1) Carry forward the participation of this state as a member of the Council of State
 Governments and of the Southern Legislative Conference <u>any regional, national, or</u>
 <u>international nonpartisan legislative organization that promotes interstate or international</u>
 <u>cooperation;</u>

19 (2) Encourage and assist the legislative, executive, administrative, and judicial officials
20 and employees of this state to develop and maintain friendly contact by correspondence,

by conference, and otherwise with officials and employees of the other states, of the
federal government, and of local units of government;

- (3) Endeavor to advance cooperation between this state and other units of government
 whenever it seems advisable to do so by formulating proposals for and by facilitating:
- 25 (A) The adoption of compacts;
- 26 (B) The enactment of uniform or reciprocal statutes;
- 27 (C) The adoption of uniform or reciprocal administrative rules and regulations;
- 28 (D) The informal cooperation of governmental offices with one another;
- (E) The personal cooperation of governmental officials and employees with oneanother;
- 31 (F) The interchange and clearance of research and information; and
- 32 (G) Any other suitable process; and

(4) Do all such acts as will, in the opinion of the commission, enable this state to do its
 part or more in forming a more perfect union among the various governments in the

- 1 United States and in <u>promoting international relations by</u> developing the Council of State
- 2 Governments <u>nonpartisan legislative organizations</u> for that purpose <u>such purposes</u>."
- **SECTION 4.** 3 4 Said chapter is further amended by striking Code Section 28-6-7, relating to a declaration that the Council of State Governments, Council of State Governments-Clairmont Road, 5 L.L.C., and Southern Legislative Conference are joint governmental agencies of this state, 6 7 and inserting in lieu thereof the following: 8 "28-6-7. Any nonpartisan legislative organization in which this state is a participant pursuant to 9 paragraph (1) of Code Section 28-6-3 and which has its regional or national headquarters 10 located in this state is The Council of State Governments, the Council of State 11 12 Governments - Clairmont Road, L. L. C. (of which the Council of State Governments is 13 the sole member), and the Southern Legislative Conference are each declared to be a joint governmental agency of this state and of the other states which cooperate through them it." 14 15 **SECTION 5.**
- 16 All laws and parts of laws in conflict with this Act are repealed.
