- 1 Commending Dr. Scott R. Harden for his heroism; and for other purposes.
- 2 WHEREAS, on November 26, 2005, Dr. Scott R. Harden displayed the highest degree of
- 3 heroism in his valiant rescue of Ms. Katie Quarmby; and
- 4 WHEREAS, on that day, Dr. Harden, his wife, and two children took Ms. Quarmby, a
- 5 90-year-old family friend, from Buckhead to Cumming to visit Ms. Peggy Gough on the
- 6 occasion of Ms. Gough's 91st birthday; and
- 7 WHEREAS, after a delightful day together, the party decided to visit one of Ms. Gough's
- 8 neighbors, with Ms. Gough driving Ms. Quarmby in one vehicle and Dr. Harden and his
- 9 family following in another; at the end of her driveway, however, Ms. Gough became
- 10 disoriented and stepped on the accelerator, sending the car into Lake Lanier; and
- 11 WHEREAS, Dr. Harden immediately leaped out of his car to race to the ladies' rescue,
- 12 jumping into the dark, cold water after them; and
- 13 WHEREAS, encountering a locked car, Dr. Harden was able to get Ms. Gough to unlock the
- doors, after which he managed to grab Ms. Quarmby and pull her to safety; and
- 15 WHEREAS, sadly, neither Dr. Harden nor any other rescuers who arrived at the scene were
- able to rescue Ms. Gough, but Dr. Harden's quick action and remarkable bravery saved at
- 17 least one life in the midst of this tragic accident; and
- 18 WHEREAS, Dr. Harden's noble efforts on that fateful evening are a testament to the power
- 19 of heroism, and it is most fitting and proper that this body appropriately recognize the
- 20 life-saving actions of this outstanding Georgian.
