# A BILL TO BE ENTITLED AN ACT

1 To incorporate the City of Chattahoochee Hill Country in Fulton County; to provide for a 2 charter for the City of Chattahoochee Hill Country; to provide for incorporation, boundaries, 3 and powers of the city; to provide for general powers and limitations on powers; to provide 4 for a governing authority of such city and the powers, duties, authority, election, terms, 5 method of filling vacancies, compensation, expenses, qualifications, prohibitions, and districts relative to members of such governing authority; to provide for inquiries and 6 investigations; to provide for organization and procedures; to provide for ordinances; to 7 8 provide for the office of mayor and certain duties and powers relative to the office of mayor; 9 to provide for administrative responsibilities; to provide for boards, commissions, and 10 authorities; to provide for a city manager, a city attorney, a city clerk, a tax collector, a city 11 accountant, and other personnel; to provide for a municipal court and the judge or judges 12 thereof; to provide for practices and procedures; to provide for ethics and disclosures; to 13 provide for taxation, licenses, and fees; to provide for franchises, service charges, and 14 assessments; to provide for bonded and other indebtedness; to provide for accounting and 15 budgeting; to provide for purchases; to provide for homestead exemptions; to provide for 16 bonds for officials; to provide for other matters relative to the foregoing; to provide for 17 referenda; to provide effective dates and transitional provisions governing the transfer of various functions and responsibilities from Fulton County to the City of Chattahoochee Hill 18 19 Country; to provide for severability; to repeal conflicting laws; and for other purposes.

- 21 ARTICLE I
  22 CREATION, INCORPORATION, POWERS

#### **SECTION 1.01.**

# Incorporation.

This Act shall constitute the charter of the City of Chattahoochee Hill Country. The City of Chattahoochee Hill Country in the County of Fulton, and the inhabitants thereof, are constituted and declared a body politic and corporate under the same name and style of the "City of Chattahoochee Hill Country" and by that name shall have perpetual succession, may sue and be sued, plead and be impleaded, in all courts of law and equity, and in all actions whatsoever, and may have and use a common seal.

# SECTION 1.02.

10 Corporate boundaries.

The boundaries of the City of Chattahoochee Hill Country shall be as set forth and described in Appendix A of this Act, and said Appendix A is incorporated into and made a part of this Act. The city manager shall maintain a current map and written legal description of the corporate boundaries of the city, and such map and description shall incorporate any changes which may hereafter be made in such corporate boundaries.

# 16 SECTION 1.03.

17

Powers and construction.

(a) This city shall have all powers possible for a city to have under the present or future
Constitution and laws of this state as fully and completely as though they were specifically
enumerated in this Act. This city shall have all the powers of self-government not otherwise
prohibited by this Act or by general law.

(b) The powers of this city shall be construed liberally in favor of the city. The specific
mention or failure to mention particular powers shall not be construed as limiting in any way
the powers of this city. These powers shall include, but not be limited to, the following:

(1) Animal regulations. To regulate and license or to prohibit the keeping or running
at-large of animals and fowl, and to provide for the impoundment of same if in violation
of any ordinance or lawful order; to provide for the disposition by sale, gift, or humane
destruction of animals and fowl when not redeemed as provided by ordinance; and to
provide punishment for violation of ordinances enacted hereunder;

30 (2) Appropriations and expenditures. To make appropriations for the support of the
 31 government of the city; to authorize the expenditure of money for any purposes

authorized by this Act and for any purpose for which a municipality is authorized by the
 laws of the State of Georgia; and to provide for the payment of expenses of the city;

3 (3) Building regulation. To regulate and to license the erection and construction of
4 buildings and all other structures; to adopt building, housing, plumbing, electrical, gas,
5 and heating and air conditioning codes; and to regulate all housing and building trades
6 to the extent permitted by general law;

(4) Business regulation and taxation. To levy and to provide for the collection of
regulatory fees and taxes on privileges, occupations, trades, and professions as authorized
by Title 48 of the O.C.G.A. or other such applicable laws as are or may hereafter be
enacted; to permit and regulate the same; to provide for the manner and method of
payment of such regulatory fees and taxes; and to revoke such permits after due process
for failure to pay any city taxes or fees;

(5) Condemnation. To condemn property, inside or outside the corporate limits of the
city, for present or future use and for any corporate purpose deemed necessary by the city
council, utilizing procedures enumerated in Title 22 of the O.C.G.A., or such other
applicable laws as are or may hereafter be enacted;

17 (6) Contracts. To enter into contracts and agreements with other governmental entities18 and with private persons, firms, and corporations;

(7) Emergencies. To establish procedures for determining and proclaiming that an
emergency situation exists within or outside the city, and to make and carry out all
reasonable provisions deemed necessary to deal with or meet such an emergency for the
protection, safety, health, or well-being of the citizens of the city;

(8) Environmental protection. To protect and preserve the natural resources,
environment, and vital areas of the city, the region, and the state through the preservation
and improvement of air quality, the restoration and maintenance of water resources, the
control of erosion and sedimentation, the management of storm water and establishment
of a storm-water utility, the management of solid and hazardous waste, and other
necessary actions for the protection of the environment;

(9) Ethics. To adopt ethics ordinances and regulations governing the conduct of
municipal elected officials, appointed officials, and employees, establishing procedures
for ethics complaints and setting forth penalties for violations of such rules and
procedures;

(10) Fire regulations. To fix and establish fire limits and from time to time to extend,
enlarge, or restrict the same; to prescribe fire safety regulations not inconsistent with
general law, relating to both fire prevention and detection and to fire fighting; and to
prescribe penalties and punishment for violations thereof;

1 (11) Garbage fees. To levy, fix, assess, and collect a garbage, refuse, and trash collection 2 and disposal and other sanitary service charge, tax, or fee for such services as may be 3 necessary in the operation of the city from all individuals, firms, and corporations 4 residing in or doing business therein benefiting from such services; to enforce the 5 payment of such charges, taxes, or fees; and to provide for the manner and method of 6 collecting such service charges;

7 (12) General health, safety, and welfare. To define, regulate, and prohibit any act,
8 practice, conduct, or use of property which is detrimental to health, sanitation,
9 cleanliness, welfare, and safety of the inhabitants of the city, and to provide for the
10 enforcement of such standards;

(13) Gifts. To accept or refuse gifts, donations, bequests, or grants from any source for
any purpose related to powers and duties of the city and the general welfare of its
citizens, on such terms and conditions as the donor or grantor may impose;

(14) Health and sanitation. To prescribe standards of health and sanitation and to providefor the enforcement of such standards;

- (15) Jail sentences. To provide that persons given jail sentences in the city's court may
  work out such sentences in any public works or on the streets, roads, drains, and other
  public property in the city; to provide for commitment of such persons to any jail; to
  provide for the use of pretrial diversion and any alternative sentencing allowed by law;
  or to provide for commitment of such persons to any county work camp or county jail by
  agreement with the appropriate county officials;
- (16) Motor vehicles. To regulate the operation of motor vehicles and exercise control
  over all traffic, including parking upon or across the streets, roads, alleys, and walkways
  of the city;
- (17) Municipal agencies and delegation of power. To create, alter, or abolish
  departments, boards, offices, commissions, and agencies of the city, and to confer upon
  such agencies the necessary and appropriate authority for carrying out all the powers
  conferred upon or delegated to the same;
- (18) Municipal debts. To appropriate and borrow money for the payment of debts of the
  city and to issue bonds for the purpose of raising revenue to carry out any project,
  program, or venture authorized by this Act or the laws of the State of Georgia;
- 32 (19) Municipal property ownership. To acquire, dispose of, lease, and hold in trust or
  33 otherwise any real, personal, or mixed property, in fee simple or lesser interest, inside or
  34 outside the property limits of the city;
- (20) Municipal property protection. To provide for the preservation and protection of
   property and equipment of the city and the administration and use of same by the public;
   and to prescribe penalties and punishment for violations thereof;

(21) Municipal utilities. To acquire, lease, construct, operate, maintain, sell, and dispose
of public utilities, including but not limited to a system of waterworks, sewers and drains,
sewage disposal, storm-water management, gas works, electric light plants, cable
television and other telecommunications, transportation facilities, public airports, and any
other public utility; to fix the taxes, charges, rates, fares, fees, assessments, regulations,
and penalties; and to provide for the withdrawal of service for refusal or failure to pay the
same;

8 (22) Nuisance. To define a nuisance and provide for its abatement whether on public or
9 private property;

(23) Penalties. To provide penalties for violation of any ordinances adopted pursuant to
the authority of this Act and the laws of the State of Georgia;

(24) Planning and zoning. To provide comprehensive city planning for development by
zoning; and to provide subdivision regulation and the like as the city council deems
necessary and reasonable to ensure a safe, healthy, and esthetically pleasing community;
(25) Police and fire protection. To exercise the power of arrest through duly appointed
police officers; and to establish, operate, or contract for a police and a fire-fighting
agency;

- (26) Public hazards: removal. To provide for the destruction and removal of any building
  or other structure which is or may become dangerous or detrimental to the public;
- 20 (27) Public improvements. To provide for the acquisition, construction, building, 21 operation, and maintenance of public ways, parks and playgrounds, recreational facilities, 22 cemeteries, public buildings, libraries, public housing, parking facilities, or charitable, 23 cultural, educational, recreational, conservation, sport, detentional, penal, and medical institutions, agencies, and facilities; and to provide any other public improvements inside 24 25 or outside the corporate limits of the city and to regulate the use of public improvements; 26 and for such purposes, property may be acquired by condemnation under Title 22 of the O.C.G.A., or such other applicable laws as are or may hereafter be enacted; 27
- (28) Public peace. To provide for the prevention and punishment of loitering, disorderly
   conduct, drunkenness, riots, and public disturbances;

30 (29) Public transportation. To organize and operate such public transportation systems
31 as are deemed beneficial;

(30) Public utilities and services. To grant franchises or make contracts for, or impose
taxes on, public utilities and public service companies; and to prescribe the rates, fares,
regulations, and standards and conditions of service applicable to the service to be
provided by the franchise grantee or contractor, insofar as not in conflict with valid
regulations of the Public Service Commission;

(31) Regulation of roadside areas. To prohibit or regulate and control the erection,
removal, and maintenance of signs, billboards, trees, shrubs, fences, buildings, and any
and all other structures or obstructions upon or adjacent to the rights of way of streets and
roads or within view thereof, within or abutting the corporate limits of the city; and to
prescribe penalties and punishment for violation of such ordinances;

6 (32) Retirement. To provide and maintain a retirement plan for officers and employees7 of the city;

8 (33) Roadways. To lay out, open, extend, widen, narrow, establish or change the grade 9 of, abandon or close, construct, pave, curb, gutter, adorn with shade trees, or otherwise 10 improve, maintain, repair, clean, prevent erosion of, and light the roads, alleys, and 11 walkways within the corporate limits of the city; to grant franchises and rights of way 12 throughout the streets and roads and over the bridges and viaducts for the use of public 13 utilities; and to require real estate owners to repair and maintain in a safe condition the 14 sidewalks adjoining their lots or lands and to impose penalties for failure to do so;

(34) Sewer fees. To levy a fee, charge, or sewer tax as necessary to assure the acquiring, constructing, equipping, operating, maintaining, and extending of a sewage disposal plant and sewerage system, and to levy on those to whom sewers and sewerage systems are made available a sewer service fee, charge, or sewer tax for the availability or use of the sewers; to provide for the manner and method of collecting such service charges and for enforcing payment of the same; and to charge, impose, and collect a sewer connection fee or fees to those connected with the system;

(35) Solid waste disposal. To provide for the collection and disposal of garbage, rubbish,
and refuse and to regulate the collection and disposal of garbage, rubbish, and refuse by
others; and to provide for the separate collection of glass, tin, aluminum, cardboard,
paper, and other recyclable materials and to provide for the sale of such items;

26 (36) Special assessments. To levy and provide for the collection of special assessments
 27 to cover the costs for any public improvements;

(37) Taxes: ad valorem. To levy and provide for the assessment, valuation, revaluation,
and collection of taxes on all property subject to taxation;

30 (38) Taxes: other. To levy and collect such other taxes as may be allowed now or in the
31 future by law;

- 32 (39) Taxicabs. To regulate and license vehicles operated for hire in the city; to limit the
  33 number of such vehicles; to require the operators thereof to be licensed; to require public
  34 liability insurance on such vehicles in the amounts to be prescribed by ordinance; and to
  35 regulate the parking of such vehicles;
- 36 (40) Urban redevelopment. To organize and operate an urban redevelopment program;37 and

1 (41) Other powers. To exercise and enjoy all other powers, functions, rights, privileges, 2 and immunities necessary or desirable to promote or protect the safety, health, peace, 3 security, good order, comfort, convenience, or general welfare of the city and its inhabitants; to exercise all implied powers necessary or desirable to carry into execution 4 5 all powers granted in this Act as fully and completely as if such powers were fully stated 6 herein; and to exercise all powers now or in the future authorized to be exercised by other 7 municipal governments under other laws of the State of Georgia; and any listing of particular powers in this Act shall not be held to be exclusive of others or restrictive of 8 9 general words and phrases granting powers, but shall be held to be in addition to such powers unless expressly prohibited to municipalities under the Constitution or applicable 10 laws of the State of Georgia. 11

## **SECTION 1.04.**

13 Exercise of powers.

All powers, functions, rights, privileges, and immunities of the city, its officers, agencies, or 14 employees shall be carried into execution as provided by this Act. If this Act makes no 15 16 provision, such shall be carried into execution as provided by ordinance or as provided by 17 pertinent laws of the State of Georgia.

18	ARTICLE II
19	GOVERNMENT STRUCTURE, ELECTIONS,
20	AND LEGISLATIVE BRANCH
21	<b>SECTION 2.01.</b>
22	City council creation; number; election.
23	(a) The legislative authority of the government of Chattahoochee Hill Country, except as
24	otherwise specifically provided in this Act, shall be vested in a city council to be composed

25 of a mayor and five councilmembers.

(b) The mayor shall be elected by a majority vote of the qualified electors of the city at large 26

27 voting at the elections of the city.

(c) Each councilmember shall be elected by a majority vote of the qualified electors of his 28 or her respective council district voting at the elections of the city. For the purpose of 29 electing the five councilmembers, there shall be five council districts, designated Council 30 31 Districts 1 through 5, as described in Appendix B of this Act and the accompanying 32 Redistricting Plan Components Report, which are attached to and made a part of the Act of 1 the City of Chattahoochee Hill Country. Each person desiring to offer as a candidate for

2 councilmember shall designate the council district for which he or she is offering.

# SECTION 2.02.

Mayor and city councilmembers; election, terms, and qualifications for office.

(a) Except as otherwise provided in subsection (c) of this section, the mayor and members 6 7 of the city council shall serve for terms of four years and until their respective successors are 8 elected and qualified. No person shall be eligible to serve as mayor or councilmember unless that person shall have been a resident of the area comprising the corporate limits of the City 9 10 of Chattahoochee Hill Country for a continuous period of at least 12 months immediately 11 prior to the date of the election for mayor or councilmember, shall continue to reside therein during that person's period of service, and shall continue to be registered and qualified to 12 13 vote in municipal elections of the City of Chattahoochee Hill Country. In addition to the above requirements, no person shall be eligible to serve as a councilmember representing a 14 council district unless that person has been a resident of the district such person seeks to 15 represent for a continuous period of at least six months immediately prior to the date of the 16 17 election for councilmember and continues to reside in such district during that person's 18 period of service.

(b) The first general municipal elections shall be held on the next special election date permissible pursuant to the provisions of Code Section 21-2-540 of the O.C.G.A. following the date of the approval of this Act as provided for by Section 6.01 of this Act. Thereafter, general municipal elections shall be held on the Tuesday next following the first Monday in November in the odd-numbered year following by more than two years the year in which said first municipal election is held, and quadrennially thereafter.

(c) The first mayor and the initial councilmembers shall take office on the first day of the 25 26 first month immediately following the first municipal election provided for in subsection (b) of this section and shall serve for terms which expire when their successors take office in 27 January of the first year immediately following the second municipal election provided for 28 therein. Thereafter the mayor and councilmembers shall take office as provided in Code 29 30 Section 21-2-541.1 of the O.C.G.A. and serve for terms of four years. The initial members 31 and future members of the governing authority shall serve until their successors are elected 32 and qualified.

1	SECTION 2.03.
2	Vacancy; filling of vacancies; suspensions.
3	The office of mayor or councilmember shall become vacant upon the incumbent's death,
4	resignation, forfeiture of office, or removal from office in any manner authorized by this Act
5	or the general laws of the State of Georgia. A vacancy in the office of mayor or
6	councilmember shall be filled for the remainder of the unexpired term by a special election
7	if such vacancy occurs 12 months or more prior to the expiration of the term of that office.
8	If such vacancy occurs within 12 months of the expiration of the term of that office, the city
9	council or those members remaining shall appoint a successor for the remainder of the term.
10	This provision shall also apply to a temporary vacancy created by the suspension from office
11	of the mayor or any councilmember.
12	SECTION 2.04.
13	Nonpartisan elections.
14	Political parties shall not conduct primaries for city offices and all names of candidates for
15	city offices shall be listed without party designation.
16	
16	SECTION 2.05.
17	Election by majority vote.
18	The candidates for mayor and councilmember who receive a majority of the votes cast in the
19	applicable election shall be elected to a term of office. In the event no candidate receives a
20	majority of the votes cast in said election, a run-off election shall be held between the two
21	candidates receiving the highest number of votes. Such runoff shall be held at the time
22	specified by state election law, unless such run-off date is postponed by court order.
23	SECTION 2.06.
24	Applicability of general laws; qualifying; other provisions.
25	All primaries and elections shall be held and conducted in accordance with Chapter 2 of Title
26	21 of the O.C.G.A., the "Georgia Election Code," as now or hereafter amended. Except as
27	otherwise provided by this Act, the city council shall, by ordinance or resolution, prescribe
28	such rules and regulations as it deems appropriate, including but not limited to the
29	establishment of qualifying fees, to fulfill any options and duties under Chapter 2 of Title 21
30	of the O.C.G.A., the "Georgia Election Code," as now or hereafter amended.

# **SECTION 2.07.**

#### Compensation and expenses.

The annual salary of the mayor shall be \$16,500.00 and the annual salary for each councilmember shall be \$12,500.00. Such salary shall be paid from municipal funds in monthly installments. The city council may provide by ordinance for the provision of insurance, retirement, workers' compensation, and other employee benefits to the mayor and members of the city council and may provide by ordinance for the reimbursement of expenses actually and necessarily incurred by the mayor and members of the city council in carrying out their official duties.

# 10 SECTION 2.08.

11 Inquiries and investigations.

The city council may make inquiries and investigations into the affairs of the city and conduct of any department, office, or agency thereof and for this purpose may subpoena witnesses, administer oaths, take testimony, and require the production of evidence. Any person who fails or refuses to obey a lawful order issued in the exercise of these powers by the city council shall be punished as may be provided by ordinance.

# SECTION 2.09.

Meetings and mayor pro tempore.

(a) The city council shall meet on the first working day in January immediately following
each regular municipal election. The meeting shall be called to order by the mayor-elect and
the oath of office shall be administered to the newly elected mayor and councilmembers by
a judicial officer authorized to administer oaths. The oath shall, to the extent that it comports
with federal and state law, be as follows:
"I do solemnly swear or affirm that I will faithfully execute the office of [councilmember
or mayor as the case may be] of the City of Chattahoochee Hill Country, and will to the

best of my ability support and defend the Constitution of the United States, the Constitution
of Georgia, and the Act, ordinances, and regulations of the City of Chattahoochee Hill
Country. I am not the holder of any unaccounted for public money due this state or any
political subdivision or authority thereof. I am not the holder of any office of trust under
the government of the United States, any other state, or any foreign state which I by the
laws of the State of Georgia am prohibited from holding. I am otherwise qualified to hold
said office according to the Constitution and laws of Georgia. I have been a resident of my

district and the City of Chattahoochee Hill Country for the time required by the
Constitution and laws of this state and by the municipal Act. I will perform the duties of
my office in the best interest of the City of Chattahoochee Hill Country to the best of my
ability without fear, favor, affection, reward, or expectation thereof."

5 (b) Following the induction of the mayor and councilmembers, the city council, by a majority vote of the councilmembers, shall elect a councilmember to be mayor pro tempore, 6 7 who shall serve for a term of four years and until a successor is elected and qualified. The mayor pro tempore shall assume the duties and powers of the mayor during the mayor's 8 9 disability or absence, except that the mayor pro tempore shall continue to vote as a 10 councilmember and may not exercise the mayor's prerogative to vote in the case of a tie. 11 During the mayor's disability or absence, the mayor pro tempore may veto any action of the 12 city council. If the mayor pro tempore is absent because of sickness or disqualification, any 13 one of the remaining councilmembers, chosen by the members present, shall be clothed with 14 all the rights and privileges of the mayor and shall perform the mayor's duties in the same 15 manner as the mayor pro tempore.

(c) The city council shall, at least once a month, hold regular meetings at such times and
places as prescribed by ordinance. The council may recess any regular meeting and continue
such meeting on any weekday or hour it may fix and may transact any business at such
continued meeting as may be transacted at any regular meeting.

20 (d) Special meetings of the council may be held on the call of the mayor or three members 21 of the council. Notice of such special meetings shall be delivered to all members of the 22 council and the mayor personally, by registered mail, or by electronic means, at least 24 23 hours in advance of the meeting. Such notice to councilmembers shall not be required if the 24 mayor and all councilmembers are present when the special meeting is called. Such notice 25 of any special meeting may be waived by the mayor or a councilmember in writing before 26 or after such a meeting and attendance at the meeting shall also constitute a waiver of notice. The notice of such special meeting shall state what business is to be transacted at the special 27 28 meeting. Only the business stated in the call may be transacted at the special meeting.

#### **SECTION 2.10.**

30

) Quorum; voting.

Three councilmembers shall constitute a quorum and shall be authorized to transact business for the council. Voting on the adoption of ordinances shall be taken by voice vote and the yeas and nays shall be recorded in the minutes, but on the request of any member there shall be a roll-call vote. In order for any ordinance, resolution, motion, or other action of the council to be adopted, the measure must receive at least two affirmative votes and must

1 receive the affirmative votes of a majority of those voting. No member of the city council shall abstain from voting on any matter properly brought before the council for official action 2 3 except when such member of council has a conflict of interest which is disclosed in writing 4 prior to or at the meeting and made a part of the minutes. Any member of the city council 5 present and eligible to vote on a matter and refusing to do so for any reason other than a properly disclosed and recorded conflict of interest shall be deemed to have acquiesced or 6 7 concurred with the members of the majority who did vote on the question involved. The mayor shall vote only in the case of a tie or in the case where his or her vote will provide the 8 9 affirmative vote required for approval of a matter.

# SECTION 2.11.

11

General power and authority of the council.

(a) Except as otherwise provided by law or by this Act, the council shall be vested with allthe powers of government of the City of Chattahoochee Hill Country as provided by Article

14 I of this Act.

(b) In addition to all other powers conferred upon it by law, the council shall have the 15 16 authority to adopt and provide for the execution of such ordinances, resolutions, rules, and 17 regulations, not inconsistent with this Act and the Constitution and the laws of the State of Georgia, which it shall deem necessary, expedient, or helpful for the peace, good order, 18 19 protection of life and property, health, welfare, sanitation, comfort, convenience, prosperity, 20 or well-being of the inhabitants of the City of Chattahoochee Hill Country and may enforce 21 such ordinances by imposing penalties for violation thereof. 22 (c) The city council may, by ordinance or resolution, adopt rules and bylaws to govern the 23 conduct of its business, including procedures and penalties for compelling the attendance of

24 absent members. Such rules may include punishment for contemptuous behavior conducted

25 in the presence of the city council.

# SECTION 2.12.

Administrative and service departments.

The council, by ordinance, may establish, abolish, merge, or consolidate offices, positions of employment, departments, and agencies of the city as it shall deem necessary for the proper administration of the affairs and government of the city; provided, however, that the office of city manager may be abolished only upon an affirmative vote of four of the five members of the council. The council shall prescribe the functions and duties of existing departments, offices, and agencies or of any departments, offices, and agencies hereinafter 1 created or established; may provide that the same person shall fill any number of offices and

2 positions of employment; and may transfer or change the functions and duties of offices,

3 positions of employment, departments, and agencies of the city.

4 (b) The operations and responsibilities of each department now or hereafter established in
5 the city shall be distributed among such divisions or bureaus as may be provided by
6 ordinance of the council. Each department shall consist of such officers, employees, and

# ARTICLE IV MUNICIPAL COURT

#### SECTION 4.01.

Creation.

7 There is established a court to be known as the Municipal Court of the City of Chattahoochee Hill Country which shall have jurisdiction and authority to try offenses against the laws and 8 9 ordinances of said city and to punish for a violation of the same. Such court shall have the 10 power to enforce its judgments by the imposition of such penalties as may be provided by law, including ordinances of the city; to punish witnesses for nonattendance and to punish 11 12 also any person who may counsel or advise, aid, encourage, or persuade another whose 13 testimony is desired or material in any proceeding before said court to go or move beyond the reach of the process of the court; to try all offenses within the territorial limits of the city 14 15 constituting traffic cases which, under the laws of Georgia, are placed within the jurisdiction 16 of municipal courts to the extent of, and in accordance with, the provisions of such laws and all laws subsequently enacted amendatory thereof. Said court shall be presided over by the 17 18 judge of said court. In the absence or disqualification of the judge, the judge pro tempore 19 shall preside and shall exercise the same powers and duties as the judge when so acting.

#### SECTION 4.02.

Judge.

(a) No person shall be qualified or eligible to serve as judge unless he or she shall have
attained the age of 21 years and shall have been a member of the State Bar of Georgia for a
minimum of three years. The judge shall be appointed by resolution of the council. The
compensation of the judge shall be fixed by the council. The position of judge created in this
article shall not be a full-time position, and the person serving in said position may engage
in the private practice of law.

The superintendent shall issue 11 12 the call for such election at least 30 days prior to the date thereof. All persons desiring to vote for approval of the Act shall vote "Yes," and those persons 18 desiring to vote for rejection of the Act shall vote "No." If more than one-half of the votes 19 20 cast on such question are for approval of the Act, it shall become of full force and effect as 21 provided in Section 6.02 of this Act; otherwise this Act shall not take effect and a second 22 referendum shall be called and held in like manner on the Tuesday next following the first 23 Monday in November, 2007. If more than one-half of the votes cast on such question are for 24 approval of this Act, it shall become of full force and effect; otherwise it shall be void and 25 of no force and effect. The initial expense of such election shall be borne by Fulton County. 26 Within two years after the election if the incorporation is approved, the City of 27 Chattahoochee Hill Country shall reimburse Fulton County for the actual cost of printing and 28 personnel services for such election and for the initial election of the mayor and members of 29 the city council pursuant to subsection (b) of Section 2.02 of this Act. It shall be the duty of the superintendent to hold and conduct such election. It shall be his or her further duty to 30 31 certify the result thereof to the Secretary of State.

(b) For the purposes of the referendum election provided for in this section and for the purposes of the election to be held on the next special election date thereafter permissible pursuant to the provisions of Code Section 21-2-540 of the O.C.G.A., the qualified electors of the City of Chattahoochee Hill Country shall be those qualified electors of Fulton County residing within the corporate limits of the City of Chattahoochee Hill Country as described by Appendix A of this Act. At subsequent municipal elections, the qualified electors of the 1 City of Chattahoochee Hill Country shall be determined pursuant to the authority of Chapter

2 2 of Title 21 of the O.C.G.A., the "Georgia Election Code."

- 3 (c) Only for the purposes of holding and conducting the referendum election provided for
- 4 by this section and holding and conducting the election of the City of Chattahoochee Hill

5 Country to be held on the next special election date thereafter permissible pursuant to the

6 provisions of Code Section 21-2-540 of the O.C.G.A., the election superintendent of Fulton

7 County is vested with the powers and duties of the election superintendent of the City of

- 8 Chattahoochee Hill Country and the powers and duties of the governing authority of the City
- 9 of Chattahoochee Hill Country.

# SECTION 6.02.

Effective dates.

(a) This Act shall become effective upon its approval by the Governor or upon its becoming
law without such approval. The provisions of this Act necessary for the election to be held
on the next special election date permissible pursuant to the provisions of Code Section
21-2-540 of the O.C.G.A. following the date of the approval of this Act as provided for by
Section 6.01 of this Act shall be effective upon the certification of the results of such
referendum election.

(b) A period of time will be needed for an orderly transition of various government functions 18 19 from Fulton County to the City of Chattahoochee Hill Country. Accordingly, if this Act is 20 approved at the referendum election provided for by Section 6.01 of this Act, there shall be 21 a transition period beginning the first day of the first month immediately following the 22 special election to be held on the next special election date permissible pursuant to the 23 provisions of Code Section 21-2-540 of the O.C.G.A. following the date of such approval, 24 and ending at midnight of the last day of the seventeenth month following said first month after said special election. During such transition period, all provisions of this Act shall be 25 effective as law, but not all provisions of this Act shall be implemented. 26

27 (c) During such transition period, Fulton County shall continue to provide within the territorial limits of Chattahoochee Hill Country all government services and functions which 28 Fulton County provided in that area as of the date of enactment of this Act, except to the 29 30 extent otherwise provided in this section; provided, however, that by agreement of Fulton County and the City of Chattahoochee Hill Country responsibility for any such service or 31 function may be transferred to the City of Chattahoochee Hill Country at such time as may 32 33 be agreed upon by the parties. If this Act is approved as provided for by Section 6.01 of this Act, effective the first day of the first month immediately following the election to be held 34 on the next special election date permissible pursuant to the provisions of Code Section 35

21-2-540 of the O.C.G.A. following the date of such approval, the City of Chattahoochee 1 2 Hill Country shall collect taxes, fees, assessments, fines and forfeitures, and other moneys 3 within the territorial limits of Chattahoochee Hill Country. Where a particular tax, fee, 4 assessment, fine, forfeiture, or other amount collected is specifically related to the provision of a particular government service or function by Fulton County, the service or function shall 5 continue to be provided by the county contingent upon payment by the city of the actual cost 6 7 of providing such service or function unless otherwise provided in a written agreement between the city and the county. Any existing contract for the performance of a 8 9 governmental service with a private person residing or doing business within the city limits shall not be altered or adversely affected by the establishment of this Act of the City of 10 11 Chattahoochee Hill Country. 12 (d) During the transition period, the governing authority of the City of Chattahoochee Hill 13 Country: (1) Shall hold regular meetings and may hold special meetings as provided in this Act; 14 15 (2) May enact ordinances and resolutions as provided in this Act; (3) May amend this Act by home rule action as provided by general law; 16 (4) May accept gifts and grants; 17 18 (5) May borrow money and incur indebtedness to the extent authorized by this Act and 19 general law; (6) May levy and collect an ad valorem tax for the calendar year next following the first 20 21 municipal election; 22 (7) May establish a fiscal year and budget; 23 (8) May create, alter, or abolish departments, boards, offices, commissions, and agencies of the city; appoint and remove officers and employees; and exercise all necessary or 24 25 appropriate personnel and management functions; and 26 (9) May generally exercise any power granted by this Act or general law, except to the extent that a power is specifically and integrally related to the provision of a 27 governmental service, function, or responsibility not yet provided or carried out by the 28 29 city. (e) During the transition period, the Municipal Court of Chattahoochee Hill Country shall 30 exercise its jurisdiction to the extent appropriate with respect to the government services and 31 functions performed by the City of Chattahoochee Hill Country and the appropriate court or 32 courts of Fulton County shall retain jurisdiction over the area incorporated as the City of 33 Chattahoochee Hill Country with respect to government services and functions performed 34 by Fulton County. Any transfer of jurisdiction to the City of Chattahoochee Hill Country at 35 the beginning of, during, at the end of, or after the transition period shall not in and of itself 36

1 abate any judicial proceeding pending in Fulton County or the pending prosecution of any 2 violation of any ordinance of Fulton County. 3 (f) During the transition period, the governing authority of Chattahoochee Hill Country may 4 at any time, without the necessity of any agreement by Fulton County, commence to exercise 5 its planning and zoning powers; provided, however, that the city shall give the county at least 30 days' written notice of the date on which the city will assume the exercise of such powers. 6 7 Upon the governing authority of Chattahoochee Hill Country commencing to exercise its planning and zoning powers, the Municipal Court of Chattahoochee Hill Country shall 8 9 immediately have jurisdiction to enforce the planning and zoning ordinances of the city. The provisions of this subsection shall control over any conflicting provisions of any other 10 11 subsection of this section. 12 (g) Effective upon the termination of the transition period, subsections (c) through (f) of this 13 section shall cease to apply except for the last sentence of subsection (e) which shall remain 14 effective. Effective upon the termination of the transition period, the City of Chattahoochee

15 Hill Country shall be a fully functioning municipal corporation and subject to all general

16 laws of this state.

20 otherwise, are intended as mere catchwords to indicate the contents of the section, and:

(1) Shall not be deemed or taken to be titles of such sections or as any part of the section;and

(2) Shall not be so deemed when any of such sections, including the catchlines, are
amended or reenacted unless expressly provided to the contrary.

Furthermore, the article and section headings contained in this Act shall not be deemed to govern, limit, or modify or in any manner affect the scope, meaning, or intent of the provisions of any article or section hereof.

# **SECTION 6.04.**

Directory nature of dates.

30 It is the intention of the General Assembly that this Act be construed as directory rather than 31 mandatory with respect to any date prescribed in this Act. If it is necessary to delay any 32 action called for in this Act for providential cause, delay in securing approval under the 33 federal Voting Rights Act, or any other reason, it is the intention of the General Assembly 1 that the action be delayed rather than abandoned. Any delay in performing any action under

2 this Act, whether for cause or otherwise, shall not operate to frustrate the overall intent of this

3 Act. Without limiting the generality of the foregoing, it is specifically provided that:

4 (1) If it is not possible to hold the referendum election provided for in Section 6.01 of
5 this Act on either date specified in that section, then such referendum shall be held as
6 soon after such date as is reasonably practicable; and

7 (2) If it is not possible to hold the first regular municipal election provided for in Section
8 2.02 of this Act on the date specified in that section, then there shall be a special election

for the initial members of the governing authority to be held as soon thereafter as is
reasonably practicable, and the commencement of the initial terms of office shall be

11 delayed accordingly.

# SECTION 6.05.

# Severability.

In the event any section, subsection, sentence, clause, or phrase of this Act shall be declared or adjudged invalid or unconstitutional, such adjudication shall in no manner affect the other sections, subsections, sentences, clauses, or phrases of this Act, which shall remain of full force and effect, as if the section, subsection, sentence, clause, or phrase so declared or adjudged invalid or unconstitutional were not originally a part hereof. The General Assembly hereby declares that it would have passed the remaining parts of this Act if it had known that such part or parts hereof would be declared or adjudged invalid or unconstitutional.

The separate 8 numeric designations in a Tract description which are underneath a "BG" heading shall mean 9 and describe individual Blocks within a Block Group as provided in the report of the Bureau of the Census for the United States decennial census of 2000 for the State of Georgia. Any 10 part of the City of Chattahoochee Hill Country which is not included in any such district 11 12 described in that attachment shall be included within that district contiguous to such part which contains the least population according to the United States decennial census of 2000 13 14 for the State of Georgia. Any part of the City of Chattahoochee Hill Country which is described in that attachment as being in a particular district shall nevertheless not be included 15 within such district if such part is not contiguous to such district. Such noncontiguous part 16 17 shall instead be included with that district contiguous to such part which contains the least 18 population according to the United States decennial census of 2000 for the State of Georgia.
