- 1 Commending City of McDonough mayor, Richard Craig; and for other purposes.
- 2 WHEREAS, Richard Craig served the City of McDonough with honor and distinction as
- 3 mayor for 8 years and expertly guided his community through a multitude of challenges, as
- 4 recognized in his being the first mayor to receive the Georgia Municipal Association's
- 5 Award of Excellence; and
- 6 WHEREAS, a native of McDonough, Mayor Craig has presided over the city's enormous
- 7 growth and its transition from a sleepy rural village just south of Atlanta to its present
- 8 position as a desired commercial and residential destination, growing in population from
- 9 around 5,000 to close to 15,000; and
- 10 WHEREAS, after two years of honorable service in the United States Army, he went to work
- 11 for Southern Bell, retiring in 1990 after 35 years, during which time he acquired a taste for
- 12 public service with a tenure on the Henry County Board of Education from 1964 to 1973,
- 13 then two two-year terms and a three-year term on the McDonough City Council; and
- 14 WHEREAS, Mayor Craig, at the age of 71, has decided to retire from public service to spend
- more time with his wonderful family; and
- 16 WHEREAS, he is leaving behind a legacy that includes playing such an integral role in
- 17 increasing the quality of life of McDonough citizens through the expansion and improvement
- 18 of recreational facilities such as baseball and football fields, that his profound impact has
- 19 been acknowledged by changing the name of the city's park to Richard Craig Park; and
- 20 WHEREAS, because of his magnanimous strengths and unimpeachable reputation for
- 21 integrity, intelligence, fairness, and kindness, and the example he has made of his life, it is
- 22 fair to say that Mayor Craig is responsible for the City of McDonough being known as a
