

The House Committee on Regulated Industries offers the following substitute to
HB 1170:

A BILL TO BE ENTITLED
AN ACT

To amend Chapter 10 of Title 43 of the Official Code of Georgia Annotated, relating to cosmetologists, so as to change certain provisions relating to the Board of Cosmetology; to change certain provisions relating to examination fees for application for certificate of registration; to provide for an effective date; to repeal conflicting laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

SECTION 1.

Chapter 10 of Title 43 of the Official Code of Georgia Annotated, relating to cosmetologists, is amended by striking subsection (c) of Code Section 43-10-2, relating to creation of the Board of Cosmetology, and inserting in lieu thereof the following:

"(c) The board shall meet as necessary each year for the purpose of ~~holding examinations,~~ adopting rules and regulations, and handling other matters pertaining to duties of the board. Board members may attend and observe all written and practical examinations held for certificates of registration pursuant to this chapter.

SECTION 2.

Said chapter is further amended by striking Code Section 43-10-9, relating to application for certificate of registration, examination, work permit, reciprocity, study at technical college or public school, and eligibility of licensed barber, and inserting in lieu thereof the following:

"43-10-9.

(a) Any person desiring to obtain a certificate of registration to enable him or her to engage in the occupation of cosmetology shall make application through the division director to the board and shall present proof that he or she has obtained a high school diploma, a general educational development (GED) diploma, or a postsecondary education or college degree. If, after review of the application, it is determined that the applicant is at least 17

1 years of age; has met the minimum educational requirements; is of good moral character;
2 has completed a 1,500 credit hour study course with at least nine months at a board
3 approved school or has served as an apprentice in a beauty shop or beauty salon for a
4 period of at least 3,000 credit hours; has practiced or studied the occupation of
5 cosmetology; is possessed of the requisite skill in such occupation to perform properly all
6 the duties of the occupation, including his or her ability in the preparation of tools, in
7 performing the services mentioned in paragraph (4) of Code Section 43-10-1, and in all the
8 duties and services incident thereto; ~~has paid to the division director an examination fee in~~
9 ~~such amount as shall be set by the board by regulation; and has presented himself or herself~~
10 ~~at the next meeting of the board held for examination of applicants at which such person~~
11 ~~is scheduled for examination~~ and has passed both a written and a practical examination
12 approved by the board, a certificate of registration shall be issued to him or her entitling
13 him or her to practice the occupation of master cosmetologist. Notwithstanding any other
14 provisions of this subsection, the board shall be authorized to waive any education
15 requirements under this subsection in cases of hardship, disability, or illness or under such
16 other circumstances as the board deems appropriate with respect to any applicant who was
17 enrolled in a board approved school or had completed a board approved study course as of
18 June 30, 2000.

19 (b) Should an applicant under this Code section fail to pass the written or the practical
20 examination, the board shall furnish the applicant a statement in writing, stating wherein
21 the applicant was deficient. Nothing in this chapter shall be construed to prevent applicants
22 from making subsequent applications to qualify under this Code section, provided they
23 again pay the required examination fee.

24 (c) An approved applicant for examination under this Code section may be issued a work
25 permit authorizing said applicant to practice such occupation until the release of the results
26 of the written and the practical examination for which the applicant is scheduled. If the
27 applicant fails to appear for the examination or fails any portion of the examination, the
28 work permit shall be revoked unless the applicant provides just cause to the board as to
29 why the applicant was unable to appear for the examination.

30 (d) Should an applicant have a current cosmetology license in force from another state or
31 country, or territory of the United States, or the District of Columbia, where similar
32 reciprocity is extended to this state and licensure requirements are substantially equal to
33 those in this state, ~~and have paid to the division director a fee in such amount as shall be~~
34 ~~set by the board by regulation~~ and pays a fee and submits an application, the applicant may
35 be issued, without examination, a certificate of registration at the appropriate level,
36 entitling the applicant to practice the occupation of cosmetology or the teaching of
37 cosmetology at that level, unless the board, in its discretion, sees fit to require a written or

1 a practical examination subject to the terms and provisions of this chapter.
2 Notwithstanding any other provisions of this subsection, the board shall be authorized to
3 waive any education or experience requirements applicable to any person who holds a
4 current license or certificate to practice cosmetology outside of this state and who desires
5 to obtain a license or certificate at a level authorized under this Code section to practice at
6 such level in this state in cases of hardship, disability, or illness or under such other
7 circumstances as the board deems appropriate.

8 (e) Any person desiring to obtain a certificate of registration at the esthetician level under
9 the terms of this chapter shall make application through the division director to the board
10 and shall present proof that he or she has obtained a high school diploma, a general
11 educational development (GED) diploma, or a postsecondary education or college degree.
12 If, after review of the application, it is determined that the applicant is at least 17 years of
13 age; has met the minimum educational requirements; is of good moral character; has
14 completed a 1,000 credit hour study course of at least nine months at a board approved
15 school or has served as an apprentice in a beauty shop or beauty salon for a period of at
16 least 2,000 credit hours; has practiced or studied cosmetic skin care as defined in paragraph
17 (5) of Code Section 43-10-1; is possessed of the requisite skill to perform properly these
18 services; ~~has paid to the division director an examination fee in such amount as shall be set~~
19 ~~by the board by regulation; and has presented himself or herself at the next meeting of the~~
20 ~~board for examination of applicants at which such person is scheduled for examination and~~
21 has passed a written and a practical examination approved by the board, a certificate of
22 registration shall be issued to the applicant entitling the applicant to practice the occupation
23 of cosmetology at the esthetician level. Notwithstanding any other provisions of this
24 subsection, the board shall be authorized to waive any education requirements under this
25 subsection in cases of hardship, disability, or illness or under such other circumstances as
26 the board deems appropriate with respect to any applicant who was enrolled in a board
27 approved school or had completed a board approved study course as of June 30, 2000.

28 (f) Any person desiring to obtain a certificate of registration at the nail technician level
29 under the terms of this chapter shall make application through the division director to the
30 board and shall present proof that he or she has obtained a high school diploma, a general
31 educational development (GED) diploma, or a postsecondary education or college degree.
32 If, after review of the application, it is determined that the applicant is at least 17 years of
33 age; has met the minimum educational requirements; is of good moral character; has
34 completed a 525 credit hour study course of at least four months at a board approved
35 school or has served as an apprentice in a beauty shop or beauty salon for a period of at
36 least 1,050 credit hours; has practiced or studied nail care; is possessed of the requisite skill
37 to perform properly these services; ~~has paid to the division director an examination fee in~~

1 ~~such amount as shall be set by the board by regulation, and has presented himself or herself~~
2 ~~at the next meeting of the board held for examination of applicants at which such person~~
3 ~~is scheduled for examination~~ and has passed both a written and a practical examination
4 approved by the board, a certificate of registration shall be issued to the applicant entitling
5 the applicant to practice the occupation of cosmetology at the nail technician level.
6 Notwithstanding any other provisions of this subsection, the board shall be authorized to
7 waive any education requirements under this subsection in cases of hardship, disability, or
8 illness or under such other circumstances as the board deems appropriate with respect to
9 any applicant who was enrolled in a board approved school or had completed a board
10 approved study course as of June 30, 2000.

11 (g) Nothing in this Code section shall be construed as preventing a person from obtaining
12 a certificate of registration for the occupation of cosmetology at the master level, the
13 esthetician level, or the nail technician level if such person obtains his or her credit hour
14 study at a State Board of Education approved school or a technical college under the
15 jurisdiction of the Department of Technical and Adult Education or the Department of
16 Education rather than at a board approved school.

17 (h) A person licensed to practice barbering under Chapter 7 of this title shall be eligible
18 to take the master cosmetologist examination provided for in this Code section if that
19 person completes a board approved 250 hour prescribed course in an approved
20 cosmetology school, submits a completed application, and pays the proper fees established
21 by the board.

22 (i) Board members may attend and observe all written and practical examinations held for
23 certificates of registration pursuant to this Code section."

24 **SECTION 3.**

25 This Act shall become effective upon its approval by the Governor or upon its becoming law
26 without such approval.

27 **SECTION 4.**

28 All laws and parts of laws in conflict with this Act are repealed.
