A BILL TO BE ENTITLED AN ACT

1	To incorporate the City of Johns Creek in Fulton County, Georgia; to provide a charter for
2	the City of Johns Creek; to provide for incorporation, boundaries, and powers of the city; to
3	provide for a governing authority of such city and the powers, duties, authority, election,
4	terms, method of filling vacancies, compensation, qualifications, prohibitions, and removal
5	from office relative to members of such governing authority; to provide for inquiries and
6	investigations; to provide for organization and procedures; to provide for ordinances and
7	codes; to provide for the offices of mayor and city manager and certain duties and powers
8	relative to those offices; to provide for administrative responsibilities; to provide for boards,
9	commissions, and authorities; to provide for a city attorney, a city clerk, a city tax collector,
10	a city accountant, and other personnel; to provide for rules and regulations; to provide for a
11	municipal court and the judge or judges thereof; to provide for practices and procedures; to
12	provide for taxation and fees; to provide for franchises, service charges, and assessments; to
13	provide for bonded and other indebtedness; to provide for accounting and budgeting; to
14	provide for purchases; to provide for the sale of property; to provide for bonds for officials;
15	to provide for eminent domain; to provide for penalties; to provide for definitions and
16	construction; to provide for other matters relative to the foregoing; to provide for a
17	referendum; to provide effective dates; to provide for transition of powers and duties; to
18	provide for directory nature of dates; to provide for a charter commission; to provide for
19	severability; to repeal conflicting laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

21	ARTICLE I
22	INCORPORATION AND POWERS
23	SECTION 1.10.
24	Incorporation.

20

1 The City of Johns Creek in Fulton County is incorporated by the enactment of this charter

- 2 and is constituted and declared a body politic and corporate under the name of the "City of
- 3 Johns Creek." References in this charter to "the city" or "this city" refer to the City of Johns
- 4 Creek. The city shall have perpetual existence.

5	SECTION 1.11	

Corporate boundaries.

- 7 (a) The incorporated area of this city shall include all of that portion of Fulton County as set
- 8 forth and described in Appendix A of this charter, which appendix is incorporated herein by
- 9 reference, subject to approval by the voters at a referendum as provided in Section 7.14 of
- 10 this Act.

- 11 (b) The incorporated area of this city may also include all of that portion of Fulton County
- 12 as set forth and described in Appendix B of this charter, which appendix is incorporated
- herein by reference, subject to approval by the voters at a referendum as provided in Section
- 14 7.14 of this Act.
- 15 (c) After the original incorporation of this city, the boundaries of this city shall be subject
- 16 to such alterations as may be made thereafter from time to time by local law or in the manner
- provided by general state law. As used in this charter, the term "territory" means the area of
- 18 the city as described in this section. The boundaries of this city at all times shall be shown
- on a map, a written description, or any combination thereof, to be retained permanently in
- 20 the office of the city clerk of the city and to be designated, as the case may be: "Official Map
- 21 or Description of the Corporate Limits of the City of Johns Creek, Georgia." Photographic,
- 22 typed, or other copies of such map or description certified by the mayor shall be admitted as
- 23 evidence in all courts and shall have the same force and effect as the original map or
- 24 description.

25 **SECTION 1.12.**

26 Municipal powers.

- 27 (a) This city shall have all powers possible for a city to have under the present or future
- 28 Constitution and laws of this state as fully and completely as though they were specifically
- 29 enumerated in this charter. This city shall have all the powers of self-government not
- 30 otherwise prohibited by this charter or by general law.
- 31 (b) The powers of this city shall be construed liberally in favor of the city. The specific
- 32 mention or failure to mention particular powers shall not be construed as limiting in any way
- 33 the powers of this city. Said powers shall include, but are not limited to, the following:

1 (1) Air and water pollution. To regulate the emission of smoke or other exhaust which 2 pollutes the air and to prevent the pollution of natural streams which flow within the 3 corporate limits of the city;

- (2) Animal regulations. To regulate and license or to prohibit the keeping or running at large of animals and fowl and to provide for the impoundment of same if in violation of any ordinance or lawful order; to provide for the disposition by sale, gift, or humane destruction of animals and fowl when not redeemed as provided by ordinance; and to provide punishment for violation of ordinances enacted under this paragraph;
- 9 (3) Appropriations and expenditures. To make appropriations for the support of the government of the city; to authorize the expenditure of money for any purposes authorized by this charter and for any purpose for which a municipality is authorized by the laws of the State of Georgia; and to provide for the payment of expenses of this city;
- 13 (4) Building regulations. To regulate and to license the erection and construction of 14 buildings and all other structures not inconsistent with general law; to adopt building, 15 housing, plumbing, electrical, gas, and heating and air-conditioning codes; and to regulate
- all housing and building trades except as otherwise prohibited by general law;
- 17 (5) Business regulation and taxation. To levy and to provide for the collection of license 18 fees and taxes on privileges, occupations, trades, and professions; to license and regulate 19 the same; to provide for the manner and method of payment of such licenses and taxes; 20 and to revoke such licenses after due process for the failure to pay any city taxes or fees;
 - (6) Condemnation. To condemn property, inside or outside the corporate limits of the city, for present or future use and for any corporate purpose deemed necessary by the governing authority, utilizing procedures enumerated in Title 22 of the O.C.G.A. or such other laws as are or may hereafter be enacted;
 - (7) Contracts. To enter into contracts and agreements with other governments and entities and with private persons, firms, and corporations;
- 27 (8) Emergencies. To establish procedures for determining and proclaiming that an 28 emergency situation exists inside or outside the city and to make and carry out all 29 reasonable provisions deemed necessary to deal with or meet such an emergency for the 30 protection, safety, health, or well-being of the citizens of the city;
 - (9) Environmental protection. To protect and preserve the natural resources, environment, and vital areas of the city, the region, and the state through the preservation and improvement of air quality, the restoration and maintenance of water resources, the control of erosion and sedimentation, the management of storm water and establishment of a storm-water utility, the management of solid and hazardous waste, and other necessary actions for the protection of the environment;

1 (10) Ethics. To adopt ethics ordinances and regulations governing the conduct of

- 2 municipal elected officials, appointed officials, and employees, establishing procedures
- 3 for handling ethics complaints, and setting forth penalties for violations of such rules and
- 4 procedures;
- 5 (11) Fire regulations. To fix and establish fire limits and from time to time extend,
- 6 enlarge, or restrict the same; to prescribe fire safety regulations, not inconsistent with
- 7 general law relating to both fire prevention and detection and to fire fighting; and to
- 8 prescribe penalties and punishment for violations thereof;
- 9 (12) Garbage fees. To levy, fix, assess, and collect a garbage, refuse, and trash collection
- and disposal and other sanitary service charge, tax, or fee for such services as may be
- 11 necessary in the operation of the city from all individuals, firms, and corporations
- residing in or doing business within the city and benefiting from such services; to enforce
- the payment of such charges, taxes, or fees; and to provide for the manner and method
- of collecting such service charges;
- 15 (13) General health, safety, and welfare. To define, regulate, and prohibit any act,
- practice, conduct, or use of property which is detrimental to the health, sanitation,
- 17 cleanliness, welfare, and safety of the inhabitants of the city and to provide for the
- 18 enforcement of such standards;
- 19 (14) Gifts. To accept or refuse gifts, donations, bequests, or grants from any source for
- any purpose related to the powers and duties of the city and the general welfare of its
- 21 citizens on such terms and conditions as the donor or grantor may impose;
- 22 (15) Health and sanitation. To prescribe standards of health and sanitation within the
- 23 city and to provide for the enforcement of such standards;
- 24 (16) Homestead exemption. To establish and maintain procedures for offering
- 25 homestead exemptions to residents of the city as authorized by Act of the General
- 26 Assembly;
- 27 (17) Jail sentences. To provide that persons given jail sentences in the municipal court
- 28 may work out such sentences in any public works or on the streets, roads, drains, and
- squares in the city; to provide for the commitment of such persons to any jail; or to
- provide for the commitment of such persons to any county work camp or county jail by
- agreement with the appropriate county officials;
- 32 (18) Motor vehicles. To regulate the operation of motor vehicles and exercise control
- over all traffic, including parking, upon or across the streets, roads, alleys, and walkways
- of the city;
- 35 (19) Municipal agencies and delegation of power. To create, alter, or abolish
- departments, boards, offices, commissions, and agencies of the city and to confer upon

such agencies the necessary and appropriate authority for carrying out all the powers

- 2 conferred upon or delegated to the same;
- 3 (20) Municipal debts. To appropriate and borrow money for the payment of debts of the
- 4 city and to issue bonds for the purpose of raising revenue to carry out any project,
- 5 program, or venture authorized by this charter or the laws of the State of Georgia;
- 6 (21) Municipal property ownership. To acquire, dispose of, and hold in trust or
- 7 otherwise any real, personal, or mixed property, in fee simple or lesser interest, inside or
- 8 outside the property limits of the city;
- 9 (22) Municipal property protection. To provide for the preservation and protection of
- property and equipment of the city and the administration and use of same by the public;
- and to prescribe penalties and punishment for violations thereof;
- 12 (23) Municipal utilities. To acquire, lease, construct, operate, maintain, sell, and dispose
- of public utilities, including, but not limited to, a system of waterworks, sewers, and
- drains, sewage disposal, gas works, electric plants, transportation facilities, public
- airports, and any other public utility; and to fix the taxes, charges, rates, fares, fees,
- assessments, regulations, and penalties therefor; and to provide for the withdrawal of
- service for refusal or failure to pay the same; and to authorize the extension of water,
- sewerage, and electrical distribution systems, and all necessary appurtenances by which
- said utilities are distributed, inside and outside the corporate limits of the city; and to
- 20 provide utility services to persons, firms, and corporations inside and outside the
- corporate limits of the city as provided by ordinance;
- 22 (24) Nuisances. To define a nuisance and provide for its abatement whether on public
- or private property;
- 24 (25) Penalties. To provide penalties for violation of any ordinances adopted pursuant to
- 25 the authority of this charter and the laws of the State of Georgia;
- 26 (26) Planning and zoning. To provide comprehensive city planning for development by
- zoning and to provide subdivision regulation and the like as the city council deems
- 28 necessary and reasonable to ensure a safe, healthy, and esthetically pleasing community;
- 29 (27) Police and fire protection. To exercise the power of arrest through duly appointed
- 30 police officers and to establish, operate, or contract for a police and a fire-fighting
- 31 agency;
- 32 (28) Public hazards; removal. To provide for the destruction and removal of any
- building or other structure which is or may become dangerous or detrimental to the
- 34 public;
- 35 (29) Public improvements. To provide for the acquisition, construction, building,
- operation, and maintenance of public ways, parks, playgrounds, recreational facilities,
- cemeteries, markets and market houses, public buildings, libraries, public housing,

1 airports, hospitals, terminals, docks, parking facilities, or charitable, cultural, educational,

- 2 recreational, conservation, sport, curative, corrective, detentional, penal, and medical
- 3 institutions, agencies, and facilities; to provide any other public improvements inside or
- 4 outside the corporate limits of the city; to regulate the use of public improvements; and,
- for such purposes, property may be acquired by condemnation under Title 22 of the
- 6 O.C.G.A. or such other applicable laws as are or may hereafter be enacted;
- 7 (30) Public peace. To provide for the prevention and punishment of drunkenness, riots,
- 8 and public disturbances;
- 9 (31) Public transportation. To organize and operate or contract for such public
- transportation systems as are deemed beneficial;
- 11 (32) Public utilities and services. To grant franchises or make contracts for public
- 12 utilities and public services and to prescribe the rates, fares, regulations, and the standards
- and conditions of service applicable to the service to be provided by the franchise grantee
- or contractor, insofar as not in conflict with valid regulations of the Public Service
- 15 Commission;
- 16 (33) Regulation of roadside areas. To prohibit or regulate and control the erection,
- 17 removal, and maintenance of signs, billboards, trees, shrubs, fences, buildings, and any
- and all other structures or obstructions upon or adjacent to the rights of way of streets and
- roads or within view thereof, inside or abutting the corporate limits of the city and to
- prescribe penalties and punishment for violation of such ordinances;
- 21 (34) Retirement. To provide and maintain a retirement plan for officers and employees
- of the city;
- 23 (35) Roadways. To lay out, open, extend, widen, narrow, establish or change the grade
- of, abandon or close, construct, pave, curb, gutter, adorn with shade trees, or otherwise
- improve, maintain, repair, clean, prevent erosion of, and light the roads, alleys, and
- 26 walkways within the corporate limits of the city; and to negotiate and execute leases over,
- 27 through, under, or across any city property or the right of way of any street, road, alley,
- and walkway or portion thereof within the corporate limits of the city for bridges,
- 29 passageways, or any other purpose or use between buildings on opposite sides of the
- 30 street and for other bridges, overpasses, and underpasses for private use at such location
- and to charge a rental therefor in such manner as may be provided by ordinance; and to
- authorize and control the construction of bridges, overpasses, and underpasses within the
- corporate limits of the city; and to grant franchises and rights of way throughout the
- streets and roads and over the bridges and viaducts for the use of public utilities and for
- 35 private use;
- 36 (36) Solid waste disposal. To provide for the collection and disposal of garbage, rubbish,
- and refuse and to regulate the collection and disposal of garbage, rubbish, and refuse by

1 others; and to provide for the separate collection of glass, tin, aluminum, cardboard,

- 2 paper, and other recyclable materials and provide for the sale of such items;
- 3 (37) Special areas of public regulation. To regulate or prohibit junk dealers, pawn shops,
- 4 the manufacture, sale, or transportation of intoxicating liquors, and the use of firearms;
- 5 to regulate the transportation, storage, and use of combustible, explosive, and
- 6 inflammable materials, the use of lighting and heating equipment, and any other business
- or situation which may be dangerous to persons or property; to regulate and control the
- 8 conduct of peddlers and itinerant traders, theatrical performances, exhibitions, and shows
- 9 of any kind, by taxing or otherwise; and to license, tax, regulate, or prohibit professional
- fortunetelling, palmistry, adult bookstores, adult entertainment, and massage parlors;
- 11 (38) Special assessments. To levy and provide for the collection of special assessments
- to cover the costs of any public improvement;
- 13 (39) Taxes (ad valorem). To levy and provide for the assessment, valuation, revaluation,
- and collection of taxes on all property subject to taxation; provided, however, that:
- 15 (A) For all years, the millage rate imposed for ad valorem taxes on real property shall
- not exceed 4.731 unless a higher limit is recommended by resolution of the city council
- and approved by a majority of the qualified voters of the city; provided, however, that
- for the purposes of compliance with Code Section 48-8-91 of the O.C.G.A., the millage
- rate may be adjusted upward for the sole purpose of complying with the millage rate
- 20 rollback provisions set forth therein;
- 21 (B) For all years, the fair market value of all property subject to taxation shall be
- determined according to the tax digest of Fulton County, as provided in Code Section
- 23 48-5-352 of the O.C.G.A.; and
- 24 (C) For all years, the billing date or dates and due date or dates for municipal ad
- valorem taxes shall be the same as for Fulton County ad valorem taxes;
- 26 (40) Taxes (other). To levy and collect such other taxes as may be allowed now or in the
- 27 future by law;
- 28 (41) Taxicabs. To regulate and license vehicles operated for hire in the city; to limit the
- 29 number of such vehicles; to require the operators thereof to be licensed; to require public
- 30 liability insurance on such vehicles in the amounts to be prescribed by ordinance; and to
- regulate the parking of such vehicles;
- 32 (42) Urban redevelopment. To organize and operate an urban redevelopment program;
- 33 and
- 34 (43) Other powers. To exercise and enjoy all other powers, functions, rights, privileges,
- and immunities necessary or desirable to promote or protect the safety, health, peace,
- security, good order, comfort, convenience, or general welfare of the city and its
- inhabitants; to exercise all implied powers necessary to carry into execution all powers

granted in this charter as fully and completely as if such powers were fully stated in this charter; and to exercise all powers now or in the future authorized to be exercised by other municipal governments under other laws of the State of Georgia; and no listing of particular powers in this charter shall be held to be exclusive of others, nor restrictive of general words and phrases granting powers, but shall be held to be in addition to such powers unless expressly prohibited to municipalities under the Constitution or applicable laws of the State of Georgia.

Exercise of powers.

10 All powers, functions, rights, privileges, and immunities of the city, its officers, agencies, or 11 employees shall be carried into execution as provided by this charter. If this charter makes no provision, such shall be carried into execution as provided by ordinance or as provided 12 13 by pertinent laws of the State of Georgia.

14 **ARTICLE II** 15

GOVERNMENT STRUCTURE, ELECTIONS, AND REMOVAL

16 SECTION 2.10.

City council creation; composition; number; election.

- (a) The legislative authority of the government of this city, except as otherwise specifically provided in this charter, shall be vested in a city council to be composed of a mayor and six councilmembers who shall be elected to Posts 1 through 6. Each person desiring to offer as a candidate for councilmember shall designate the council post for which he or she is offering. (b) The mayor and councilmembers shall serve for terms of four years and until their
- 24 respective successors are elected and qualified, except as otherwise provided in subsection (d) of Section 2.11 of this charter. No person shall be eligible to serve as mayor or 25 councilmember unless that person is at least 21 years of age and shall have been a resident 26 of the territory for 12 months immediately preceding his or her election; and each such 27 28 person shall continue to reside within the city during said period of service and shall be 29 registered and qualified to vote in municipal elections of this city. No person's name shall be listed as a candidate on the ballot for election for either mayor or councilmember unless 30 31 such person shall file a written notice with the clerk of said city that such person desires his 32 or her name to be placed on said ballot as a candidate either for mayor or councilmember and

1 candidate. No person shall be eligible for the office of mayor or councilmember unless such

- 2 person shall file said notice within the time provided for in Chapter 2 of Title 21 of the
- 3 O.C.G.A., the "Georgia Election Code."

4 **SECTION 2.11.**

5 Elections.

- 6 (a) At any election, all persons who are qualified under the Constitution and laws of Georgia
- 7 to vote for members of the General Assembly of Georgia and who are bona fide residents of
- 8 the territory or of said city shall be eligible to qualify as voters in the election.
- 9 (b) All primaries and elections, including without limitation the special election of 2006 to
- 10 elect the first mayor and council, shall be held and conducted in accordance with Chapter 2
- of Title 21 of the O.C.G.A., the "Georgia Election Code." Except as otherwise provided by
- 12 this charter, the city council shall, by ordinance, prescribe such rules and regulations it deems
- 13 appropriate to fulfill any options and duties under the "Georgia Election Code."
- 14 (c) All elections for the mayor and all councilmembers shall be at-large by the voters of the
- 15 entire city.
- 16 (d) The first election for mayor and councilmembers shall be a special election held in 2006
- 17 on the date specified in subsection (e) of this section. At said election, the mayor and
- 18 councilmembers elected to Council Posts 1, 3, and 5 shall be elected for initial terms of office
- 19 beginning immediately after their election and expiring on December 31, 2009. The
- 20 councilmembers elected to Council Posts 2, 4, and 6 shall be elected for initial terms of office
- 21 beginning immediately after their election and expiring on December 31, 2007. Thereafter,
- 22 at the elections provided for by subsection (e) of this section, their successors shall be elected
- 23 for terms of four years. All members shall serve until their successors are elected and
- 24 qualified.
- 25 (e) A special election shall be held on the Tuesday after the first Monday in November,
- 26 2006, to elect the first mayor and council as provided in subsection (d) of this section. At
- 27 such election, the first mayor and council shall be elected to serve for the initial terms of
- 28 office specified in said subsection (d) of this section. Thereafter, the time for holding regular
- 29 municipal elections shall be on the Tuesday next following the first Monday in November
- 30 of each odd-numbered year beginning in 2007. The successors to the first mayor and
- 31 councilmembers and future successors shall be elected at the municipal election immediately
- 32 preceding the expiration of the respective terms of office and shall take office on the first day
- 33 of January immediately following their election for terms of four years and until their
- 34 successors are elected and qualified.
- 35 (f) All municipal elections shall be nonpartisan and without primaries.

1	SECTION 2.12.
2	Vacancies in office.
2	(a)(1) The office of mayor or councilmant or shall become vecent upon the incompant.
3	(a)(1) The office of mayor or councilmember shall become vacant upon the incumbent's
4	death, resignation, forfeiture of office, or removal from office in any manner authorized
5	by this charter or the general laws of the State of Georgia.
6	(2) Upon the suspension from office of mayor or councilmember in any manner
7	authorized by the general laws of the State of Georgia, the city council or those remaining
8	shall appoint a successor for the duration of the suspension. If the suspension becomes
9	permanent, then the office shall become vacant and shall be filled as provided in
0	subsection (b) of this section.
1	(b) In the event that the office of mayor or councilmember shall become vacant, the city
12	council or those remaining shall order a special election to fill the balance of the unexpired
13	term of such official; provided, however, if such vacancy occurs within six months of the
4	expiration of the term of that office, the city council or those members remaining shall
15	appoint a successor for the remainder of the term. In all other respects, the special election
6	shall be held and conducted in accordance with Chapter 2 of Title 21 of the O.C.G.A., the
7	"Georgia Election Code," as now or hereafter amended.
18	SECTION 2.13.
9	Election by majority vote.
20	The candidate receiving a majority of the votes cast for any city office shall be elected.
21	SECTION 2.14.
22	Compensation and expenses.
23	The annual salary of the mayor shall be \$25,000.00 and the annual salary for each
24	councilmember shall be \$15,000.00. Such salary shall be paid from municipal funds in
25	monthly installments. The city council may provide by ordinance for the provision of
26	insurance, retirement, workers' compensation, and other employee benefits to the mayor and
27	members of the city council and may provide by ordinance for the reimbursement of
28	expenses actually and necessarily incurred by the mayor and members of the city council in
29	carrying out their official duties.

1 **SECTION 2.15.**

Prohibitions.

(a) No elected official, appointed officer, or employee of the city or any agency or political
 entity to which this charter applies shall knowingly:

- 5 (1) Engage in any business or transaction or have a financial or other personal interest,
- 6 direct or indirect, which is incompatible with the proper discharge of official duties or
- which would tend to impair the independence of his or her judgment or action in the
- 8 performance of official duties;
- 9 (2) Engage in or accept private employment or render services for private interests when
- such employment or service is incompatible with the proper discharge of official duties
- or would tend to impair the independence of his or her judgment or action in the
- 12 performance of official duties;
- 13 (3) Disclose confidential information concerning the property, government, or affairs of
- the governmental body by which engaged without proper legal authorization or use such
- information to advance the financial or other private interest of himself or herself or
- 16 others;
- 17 (4) Accept any valuable gift, whether in the form of service, loan, object, or promise,
- from any person, firm, or corporation which to his or her knowledge is interested, directly
- or indirectly, in any manner whatsoever in business dealings with the governmental body
- by which he or she is engaged; provided, however, that an elected official who is a
- 21 candidate for public office may accept campaign contributions and services in connection
- with any such campaign;
- 23 (5) Represent other private interests in any action or proceeding against this city or any
- portion of its government; or
- 25 (6) Vote or otherwise participate in the negotiation or in the making of any contract with
- any business or entity in which he or she has a financial interest.
- 27 (b) Any elected official, appointed officer, or employee who has any private financial
- 28 interest, directly or indirectly, in any contract or matter pending before or within any
- 29 department of the city shall disclose such private interest to the city council. The mayor or
- 30 any councilmember who has a private interest in any matter pending before the city council
- 31 shall disclose such private interest and such disclosure shall be entered on the records of the
- 32 city council, and he or she shall disqualify himself or herself from participating in any
- decision or vote relating thereto. Any elected official, appointed officer, or employee of any
- 34 agency or political entity to which this charter applies who shall have any private financial
- interest, directly or indirectly, in any contract or matter pending before or within such entity
- 36 shall disclose such private interest to the governing body of such agency or entity.

1 (c) No elected official, appointed officer, or employee of the city or any agency or entity to

- 2 which this charter applies shall use property owned by such governmental entity for personal
- 3 benefit, convenience, or profit, except in accordance with policies promulgated by the city
- 4 council or the governing body of such agency or entity.
- 5 (d) Any violation of this section which occurs with the knowledge, express or implied, of
- 6 a party to a contract or sale shall render said contract or sale voidable at the option of the city
- 7 council.
- 8 (e) Except as authorized by law, no member of the council shall hold any other elective city

- Removal of officers.
- 14 (a) The mayor, a councilmember, or other appointed officers provided for in this charter
- shall be removed from office for any one or more of the following causes:
- 16 (1) Incompetence, misfeasance, or malfeasance in office;
- 17 (2) Conviction of a crime involving moral turpitude;
- 18 (3) Failure at any time to possess any qualifications of office as provided by this charter
- or by law;
- 20 (4) Knowingly violating Section 2.15 or any other express prohibition of this charter;
- 21 (5) Abandonment of office or neglect to perform the duties thereof; or
- 22 (6) Failure for any other cause to perform the duties of office as required by this charter
- or by state law.
- 24 (b) Removal of any officer pursuant to subsection (a) of this section shall be accomplished
- 25 by one of the following methods:
- 26 (1) By the vote of five councilmembers after an investigative hearing. In the event an
- elected officer is sought to be removed by the action of the city council, such officer shall
- be entitled to a written notice specifying the ground or grounds for removal and to a
- 29 public hearing which shall be held not less than ten days after the service of such written
- 30 notice. Any elected officer sought to be removed from office as provided in this section
- 31 shall have the right of appeal from the decision of the city council to the Superior Court
- of Fulton County. Such appeal shall be governed by the same rules as govern appeals to
- 33 the superior court from the probate court; or
- 34 (2) By an order of the Superior Court of Fulton County following a hearing on a
- complaint seeking such removal brought by any resident of the City of Johns Creek.

3	AUTHORITY, AND ORDINANCES
4	SECTION 3.10.
5	General power and authority.
_	
6	Except as otherwise provided by this charter, the city council shall be vested with all the
7	powers of government of this city as provided by Article I of this charter.
8	SECTION 3.11.
9	Organization.
0	(a) The city council shall hold an organizational meeting at the first regular meeting in
11	January following an election. The meeting shall be called to order by the city clerk or the
12	mayor-elect if the office of clerk is vacant. The city clerk or any judge shall administer the
13	oaths required by Chapter 3 of Title 45 of the O.C.G.A. and the following oath:

	"I do solemnly (swear) (affirm) that I will faithfully perform the duties of (mayor)
15	(councilmember) of this city and that I will support and defend the charter thereof as well
16	as the Constitution and laws of the State of Georgia and of the United States of America."
17	(b) By a majority vote, the city council shall elect a councilmember to serve as mayor pro
8	tempore. The mayor pro tempore shall assume the duties and powers of the mayor during
9	any disability or absence of the mayor. Any such disability or absence shall be declared by
20	a majority vote of the city council.
21	SECTION 3.12.
22	Inquiries and investigations.
12	The city council may make in equipped and investigations into the officing of the city and the
23	The city council may make inquiries and investigations into the affairs of the city and the
24	conduct of any department, office, or agency thereof and for this purpose may subpoena
25	witnesses, administer oaths, take testimony, and require the production of evidence. Any
26	person who fails or refuses to obey a lawful order issued in the exercise of these powers by
27	the council shall be punished as provided by ordinance.

Meetings.

1 SECTION 3.13.

- 3 (a) The city council shall hold regular meetings at such times and places as prescribed by
- ordinance and shall hold at least one regular meeting each month. 4
- of the city council. Notice of such special meeting shall be served on all other members 6

(b) Special meetings of the city council may be held on call of the mayor or four members

- personally, or by telephone personally, at least 48 hours in advance of the meeting. Such 7
- 8 notice to councilmembers shall not be required if the mayor and all councilmembers are
- present when the special meeting is called. Such notice of any special meeting may be 10 waived by a councilmember in writing before or after such a meeting and attendance at the

- 14 (c) All meetings of the city council shall be public to the extent required by law and notice
- 15 to the public of special meetings shall be given as required by law.

16 SECTION 3.14.

17 Procedures.

- 18 (a) The city council shall adopt its rules of procedure and order of business consistent with
- 19 the provisions of this charter and shall provide for keeping a journal of its proceedings which
- 20 shall be a public record.
- 21 (b) All committees and committee chairpersons and officers of the city council shall be
- 22 appointed by the mayor.

23 SECTION 3.15.

24 Voting.

- (a) Except as otherwise provided in subsection (c) of this section, four councilmembers shall 25
- 26 constitute a quorum and shall be authorized to transact the business of the city council. For
- 27 voting and quorum purposes, the mayor shall be counted as one of the councilmembers.
- 28 Voting on the adoption of ordinances shall be by voice vote and the vote shall be recorded
- in the journal, but any member of the city council shall have the right to request a roll-call 29
- 30 vote and such vote shall be recorded in the journal. No councilmember shall abstain from
- voting except in the case of a conflict of interest or if absent when a motion being voted upon 31

1 was made. The councilmember shall provide a specific explanation of the conflict, and the

- 2 explanation shall be recorded in the journal.
- 3 (b) Except as otherwise provided in this charter, the affirmative vote of a majority of the
- 4 councilmembers present shall be required for the adoption of any ordinance, resolution, or
- 5 motion.
- 6 (c) In the event vacancies in office result in less than a quorum of councilmembers holding
- 7 office, then the remaining councilmembers in office shall constitute a quorum and shall be
- 8 authorized to transact business of the city council. A vote of a majority of the remaining
- 9 councilmembers shall be required for the adoption of any ordinance, resolution, or motion.

10 **SECTION 3.16.**

11 Ordinances.

- 12 (a) Every proposed ordinance shall be introduced in writing and in the form required for
- 13 final adoption. No ordinance shall contain a subject which is not expressed in its title. The
- enacting clause shall be "The Council of the City of Johns Creek hereby ordains..." and every
- 15 ordinance shall so begin.
- 16 (b) An ordinance may be introduced by the mayor or any councilmember and be read at a
- 17 regular or special meeting of the city council. Ordinances shall be considered and adopted
- or rejected by the city council in accordance with the rules which it shall establish; provided,
- 19 however, an ordinance shall not be adopted the same day it is introduced, except for
- 20 emergency ordinances provided for in Section 3.18 of this charter. Upon introduction of any
- 21 ordinance, the clerk shall, as soon as possible, distribute a copy to the mayor and to each
- 22 councilmember and shall file a reasonable number of copies in the office of the clerk and at
- 23 such other public places as the city council may designate.

24 **SECTION 3.17.**

Effect of ordinances.

26 Acts of the city council which have the force and effect of law shall be enacted by ordinance.

27 **SECTION 3.18.**

Emergencies.

- 29 To meet a public emergency affecting life, health, property, or public peace, the city council
- 30 may convene on call of the mayor or four councilmembers and may promptly adopt an
- 31 emergency ordinance, but such ordinance shall not levy taxes; grant, renew, or extend a

1 franchise; regulate the rate charged by any public utility for its services; or authorize the borrowing of money except for loans to be repaid within 30 days. An emergency ordinance 2 3 shall be introduced in the form prescribed for ordinances generally, except that it shall be 4 plainly designated as an emergency ordinance and shall contain, after the enacting clause, a declaration stating that an emergency exists and describing the emergency in clear and 5 specific terms. An emergency ordinance may be adopted, with or without amendment, or 6 7 rejected at the meeting at which it is introduced, but the affirmative vote of a majority of the councilmembers present shall be required for adoption. It shall become effective upon 8 9 adoption or at such later time as it may specify. Every emergency ordinance shall 10 automatically stand repealed 30 days following the date upon which it was adopted, but this 11 shall not prevent reenactment of the ordinance in the manner specified in this section if the 12 emergency continues to exist. An emergency ordinance shall also be repealed by adoption 13 of a repealing ordinance in the same manner specified in this section for adoption of 14 emergency ordinances.

15 **SECTION 3.19.**

Codes.

(a) The city council may adopt any standard code of technical regulations by reference thereto in an adopting ordinance. The procedure and requirements governing such adopting ordinance shall be as prescribed for ordinances generally except that: (1) the requirements of subsection (b) of Section 3.16 of this charter for distribution and filing of copies of the ordinance shall be construed to include copies of any code of technical regulations, as well as the adopting ordinance; and (2) a copy of each adopted code of technical regulations, as well as the adopting ordinance, shall be authenticated and recorded by the clerk pursuant to

24 Section 3.20 of this charter.

25 (b) Copies of any adopted code of technical regulations shall be made available by the clerk

26 for distribution or for purchase at a reasonable price.

27 **SECTION 3.20.**

28 Codification of ordinances.

- 29 (a) The clerk shall authenticate by the clerk's signature and record in full in a properly
- 30 indexed book kept for that purpose all ordinances adopted by the council.
- 31 (b) The city shall provide for the preparation of a general codification of all the ordinances
- 32 of the city having the force and effect of law. The general codification shall be adopted by
- 33 the city council by ordinance and shall be published promptly together with all amendments

1 thereto and shall contain such codes of technical regulations and other rules and regulations

- 2 as the city council may specify. This compilation shall be known and cited officially as "The
- 3 Code of the City of Johns Creek, Georgia." Copies of the code shall be furnished to all
- 4 officers, departments, and agencies of the city and shall be made available for purchase by
- 5 the public at a reasonable price as fixed by the city council.
- 6 (c) The city council shall cause each ordinance and each amendment to this charter to be
- 7 printed promptly following its adoption, and the printed ordinances and charter amendments
- 8 shall be made available for purchase by the public at reasonable prices to be fixed by the city
- 9 council. Following publication of the first code under this charter and at all times thereafter,
- 10 the ordinances and charter amendments shall be printed in substantially the same style as the
- 11 code then in effect and shall be suitable in form for incorporation within the code. The city
- 12 council shall make such further arrangements as deemed desirable with reproduction and
- 13 distribution of any changes in or additions to codes of technical regulations and other rules
- 14 and regulations included in the code.

15 **SECTION 3.21.**

Submission of ordinances to the mayor.

- 17 (a) Every ordinance, resolution, and other action adopted by the council shall be presented
- 18 promptly to the mayor for signature. Except for council approval of appointments to
- 19 committees, boards, and commissions, the employment of any appointed officer, internal
- affairs, or matters which must be approved by the voters, the mayor may veto any action
- 21 adopted by the city council.

- 22 (b) The veto must be exercised no later than the next regular city council meeting following
- 23 the meeting at which the action was taken. If an action is disapproved, the mayor shall submit
- 24 to the council a written statement of the reasons for the mayor's veto.
- 25 (c) An action vetoed by the mayor shall automatically be on the agenda at the next regular
- 26 meeting of the city council for reconsideration. If the minimum number of councilmembers
- 27 necessary to vote on overriding the veto are not present, the action may be continued until
- 28 the next meeting at which the minimum number of councilmembers are present. Such action
- 29 shall not become effective unless it is readopted by the affirmative votes of at least five
- 30 councilmembers within 60 days of the veto and for this purpose the mayor shall vote as a

- 32 (d) The mayor may disapprove or reduce any item or items of appropriation in any ordinance
- 33 or resolution. The approved part or parts of any ordinance or resolution making
- 34 appropriations shall become law, and the part or parts disapproved or reduced shall not

1 become law unless subsequently passed by the city council over the mayor's veto as provided

- 2 in this charter.
- 3 (e) If an ordinance or resolution has been signed by the mayor, it shall become effective. If
- 4 an ordinance or resolution is neither approved nor disapproved by the next regular meeting
- 5 of the city council, it shall become effective.

6 **SECTION 3.22.**

Powers and duties of the mayor.

8 (a) The mayor shall be the chief executive officer of the city government, a member of and

- 9 the presiding officer of the city council, and responsible for the efficient and orderly
- 10 administration of the city's affairs. The mayor shall be responsible for the enforcement of
- laws, rules, regulations, ordinances, and franchises in the city. The mayor may conduct
- inquiries and investigations into the conduct of the city's affairs and shall have such powers
- and duties as specified in this charter or as may be provided by ordinance consistent with this
- 14 charter.
- 15 (b) The mayor shall:
- 16 (1) Preside at all meetings of the city council;
- 17 (2) Be the head of the city for the purpose of service of process and for ceremonial
- purposes and be the official spokesperson for the city and the advocate of policy;
- 19 (3) Sign as a matter of course on behalf of the city all written and approved contracts,
- ordinances, resolutions, and other instruments executed by the city which by law are
- 21 required to be in writing;
- 22 (4) See that all laws and ordinances of the city are faithfully executed;
- 23 (5) Vote on any motion, resolution, ordinance, or other question before the council and
- vote on any matter before a committee on which he or she serves;
- 25 (6) Obtain short term loans in the name of the city when authorized by the city council
- 26 to do so;
- 27 (7) Appoint city council committees and appoint councilmembers to oversee and report
- on the functions of the various departments of the city;
- 29 (8) Require the city manager to meet with him or her at a time and place designated for
- consultation and advice upon the affairs of the city;
- 31 (9) Name qualified residents of the city to boards and commissions with approval of the
- 32 city council;
- 33 (10) Nominate the city attorney, city clerk, city tax collector, and city accountant, subject
- to ratification by the city council;

1	(11) Prepare or have prepared an agenda for each meeting of the city council which shall
2	include all business submitted by the mayor, any councilmember, the city manager, and
3	the city attorney; and
4	(12) Fulfill and perform such other duties as are imposed by this charter and duly
5	adopted ordinances.
6	(c) The mayor shall in his or her sole discretion appoint an executive aide to the mayor. The
7	executive aide shall serve at the pleasure of the mayor. The executive aide shall receive a
8	salary comparable to that of city department heads, which salary shall be fixed by the mayor.
9	The executive aide shall report directly to the mayor. The duties and responsibilities of the
10	executive aide shall at all times be as set forth by the mayor. The executive aide shall have
11	the authority, upon the specific request of the mayor, to act on behalf of the mayor in the
12	mayor's ceremonial or administrative capacity. The executive aide shall have no authority
13	to act on behalf of the mayor in a legislative or executive capacity.
14	SECTION 3.23.
15	City manager; appointment, qualification, and compensation.
16	The mayor shall appoint for an indefinite term an officer whose title shall be the "city
17	manager" and the city manager shall serve at the pleasure of the mayor. The city manager
18	shall be appointed without regard to political beliefs and solely on the basis of his or her
19	executive and administrative qualifications with special reference to his or her educational
20	background and actual experience in, and knowledge of, the duties of office as hereinafter
21	prescribed.
22	SECTION 3.24.
23	City manager; chief administrative officer.
24	The city manager shall be the chief administrative officer of the government of the City of
25	Johns Creek. The city manager must devote all of his or her working time and attention to
26	the affairs of the city and shall be responsible to the mayor and council for the proper and
27	efficient administration of the affairs of the city over which said officer has jurisdiction.
28	SECTION 3.25.
29	City manager; powers and duties enumerated.
30	The city manager shall have the power, and it shall be his or her duty to:
31	(1) See that all laws and ordinances are enforced;

1 (2) Appoint and employ all necessary employees of the city, provided that excepted from

- 2 the power of this appointment are those officers and employees who by this Act are
- 3 appointed or elected by the mayor or council or departments not under the jurisdiction of
- 4 the city manager;
- 5 (3) Remove employees employed by said officer without the consent of the council and
- 6 without assigning any reason therefore;
- 7 (4) Exercise supervision and control of all departments and all divisions created in this
- 8 charter or that may hereafter be created by the council except as otherwise provided in
- 9 this Act;
- 10 (5) Attend all meetings of the council with a right to take part in the discussions, but
- having no vote. The city manager shall be entitled to notice of all special meetings;
- 12 (6) Recommend to the council, after prior review and approval by the mayor, for
- adoption such measures as the city manager may deem necessary or expedient;
- 14 (7) See that all terms and conditions imposed in favor of the city or its inhabitants in any
- public utility franchise are faithfully kept and performed and upon knowledge of any
- violation thereof to call the same to the attention of the city attorney, whose duty it shall
- be forthwith to take such steps as are necessary to protect and enforce the same;
- 18 (8) Make and execute all lawful contracts on behalf of the city as to matters within said
- officer's jurisdiction to the extent that such contracts are funded in the city's budget,
- 20 except such as may be otherwise provided by law; provided, however, that no contract
- 21 purchase or obligation requiring a budget amendment shall be valid and binding until
- after approval of the council;
- 23 (9) Act as budget officer to prepare and submit to the council, after review and approval
- by the mayor, prior to the beginning of each fiscal year a budget of proposed expenditures
- for the ensuing year, showing in as much detail as practicable the amounts allotted to
- 26 each department of the city government and the reasons for such estimated expenditures;
- 27 (10) Keep the council at all times fully advised as to the financial condition and needs
- of the city;
- 29 (11) Make a full written report to the council on the first of each month showing the
- 30 operations and expenditures of each department of the city government for the preceding
- 31 month, and a synopsis of such reports shall be published by the clerk of the city;
- 32 (12) Fix all salaries and compensation of city employees in accordance with the city
- budget and the city pay and classification plan; and
- 34 (13) Perform such other duties as may be prescribed by this Act or required by ordinance
- or resolution of the council.

1 **SECTION 3.26.**

2 Council interference with administration.

- 3 Except for the purpose of inquiries and investigations under Section 2.08 of this charter, the
- 4 city council or its members shall deal with city officers and employees who are subject to the
- 5 direction or supervision of the manager solely through the manager, and neither the city
- 6 council nor its members shall give orders to any such officer or employee, either publicly or
- 7 privately.
- 8 **SECTION 3.27.**
- 9 Selection of mayor pro tempore.
- 10 There shall be a mayor pro tempore elected from among the councilmembers by the city
- 11 council. The initial mayor pro tempore shall serve for a term expiring December 31, 2007,
- 12 and successors shall serve for terms of four years. The mayor pro tempore shall continue to
- 13 vote and otherwise participate as a councilmember. A vacancy in the position of mayor pro
- 14 tempore resulting from the mayor pro tempore ceasing to serve as a councilmember or from
- any other cause shall be filled for the remainder of the unexpired term in the same manner
- 16 as the original election.
- 17 **SECTION 3.28.**
- Mayor pro tempore.
- 19 During the absence or physical or mental disability of the mayor for any cause, the mayor
- 20 pro tempore of the city council, or in such person's absence or disability for any reason, any
- 21 one of the councilmembers chosen by a majority vote of the city council, shall be clothed
- 22 with all the rights and privileges of the mayor and shall perform the duties of the office of
- 23 the mayor so long as such absence or disability shall continue. A councilmember acting as
- 24 mayor shall have only one vote. A councilmember acting as mayor shall have veto power
- 25 in the case of disability of the mayor but not in the case of absence of the mayor. Any such
- 26 absence or disability shall be declared by majority vote of all councilmembers. The mayor
- 27 pro tempore or selected councilmember shall sign all contracts and ordinances in which the
- 28 mayor has a disqualifying financial interest.

2	ADMINISTRATIVE AFFAIRS
3	SECTION 4.10.
4	Department heads.
5	(a) Except for the offices of city manager and executive aide to the mayor, the council, by
6	ordinance, may establish, abolish, merge, or consolidate nonelective offices, positions of
7	employment, departments, and agencies of the city as they shall deem necessary for the
8	proper administration of the affairs and government of the city. The council shall prescribe
9	the functions and duties of existing departments, offices, and agencies or of any departments,
10	offices, and agencies hereinafter created or established; may provide that the same person
11	shall fill any number of offices and positions of employment; and may transfer or change the
12	functions and duties of offices, positions of employment, departments, and agencies of the
13	city. The council may also contract with private or governmental parties for the performance
14	of the functions of any such offices, departments, or agencies.
15	(b) Except as otherwise provided by this charter or by law, the directors of departments and
16	other officers of the city shall be appointed solely on the basis of their respective
17	administrative and professional qualifications.
18	(c) All appointed officers and directors of departments shall receive such compensation as
19	prescribed by the city council.
20	(d) There shall be a director of each department or agency who shall be its principal officer.
21	Each director shall, subject to the direction and supervision of the city manager, be
22	responsible for the administration and direction of the affairs and operations of the director's
23	department or agency.
24	(e) The city manager may suspend directors. The director involved may appeal to the city
25	council which, after a hearing, may override the suspension. Any removal of a director shall
26	be by the city council.
27	SECTION 4.11.
28	Boards.
29	(a) The city council shall create by ordinance such boards, commissions, and authorities to
30	fulfill any investigative, quasi-judicial, or quasi-legislative function the city council deems
31	necessary and shall by ordinance establish the composition, period of existence, duties, and
32	powers thereof.
33	(b) All members of boards, commissions, and authorities of the city shall be appointed by
34	the mayor subject to approval by the city council for such terms of office and in such manner

1 as shall be provided by ordinance, except where other appointing authority, terms of office,

- 2 or manner of appointment is prescribed by this charter or by law.
- 3 (c) The city council, by ordinance, may provide for the compensation and reimbursement
- 4 for actual and necessary expenses of the members of any board, commission, or authority.
- 5 (d) Except as otherwise provided by charter or by law, no member of any board,
- 6 commission, or authority shall hold any elective office in the city.
- 7 (e) Any vacancy on a board, commission, or authority of the city shall be filled for the
- 8 unexpired term in the manner prescribed for the original appointment, except as otherwise
- 9 provided by this charter or by law.
- 10 (f) No member of a board, commission, or authority shall assume office until he or she has
- executed and filed with the clerk of the city an oath obligating himself or herself to perform
- 12 faithfully and impartially the duties of the office, such oath to be prescribed by ordinance and
- 13 administered by the mayor.
- 14 (g) Any member of a board, commission, or authority may be removed from office for cause
- by a vote of the city council.
- 16 (h) Except as otherwise provided by this charter or by law, each board, commission, or
- 17 authority of the city shall elect one of its members as chairperson and one member as
- 18 vice-chairperson, and may elect as its secretary one of its members or may appoint as
- 19 secretary an employee of the city. Each board, commission, or authority of the city
- 20 government may establish such bylaws, rules, and regulations, not inconsistent with this
- 21 charter, an ordinance of the city, or law, as it deems appropriate and necessary for the
- 22 fulfillment of its duties or the conduct of its affairs. Copies of such bylaws, rules, and
- 23 regulations shall be filed with the clerk of the city.

24 **SECTION 4.12.**

25 City attorney.

- 26 The mayor shall nominate a city attorney subject to ratification by the council who shall be
- a member of the State Bar of Georgia and shall have actively practiced law for at least one
- 28 year. The city attorney shall serve at the pleasure of the mayor. The city attorney shall be
- 29 responsible for representing and defending the city in all litigation in which the city is a
- 30 party, may be the prosecuting officer in the municipal court, shall attend the meetings of the
- 31 council as directed, shall advise the city council, mayor, and other officers and employees
- 32 of the city concerning legal aspects of the city's affairs, and shall perform such other duties
- as may be required by virtue of the position of city attorney. The city council shall provide
- 34 for the compensation of the city attorney.

SECTION 4.13.

2	City clerk.
3	The mayor shall nominate a city clerk who shall not be a councilmember subject to
4	ratification by the council. The city clerk shall serve at the pleasure of the mayor. The city
5	clerk shall be custodian of the official city seal, maintain city council records required by this
6	charter, and perform such other duties as may be required by the city council. The city
7	council shall provide for the compensation of the city clerk.
8	SECTION 4.14.
9	City tax collector.
0	The mayor shall nominate a city tax collector subject to ratification by the council. The city
1	tax collector shall serve at the pleasure of the mayor. The city tax collector shall collect all
12	taxes, licenses, fees, and other moneys belonging to the city subject to the provisions of this
13	charter and the ordinances of the city and to enforce all laws of Georgia relating to the
4	collection of delinquent taxes and sale or foreclosure for nonpayment of taxes to the city.
15	The city council shall provide for the compensation of the city tax collector.
16	SECTION 4.15.
17	City accountant.
18	The mayor shall nominate a city accountant subject to ratification by the council. The city
9	accountant shall serve at the pleasure of the mayor. The city council shall provide for the
20	compensation of the city accountant.
21	SECTION 4.16.
22	Rules and regulations.
23	The city council shall adopt rules and regulations consistent with this charter concerning:
24	(1) The method of employee selection and probationary periods of employment;
25	(2) The administration of a position classification and pay plan, methods of promotion
26	and applications of service ratings thereto, and transfer of employees within the
27	classification plan;
28	(3) Hours of work, vacation, sick leave, and other leaves of absence, overtime pay, and
29	the order and manner in which layoffs shall be effected;
30	(4) Such dismissal hearings as due process may require; and

17 Roads.

The city council by ordinance shall have the power to assess, charge, and collect the costs of constructing, reconstructing, widening, or improving any public way, street, sidewalk, curbing, gutters, sewers, or other utility mains and appurtenances from the abutting property owners under such terms and conditions as are reasonable. If unpaid, such charges shall be collected as provided in Section 6.18 of this charter.

Other taxes.

If more than one-half of the votes cast on such question in the special election in the area described in Appendix A of this charter are for approval of the Act and one-half or less of the votes cast on such question in the special election in the area described in Appendix B of this charter are for approval of the Act, the territorial limits of the city shall include the area described in Appendix A but shall not include the area described in Appendix B of this charter.

17 Effective dates.

18 (a) Sections 1.10 and 1.11 of this Act and those provisions of the Act necessary for the

- 19 special election provided for in Section 7.14 of this charter shall become effective

- 34 the extent that a power is specifically and integrally related to the provision of a

1 (d) Except as otherwise provided in this section, during the transition period the Municipal 2 Court of the City of Johns Creek shall not exercise its jurisdiction. During the transition 3 period, all ordinances of Fulton County shall remain applicable within the territorial limits 4 of Johns Creek and the appropriate court or courts of Fulton County shall retain jurisdiction to enforce such ordinances. Upon notice by the City of Johns Creek, Fulton County shall 5 transfer all or part of such regulatory authority and the appropriate court jurisdiction to the 6 7 City of Johns Creek as contained in such notice. Any transfer of jurisdiction to the City of Johns Creek during or at the end of the transition period shall not in and of itself abate any 8 9 judicial proceeding pending in Fulton County or the pending prosecution of any violation of 10 any ordinance of Fulton County. (e) During the transition period, the governing authority of Johns Creek may at any time, 11 12 without the necessity of any agreement by Fulton County, commence to exercise its planning and zoning powers; provided, however, that the city shall give the county notice of the date 13 14 on which the city will assume the exercise of such powers. Upon the governing authority of 15 Johns Creek commencing to exercise its planning and zoning powers, the Municipal Court of the City of Johns Creek shall immediately have jurisdiction to enforce the planning and 16 zoning ordinances of the city. The provisions of this subsection shall control over any 17 18 conflicting provisions of any other subsection of this section. 19 (f) Effective upon the termination of the transition period, subsections (b) through (e) of this 20 section shall cease to apply except for the last sentence of subsection (d) which shall remain 21 effective. Effective upon the termination of the transition period, the City of Johns Creek 22 shall be a full functioning municipal corporation and subject to all general laws of this state.

Directory nature of dates.

It is the intention of the General Assembly that this Act be construed as directory rather than mandatory with respect to any date prescribed in this Act. If it is necessary to delay any action called for in this Act for providential cause, delay in securing approval under the federal Voting Rights Act, or any other reason, it is the intention of the General Assembly that the action be delayed rather than abandoned. Any delay in performing any action under this Act, whether for cause or otherwise, shall not operate to frustrate the overall intent of this Act. Without limiting the generality of the foregoing it is specifically provided that:

(1) If it is not possible to hold the referendum election provided for in Section 7.14 of this Act on the date specified in that section, then such referendum shall be held as soon

1 (2) If it is not possible to hold the first municipal election provided for in Section 2.11 2 of this Act on the date specified in that section, then there shall be a special election for 3 the initial members of the governing authority to be held as soon thereafter as is 4 reasonably practicable, and the commencement of the initial terms of office shall be 5 delayed accordingly.

6 **SECTION 7.18.**

7 Charter commission.

- 8 At the first regularly scheduled city council meeting, five years after the inception of the City
- 9 of Johns Creek, the mayor and city council shall create a charter commission to review the
- 10 city's experience and recommend to the General Assembly any changes to the city charter.
- 11 All members of the charter commission must reside in the City of Johns Creek. The
- 12 commission must complete the recommendations within six months of its creation.
