House Bill 978 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED AN ACT

- 1 To amend Article 4 of Chapter 13 of Title 45 of the Official Code of Georgia Annotated,
- 2 relating to the Georgia Capitol Museum, so as to create the Capitol Art Standards
- 3 Commission; to provide for its membership and appointment; to provide for the terms of
- 4 members of the commission and the filling of vacancies; to provide for duties and
- 5 responsibilities; to provide for certain recommendations; to provide a definition; to provide
- 6 for the acceptance of certain funds; to provide a statement of legislative intent; to provide for
- 7 related matters; to repeal Code Section 50-16-5.2 of the Official Code of Georgia Annotated,
- 8 relating to the creation of the Georgia Art Policy Committee; to repeal conflicting laws; and
- 9 for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

SECTION 1.

- 12 Article 4 of Chapter 13 of Title 45 of the Official Code of Georgia Annotated, relating to the
- 13 Georgia Capitol Museum, is amended by designating the existing matters within such article
- 14 as Part 1 and adding a new Part 2 to read as follows:
- 15 "Part 2
- 16 45-13-70.
- 17 (a) There is created the Capitol Art Standards Commission, which is assigned to the Office
- of the Secretary of State for administrative purposes only, as prescribed in Code Section
- 19 50-4-3.
- 20 (b) The Capitol Art Standards Commission shall be comprised of 15 members. Three
- 21 members shall be appointed by the Governor, of whom one shall be designated as
- chairperson. Three members shall be appointed by the Senate Committee on Assignments
- and three members shall be appointed by the Speaker of the House of Representatives.
- One member each shall be appointed by the Georgia Historical Society, the Georgia

1 Council for the Humanities, and the Georgia Council for the Arts. One member each shall

- 2 be appointed by the Board of Regents of the University System of Georgia and the Georgia
- 3 Foundation for Independent Colleges, each of whom shall be proficient in the history of
- 4 the State of Georgia. Each of the appointed members shall serve two-year terms of office
- 5 and shall be eligible to succeed themselves. In addition, the director of the Georgia Capitol
- 6 Museum or his or her designee shall be a member of the commission. Vacancies in the
- 7 positions of appointed members of the commission shall be filled for the remainder of the
- 8 unexpired term of office by the original appointing authority.
- 9 (c) Members of the commission shall serve without compensation but members of the
- 10 commission who are not state officials or employees shall receive the same expense
- allowance per day as that received by a member of the General Assembly for each day such
- member of the commission is in attendance at a meeting of such commission, plus either
- reimbursement for actual transportation costs while traveling by public carrier or the same
- mileage allowance for use of a personal car in connection with such attendance as members
- of the General Assembly receive. Members of the commission who are state officials or
- 16 employees shall receive reimbursement for actual transportation costs in accordance with
- the policies of their respective agencies.
- 18 (d) Membership on the commission does not constitute a public office, and no member
- shall be disqualified from holding public office by reason of his or her membership.
- 20 (e) The commission, with the approval of the Governor, may employ such professional,
- 21 technical, or clerical personnel as deemed necessary to carry out the purposes of this part.
- 22 45-13-71.
- 23 The Capitol Art Standards Commission shall have the following duties and responsibilities:
- 24 (1) To meet at such times and places as it shall determine necessary or convenient to
- 25 perform its duties. The commission shall also meet on the call of the chairperson or the
- 26 Governor;
- 27 (2) To maintain minutes of its meetings;
- 28 (3) To adopt rules and regulations for the transaction of its business;
- 29 (4) To organize itself as it deems appropriate to carry out its functions;
- 30 (5) To be responsible for developing policies and procedures for and to oversee the
- acquisition, installation, preservation, maintenance, display, and storage of all capitol
- artwork. As used in this part, the term 'capitol artwork' means visual art of museum
- quality owned by the State of Georgia that is displayed in or on the grounds of the capitol
- or is held for the purpose of future display to include, but not be limited to, portraits,
- paintings, sculptures, and plaques. The Georgia Capitol Museum shall remain

1 responsible for the documentation, appraisal, control, handling, and conservation of the

- 2 present and future artwork in the capitol art collection;
- 3 (6) To establish a collection policy for all capitol artwork;
- 4 (7) To develop standards and procedures for determining whether to acquire new artwork
- 5 which shall include criteria for judging the relevance of the subject, the historical
- 6 significance to the State of Georgia, and the quality of the artwork produced and an
- 7 approval process for such acquisitions. No artwork shall be acquired or installed without
- 8 final approval of the commission;
- 9 (8) To develop a process for the selection, placement, installation, and rotation of
- artwork in the capitol, in the capitol museum, and on the capitol grounds;
- 11 (9) To develop policies and procedures for outgoing loans from the capitol art collection
- and for temporary displays of artwork in the capitol, in the capitol museum, and on the
- capitol grounds;
- 14 (10) To develop deaccession policies and procedures for artwork in the capitol art
- 15 collection that should be removed based upon poor quality or lack of relevance or similar
- 16 factors; and
- 17 (11) To perform such other duties and responsibilities as required by law.
- 18 45-13-72.
- 19 The Capitol Art Standards Commission may recommend to the Governor and the General
- Assembly changes in state statutes, policies, budgets, and standards relating to the capitol
- 21 art collection, with the objective of keeping the collection at the highest museum standards.
- 22 45-13-73.
- 23 The Capitol Art Standards Commission may accept federal funds granted by Congress or
- 24 executive order for the purposes of this part as well as gifts and donations from individuals,
- 25 private organizations, or foundations. The acceptance and use of federal funds shall not
- commit state funds and shall not place an obligation upon the General Assembly to
- 27 continue the purposes for which the federal funds are made available.
- 28 45-13-74.
- 29 The General Assembly finds that this part constitutes a general law within the meaning of
- 30 Article III, Section VI, Paragraph IV(a) of the Constitution. The General Assembly intends
- 31 that there be no enactment of any bill or resolution proposing a special law with respect to
- 32 capitol artwork."

SECTION 2.

- 2 Code Section 50-16-5.2 of the Official Code of Georgia Annotated, relating to the creation
- 3 of the Georgia Art Policy Committee, is hereby repealed.

4 SECTION 3.

5 All laws and parts of laws in conflict with this Act are repealed.
