## A RESOLUTION

- 1 Recognizing Dr. Lynda D. Woodruff Appreciation Day; and for other purposes.
- 2 WHEREAS, for over 30 years Dr. Woodruff has selflessly given of her time, resources, and
- 3 tireless energy to personally impact the physical therapy profession in a positive manner; and
- 4 WHEREAS, she received her Bachelor of Arts and Master of Science in the first graduate
- 5 program of physical therapy at Case Western Reserve University in 1971 and her Ph.D. from
- 6 Georgia State University in 1984; and
- 7 WHEREAS, Dr. Woodruff made history as the first African American to join the physical
- 8 therapy department as an assistant professor of physical therapy in the Division of Physical
- 9 Therapy School of Medicine at the University of North Carolina; and
- 10 WHEREAS, Dr. Woodruff accepted a position in 1978 as an assistant professor of physical
- 11 therapy at Georgia State University, where she directed the award winning programs for
- 12 minority student recruitment and retention implemented by Dr. Pat Yarbrough, before being
- 13 elevated to associate professor with tenure; and
- 14 WHEREAS, Dr. Woodruff served as a full professor at North Georgia College and State
- 15 University from 1996 to 2005; and
- 16 WHEREAS, in July 1991, Dr. Woodruff was appointed as a full professor with tenure and
- 17 the founding chairperson of the department of physical therapy at North Georgia College in
- 18 Dahlonega, Georgia, the state university system's first post baccalaureate physical therapy
- 19 education program; and
- 20 WHEREAS, Dr. Woodruff has been the recipient of numerous awards and recognitions
- 21 including the APTA Lucy Blair Award, the Kellogg Fellowship for International Leadership,
- 22 and the Distinguished Service Award for the Section on Clinical Electrophysiology;

- 2 a gubernatorial appointment to the Georgia State Board of Physical Therapy on which she
- 3 served for more than ten years; and

- 5 reflected in the organizations of which she is a founding member, including: the Foundation
- 6 for Physical Therapy, the American Academy of Physical Therapy, the Georgia Student
- 7 Physical Therapy Organization, the North American Association of Laser Therapy, the
- 8 Physical Therapy Learning Institute, and the American Congress on Electroncuromyography.
