## A BILL TO BE ENTITLED AN ACT

- 5 3108), an Act approved March 30, 1977 (Ga. L. 1977, p. 4238), an Act approved March 13,
- 6 1978 (Ga. L. 1978, p. 3196), an Act approved April 11, 1979 (Ga. L. 1979, p. 3452), an Act
- 7 approved April 6, 1981 (Ga. L. 1981, p. 4129), an Act approved March 21, 1984 (Ga. L.
- 8 1984, p. 4534), and an Act approved March 28, 1986 (Ga. L. 1986, p. 5545), so as to change
- 9 the compensation of the coroner; to provide an effective date; to repeal conflicting laws; and
- 10 for other purposes.

## BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

SECTION 1.

- 13 An Act abolishing the fee system as the mode of compensation of the Coroner of Spalding

- 15 March 6, 1962 (Ga. L. 1962, p. 3068), as amended, particularly by an Act approved February

- 17 Act approved March 30, 1977 (Ga. L. 1977, p. 4238), an Act approved March 13, 1978 (Ga.
- 18 L. 1978, p. 3196), an Act approved April 11, 1979 (Ga. L. 1979, p. 3452), an Act approved
- 19 April 6, 1981 (Ga. L. 1981, p. 4129), an Act approved March 21, 1984 (Ga. L. 1984, p.
- 20 4534), an Act approved March 28, 1986 (Ga. L. 1986, p. 5545), is amended by striking
- 21 Section 2 of said Act in its entirety and substituting in lieu thereof a new Section 2 to read
- 22 as follows:
- 23 "SECTION 2.
- 24 From and after June 30, 2006, the Coroner of Spalding County shall be paid a salary equal
- 25 to 33.87 percent of the salary of the Sheriff of Spalding County per annum which shall be

1 payable from the funds of Spalding County. Said compensation shall be payable in equal

- 2 monthly installments, as accrued, on the last day of each month, which compensation shall
- 3 be in full payment of all services rendered by said officer and shall be inclusive. Said officer
- 4 shall not receive any other compensation for services performed or for expenses of travel
- 5 within Spalding County incurred by him or her as coroner of said county."

6 SECTION 2.

7 This Act shall become effective on July 1, 2006.

8 SECTION 3.

9 All laws and parts of laws in conflict with this Act are repealed.
