The House Committee on Judiciary offers the following substitute to HB 1073:

- 3 (d) For all other purposes, Parts I and VII of this Act shall become effective upon this Act's
- 4 approval by the Governor or upon its becoming law without such approval.

## **SECTION 7-3.**

6 All laws and parts of laws in conflict with this Act are repealed.
