## A RESOLUTION

- 1 Remembering and honoring the life of Mr. Adam Michael Stevens; and for other purposes.
- 2 WHEREAS, Mr. Adam Michael Stevens of Norcross, Georgia, was born on September 15,  
3 1981, in Asheville, North Carolina; and
- 4 WHEREAS, he was a graduate of Socastee High School in South Carolina and the Georgia  
5 Institute of Technology, where he earned a degree in computer science, and worked as a  
6 project manager for Intelliworks, Inc.; and
- 7 WHEREAS, passionate about politics, he was highly involved in the Young Democrats of  
8 Georgia, beginning with his founding of the Georgia Tech Young Democrats after the 2000  
9 election; and
- 10 WHEREAS, Mr. Stevens served the Young Democrats of Georgia in a variety of leadership  
11 positions, including communications director, vice president of programs, president of the  
12 College Democrats of Georgia, and vice president of membership; and
- 13 WHEREAS, on the chapter level, Mr. Stevens served as president of the Georgia Tech  
14 Young Democrats, communication chair for the Young Democrats of Fulton County, and as  
15 founder and president of the Young Democrats of Gwinnett County; and
- 16 WHEREAS, known for his outspokenness and fervent dedication to his ideals, Mr. Stevens  
17 devoted himself to making the world a better place and was very active in volunteer work on  
18 behalf of the homeless of Atlanta and in several local campaigns; and
- 19 WHEREAS, this intelligent and talented young man was a member of the marching bands  
20 at both his high school and Georgia Tech and was an aspiring Rodeo Saddle Bronc Rider of  
21 the Rodeo; and

1 WHEREAS, he leaves behind a loving and devoted family, including his mother, Jayne  
2 Edwards Stevens; his father, C. Michael Stevens; his two sisters, Megan Jayne Stevens and  
3 Caitlin Louise Stevens; and his grandparents, Charles and Peggy Stevens; and

4 WHEREAS, Mr. Stevens passed away on March 2, 2006, leaving an unfillable void in the  
5 hearts of his many friends and loved ones; and

6 WHEREAS, all who knew this exceptional gentleman will always remember him with the  
7 greatest affection for his tremendous kindness, generosity, and gentle and loving spirit.
