## A RESOLUTION

- 1 Recognizing the Daniel B. Warnell School of Forestry and Natural Resources on its
- 2 centennial anniversary; and for other purposes.
- 3 WHEREAS, the Daniel B. Warnell School of Forestry and Natural Resources was
- 4 established in 1906 by the University of Georgia as the result of a gracious gift from the great
- 5 Georgia born philanthropist and University of Georgia friend George Foster Peabody; and
- 6 WHEREAS, the school, originally established as the George Foster Peabody School of
- 7 Forestry, was granted the mission of training and educating professional foresters to best
- 8 manage and care for this most important natural resource to Georgia; and
- 9 WHEREAS, the forestry and forest products industries have been well established as one of
- 10 the primary traditional industries and economic engines supporting the citizenry in the State
- of Georgia for well over 100 years; and
- 12 WHEREAS, graduates from the school have played an important and significant role in
- 13 increasing Georgia's forest cover to record levels since settlement, while at the same time
- 14 creating and maintaining the largest forest products industry in the nation; and
- 15 WHEREAS, the school has produced outstanding graduates through times of peace and
- abundance, as well as through times of depression and war; and
- 17 WHEREAS, the school continues to enhance its role in the management and conservation
- 18 of Georgia's natural resources by educating future resource managers and scientists in the
- 19 areas of wildlife, forestry, fisheries and aquaculture, and water and soil resources and by
- 20 implementing a newly approved natural resource recreation and tourism program major; and

1 WHEREAS, the school was renamed the Daniel B. Warnell School of Forest Resources in

- 2 1991 resulting from a substantial gift presented to the school by the daughters of the late
- 3 Georgia senator to recognize and honor his many contributions to Georgia; and
- 4 WHEREAS, to better reflect its broader programming mission, the school has recently
- 5 changed its name from the Daniel B. Warnell School of Forest Resources to the Daniel B.
- 6 Warnell School of Forestry and Natural Resources; and
- 7 WHEREAS, it is only fitting this body should recognize this great institution and commend
- 8 it on the occasion of its centennial anniversary.
- 9 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE that the members of this body
- 10 recognize and commend the Daniel B. Warnell School of Forestry and Natural Resources on
- 11 its 100 years as the flagship forestry and natural resource school in the State of Georgia.
- 12 BE IT FURTHER RESOLVED that the Secretary of the Senate is authorized and directed
- 13 to transmit an appropriate copy of this resolution to the Daniel B. Warnell School of Forestry
- 14 and Natural Resources.
