A BILL TO BE ENTITLED AN ACT

1 To provide a new charter for the City of Lithonia in DeKalb County, Georgia; to provide for 2 incorporation, boundaries, and powers of the city; to provide for a governing authority of 3 such city and the powers, duties, authority, election, terms, method of filling vacancies, 4 compensation, qualifications, prohibitions, and removal from office relative to members of 5 such governing authority; to provide for inquiries and investigations; to provide for organization and procedures; to provide for ordinances and codes; to provide for the office 6 7 of mayor and certain duties and powers relative thereto; to provide for administrative responsibilities; to provide for boards, commissions, and authorities and other personnel; to 8 9 provide for rules and regulations; to provide for a municipal court and the judge or judges 10 thereof; to provide for practices and procedures; to provide for taxation and fees; to provide 11 for franchises, service charges, and assessments; to provide for bonded and other 12 indebtedness; to provide for accounting and budgeting; to provide for purchases; to provide 13 for the sale of property; to provide for bonds for officials; to provide for penalties; to provide 14 for definitions and construction; to provide for other matters relative to the foregoing; to 15 provide for transition; to provide for severability; to repeal conflicting laws; and for other 16 purposes.

17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

18	ARTICLE I
19	INCORPORATION AND POWERS

SECTION 1.10.

The City of Lithonia in DeKalb County, Georgia, and the inhabitants thereof, are reincorporated by the enactment of this charter and are hereby constituted and declared a body politic and corporate under the name and style Lithonia, Georgia, and by that name shall have perpetual succession.

	Corporate boundaries.
a) '	The boundaries of this city shall be those existing on the ef
of tl	his charter with such alterations as may be made from the

3 fective date of the adoption (; 4 ime to time in the manner 0 5 provided by law. The boundaries of this city at all times shall be shown on a map, a written description or any combination thereof, to be retained permanently in the office of the city 6 7 clerk and to be designated, as the case may be: "Official Map (or Description) of the 8 corporate limits of the City of Lithonia, Georgia." Photographic, typed, or other copies of 9 such map or description certified by the city clerk shall be admitted as evidence in all courts and shall have the same force and effect as with the original map or description. 10

11 (b) The city council may provide for the redrawing of any such map by ordinance to reflect

12 lawful changes in the corporate boundaries. A redrawn map shall supersede for all purposes

13 the entire map or maps which it is designated to replace.

SECTION 1.12.

15	Powers and construction.

16 (a) This city shall have all powers possible for a city to have under the present or future

17 Constitution and laws of this state as fully and completely as though they were specifically 18 enumerated in this charter. This city shall have all the powers of self-government not

19 otherwise prohibited by this charter or by general law.

20 (b) The powers of this city shall be construed liberally in favor of the city. The specific

21 mention or failure to mention particular powers shall not be construed as limiting in any way22 the powers of this city.

- 23 SECTION 1.13.
- 24 Exercise of powers.

All powers, functions, rights, privileges, and immunities of the city, its officers, agencies, or
employees shall be carried into execution as provided by this charter. If this charter makes
no provision, such shall be carried into execution as provided by ordinance or as provided
by pertinent laws of the State of Georgia.

2	SECTION 2.10.
4	City council creation; number; election.
т	City coulon creation, number, creation.
5	The legislative authority of the government of this city, except as otherwise specifically
6	provided in this charter, shall be vested in a city council to be composed of a mayor and five
7	councilmembers. The city council established shall in all respects be a successor to and
8	continuation of the governing authority under prior law. The mayor and councilmembers
9	shall be elected in the manner provided by general law and this charter.
10	SECTION 2.11.
11	City council terms and qualifications for office.
12	The members of the city council shall serve for terms of four years and until their respective
13	successors are elected and qualified. No person shall be eligible to serve as mayor or
14	councilmember unless that person shall have been a resident of the city for 12 months prior
15	to the date of election of mayor or members of the council; each shall continue to reside
16	therein during that member's period of service and to be registered and qualified to vote in
17	municipal elections of this city.
18	SECTION 2.12.
19	Election of mayor; forfeiture; compensation.
20	The mayor shall be elected and serve for a term of four years and until a successor is elected
21	and qualified. The mayor shall be a qualified elector of this city and shall have been a
22	resident of the city for 12 months preceding the election. The mayor shall continue to reside
23	in this city during the period of service. The mayor shall forfeit the office on the same
24	grounds and under the same procedure as for councilmembers. The compensation of the
25	mayor shall be established in the same manner as for councilmembers.
26	SECTION 2.13.
27	Vacancy; filling of vacancies.
20	
28	(a) Vacancies - The office of mayor or councilmember shall become vacant upon the
29 20	occurrence of any event specified by the Constitution of the State of Georgia, Title 45 of the
30	O.C.G.A., or such other applicable laws as are or may hereafter be enacted.

1 (b) Filling of vacancies - A vacancy in the office of mayor or councilmember shall be filled for the remainder of the unexpired term, if any, by appointment if less than 12 months 2 3 remains in the unexpired term, otherwise by an election, as provided for in Section 5.14 of this charter and in accordance with Titles 21 and 45 of the O.C.G.A. or other such laws as 4 5 are or may hereafter be enacted. 6 SECTION 2.14. 7 Compensation and expenses. 8 The mayor and councilmembers shall receive compensation and expenses for their services 9 as provided by ordinance. 10 **SECTION 2.15.** Holding other office; voting when financially interested. 11 (a) Elected and appointed officers of the city are trustees and servants of the residents of the 12 city and shall act in a fiduciary capacity for the benefit of such residents. 13 14 (b) Except as authorized by law, the mayor or any councilmember shall not hold any other 15 city office or city employment during the term for which that person was elected. (c) Neither the mayor nor any member of the city council shall vote upon, sign, or veto any 16 17 ordinance, resolution, contract, or other matter in which that person is financially interested. 18 SECTION 2.16. 19 Inquiries and investigations. Following the adoption of an authorizing resolution, the city council may make inquiries and 20 investigations into the affairs of the city and the conduct of any department, office, or agency 21 thereof, and for this purpose may subpoena witnesses, administer oaths, take testimony, and 22 23 require the production of evidence. Any person who fails or refuses to obey a lawful order 24 issued in the exercise of these powers by the city council shall be punished as provided by

25 ordinance.

2	Chief executive officer.
3	The mayor shall be the chief executive of this city. The mayor shall possess all of the
4	executive and administrative power granted to the city under the Constitution and laws of the
5	State of Georgia and all the executive and administrative powers contained in this charter.
6	SECTION 2.18.
7	Powers and duties of mayor.
8	The mayor shall:
9	(1) Preside at all meetings of the city council;
10	(2) Be the head of the city for the purpose of service of process and for ceremonial
11	purposes, and be the official spokesperson for the city and the chief advocate of policy;
12	(3) Have power to administer oaths and to take affidavits;
13	(4) Sign as a matter of course on behalf of the city all written and approved contracts,

1	SECTION 2.19.
2	General power and authority of the city council.
3	Except as otherwise provided by law or this charter, the city council shall be vested with all
4	the powers of government of this city.
5	SECTION 2.20.
6	Organizational meetings.
7	The city council shall hold an organizational meeting on the first regularly scheduled meeting
8	in January following the November election. The meeting shall be called to order by the city
9	clerk and the oath of office shall be administered to the newly elected members as follows:
10	"I do solemnly (swear)(affirm) that I will faithfully perform the duties of
11	(mayor)(councilmember) of this city and that I will support and defend the charter thereof
12	as well as the Constitution and laws of the State of Georgia and of the United States of
13	America."
14	SECTION 2.21.
15	Regular and special meetings.
16	(a) The city council shall hold regular meetings at such times and places as shall be
17	prescribed by ordinance.
18	(b) Special meetings of the city council may be held on call of the mayor or two members
19	of the city council. Notice of such special meetings shall be served on all other members
20	personally, or by telephone personally, at least 48 hours in advance of the meeting. Such
21	notice to councilmembers shall not be required if the mayor and all councilmembers are
22	present when the special meeting is called. Such notice of any special meeting may be
23	waived by a councilmember in writing before or after such a meeting, and attendance at the
24 25	meeting shall also constitute a waiver of notice on any business transacted in such
25	councilmember's presence. Only the business stated in the call may be transacted at the
26	special meeting.
27	(c) All meetings of the city council shall be public to the extent required by law, and notice
28 20	to the public of special meetings shall be made as fully as is reasonably possible as provided by Code Section 50.14.1 of the O.C.G.A. or other such applicable laws as are or may

SECTION 2.22.

Rules of procedure.

3 (a) The city council shall adopt its rules of procedure and order of business consistent with

4 the provisions of this charter and shall provide for keeping a journal of its proceedings, which
5 shall be a public record.

6 (b) All committee chairs of the city council shall be appointed by the mayor and shall serve
7 at the pleasure of the mayor. The committee chair may have the power to appoint
8 citizen/volunteer members to be on his or her committee at any time.

SECTION 2.23.

10 Quorum: voting.

Three councilmembers shall constitute a quorum and shall be authorized to transact business of the city council. Voting on the adoption of ordinances shall be by voice vote and the vote shall be recorded in the journal, but any member of the city council shall have the right to request a roll-call vote and such vote shall be recorded in the journal. Except as otherwise provided in this charter, the affirmative vote of three councilmembers shall be required for the adoption of any ordinance, resolution, or motion. An abstention shall not be counted as a vote for or against.

SECTION 2.24.

19 Ordinance form; procedures.

(a) Every proposed ordinance shall be introduced in writing and in the form required for
final adoption. No ordinance shall contain a subject which is not expressed in its title. The
enacting clause shall be "It is hereby ordained by the governing authority of the City of
Lithonia" and every ordinance shall so begin.
(b) An ordinance may be introduced by any councilmember and be read at a regular or
special meeting of the city council. Ordinances shall be considered and adopted or rejected
by the city council in accordance with the rules which it shall establish. Upon introduction

27 of any ordinance, the city clerk shall as soon as possible distribute a copy to the mayor and

to each councilmember and shall file a reasonable number of copies in the office of the city

29 clerk and at such other public places as the city council may designate.

2	Action requiring an ordinance.
3	Acts of the city council which have the force and effect of law shall be enacted by ordinance.
4	SECTION 2.26.
5	Submission of ordinances to the mayor; veto power.
6	(a) Every ordinance adopted by the city council shall be presented promptly by the city clerk
7	to the mayor.
8	(b) The mayor, within ten calendar days of receipt of an ordinance, shall return it to the city
9	clerk with or without the mayor's approval, or with the mayor's disapproval. If the ordinance
10	has been approved by the mayor, it shall become law upon its return to the city clerk; if the
11	ordinance is neither approved nor disapproved, it shall become law at 12:00 Noon on the
12	tenth calendar day after its adoption; if the ordinance is disapproved, the mayor shall submit
13	to the city council through the city clerk a written statement of reasons for the veto. The city
14	clerk shall record upon the ordinance the date of its delivery to and receipt from the mayor.
15	(c) Ordinances vetoed by the mayor shall be presented by the city clerk to the city council
16	at its next meeting. If the city council then or at its next meeting adopts the ordinance by an
17	affirmative vote of two-thirds of its members, it shall become law.
18	(d) The mayor may disapprove or reduce any item or items of appropriation in any
19	ordinance. The approved part or parts of any ordinance making appropriations shall become
20	law, and the part or parts disapproved shall not become law unless subsequently passed by
21	the city council over the mayor's veto as provided herein. The reduced part or parts shall be
22	presented to city council as though disapproved and shall not become law unless overridden
23	by the council as provided in subsection (c) of this section.

SECTION 2.27.

Emergencies.

(a) To meet a public emergency affecting life, health, property, or public peace, the city
council may convene on call of the mayor or two councilmembers and promptly adopt an
emergency ordinance, but such ordinance may not levy taxes; grant, renew, or extend a
franchise; regulate the rate charged by any public utility for its services; or authorize the
borrowing of money except for loans to be repaid within 30 days. An emergency ordinance
shall be introduced in the form prescribed for ordinances generally, except that it shall be
plainly designated as an emergency ordinance and shall contain, after the enacting clause,

1 a declaration stating that an emergency exists and describing the emergency in clear and specific terms. An emergency ordinance may be adopted, with or without amendment, or 2 3 rejected at the meeting at which it is introduced, but the affirmative vote of at least three 4 councilmembers shall be required for adoption. It shall become effective upon adoption or at such later time as it may specify. Every emergency ordinance shall automatically stand 5 repealed 30 days following the date upon which it was adopted, but this shall not prevent 6 7 reenactment of the ordinance in the manner specified in this section if the emergency still exists. An emergency ordinance may also be repealed by adoption of a repealing ordinance 8 9 in the same manner specified in this section for adoption of emergency ordinances.

(b) Such meetings shall be open to the public to the extent required by law, and notice to the
public of emergency meetings shall be made as fully as is reasonably possible in accordance
with Code Section 50-14-1 of the O.C.G.A. or such other applicable laws as are or may

SECTION 2.28.

Codes of technical regulations.

16 (a) The city council may adopt any standard code of technical regulations by reference

17 thereto in an adopting ordinance. The procedure and requirements governing such adopting

18 ordinance shall be as prescribed for ordinances generally except that: (1) the requirements

19 of subsection (b) of Section 2.24 of this charter for distribution and filing of copies of the

20 ordinance shall be construed to include copies of any code of technical regulations, as well

as the adopting ordinance; and (2) a copy of each adopted code of technical regulations, as

22 well as the adopting ordinance, shall be authenticated and recorded by the city clerk pursuant

23 to Section 2.29 of this charter.

24 (b) Copies of any adopted code of technical regulations shall be made available by the city

- 25 clerk for inspection by the public.

SECTION 2.29.

Signing; authenticating; recording; codification; printing.

(a) The city clerk shall authenticate by the city clerk's signature and record in full in aproperly indexed book kept for that purpose all ordinances adopted by the city council.

30 (b) The city council shall provide for the preparation of a general codification of all the

31 ordinances of the city having the force and effect of law. The general codification shall be

32 adopted by the city council by ordinance and shall be published promptly, together with all

33 amendments thereto and such codes of technical regulations and other rules and regulations

1 as the city council may specify. This compilation shall be known and cited officially as "The

2 Code of the City of Lithonia, Georgia." Copies of the code shall be furnished to all officers,

- 3 departments, and agencies of the city and made available for purchase by the public at a
- 4 reasonable price as fixed by the city council.
- 5 (c) The city council shall cause each ordinance and each amendment to this charter to be
- 6 printed promptly following its adoption, and the printed ordinances and charter amendments
- 7 shall be made available for purchase by the public at reasonable prices to be fixed by the city
- 8 council. Following publication of the first code under this charter and at all times thereafter,
- 9 the ordinances and charter amendments shall be printed in substantially the same style as the
- 10 code currently in effect and shall be suitable in form for incorporation therein. The city
- 11 council shall make such further arrangements as deemed desirable with reproduction and
- 12 distribution of any current changes in or additions to codes of technical regulations and other
- 13 rules and regulations included in the code.

15 Selection of mayor pro tempore.

16 By a majority vote of all its members, the city council shall elect a councilmember to serve

17 as mayor pro tempore who shall serve at the pleasure of the city council. The mayor pro

- 18 tempore shall continue to vote and otherwise participate as a councilmember.
- 19

SECTION 2.31.

20 Mayor pro tempore.

21 During the absence or physical or mental disability of the mayor for any cause, the mayor 22 pro tempore, or in the mayor pro tempore's absence or disability for any reason, any one of the councilmembers chosen by a majority vote of the city council, shall be clothed with all 23 the rights and privileges of the mayor and shall perform the duties of the office of the mayor 24 25 so long as such absence or disability shall continue. Any such absence or disability shall be declared by majority vote of all councilmembers. The mayor pro tempore or selected 26 councilmember shall sign all contracts and ordinances in which the mayor has a disqualifying 27 financial interest as provided in Section 2.15 of this charter. 28

3	SECTION 3.10.
4	Administrative and service departments.
5	(a) Except as otherwise provided in this charter, the city council, by ordinance, shall
6	prescribe the functions or duties of, and establish, abolish, alter, consolidate, or leave vacant,
7	all nonelective offices, positions of employment, departments, and agencies of the city as
8	necessary for the proper administration of the affairs and government of this city.
9	(b) Except as otherwise provided by this charter or by law, the directors of departments and
10	other appointed officers of the city shall be appointed solely on the basis of their respective
11	administrative and professional qualifications.
12	(c) All appointive officers and directors of departments shall receive such compensation as
13	prescribed by ordinance.
14	(d) There shall be a director of each department or agency who shall be its principal officer.
15	Each director shall, subject to the direction and supervision of the city council, be responsible
16	for the administration and direction of the affairs and operations of that director's department
17	or agency.
18	SECTION 3.11.
19	Boards, commissions, and authorities.
20	(a) The city council shall create by ordinance such boards, commissions, and authorities to
21	fulfill any investigative, quasi-judicial, or quasi-legislative function as the city council deems

necessary and shall by ordinance establish the composition, period of existence, duties, andpowers thereof.

(b) All members of boards, commissions, and authorities of the city shall be appointed by
the city council for such terms of office and in such manner as shall be provided by
ordinance, except where other appointing authority, terms of office, or manner of
appointment is prescribed by this charter or by law.

28 (c) The city council, by ordinance, may provide for the compensation and reimbursement

29 for actual and necessary expenses of the members of any board, commission, or authority.

30 (d) Except as otherwise provided by charter or by law, no member of any board,31 commission, or authority shall hold any elective office in the city.

32 (e) Any vacancy on a board, commission, or authority of the city shall be filled for the

33 unexpired term in the manner prescribed herein for original appointment, except as otherwise

34 provided by this charter or by law.

1 (f) No member of a board, commission, or authority shall assume office until that person has

2 executed and filed with the city clerk an oath obligating himself or herself to faithfully and

impartially perform the duties of that member's office, such oath to be prescribed by

4 ordinance and administered by the mayor.

5 (g) All board members serve at will and may be removed at any time by a vote of three6 members of the city council unless otherwise provided by law.

7 (h) Except as otherwise provided by this charter or by law, each board, commission, or authority of the city shall elect one of its members as chair and one member as vice chair, 8 9 and may elect as its secretary one of its own members or may appoint as secretary an employee of the city. Each board, commission, or authority of the city government may 10 establish such bylaws, rules, and regulations, not inconsistent with this charter, ordinances 11 12 of the city, or law, as it deems appropriate and necessary for the fulfillment of its duties or the conduct of its affairs. Copies of such bylaws, rules, and regulations shall be filed with the 13 14 city clerk.

SECTION 3.12.

City attorney.

17 The city council shall appoint a city attorney, together with such assistant city attorneys as may be authorized, and shall provide for the payment of such attorney or attorneys for 18 19 services rendered to the city. The city attorney shall be responsible for providing for the 20 representation and defense of the city in all litigation in which the city is a party; may be the 21 prosecuting officer in the municipal court; shall attend the meetings of the city council as 22 directed; shall advise the city council, mayor, and other officers and employees of the city 23 concerning legal aspects of the city's affairs; and shall perform such other duties as may be 24 required by virtue of the person's position as city attorney.

SECTION 3.13.

City clerk.

The city council shall appoint a city clerk who shall not be a councilmember. The city clerk shall be custodian of the official city seal and city records; maintain city council records required by this charter; and perform such other duties as may be required by the city council.

9	There shall be a court to be known as the Municipal Court of the City of Lithonia.
10	SECTION 4.11.
11	Chief judge; associate judge.
12	(a) The municipal court shall be presided over by a chief judge and such part-time, full-time,
13	or stand-by judges as shall be provided by ordinance.
14	(b) No person shall be qualified or eligible to serve as a judge on the municipal court unless
15	that person shall have attained the age of 21 years, shall be a member of the State Bar of
16	Georgia, and shall possess all qualifications required by law. All judges shall be appointed
17	by the city council and shall serve until a successor is appointed and qualified.
18	(c) Compensation of the judges shall be fixed by ordinance.
19	(d) Judges serve at will and may be removed from office at any time by the city council
20	unless otherwise provided by ordinance.
21	(e) Before assuming office, each judge shall take an oath, given by the mayor, that the judge
22	will honestly and faithfully discharge the duties of the office to the best of that person's
23	ability and without fear, favor, or partiality. The oath shall be entered upon the minutes of
24	the city council journal.
25	SECTION 4.12.
26	Convening.

27 The municipal court shall be convened at regular intervals as provided by ordinance.

Jurisdiction; powers.

3 (a) The municipal court shall try and punish violations of this charter, all city ordinances,4 and such other violations as provided by law.

5 (b) The municipal court shall have authority to punish those in its presence for contempt,
6 provided that such punishment shall not exceed \$200.00 or ten days in jail.

7 (c) The municipal court may fix punishment for offenses within its jurisdiction not 8 exceeding a fine of \$1,000.00 or imprisonment for 120 days, or both such fine and 9 imprisonment, or may fix punishment by fine, imprisonment, or alternative sentencing, as 10 now or hereafter provided by law.

11 (d) The municipal court shall have authority to establish a schedule of fees to defray the cost

12 of operation and shall be entitled to reimbursement of the cost of meals, transportation, and

13 caretaking of prisoners bound over to superior courts for violations of state law.

(e) The municipal court shall have authority to establish bail and recognizances to ensure
the presence of those charged with violations before said court and shall have discretionary
authority to accept cash or personal or real property as surety for the appearance of persons
charged with violations. Whenever any person shall give bail for that person's appearance

18 and shall fail to appear at the time fixed for trial, the bond shall be forfeited by the judge

19 presiding at such time and an execution issued thereon by serving the defendant and the

20 defendant's sureties with a rule nisi at least two days before a hearing on the rule nisi. In the

21 event that cash or property is accepted in lieu of bond for security for the appearance of a

22 defendant at trial and such defendant fails to appear at the time and place fixed for trial, the

23 cash so deposited shall be on order of the judge declared forfeited to the city or the property

so deposited shall have a lien against it for the value forfeited which lien shall be enforceable

in the same manner and to the same extent as a lien for city property taxes.

26 (f) The municipal court shall have the same authority as superior courts to compel the27 production of evidence in the possession of any party; to enforce obedience to its orders,

28 judgments, and sentences; and to administer such oaths as are necessary.

(g) The municipal court may compel the presence of all parties necessary to a properdisposal of each case by the issuance of summonses, subpoenas, and warrants which may be

31 served as executed by any officer as authorized by this charter or by law.

32 (h) Each judge of the municipal court shall be authorized to issue warrants for the arrest of

33 persons charged with offenses against any ordinance of the city, and each judge of the

34 municipal court shall have the same authority as a magistrate of the state to issue warrants

35 for offenses against state laws committed within the city.

The city council may assess, levy, and collect an ad valorem tax on all real and personal property within the corporate limits of the city that is subject to such taxation by the state and county. Sale and lease of city property.

3 (a) The city council may sell and convey or lease any real or personal property owned or4 held by the city for governmental or other purposes as now or hereafter provided by law.

5 (b) The city council may quitclaim any rights it may have in property not needed for public

6 purposes upon report by the mayor and adoption of a resolution, both finding that the

7 property is not needed for public or other purposes and that the interest of the city has no

8 readily ascertainable monetary value.

9 (c) Whenever in opening, extending, or widening any street, avenue, alley, or public place 10 of the city, a small parcel or tract of land is cut off or separated by such work from a larger 11 tract or boundary of land owned by the city, the city council may authorize the mayor to sell 12 and convey said cut off or separated parcel or tract of land to an abutting or adjoining property owner or owners where such sale and conveyance facilitates the enjoyment of the 13 14 highest and best use of the abutting owner's property. Included in the sales contract shall be a provision for the rights of way of said street, avenue, alley, or public place. Each abutting 15 property owner shall be notified of the availability of the property and given the opportunity 16 17 to purchase said property under such terms and conditions as set out by ordinance. All deeds 18 and conveyances heretofore and hereafter so executed and delivered shall convey all title and 19 interest the city has in such property, notwithstanding the fact that no public sale after 20 advertisement was or is hereafter made.
