## A RESOLUTION

- 1 Applauding the Association County Commissioners of Georgia and the Georgia Municipal
- 2 Association and urging the Council of Local Governments to address those issues of conflict
- 3 between cities and counties such as service delivery, local government revenues, and land
- 4 use; and for other purposes.
- 5 WHEREAS, cities and counties are important partners to the State of Georgia in providing
- 6 a high quality of life for residents across the state; and
- 7 WHEREAS, cities provide centers of commerce, a sense of place, a variety of municipal
- 8 services, and government closest to the people; and
- 9 WHEREAS, county governments within Georgia have historically and traditionally provided
- 10 constitutionally mandated services and have served as administrative units for the provision
- 11 of state services; and
- 12 WHEREAS, the roles of cities and counties have evolved over the years as the State of
- 13 Georgia and local governments have struggled to accommodate Georgia's swelling
- 14 population; and
- 15 WHEREAS, duplication of services, competition for revenue, and confusion over the proper
- 16 yet distinct roles of cities and counties have been caused by actions of the General Assembly;
- 17 and
- 18 WHEREAS, vibrant, prosperous, and responsive local governments working cooperatively
- 19 with one another and the state are of vital importance to the future health and prosperity of
- 20 the State of Georgia; and
- 21 WHEREAS, the Association County Commissioners of Georgia and the Georgia Municipal
- 22 Association, acting through their respective Board of Managers and Board of Directors, have

1 created the Council of Local Governments as a forum for the elected officials participating

- 2 in each association to discuss areas of agreement and areas of disagreement; and
- 3 WHEREAS, a limited number of issues straining city-county relations surface each year in
- 4 the legislature, prompted by attempts at state-wide solutions to local problems.
- 5 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE that the members of this body
- 6 applaud the Association County Commissioners of Georgia and the Georgia Municipal
- 7 Association for their foresight in creating the Council of Local Governments as a venue to
- 8 openly and candidly address areas of conflict but to also identify areas where cities and
- 9 counties can work together on a common and focused agenda.
- 10 BE IT FURTHER RESOLVED that Senate urges the Council of Local Governments to
- 11 address several of the top issues that create conflict between cities and counties, including
- 12 service delivery, local government revenues, and land use, and to make any
- 13 recommendations for legislative or administrative action.
- 14 BE IT FURTHER RESOLVED that the Secretary of the Senate is authorized and directed
- 15 to transmit an appropriate copy of this resolution to the Association County Commissioners,
- 16 the Georgia Municipal Association, and the Council of Local Governments.
