## BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

### 5 **SECTION 1.** 6 Any other provision of law to the contrary notwithstanding, in addition to all other territory 7 included in the corporate limits of the City of Guyton, the following described property shall 8 also be within and a part of the corporate limits of the City of Guyton: 9 Property in Pleasant Point Subdivision and the vicinity thereof: 10 All that land lying and being in the Tenth G.M. ## **SECTION 2.**

22 Unless prohibited by the federal Voting Rights Act of 1965, as amended, the election superintendent of Effingham County shall call and conduct an election as provided in this 23 24 section for the purpose of submitting this Act to the electors of Effingham County residing 25 in the area described in Section 1 of this Act as the Sugar Hill Community, but outside the existing municipal boundaries of the city, for approval or rejection. 26 The election superintendent shall conduct that election on the earliest date therefor permissible under 27 Code Section 21-2-540 of the O.C.G.A. and shall issue the call and conduct that election as 28 provided by general law. The superintendent shall cause the date and purpose of the election 29 to be published once a week for two weeks immediately preceding the date thereof in the 30 official organ of Effingham County. The ballot shall have written or printed thereon the 31 32 words:

33 "() YES Shall the Act be approved which annexes the Pleasant Point Subdivision

34 () NO community into the corporate limits of the City of Guyton?"

All persons desiring to vote for approval of the Act shall vote "Yes," and all persons desiringto vote for rejection of the Act shall vote "No." If more than one-half of the votes cast on

such question are for approval of the Act, it shall become of full force and effect immediately. If the Act is not so approved or if the election is not conducted as provided in this section, the remaining sections of this Act shall not become effective and this Act shall be automatically repealed on the first day of January immediately following that election date. The expense of such election shall be borne by the City of Guyton. It shall be the

6 election superintendent's duty to certify the result thereof to the Secretary of State.

# 8 The governing authority of the City of Guyton shall through its legal counsel cause this Act 9 to be submitted for preclearance under the federal Voting Rights Act of 1965, as amended; 10 and such submission shall be made to the United States Department of Justice or filed with 11 the appropriate court no later than 30 days after the date on which this Act is approved by the 12 Governor or otherwise becomes law without such approval.

14 Except as otherwise provided in Section 2 of this Act, this Act shall become effective upon

15 its approval by the Governor or upon its becoming law without such approval.

17 All laws and parts of laws in conflict with this Act are repealed.
