

## House Resolution 1920

## A RESOLUTION

1 Proposing an amendment to the Constitution so as to provide for state-wide grand juries; to  
 2 provide for the jurisdiction, powers, and duties of state-wide grand juries; to authorize the  
 3 General Assembly to provide by law for procedures for the summoning and empaneling of  
 4 state-wide grand juries; to provide for a presiding judge; to provide that the Attorney General  
 5 or his or her designee shall act as the legal adviser and prosecutor for such state-wide grand  
 6 juries; to provide for the submission of this amendment for ratification or rejection; and for  
 7 other purposes.

8 BE IT RESOLVED BY THE GENERAL ASSEMBLY OF GEORGIA:

9 **SECTION 1.**

10 Article VI of the Constitution is amended by adding at the end thereof a new Section XI to  
 11 read as follows:

12 "SECTION XI.

13 STATE-WIDE GRAND JURIES

14 Paragraph I. *State-wide grand juries.* (a) State-wide grand juries shall be summoned  
 15 and empaneled upon petition of the Attorney General to the Supreme Court under  
 16 procedures provided by law.

17 (b) A state-wide grand jury shall consist of not fewer than 13 nor more than 23 persons.  
 18 The jurisdiction of a state-wide grand jury shall extend throughout the state, and it may  
 19 investigate and return indictments for crimes committed anywhere within the state. The  
 20 term of any such state-wide grand jury shall not exceed 12 months.

21 (c) The Chief Justice of the Supreme Court shall designate a superior court judge to act  
 22 as presiding judge for each state-wide grand jury. Upon designation by the Chief Justice,  
 23 the presiding judge shall summon and empanel a state-wide grand jury in accordance with  
 24 procedures provided by law.

1 (d) The Attorney General or his or her designee shall act as legal adviser to any  
 2 state-wide grand jury. The Attorney General, in his or her discretion, may designate any  
 3 member of his or her staff or any district attorney to provide legal advice, counsel, or  
 4 assistance to a state-wide grand jury.

5 (e) The subject matter jurisdiction of state-wide grand juries shall extend to the  
 6 investigation and indictment of persons and other legal entities for any crime involving  
 7 corruption in the executive, legislative, or judicial branch of the state, any political  
 8 subdivision or municipality of the state, or any authority or instrumentality of the state, a  
 9 political subdivision, or municipality; fraud by a vendor or recipient of goods or services  
 10 for which funding has been provided by the Department of Medical Assistance; any  
 11 violation of the election laws of this state; violation of the oath of a public officer; bribery;  
 12 false statements, representations, or writings concerning matters within the jurisdiction of  
 13 state and local governments; conspiracy to defraud the state or any political subdivision or  
 14 municipality thereof; and any other criminal activity for which the Governor has directed  
 15 the Attorney General to petition the Supreme Court for the empaneling of a state-wide  
 16 grand jury.

17 (f) It shall not be necessary for a proposed bill of indictment to be presented to a  
 18 state-wide grand jury prior to its engaging in investigative activities. The attendance of  
 19 witnesses and the production of documents at such investigations may be compelled by  
 20 subpoena, signed by any official authorized by the state-wide grand jury to issue such  
 21 process."

## 22 SECTION 2.

23 The above proposed amendment to the Constitution shall be published and submitted as  
 24 provided in Article X, Section I, Paragraph II of the Constitution. The ballot submitting the  
 25 above proposed amendment shall have written or printed thereon the following:

26 "( ) YES Shall the Constitution of Georgia be amended so as to provide for state-wide  
 27 grand juries which shall have the authority to investigate and indict for  
 28 ( ) NO crimes committed anywhere in the state, including those committed by  
 29 public officials; to provide for the types of offenses which may be  
 30 investigated and acted upon by such state-wide grand juries; to provide for  
 31 a presiding judge; to provide authority for the Attorney General or his or her  
 32 designee to act as legal adviser and to prosecute any indictments rendered  
 33 by such state-wide grand juries; and to further authorize the General  
 34 Assembly to establish by law procedures for the summoning and  
 35 empaneling of such state-wide grand jurors?"

- 1 All persons desiring to vote in favor of ratifying the proposed amendment shall vote "Yes."
- 2 All persons desiring to vote against ratifying the proposed amendment shall vote "No." If
- 3 such amendment shall be ratified as provided in said Paragraph of the Constitution, it shall
- 4 become a part of the Constitution of this state.
