## A RESOLUTION

1 Creating the House Study Committee on the Restructuring of DeKalb County Government;  
2 and for other purposes.

3 WHEREAS, DeKalb County's form of government is unique in the state of Georgia; and

4 WHEREAS, the local Act of the General Assembly which established this unique form of  
5 county government and fixed the powers and duties of the officers constituting the governing  
6 authority was enacted in 1981 (Ga. L.1981, p. 4304); and

7 WHEREAS, many portions of the local Act may be amended only after approval by the  
8 voters of DeKalb County in a referendum; and

9 WHEREAS, DeKalb County's form of government was adopted after careful study by  
10 several committees, political representatives, and civic organizations; and

11 WHEREAS, DeKalb County has been through many changes in the nearly 25 years since the  
12 adoption of its form of government, and the time has come for another careful study to  
13 determine if a reorganization of the county's government could provide a government more  
14 representative of the county's citizens and more efficient in the delivery of government  
15 services for the citizens of the county; and

16 WHEREAS, the citizens of DeKalb County would be well served if a distinguished  
17 committee took a critical look at what changes, if any, might best serve the residents of the  
18 county.

19 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that  
20 there is created the House Study Committee on the Restructuring of DeKalb County  
21 Government. The committee shall consist of seven members to be appointed by the Speaker  
22 of the House of Representatives who shall be members who make up the DeKalb County

1 delegation in the House. The members of the committee shall determine by majority vote  
2 who shall serve as chairperson of the committee. The committee shall work in cooperation  
3 with any similar committee established by the Senate. The chairperson shall call all meetings  
4 of the committee.

5 BE IT FURTHER RESOLVED that the committee shall undertake a study of the conditions,  
6 needs, issues, and problems mentioned above or related thereto and recommend any action  
7 or legislation the committee deems necessary or appropriate. The committee may conduct  
8 such meetings at such places and at such times as it may deem necessary or convenient to  
9 enable it to exercise fully and effectively its powers, perform its duties, and accomplish the  
10 objectives and purposes of this resolution. The committee shall, whenever possible, meet  
11 with any similar committee established by the Senate. The legislative members of the  
12 committee shall receive the allowance provided for in Code Section 28-1-8 of the Official  
13 Code of Georgia Annotated. All funds necessary to carry out the provisions of this resolution  
14 shall come from funds appropriated to the House of Representatives. The expenses and  
15 allowances authorized by this resolution shall not be received by any member of the  
16 committee for more than five days unless additional days are authorized. In the event the  
17 committee makes a report of its findings and recommendations, with suggestions for  
18 proposed legislation, if any, such report shall be made on or before December 1, 2006. The  
19 committee shall stand abolished on December 1, 2006.
