A RESOLUTION

- 1 Congratulating Valdosta State University on its 100th anniversary and recognizing Valdosta
- 2 State University Day in Georgia and the Valdosta State University Centennial Years
- 3 Celebration; and for other purposes.
- 4 WHEREAS, in 1906, the General Assembly of Georgia approved legislation establishing
- 5 what is today known as Valdosta State University; and
- 6 WHEREAS, first opening its doors for classes in 1913, the school was originally named
- 7 South Georgia State Normal College and was for women only; and
- 8 WHEREAS, in 1922, a legislative act changed the name to Georgia State Women's College
- 9 and authorized a four-year program leading to a bachelor's degree; and
- 10 WHEREAS, the Georgia Board of Regents of the University System of Georgia made the
- 11 college coeducational in 1950 and changed the school's name to Valdosta State College; and
- 12 WHEREAS, Valdosta State College became Valdosta State University on July 1, 1993,
- making it one of the University System of Georgia's two regional universities; and
- 14 WHEREAS, today, Valdosta State University offers a total of 129 degree programs through
- 15 its five colleges, divisions, and schools, including the College of the Arts, the College of Arts
- and Sciences, the Harley Langdale, Jr., College of Business Administration, the James L. and
- 17 Dorothy H. Dewar College of Education, the College of Nursing, the Division of Social
- 18 Work, the Division of Aerospace Studies (AFROTC), and the Graduate School; and
- 19 WHEREAS, the university is home to 10,500 students coming from 152 of Georgia's 159
- 20 counties, 44 states, and 68 countries, along with a faculty and staff of 1,400; and

1 WHEREAS, Valdosta State University has 46,000 living alumni, including three Honorary

- 2 Co-Chairs of the VSU Centennial Steering Committee, Alfred W. (Bill) Jones III, chairman
- 3 of the Sea Island Company; Martha Barrs (Jones) Robertson, retired, the first female vice
- 4 president at Coca Cola USA; and David Ratcliffe, president, chairman, and CEO of the
- 5 Southern Company; and
- 6 WHEREAS, the university's economic impact on Valdosta's four-county metropolitan
- 7 statistical area annually produces more than \$304 million and 4,900 jobs; and
- 8 WHEREAS, Valdosta State University has a mission to serve 41 counties from the Atlantic
- 9 Ocean to the Alabama state line; and
- 10 WHEREAS, Valdosta State University is the home of the Governor's Honors Program, the
- 11 Peach State Summer Theatre, the Valdosta Symphony Orchestra, and Blazer Athletics, which
- 12 includes the 2004 NCAA Division II National Championship Football Team; and
- WHEREAS, this venerable institution of higher learning will officially celebrate its 100th
- birthday on August 18, 2006, and its Centennial Years during 2006-2013.
- 15 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that
- 16 the members of this body join in congratulating Valdosta State University on its 100th
- 17 anniversary and in recognizing August 18, 2006, as Valdosta State University Day in
- 18 Georgia and the period 2006-2013 as the Valdosta State University Centennial Years
- 19 Celebration.
- 20 BE IT FURTHER RESOLVED that the Clerk of the House of Representatives is authorized
- 21 and directed to transmit an appropriate copy of this resolution to Valdosta State University.
