

House Bill 1614 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED
AN ACT

1 To amend an Act creating a new charter for the City of Glennville, approved August 21,
2 1911 (Ga. L. 1911, p. 1228), as amended, particularly by an Act approved March 22, 1990
3 (Ga. L. 1990, p. 4466), so as to change the corporate limits of the city; to repeal conflicting
4 laws; and for other purposes.

5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 An Act creating a new charter for the City of Glennville, approved August 21, 1911 (Ga. L.
8 1911, p. 1228), as amended, particularly by an Act approved March 22, 1990 (Ga. L. 1990,
9 p. 4466), is amended by adding a new section immediately following Section 2B to read as
10 follows:

12 In addition to any territory lying within the corporate limits of the City of Glennville, such
13 corporate limits shall also include the following:

14 All that certain lot, tract or parcel of land situate, lying and being in the 1432nd G. M.
15 District of Tattnall County, Georgia, containing 42.621 acres, more or less, and being
16 more particularly described on a plat of survey prepared by John O. Parker, Georgia
17 Registered Land Surveyor Number 1850, dated July 10, 2003 and recorded in Plat Book
18 22, Page 116 in the Office of the Clerk of Tattnall Superior Court. Said plat is
19 incorporated herein by reference for descriptive and all other purposes. Said property is
20 bounded now, or formerly, as follows: On the North by lands of Wayne Durrence, lands
21 of Kenneth Brian Nall, lands of Robert P. Hallman, lands of Timothy J. Strickland, lands
22 of Edgar Allen and Rose DeLoach, lands of Susan C. Linnander, lands of Michael A. and
23 Sandra L. Moody, lands of Delta Gamblin, lands of Mrs. P. Maloy Odum and lands of
24 Kenneth R. McDowell, Sr; On the Southeast by the right of way of U. S. Highway 301
25 and lands of Ricky E. Wilson, et al.; On the Southwest by lands of Timothy O. Bland and

1 Larenda S. Bland; and On the West by lands of Weitzel E. Beck, lands of Kathleen Fate,
2 et al., and lands of Steven R. & Bertraud Harris. Said lands described hereinabove are
3 inclusive of the road bed that was formerly identified as County Road 405 and which
4 traverses the lands described herein. Said road was closed by a resolution of the Tattnall
5 County Board of Commissioners dated September 13, 2004 subsequent to the preparation
6 of the plat referenced in this section. Said land is the same as that conveyed by the
7 Development Authority of the City of Glennville by General Warranty Deed to the State
8 of Georgia dated October 2, 2003 which deed is of record in the Office of the Clerk of
9 Tattnall Superior Court in Deed Book 466, Page 639."

SECTION 2.

11 All laws and parts of laws in conflict with this Act are repealed.
