

## House Resolution 9

## A RESOLUTION

1 Relative to officials, employees, and committees in the House of Representatives; and for  
2 other purposes.

3 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that the following  
4 provisions shall be in effect during the 2007 regular session of the General Assembly of  
5 Georgia and for the duration of this General Assembly and until otherwise provided for by  
6 resolution of the House:

## PART 1.

## SECTION 1-1.

9 Subject to the availability of funds appropriated or otherwise available for the House of  
10 Representatives, the Speaker of the House is authorized to employ on behalf of the House  
11 of Representatives: a sergeant-at-arms, a postmaster or postmistress, assistant postmasters  
12 or assistant postmistresses, assistant doorkeepers, pages, aides, secretaries, stenographers,  
13 typists, clerks, porters, court reporters, consultants, and other necessary personnel; and the  
14 Speaker is authorized to provide offices for staff services for the House of Representatives  
15 and to employ personnel for said offices. The numbers and compensation of personnel so  
16 employed pursuant to this section shall be fixed by the Speaker within the limitations of  
17 funds appropriated or otherwise available for the operation of the House of Representatives.  
18 Personnel employed pursuant to this section may be employed on a permanent or temporary  
19 basis and on a part-time or full-time basis, as may be determined by the Speaker. The  
20 assignment and duties of personnel employed pursuant to this section shall be as determined  
21 by the Speaker; and any such personnel may be assigned to House officers, committees,  
22 committee officers, caucuses, and caucus officers as deemed appropriate by the Speaker,  
23 including without limitation assignment of aides to the Speaker Pro Tempore, the Majority  
24 Leader, and the Minority Leader.

**SECTION 1-2.**

The Speaker is also authorized to secure the services of chaplains and interns and provide expense reimbursement allowances for them within the limitations of funds appropriated or otherwise available.

**SECTION 1-3.**

The Doorkeeper of the House and the Messenger of the House, who are elected by the House, shall be compensated in an amount to be fixed by the Speaker of the House.

**PART 2.****SECTION 2-1.**

Subject to the availability of funds appropriated or otherwise available for the Clerk of the House's office, the Clerk of the House is authorized to employ for the Clerk's office: assistant clerks, reading clerks, calendar clerks, journal clerks, secretaries, copy readers, typists, Multilith operators, Xerox operators, collator operators, porter-machinists, roll-call operators, clerical assistants, terminal operators, camera operators, supply and mail clerks, document distributors, audio operators, porters, personnel to distribute bills and other materials for members, and other necessary personnel. The numbers and compensation of personnel employed pursuant to this section shall be fixed by the Clerk within the limitations of funds appropriated or otherwise available for the operation of the Clerk of the House's office. Personnel employed pursuant to this section may be employed on a permanent or temporary basis and on a part-time or full-time basis, as may be determined by the Clerk. The assignment and duties of personnel employed pursuant to this section shall be as determined by the Clerk.

**SECTION 2-2.**

Pursuant to the provisions of Code Section 28-3-23 of the Official Code of Georgia Annotated, the salary of the Clerk of the House shall be the same amount the Clerk was receiving at the time of adoption of this resolution by the House. In addition to that amount, the Clerk shall also receive the same percentage salary increase provided in the General Appropriations Act for employees of the legislative branch of state government. During the Clerk's tenure of office, he or she shall also receive the same expense allowance and the same mileage allowance or travel allowance as received by members of the General Assembly for each day of service rendered by the Clerk.

1 PART 3.

2 SECTION 3-1.

3 Subject to the availability of funds appropriated or otherwise available for the operation of  
4 the Speaker of the House's Office, the Speaker of the House is authorized to employ interns,  
5 aides, secretaries, stenographers, typists, consultants, and other necessary personnel. The  
6 numbers and compensation of personnel employed pursuant to this section shall be fixed by  
7 the Speaker within the limitations of funds appropriated or otherwise available for the  
8 operation of the Speaker of the House's Office. Personnel employed pursuant to this section  
9 may be employed on a permanent or temporary basis and on a part-time or full-time basis as  
10 may be determined by the Speaker. The assignment and duties of personnel employed  
11 pursuant to this section shall be as determined by the Speaker.

12 PART 4.

13 SECTION 4-1.

14 During any day or period of time during which the General Assembly is not in session,  
15 including without limitation any day or period of adjournment during a regular or special  
16 session, each of the following officers shall be a committee of one for each day spent on  
17 official business: The Speaker of the House, the Speaker Pro Tempore, the Majority Leader,  
18 the Majority Whip, the Minority Leader, the Minority Whip, the Administration Floor  
19 Leader, and the Assistant Administration Floor Leaders. For each such day spent on official  
20 business each of such officers shall receive the expense, mileage, and travel allowances  
21 authorized by law for members of interim committees, provided that the Assistant  
22 Administration Floor Leaders shall receive such expense, mileage, and travel allowances  
23 only upon the authorization and approval of vouchers by the Administration Floor Leader.

24 SECTION 4-2.

25 (a) During any day or period of time during which the General Assembly is not in session,  
26 including without limitation any day or period of adjournment during a regular or special  
27 session, each member of the House of Representatives is designated as a committee of one  
28 for the purpose of carrying out legislative duties only within the State of Georgia. For each  
29 such day of service, each member shall receive the expense, mileage, and travel allowances  
30 authorized by law for legislative members of interim legislative committees but shall not  
31 receive the same for more than seven days each year.

32 (b) In addition to the days provided for in subsection (a) of this section and without counting  
33 towards the limit specified in said subsection (a), each member of the House is designated  
34 as a committee of one for the purpose of carrying out legislative duties on any weekday  
35 which: (1) is a one day recess or adjournment during a regular session; and (2) occurs after

1 Monday and prior to Friday. For each such day of service, each member shall receive the  
2 expense and travel allowances (not including mileage which shall be covered by the weekly  
3 round trip) for legislative members of interim legislative committees, if such member has  
4 engaged in legislative business on that day, but not otherwise.

5 **SECTION 4-3.**

6 Pursuant to the provisions of law, in addition to any other compensation they receive as  
7 members of the General Assembly, the Majority Leader, the Minority Leader, and the  
8 Administration Floor Leader each shall receive an amount of \$2,400.00 per annum, as salary,  
9 to be paid in equal monthly or semimonthly installments. Each of the Assistant  
10 Administration Floor Leaders shall likewise receive an amount of \$1,200.00 per annum, as  
11 salary, to be paid in equal monthly or semimonthly installments. Prior to serving as  
12 Administration Floor Leader or as an Assistant Administration Floor Leader, a  
13 Representative must be certified as such by the Governor in writing to the Speaker of the  
14 House and the Clerk of the House.

15 **PART 5.**

16 **SECTION 5-1.**

17 During any period or day of adjournment during a regular or special session, the Speaker is  
18 empowered to give authorization for standing committees of the House and such other  
19 committees as the Speaker might create to remain at the Capitol during any such period of  
20 time for the purpose of considering and studying proposed legislation and other matters.  
21 Members of such committees as shall be designated by the Speaker to remain at the Capitol  
22 shall receive the expense, mileage, and travel allowances authorized by law for members of  
23 interim committees.

24 **SECTION 5-2.**

25 The Speaker is authorized to appoint committees from the members of the House to serve  
26 as interim legislative study committees and for the purpose of performing such duties as the  
27 Speaker shall deem necessary. Such committees are authorized to serve during the interim  
28 and the members thereof shall receive the expense, mileage, and travel allowances authorized  
29 by law for legislative members of interim legislative committees. The Speaker shall  
30 designate the chairperson of any such committee and shall prescribe the time for which any  
31 such committee is authorized to function. The Speaker is authorized to extend the time  
32 allowed for any committee, whether the committee is created by resolution or by the Speaker.  
33 The Speaker is authorized to designate standing committees or any subcommittee thereof to  
34 function during the interim for the purpose of performing such duties as the Speaker shall  
35 deem necessary. The members of any such committee or subcommittee shall receive the

1 expense, mileage, and travel allowances authorized by law for legislative members of interim  
2 legislative committees.

3 **PART 6.**

4 **SECTION 6-1.**

5 The funds necessary to carry out the provisions of Parts 1, 4, and 5 of this resolution shall  
6 come from funds appropriated or otherwise available for the operation of the House of  
7 Representatives. The funds necessary to carry out the provisions of Part 2 of this resolution  
8 shall come from funds appropriated or otherwise available for the operation of the Clerk of  
9 the House's office. The funds necessary to carry out the provisions of Part 3 of this resolution  
10 shall come from funds appropriated or otherwise available for the operation of the Speaker  
11 of the House's Office.

12 **SECTION 6-2.**

13 Any personnel employed pursuant to this resolution shall serve at the pleasure of the  
14 appointing authority; and any such personnel may be discharged by the appointing authority  
15 with or without cause.

16 **SECTION 6-3.**

17 This resolution shall take effect immediately upon its adoption by the House of  
18 Representatives.
