

House Bill 179

A BILL TO BE ENTITLED
AN ACT

1 To create a new judicial circuit for the State of Georgia, to be known as the Walton Judicial
2 Circuit and to be composed of Walton County; to provide for the judges and district attorneys
3 of said new circuit and the Alcovy Judicial Circuit and their terms, selection, and
4 compensation; to revise and restate certain provisions of law relating to the Alcovy Judicial
5 Circuit and to enact provisions for the Walton Judicial Circuit; to amend Article 1 of
6 Chapter 6 of Title 15 of the Official Code of Georgia Annotated, relating to superior courts
7 in general, so as to provide for the composition, terms of court, and number of judges of said
8 circuits; to provide for other related matters; to provide for an effective date and
9 implementation; to repeal conflicting laws; and for other purposes.

10 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

PART I

SECTION 1-1.

13 Effective July 1, 2007, there is created a new judicial circuit of the superior courts of this
14 state to be known as the Walton Judicial Circuit, which circuit shall be composed of Walton
15 County. There shall be a district attorney and two judges of the Walton Judicial Circuit. The
16 offices of judge and district attorney of the Walton Judicial Circuit shall be filled as follows:

17 (1) The district attorney of the Walton Judicial Circuit shall be appointed by the
18 Governor for a term of office beginning July 1, 2007, and ending December 31, 2008,
19 and when his or her successor is elected and qualified. A successor to such district
20 attorney shall be elected by the voters of the Walton Judicial Circuit at the 2008 general
21 election and quadrennially thereafter for a term of four years and until his or her
22 successor is elected and qualified. A candidate for appointment or election to this office
23 must be a resident of Walton County;

24 (2) Honorable John M. Ott, currently a judge of the Alcovy Judicial Circuit and a
25 resident of Walton County, shall become the chief judge of the Walton Judicial Circuit.

1 Judge Ott shall serve out the current term of office for which he was elected, and his
2 successor shall be elected by the voters of the Walton Judicial Circuit at the 2008 general
3 election next preceding the expiration of that term of office, and at the general election
4 quadrennially thereafter, for a term of four years. A candidate for election to this office
5 in 2008 or thereafter must be a resident of Walton County; and

6 (3) Honorable Eugene M. Benton, currently a judge of the Alcovy Judicial Circuit and
7 a resident of Walton County, shall become the second judge of the Walton Judicial
8 Circuit. Judge Benton shall serve out the current term of office for which he was elected,
9 and his successor shall be elected by the voters of the Walton Judicial Circuit at the 2008
10 general election next preceding the expiration of that term of office, and at the general
11 election quadrennially thereafter, for a term of four years. A candidate for election to this
12 office in 2008 or thereafter must be a resident of Walton County.

13 **SECTION 1-2.**

14 All proceedings and litigations, civil, equitable, and criminal, pending in the Superior Court
15 of Walton County at such time as it was a part of the Alcovy Judicial Circuit, including all
16 complaints, pleadings, petitions, indictments, special presentments, summonses, processes,
17 motions, writs, and mesne and final proceedings, together with all books and records of any
18 kind or character belonging to or issued, returnable, filed, pending, or commenced in such
19 county, shall relate to, become a part of, and be transferred to the Walton Judicial Circuit and
20 its jurisdiction.

21 **SECTION 1-3.**

22 In addition to the compensation and expenses paid from state funds, each judge of superior
23 court of the Walton Judicial Circuit named in Section 1-1 of this Act shall continue to receive
24 the supplemental expense allowance that such judge was receiving immediately prior to the
25 effective date of this Act. Such supplemental expense allowance shall be paid from the funds
26 of Walton County.

27 **SECTION 1-4.**

28 In addition to the compensation and expenses paid from state funds, the district attorney of
29 the Walton Judicial Circuit shall receive a supplemental expense allowance of \$15,000.00
30 per annum, payable in equal monthly installments from the funds of Walton County.

31 **SECTION 1-5.**

32 The governing authority of Walton County shall be authorized, but not required, to employ
33 assistant district attorneys, deputy district attorneys, or other attorneys, investigators,

1 paraprofessionals, clerical assistants, victim and witness assistance personnel, and other
2 employees or independent contractors, as authorized under Code Section 15-18-20 of the
3 Official Code of Georgia Annotated.

4 **PART II**
5 **SECTION 2-1.**

6 Effective with the creation of the Walton Judicial Circuit, there shall be a district attorney
7 and two judges of the Alcovy Judicial Circuit which shall then be composed of Newton
8 County. The offices of the judges and district attorney of the Alcovy Judicial Circuit shall
9 be subject to the following provisions:

10 (1) The current district attorney of the Alcovy Judicial Circuit, the Honorable W. Kendall
11 Wynne, Jr., who is a resident of Newton County, shall remain and become the district
12 attorney of the Alcovy Judicial Circuit. District Attorney Wynne shall serve out the
13 current term of office to which he was elected. A successor to District Attorney Wynne
14 shall be elected by the voters of the Alcovy Judicial Circuit at the 2008 general election,
15 and at the general election quadrennially thereafter, for a term of four years. A candidate
16 for appointment or election to this office in 2008 or thereafter must be a resident of
17 Newton County;

18 (2) Honorable Samuel D. Ozburn, currently a judge of the Alcovy Judicial Circuit and
19 a resident of Newton County, shall become the chief judge of the Alcovy Judicial Circuit.
20 Judge Ozburn shall serve out the current term of office for which he was elected, and his
21 successor shall be elected by the voters of the Alcovy Judicial Circuit at the 2008 general
22 election next preceding the expiration of that term of office, and at the general election
23 quadrennially thereafter, for a term of four years. A candidate for election to this office
24 in 2008 or thereafter must be a resident of Newton County; and

25 (3) Honorable Horace J. Johnson, currently a judge of the Alcovy Judicial Circuit and
26 a resident of Newton County, shall remain as a judge of the Alcovy Judicial Circuit.
27 Judge Johnson shall serve out the current term of office for which he was selected, and
28 his successor shall be elected by the voters of the Alcovy Judicial Circuit at the 2008
29 general election next preceding the expiration of that term of office, and at the general
30 election quadrennially thereafter, for a term of four years. A candidate for election to this
31 office in 2008 or thereafter must be a resident of Newton County.

SECTION 2-2.

In addition to the compensation and expenses paid from state funds, each judge of superior court of the Alcovy Judicial Circuit named in Section 2-1 of this Act shall continue to receive the supplemental expense allowance that such judge was receiving immediately prior to the effective date of this Act. Such supplemental expense allowance shall be paid from the funds of Newton County.

SECTION 2-3.

In addition to the compensation and expenses paid from state funds, the district attorney of the Alcovy Judicial Circuit shall receive a supplemental expense allowance of \$15,000.00 per annum, payable in equal monthly installments from the funds of Newton County.

SECTION 2-4.

The governing authority of Newton County shall be authorized, but not required, to employ assistant district attorneys, deputy district attorneys, or other attorneys, investigators, paraprofessionals, clerical assistants, victim and witness assistance personnel, and other employees or independent contractors, as authorized under Code Section 15-18-20 of the Official Code of Georgia Annotated.

PART III

SECTION 3-1.

Article 1 of Chapter 6 of Title 15 of the Official Code of Georgia Annotated, relating to superior courts in general, is amended by adding a new paragraph (40.2) to Code Section 15-6-1, relating to composition of judicial circuits, to read as follows:

"(40.2) Walton Judicial Circuit, composed of the County of Walton;"

and by revising paragraph (2) to read as follows:

"(2) Alcovy Judicial Circuit, composed of the ~~Counties~~ County of Newton ~~and Walton~~;"

SECTION 3-2.

Said article is further amended in Code Section 15-6-2, relating to numbers of superior court judges, by adding a new paragraph (40.2) to read as follows:

"(40.2) Walton Circuit 2"

and by revising paragraph (2) to read as follows:

"(2) Alcovy Circuit4 2".

SECTION 3-3.

Said article is further amended by adding a new paragraph (40.2) to Code Section 15-6-3, relating to terms of court, to read as follows:

"(40.2) WALTON CIRCUIT:

Walton County - First and second Mondays in February, May, August, and November."

and by revising paragraph (2) to read as follows:

"(2) ALCOVY CIRCUIT:

(A) Newton County - Second and third Mondays in January, April, July, and October.

~~(B) Walton County - First and second Mondays in February, May, August, and November."~~

PART IV**SECTION 4-1.**

This Act shall become effective July 1, 2007, except that the provisions of this Act authorizing the Governor to make appointments shall become effective for those purposes upon the approval of this Act by the Governor or upon its becoming law without such approval.

SECTION 4-2.

All laws and parts of laws in conflict with this Act are repealed.
