- 1 Commending and congratulating Jill Goforth on her appointment as the principal of New
- 2 Holland Elementary School; and for other purposes.

- 3 WHEREAS, Jill Goforth received her calling as an educator while she was only in the second
- 4 grade when she realized that she wanted to be just like her teacher at the old Candler Street
- 5 School in Gainesville, Georgia; and

- 6 WHEREAS, she comes from a long legacy of educators as her grandmother and aunt were
- 7 teachers, her mother substitute taught for many years, and she has two sisters who teach at
- 8 Centennial Elementary School; and

- 9 WHEREAS, she earned her bachelor's and master's degrees in education as well as a
- 10 master's add-on in leadership and administration from the University of Georgia, and she
- 11 obtained her specialist degree from Brenau University in Gainesville, Georgia; and

- 12 WHEREAS, she began her professional education career at Oakwood Elementary School,
- 13 where she taught second grade for seven years and then took some time off to raise her two
- 14 children, Key and Preston, before serving two years as the director of preschool at the First
- 15 Baptist Church; and

- 16 WHEREAS, she spent the rest of her teaching years at Enota and Centennial Elementary
- 17 Schools before helping to open New Holland Elementary School in 2003 and serving as the
- 18 school's assistant principal for three years; and

- 19 WHEREAS, on December 6, 2006, the Gainesville City Board of Education named Jill
- 20 Goforth as the principal of New Holland Elementary School; and

- 21 WHEREAS, she is widely recognized throughout the state as the personification of
- 22 excellence in education; and

1 WHEREAS, this highly respected teacher and administrator believes that her role as an
2 educator is to prepare children to become adults and to do whatever it takes to reach students
3 and make sure that they are successful, which is exactly what she has been doing and will
4 continue to do at New Holland Elementary School; and

5 WHEREAS, Jill Goforth is a shining example of the important impact that the efforts of
6 educators and school administrators are making on the quality of education received by the
7 children of this state and it is abundantly fitting and proper that her superlative
8 accomplishment of being named principal of New Holland Elementary School be recognized
9 appropriately.
